

QUESTION . IV. ...

What Ministers have died since the last Conference?

ANSWER.

1. WILLIAM CROSCOMBE; who was born at Tiverton, England, on the 19th of February, 1789. When about eighteen years of age he first became acquainted with the Methodists, and was deeply convinced of sin. But having no spiritual friends to counsel him he relapsed into carelessness, until about two years after, when, under severe affliction, he began earnestly to seek salvation. At a Sabbathmorning Prayer Meeting he subsequently found mercy, and rejoiced in the liberty of the sons of God. A few months afterwards he was induced by the inward call of the Holy Spirit, and at the solicitation of beloved friends, to exhort sinners to turn to God by sincere repentance. In the discharge of this duty he was honored with success, while the effect upon his own mind was highly beneficial. His character and labors marked him out as a suitable candidate for the work of the ministry, and after passing the usual examinations he was appointed to an English Circuit in 1810. Having offer-

ed his services to the Missionary Committee, he was sent out to Nova Scotia, where he arrived on the 12th of April, 1812. Seven years were then spent in this Province and in New Brunswick, when, his health being somewhat impaired, he returned to England and labored two years in Nottingham. At the end of that time, with restored vigor, he entered the foreign work, and was appointed to Gibraltar. Here he labored for upwards of three years, and was then transferred to St. John's, Newfoundland. After leaving this he passed five years in Halifax and Windsor, and the following five in Canada. He returned to Nova Scotia in 1838, and continued to occupy some of the most important Circuits until the year 1851, when increasing infirmities compelled him to become a Supernumerary. Having fixed his residence in Halifax, he spent four years in that city, engaging, as his strength would permit, in private and public ministerial duties. His last sermon was delivered on Sabbath. the 31st of December, 1854, from the text, "What is your life? it is even a vapor that appeareth for a little time, and 'then vanisheth away." Shortly after returning from the . house of God he was seized with paralysis, which, for several months, kept him on the margin of eternity. But having overcome the severity of this attack he removed to Windsor, where he resided till his death. Our departed brother was an exemplary disciple and faithful minister of the Lord Jesus Christ. His piety was simple and ardent, and he conscientiously endeavored to enjoy all those blessings which he felt himself commissioned to preach. During a powerful revival of religion at Montreal in the year 1834, he experienced the blessing of entire sanctification, and it is believed by those who knew him best that he never lost the influence of that great work in the soul. In preparing for his public duties he was industrious, and in their performance he was punctual and persevering. Pastoral visitation was a source of delight to him, and his habits in this respect greatly endeared him to all classes. Under his ministry revivals of religion were not unfrequent, and he was no less successful in building up believers than in winning souls to Christ. Unbiased by sectarian jealousy, he was nevertheless by principle a Methodist, and had a high regard for our economy and institutions. To his Brethren in the Ministry he was strongly

attached, and they reposed great confidence in his kindness and fidelity. He successively occupied the Chairmanship of his District in Newfoundland, Nova Scotia, and Canada, and for his prudence and integrity in that important office he secured the esteem both of the Missionary Committee and of the Brethren who labored under his superintendence. From the period when he was obliged to relinquish all active duties he continued to suffer the will of God with patience. His mind was generally serene, and his conversation invariably turned upon the things of God. The language of praise often dwelt upon his lips; but for the last eight months of his life the peculiar character of his affliction precluded the experience of much joy. Nevertheless he salvation of Christ was his only theme, and the blood of Christ his only hope.

On the last day of his life he recognized a Brother Minister, and sensibly gave him a token of that peace with God and hope of heaven of which his tongue could no longer convey any expression. During the night of the 26th of August, 1859, he fell asleep in Jesus, in the seventy-third year of his age, and the fiftieth of his Ministry.

2. RICHARD KNIGHT, D. D. ; who was born in Devonshire, England, in the year 1788, and died May 23rd, 1860. Mr. Knight spent his early life in the usual pursuits of boyhood; and while he gave early indication of that strength of intellect which characterized his after life, yet he did not exhibit the promise of that piety which subsequently rendered his life a blessing to so many. Upon the verge of manhood he was awakened to a sense of his sinfulness by a powerful dream, the impression of which followed him through life. His piety soon assumed a manly and decided stamp; and while it shone conspicuously in the family circle, leading to the conversion of his parents and brothers, it also led him beyond his more immediate neighborhood in endeavoring to After exercising his gifts as a local reclaim the lost. preacher for some time, in his native country, he was accepted by the British Conference in 1816 as a candidate for missionary work, and was sent by the Committee to Newfoundland. In this Island he labored with great diligence to extend the boundaries of the Redeemer's kingdom. Travelling frequently on foot from place to place, he spared no

effort and shrunk from no sacrifice that he might win souls to Christ. Many are the seals to his ministry in Newfoundland, and his name is cherished as a household word in every Circuit where he labored. Methodism in that colony owes much to his evangelistic labors. After sixteen years of effec-. tive toil in Newfoundland, Mr. Knight was transferred by the British Conference to Nova Scotia; in which Province, as well as in New Brunswick and Prince Edward Island, he occupied the most important positions and rendered services to the cause of Christ certainly unsurpassed by those of any of his fellow-laborers in these Colonies. The confidence réposed in his piety, fidelity, and prudence, by the Parent body was evinced by the long series of years during which he sustained the responsible office of Chairman and General Superintendent, with whatever geographical department of the work he happened to become connected. Since the organization of the affiliated Conference of Eastern British America, the pastoral supremacy of the English Conference, not less than the suffrages of the members of our own, assigned to him the honorable functions of Co-Delegate. To every post of duty he brought the same high principles of incorruptible integrity, and whilst displaying on all occasions a spirit of the most expansive catholicity towards the various sections of the Christian commonwealth, he was never known to falter in his allegiance to the polity of Methodism, or to compromise any of its doctrines. A firm and consistent believer in all the doctrines of Methodism, he sought and obtained, about eight years since, the perfect love of God, and retained this precious privilege of the Christian until he was forever perfected in heaven. His death, though he had measured out his three score years and ten, will long be felt throughout the bounds of our Conference as a heavy bereavement, and it will be felt the more as it was sudden and unexpected. He left his home in his usual state of health and exhibiting every appearance of robust vigor, to attend a meeting of our Academic Board, at Sackville, on the 12th of May last. On the following Sabbath he preached with apparent comfort, and an especial measure of holy unction. On the Monday and Tuesday he attended the examination exercises of the Institution, and in a week from that time his athletic frame not only succumbed to the violence of disease, but sank exhausted into

the arms of death, in the 72nd year of his age and the 44th of his ministry. Brother Knight was the oldest effective Missionary in the world belonging to the Body sent out by the Missionary Committee-one who labored consecutively the whole period of his Ministry without a temporary retirement. It is a matter of devout gratulation that the heavenly serenity of his mind was not for a moment disturbed in his last illness by the apprehension of death, or any other species of temptation. Calmly victorious over the last enemy he entered into peace, and grasping the verdant palm of eternal triumph, has bequeathed to us who survive him an example of vigorous faith, of holy diligence, and of charity that never faileth. A few days before his death he summoned his family around him, and, in language ever to be remembered by them, gave his parting counsel, reminding them of their obligations to God, and charging each to meet him in the better Just before his death he was apparently absorbed in world. heavenly meditation, and observing that he was endeavoring to articulate something, a listening ear was placed to his lips, when he was heard to say quite distinctly, "I see his glory ! Halelujah !" And. in a few moments more he entered forever into its unclouded splendor.

THEOLOGICAL PROFESSORSHIP.

QUESTION XVI.

What are the Resolutions of the Conference respecting the Charles F. Allison Professorship of Theology?

ANSWER.

1. That while attaching the same high importance which Methodism has ever done to the maintenance of a converted and divinely-called Ministry in the Church, and being resolved to keep inviolate every guard for the preservation of the spiritual qualifications of that Ministry, the Conference is nevertheless profoundly impressed with the urgent necessity of founding an institution for the suitable training of our Ministerial candidates prior to an entrance upon their work, agreeably with the plan entertained and resolved upon at the last Conference.

2. That the Conference is much gratified with the result of the applications made during the past year in the several Districts of our Connexion on behalf of the Professorship Endowment Fund, as affording evidence that the object contemplated is one which commends itself strongly to the intelligence and affection of our people generally; and assuming that the aid of our friends in different Districts to whom application has not yet been made, will be found to be liberal in the same proportion, every reasonable indication is presented that the amount proposed as necessary to be obtained for the establishment of the Endowment of the Chair of Theology will be realized.

5. That the agent or agents of this Fund be authorised to effect a compromise with any of the annual subscribers who may be disposed, instead of allowing their subscriptions to extend over a period of ten years to make a present payment of at least one half of the full amount promised by them.

9. That, as in the judgment of this Conference there exists a pressing demand for the immediate inception of a system of training for our rising Ministry, the Superintendent of the Sackville Circuit be especially charged, during the ensuing year, with the oversight of the Divinity studies of such Students in the Mount Allison Academy as may have been recommended as candidates for our Ministry, with a view of facilitating their progress in preparation for the work to which they believe themselves to be called of God.

SUPERNUMERARY MINISTERS' AND MINISTERS' WIDOWS' FUND.

QUESTION XVII.

What are the Resolutions of the Conference respecting the Supernumerary Ministers' and Ministers' Widows' Fund?

ANSWER.

1. The Conference observes with much satisfaction the successful introduction of this Fund to the Classes generally, and hopes that by due attention to all the sources of income, namely, Public Collections, Subscriptions in the Classes, and Donations, the required average of *six pence* per member per annum will very soon be reached and permanently sustained.

2. That the cordial thanks of the Conference be presented to the Executors of the will of the late G. T. RAY, Esq., Aaron Eaton, John Fraser, and E. E. Lockhart, Esqs., for their kind proposal of immediate payment of his bequest to this Fund.

II. USE OF TOBACCO, &C.

Resolved, That in the annual examination of condidates for our Ministry it shall be the duty of the Chairmen of the Districts to propose the question, "Do you take any snuff, tobacco, or drams?" And that a distinct answer in the negative shall be required in every case as a condition of continuing on trial from year to year, or of being received into full connexion?

THE PASTORAL ADDRESS.

TO THE MEMBERS OF THE WESLEVAN METHODIST CHURCH OF EASTERN BRITISH AMERICA.

DEAR BRETHREN:

One of the most pleasing duties of the Conference is to present to our various Churches our annual salutations, and the expression of our pastoral and fraternal affection. Sharers with you in the common salvation, as we all are, and animated by the same blessed hope of a glorious immortality, we rejoice with you in the thought that "now is our salvation – nearer than when we believed." During the year which has just terminated many of our beloved people have goneto realize the glories of the heavenly world. The remembrance of their faith and patience has been most encouraging to our minds as furnishing continued evidence of the excellence of that form of Christianity which we have received from our fathers, and which, by the grace of God, we hope to transmit to posterity in all its purity and efficiency.

The hallowed joy which we are wont to experience in our assembling in Conference is chastened by the bereavements which we have sustained during the year. Two of our most esteemed and venerated ministers, each of whom had been permitted to spend a long life in the service of the Church, have been called away to their rest. They have, however, left behind them a name fragrant as ointment poured forth, and we cherish the hope that their Brethren and successors among us will be richly endued with their spirit.

It is a matter for gratitude to God that the past year has been one of revival and prosperity to our Churches. The presence of God has been with us; souls have been converted, believers sanctified, and the general piety of our Church increased. Among us revivals of religion are not novelties.

But let us not rest in the theory of religion, nor remain satisfied with occasional spiritual enjoyments. It is the privilege of every one to be assured of the Divine favor. "Because ye are sons, God hath sent forth the Spirit of His Son into your hearts crying Abba Father." This divine testimony is essential at once to our possession of the fruit of the Spirit, and to a joyful walk with God. We. therefore, affectionately urge all who are still living in the region of doubt to continue in earnest prayer and expectation for this inestimable blessing. And let those who have believed in Christ be reminded that their privilege is to be " cleansed from filthiness of the flesh and spirit, perfecting holiness in the fear of the Lord." We are instructed, not only to keep the heart with all diligence, but to walk in love as the children of God. Our tempers and our tongues, our public conduct and private deportment should always be in subjection unto the obedience of Christ. "Let brotherly love continue ;" " Bear, ye one another's burdens, and so fulfil the law of Christ." Then shall the world acknowledge the grace of God in you, and be drawn towards the same fountain of good.

While we contemplate with thankfulness the advancing catholicity of the present age, we would still affectionately urge upon your best regards our own well tried and time honoured institutions. Among us the word of God is faithfully preached, and the Sacraments are duly administered. We have also the gratification of referring to our Book Concern as an important auxiliary to our Connexional prosperity. Under the able superintendence of the Rev. Charles Churchill, A.M., its sales continue to increase from year to year, and we hope that by the countenance and support of our churches there will be a still wider diffusion of Wesleyan Literature among the families of our people.

As Methodists we solicit on behalf of all the schemes of our Church an intelligent consideration, being assured that just as our whole economy is understood will its claims, as a means of saving souls from death and of spreading Scriptural holiness throughout the land, commend themselves to every man's conscience in the sight of God./

And now, dear Brethrer, we commend you to God and to the word of his grace. Be our fellow-helpers in the truth. Prove all things: hold fast that which is good; and in the day of the Lord Jesus may we with you obtain an abundant entrance into His glorious and everlasting Kingdom.

We have heard with great interest of your proposed Mission to Labrador, and hope that in your next communication you will be able to report its successful establishment.

The venerable members of your Conference who have this year become Supernumeraries will receive from us that consideration to which they are justly entitled on account of their long and valuable labours.

Whilst rejoicing with you in the happy Conference which you held in Prince Edward's Island, we are happy to inform you that during this our annual assembly we have been filled with comfort, both by the manifest tokens of the presence of God in the midst of us, and by the review of the prosperity granted to every department of our work during the past year.

The increase of our church-members in Great Britain during the year has been 16,704; and 25,541 persons are reported on trial for church-membership. There has been a proportionate increase in our Funds, and a large increase of chapels and schools, accompanied with a very considerable extinction of debt on our chapel-property. The Missionary income has reached a larger amount than in any previous year: and we are greatly cheered by the reports which we continue to receive of the prosperity of the work of God in the Mission-field.

At the same time our Home-Mission movement has made steady progress, showing that the Gospel of Christ is sufficient of itself to restore the most wretched and degraded of our population to peace and true prosperity, and that nothing can separate any man from happiness and eternal life, save either ignorance of Christ or wilful rejection of his salvation.

Whilst, however, we are greatly cheered by what we have already witnessed, and devoutly thankful to God for the favor and mercy which he has shown us, we are especially glad to note what we believe to be the beginnings of a great revival peop

TO THE BRITISH CONFERENCE.

REVEREND AND BELOVED FATHERS AND BRETHREN :

The reading of your Address to us has afforded us peculiar pleasure. We are thankful for the interest which you manifest in our welfare and prosperity, and for the paternal consideration which you extend to our requests.

We greatly rejoice in your still increasing prosperity ; the addition of 15,704 members, with 25,541 on trial affords us unfeigned satisfaction, and causes us to join with you in devout thanksgiving to God who giveth the increase ; while the addition to your chapels and schools, and the augmentation of your Connexional Funds serves to heighten our joy, and intensify our thankfulness. That the income of the Missionary Society is steadily advancing gives assurance of the strong hold which this cause has taken of the affections of English Methodists and of the deepening interest felt in the operations of the Society throughout the bounds of the affiliated Conferences and Mission Districts.

Our hearts have been gladdened and encouraged to learn that your expectations of revival have not been vain, and we hope and pray that larger showers of Divine blessing may descend on all your Circuits, and that your Home Mission work, already so successful, may become very largely instrumental in the elevation and salvation of the neglected and degraded masses of your city populations.

We have, during the year past, been prostrating ourselves at the throne of grace, seeking an outpouring of the Holy Spirit upon the world, and especially upon our own field of

We have this year to lament the death of two of our venerable fathers in the ministry—Wm. Crosscombe and Dr. Knight, our late Co-Delegate. The former had been a Supernumerary for some years, but our beloved Dr. Knight, the oldest effective Missionary, we believe, in connection with the British Conference, continued his labours till within a few days of his death. We deeply feel our loss, but bow to the Divine will with unquestioning submission. Their deaths closing lives which had been in labours more abundant, and in piety eminent—were triumphant, and their memory will ever be fragrant throughout our Connexion.

Six of our ministers—an unusually large number—are asking permission to rest for one year; but we earnestly hope that these brethren may be restored to health, and enabled to resume labour at the next Conference.

We have just received into full connexion ten young men, eight of whom have been ordained at the present Conference; besides these, eleven young men of promising talents have now been received by the Conference as preachers on trial, but we regret to say that the supply does not yet equal the demand.

Our different Connexional Funds are growing in favor with our people, and encourage our hope in regard to their future efficiency.

The Academic Institutions at Sackville are in a very gratifying state of prosperity, and give promise of being an incalculable blessing to the youth of our Connexion and country, and the initiatory movement recently made to establish a Theological Professorship promises entire success.

The affairs of our Book Room are reported to be in a healthy condition : the extension of Methodist literature is steadily increasing; and arrangements are now being made by which we hope to render the *Provincial Wesleyan*, our Connexional organ, more influential for good. The Mission to the Labrador coast was begun favourably last year, and at present one of our brethren is labouring in that sphere, and the Mission may be regarded as established.

Our beloved brother, Dr. Richey, finds it necessary to become a Supernumerary for one year, at least. This renders the office of President among us vacant—as the lamented death of Dr. Knight had previously that of Co-Delegate. The brethren have with great unanimitv agreed respectfully to request that the Rev. Enoch Wood, D.D., may be appointed to preside at our next Conference, and the Rev. Humphrey Pickard, D D., to act as Co-Delegate; and we also earnestly request that they may be authorized to discharge the duties of these offices for the remainder of the current as well as for the subceeding Connexional year.

We continue to hold the doctrines of Methodism in their purity and completeness, and are resolved, by the blessing of God, to maintain Wesleyan discipline, and preach those doctrines which have received such marked sanction from the Head of the Church.
