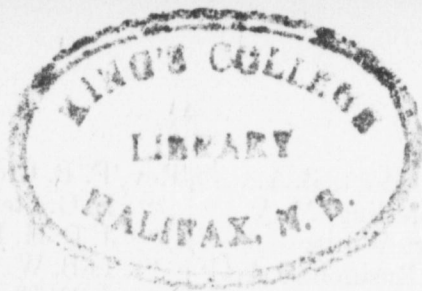

They deeply regret the loss incurred by their fellow-Churchmen in the parishes of Trinity and St. James by the destruction of their Churches, and especially that of Trinity Church, one of the oldest in this Diocese.

The members of this Synod desire also to acknowledge with deep gratitude to Almighty God, the comparatively small loss of life, and the prompt and generous aid in the relief of the suffering from various cities in this Dominion, as well as from England and elsewhere, and pre-eminently from so many portions of the United States. During the past year the Board have remitted or paid over to the various Missionary purposes directed by the donors, the sum of \$1718.51, as appears by the Treasurer's account submitted herewith (see Appendix A.), which has been distributed as follows:

The contributions during the present year are considerably in advance of those reported in 1876, and the Board record this marked and steady increase with satisfaction.

A pleasing feature in the work of the present year has been that considerable sums were obtained for Foreign Missions through the efforts of children. The result of these and other efforts only appears in part in the accounts of the Board; other sums having been raised and paid directly to the missionary object intended.

In the remittances of this year, the entire Diocese, with the exception of two Missions, has been represented.

During the year the Board has held two public Missionary Meetings. The Lord Bishop of the Diocese presided at the first meeting, held on the 3rd July last, at Saint John. The collection, which amounted to \$53.54, was appropriated to the contingent expenses of the Board, being the only sum so applied since its formation.

A second meeting was held in Saint John on St. Andrew's Day last, the collection at which, amounting to \$38.00, was equally divided between the S. P. G. and C. M. S.

With respect to the principal missionary effort aided through the Board, it may be mentioned that the contributions for our own Missionary Diocese of Algoma have been made in part for its general work, and in part for the Shingwauk Home for Indian boys, and the Wawanosh Home for Indian girls, at Sault St. Marie in the extreme west of Ontario.

The Rev. E. F. Wilson, Principal of these Homes for Indian children, having expressed an intention of making a short summer tour through the principal Canadian centres, the Board held a special meeting on May 20th to make the necessary arrangements for his reception.

In a statement lately issued on behalf of the Indian Homes for children, Mr. Wilson writes as follows:—

"The home for boys is prospering well. We have forty boys now under our charge, and, in addition to a good plain education, and instruction in the Scriptures, they are taught tailoring, tinsmithing, carpentering, bootmaking, printing, and farming.

"The Wawanosh home for girls is not yet built, but we hope to commence a part of it this summer, and require about two thousand five hundred dollars more in order to complete it. A lady from England has already been engaged to superintend it."

The Board respectfully intimates that it has standing Committees, whose special duty it is to promote the following objects:—

1. Holding or conducting and providing preachers or speakers for parochial or local missionary services or meetings.
2. Affording hints and information as to the best method for a beneficial observance of the annual day or days of intercession on behalf of Foreign Missions.
3. The circulation of Missionary publications, maps, and diagrams.

The Board will be glad, in any case where it may be desired, to furnish any such assistance as may be in their power.

#### REPORT.

The Committee of Synod formed for the purpose of increasing the number of Church of England Temperance Societies in the Diocese, of reporting on their work, and the best way of organizing a Diocesan Church Temperance Society, in order to concentrate the efforts of the members of the Church of England, for the promotion of habits of Temperance, the reformation of the intemperate, and the removal of the causes which lead to intemperance, report:—

1st. That circulars have been sent to all the clergy who had not formed Church Temperance Societies, offering them assistance towards their formation, and that twelve answers have been received, one favourable, the others giving reasons why they were not ready to form them.

2nd. Fourteen Church of England Temperance Societies are now at work in this Diocese, and have effected much good during the past year, by holding public meetings, enrolling many members, and calling attention to the evils of Intemperance and their remedies.

3rd. The Committee are happy to state that a Diocesan Church Temperance Society is established in the Diocese of Nova Scotia. They consider that such a Society ought now to be established in this Diocese, in order to promote union and co-operation among the different Parochial Temperance Societies, to promote their efficiency and increase their number.

4th. In accordance with the resolution asking them to report the best way of organizing a Diocesan Church Temperance Society, they would respectfully ask the Synod to pass the following resolution:

That this Synod appoint a Standing Committee for the pur-



pose of organizing, as soon as possible, a Diocesan Church of England Temperance Society, and that the Presidents of the Church of England Temperance Societies, being clergymen of the Diocese, be *ex officio* members of this Committee, and such other members of the Synod as the Synod may appoint, and that such Standing Committee do every year report on the work and progress of the Diocesan Church Temperance Society.

#### REPORT.

*To the Right Reverend the Lord Bishop and the Diocesan Synod of Fredericton:*

The Committee appointed at the last session of the Diocesan Synod to consider all enactments of the local Legislature affecting the Church of England in the Diocese, and to report upon the codification and amendment of the same, beg to submit the following Report:

Your Committee find that the local enactments affecting the Diocese are scattered through the Statutes of various years and in some cases are not readily accessible. Questions have already arisen as to the construction of some of their provisions which questions it appears very desirable to set at rest. There is also an absence of clear and definite direction in some matters of importance to the Church. Your Committee therefore recommend that the Statutes in question be revised and codified under the direction of the Synod, and they beg to submit the following general plan for such revision:

I. THE DIOCESAN SYNOD.—Codification of the present Acts 34 Vict. c. 8, omitting the clauses referring merely to the first meeting, which are no longer needed.

II. THE DIOCESAN CHURCH SOCIETY.—Codification of the Acts 16 Vic. c. 4, and 37 Vict. c. 59, omitting the recitals in the former Act, the Society's constitution as there given having

been materially of the Act.

III. THE BISHOP.—Act 38 Vict. c. 1, publishing the Seals of the property vested in the Bishop.

IV. PRESENTMENT.—32 Vict. c. 6, with

(a) To confine the property who shall be members of the Society other than the Bishop.

(b) A provision for the regulation of the Chapel-wardens.

V. PARISHES.—Act 12 of c. 107 of the 1868 session, suggested addition, and the summon meetings of the Vestry.

VI. UNION OF PARISHES.—Act c. 107, § 4, under the letters of Institution, choice by the people, and the sanction of the Bishop.

VII. DIVISION OF PARISHES.

(a) For setting off a parish to another.

(b) For the division of a parish without the consent of each case.

VIII. CHURCHES.—of the present law under the following heads:

(a) Number and names of the churchwardens.

(b) Electors in the church.

(c) Electors in the church.

(d) To confine the church to those who shall, in the opinion of the Church, be religiously devoted.

(e) Provision for the Church or the Bishop.

IX. FREE CHURCH.—may be declared free.

III. THE BISHOP OF FREDERICTON.—Codification of the Act 38 Vict. c. 43, confirming the Queen's letters patent establishing the See of Fredericton, and relating to lands and property vested in the Bishop.

IV. PRESENTATION TO RECTORIES.—Codification of the Act 32 Vict. c. 6, with the following suggested alterations:

- (a) To confine the right of voting in all cases to persons who shall, if required, declare themselves to be members of the Church of England, and to belong to no other religious denomination.
- (b) A provision for choice in cases where, through destruction by fire or otherwise, there may be no Church or Chapel-of-Ease in the Parish.

V. PARISHES.—Codification of sections 6, 7, 8, 9, 10, 11 and 12 of c. 107 of the Revised Statutes, with the following suggested addition, namely: provision as to the person who shall summon meetings, and fix the time and place for them.

VI. UNION OF PARISHES.—The present law (1 Rev. Stat. c. 107, § 4,) under which a Rector may receive from the Bishop letters of Institution to an adjoining parish, but substituting choice by the people, under the Act 32 Vict. c. 6, for the "sanction of the Governor," as required by the present law.

VII. DIVISION OF PARISHES.—Suggested provisions:

- (a) For setting off from any Parish a district to be attached to another Parish for ecclesiastical purposes.
- (b) For the division of Parishes, and setting off new Parishes, without the necessity of applying to the Legislature in each case.

VIII. CHURCH-WARDENS AND VESTRYMEN.—Codification of the present law (1 Rev. Stat. c. 107, sects. 5 and 6,) under the following heads and suggested alterations:

- (a) Number and qualification of Church-wardens and Vestrymen.
- (b) Electors in the case of appropriated Churches.
- (c) Electors in the case of Free Churches.
- (d) To confine the right of voting, in all cases, to persons who shall, if required, declare themselves to be members of the Church of England, and to belong to no other religious denomination.
- (e) Provision for elections in cases where there may be no Church or Chapel-of-Ease in the Parish.

IX. FREE CHURCHES.—A provision under which Churches may be declared free, or changes made in the fabric or arrange-

ments by a two-thirds or greater vote of the Parishioners, with compensation to any dissentient.

X. SALE OF CHURCHES AND GLEBE LANDS.—Codification of the present Acts 22 Vict. c. 35, 34 Vict. c. 5.

XI. PROVISION for the Bishop receiving into the Diocese clergymen ordained in the Protestant Episcopal Church in the United States.

XII. REPEAL OF THE FORMER ACTS, in order that as far as possible the entire local Statute Law affecting the Church may be contained in one Act.

Should these suggestions be received, your Committee recommend that the matters be referred to a Special Committee to report such codification at the next session of the Synod, and that the members of the Church in the several Parishes be requested, in the mean time, to take the subject into consideration, and to forward to the Committee such suggestions as they may desire to make.

At a meeting of the Governors of King's College, 12th July, 1876, it was

*Resolved*, That whereas in October last a conditional agreement was made between the Governors of King's College, Windsor, and a Committee of the Synod of Fredericton, that if the said College should be made the Theological School for the Diocese of Fredericton, and the Bishop of Fredericton would undertake to send his Divinity Students enjoying grants from S. P. G. to the said College, the said Governors would obtain for the said Bishop the appointment of *ex officio* Governor, and would grant him joint powers with the Bishop of Nova Scotia in the nomination of future Professors of Divinity, with the consent of the Bishop of Nova Scotia :

And whereas a Resolution was passed by the Diocesan Synod of Fredericton at its late session partly confirming the said agreement, but adding thereto certain limitations and reservations :—

*Resolved*, That the said limitations or reservations so materially affect the proposed terms of union, that this Board must decline to accept the resolution as fulfilling the conditions on which they undertook to secure to the Bishop of Fredericton the proposed power and authority in the College. That, however, so long as the Bishop of Fredericton shall avail himself of King's College for the instruction of his theological Students, the Governors will be happy to receive and will carefully consider any suggestions made by him with reference to such students, and will leave to him the sole management and control of any Divinity Scholarships allotted by him, and will enforce the conditions on which they may be held by any of such Students.

*Halifax, N. S., July, 1876.*

The disbursements, \$100 78, are accompanied by vouchers in due form, except an item of \$3 53 for postage, &c., for which vouchers are not to be expected. The receipts exceed the expenditure by the sum of \$25 55, which added to the balance of the previous year, agrees with the sum of \$248 65, the balance to be carried forward to this year's account.
