An Act to render valid certain Final Orders granted by the Judges or Commissioners of the Insolvent Courts of Upper Canada.

HER Majesty, by and with the advice and consent of the Legislative Council and Assembly of Canada, enacts as follows: Preamble.

I. The Final Orders heretofore granted to the several Judges or Commissioners in Bankruptcy, in any of the Counties of Upper Canada, and purporting or professing to have been made under or by virtue of the Act of the Parliament of Canada, passed in the Session held in the nineteenth and twentieth years of Her Majesty's Reign, and intituled "An Act to extend the provisions of the Insolvent Debtors' Act of Upper Canada, and for the relief of a certain class of persons therein named," shall operate to protect the person of the Insolvent from arrest and imprisonment, and also as a discharge of all debts or liabilities due or contracted by such person up to the time of the presentment of the Petition of such person for protection in each case respectively, as fully and completely, and to the same extent, as if such person had obtained a certificate under the fifty-ninth section of the Act relating to Bankrupts, notwithstanding such Final Order may not have been drawn up in exact conformity with the said Act or with the Act passed in the eighth year of Her Majesty's Reign, chapter forty-eight, intituled, "An Act for the relief of Insolvent Debtors in Upper Canada, and for the purposes therein mentioned," or either of them.

Effect of Final order under 19, 20 V., c. 93, declared.

II. This Act shall apply to Upper Canada only.
