COMPENSATION FOR SEALERS IN CASE OF ILLLEGAL SEIZURE IN BEHRING SEA.

THE WHITEWAY MINISTRY RESIGNS. Because It Had No Alternative—The Opposition Takes Office—Whiteway Resigns for New Mission.

ST. JOHN, N.F., April 12.—The resignation of the Government was announced in the Assembly yesterday and the formal resignation of the members was handed to the Governor at 3 p.m. The Governor announced that he had decided not to dissolve the House, and this left no alternative to the Government but to resign. Robert Bond, Colonial Secretary, outlined the Government's course. The Ministry believed that a miscarriage of justice had occurred. In the decisions at the trial they believed that the judge had outstepped the bounds of duty and considered matters not within his jurisdiction.

It is expected that the Opposition will win today. They are hopeful, in that event, of being able to continue their position. The Government is equally certain that the Governor will ultimately compel it to dissolve the House and have a new election.

OUTRAGEOUS PRIME RATES. A Case in Point Where the Charges Were Exorbitantly High.

A gentleman from this city yesterday shipped a thoroughbred mare from Toronto to Red Bank, New Jersey. The charge for her conveyance illustrates the difference between the American and Canadian tariffs. The through charge was \$28. Of this the Grand Truck for 80 miles charged \$17 and the American tariff \$11. PROTECTIVE DUTY ON CIGARS. WILL PROBABLY BE IMPOSED BY GREAT BRITAIN.

An Import Tax of Seven Shillings Per Found Anticipated—This Will Inevitably Protect the Domestic Manufacturer by Shutting Out All Foreign Competition.

LONDON, April 12.—The conviction that the Government intends to increase the import duty on cigars to seven shillings per pound has created a panic among the wholesale cigar dealers, who see in the enforcement of such a tax the ruin of the Havana cigar trade of Great Britain. The dealers are generally of the opinion that the Government's decision is unwarranted, and that the duty will not be able to compete with the Havana product under an increased duty. In view of the reported rise in the duty imposed on cigars, the Havana trade has been made from London, cigars and cigarettes being delivered daily to importers.

The Budget. The Budget was approved by the Ministers at the Cabinet meeting to-day. It is stated that the Budget will make his appearance in the House of Commons on Monday next. The Finance Bill is being introduced by Sir William Harcourt.

WELSH RADICALS ANGERED. Will Proceed to Rosebery for Giving Preference to Irish Legislation.

IN A DESTRUCTIVE FIRE LAST NIGHT IN BUFFALO.

The American Grape Sugar Company's Works Destroyed—Sixty Men Were in an Building at the Time and Twelve Are Unaccounted For—Some of the Injured Will Die.
