





### Annual Meeting

THE First Annual Meeting of the congregation of St. Andrew's Church was held on Wednesday evening, January 10th, 1900, Rev. J. S. Scott presiding. After devotional exercises the meeting was duly constituted for business, J. F. McLaren acting as clerk. Reports were presented as follows:—

Mr. W. B. Wood, for The Kirk Session; J. F. McLaren, Managers and Treasurer; Alex Moffat, the Sabbath School; Mrs. A. G. Montgomery, Ladies' Aid Society; Miss Spratt, Junior Christian Endeavor; G. Turnbull, Senior Christian Endeavor and Literary Society.

These reports were received and adopted and short speeches were made by Messrs. Hossie, Allen, Moffat, W. B. Wood, McLaren, T. L. Wood, McEwenTurnbull and others.

Messrs. Duncan, McEwen and Alex. Moffat, the retiring managers, were re-elected and Messrs. W. A. Hoagg, James H. Scott and W. T. Urquhart were added to the Board of Management.

Messrs, W. B. Wood, A. G. Montgomery and J. F. McLaren were elected Trustees to hold in trust the property of the congregation.

Messrs. Martin W. McEwen and John Orr were appointed auditors, and Wm. Turnbull and Alex. Graham, ushers for the ensuing year.

A short programme of music was rendered at intervals during the evening.

At the close of the meeting the ladies served refreshments, and a very pleasant hour was spent in a social way by the members

## Report of The Session For 1899.

TO THE MEMBERS AND ADHERENTS OF ST. ANDREW'S CON-GREGATION:

At a meeting of the Presbytery of Paris, held in Zion Church, Brantford, on Tuesday, March 14th., 1899, a petition from St. Andrew's Mission, Brantford, was laid before the Presbytery, and, after deliberation, it was unanimously resolved to organize the Mission into a congregation. The Presbytery appointed the Rev. E. Cockburn, M. A., of Paris, to organize the petitioners, and at a meeting of the Interim Session it was resolved to meet for organization on March the 20th, following, in St. Andrew's Church. After the sermon the Moderator stated that he was present by the authority of the Presbytery, to organize the Congregation, and the names of fifty-three members of the Presbyterian Church were then and there added to the Communion Roll. Five Elders having been elected and duly inducted in the month of May, vigorous steps were at once taken to secure a minister. After hearing a number of very excellent candidates, the unanimous choice of the Congregation fell upon the Rev. James S. Scott, B. A., pastor of the Presbyterian Church in Hespeler. Mr. Scott evidently found it very difficult to sever his connection with a very much attached people, but finally accepted our call, and was inducted on Tuesday, the 7th day of November. The people welcomed the new pastor most warmly, and Mr. Scott has met the fondest anticipations of his most ardent friends. Altogether the settlement has upon it the stamp of God's approval, and warrants the belief of the Session that the divine blessing of God will rest upon it. A district will be assigned to each member of the Session at an early date, and the congregation will probably be asked to consider the propriety of electing one or two additional Elders during the year.

The prayer meetings were regularly conducted by the Elders during the vacancy, and, since the induction of the Rev. Mr. Scott, have been well attended. It is hoped that a still larger number will share in the benefits to be derived from

social prayer and a systematic study of the Word.

The session hails with satisfaction and joy the formation of a Young Peoples' Society of Christian Endeavor, (senior and junior), a branch of the Woman's Foreign Missionary and Home Missionary Societies, a Ladies' Aid Society, and a Literary Society for young men, each of which will no doubt present its own report to the congregation.

The Session also recognizes the excellent work done by

the Choir under somewhat difficult circumstances.

The continued prosperity of the Sabbath School is a cause for profound gratitude to God. The teachers have been faith-

ful, punctual and zealous, and several new additions have been made to the staff. The growth of the School has been steady and the attendance good. Ten of its pupils were received into the membership of the Church during the year.

Since organization the membership of the Church has steadily increased, as will be seen by the following summary:

The Hand that planted our new organization in this section of the City was undoubtedly Divine, and the same loving Hand has led us through this first (very eventful) year of our history. May we never forget our dependence upon Almighty God, drinking deeply of His blessed Spirit and rising to the opportunities and responsibilities of the great work to which He has called us—may we so live and labour as to bring glory to His great and holy name.

## First Annual Report of The Board of Management for 1809.

The Board of Management present their first report to the congregation of this Church, with feelings of profound gratitude and thankfulness to God for the manner in which He has hitherto led them. But nine months have elapsed since we first gathered together here as a congregation, a mere handful of people, drawn together from various sources, with different ambitions, different ideas and hopes, and to-night we meet a united congregation rejoicing in the pastoral oversight of one who was the sole and undivided choice of the people.

The treasurer's report submitted shews, in detail, the receipts and disbursements for the period from 1st of April to 31st December last. The receipts from all sources are \$1429.75, with a balance of \$164.95 to be carried forward to next year.

Acting under the resolution adopted at our first Congregational meeting, on 29th March last, your managers set in operation the envelope, or weekly offering system, as the sole means of raising revenue for all local church purposes. The result, hitherto, has been most satisfactory, indeed. It is a system, however, which calls for constant care and vigilance on the part of the managers, and also for a hearty, sympathetic and generous response on the part of the members.

The total cost of additions and permanent improvements to the church, including re-seating, was in the vicinity of \$1,400. This was met by a temporary loan from the Bank of British North America. It is proposed to consolidate this debt with an existing mortgage, on the property, of \$750.


The Board of Managers are under a debt of obligation to the Ladies' Aid Society for the very substantial aid they have rendered. Amongst other things, the furnishing and carpeting the Vestry and pulpit platform, all of which they have done without any aid whatever, from the church treasury,

The managers desire to thank Miss Wood for her valuable services as planiste in connection with our services of music, and to express to her their thorough appreciation of her most valuable services to the church. The singing of the choir also has been very much enjoyed, and has led to very hearty singing on the part of the congregation.

The Managers retiring by rotation for the present year, are Messrs. Duncan McEwen and Alex. Moffat, both of whom are eligible for re-election.

During the nine months since organization eleven regular and two special meetings have been held, with an average attendance of twelve. Our entertainments consisted of a concert, drawing room and lecture, these with members' fees making a total revenue of \$179.98. Among the larger disbursements of the Society we mention the carpeting of the pulpit and choir platforms, the carpeting and furnishing class-room and vestry. This with sundry other expenditures causing an outlay of \$198.20 less the amount received, \$179.98, leaving a balance due by the Society of \$18.22. The present membership consists of 25. At a meeting held to-day the officers were re-elected. The ladies of this Society record their utmost gratitude to the Great King and head of the church for His blessing on their efforts to lend a hand in His name.

### Revenue.

Pews are located for all members and adherents, but the managers have adopted the weekly offering or envelope system as the sole source of revenue, it being in their judgment better, more equitable and more scriptural than the pew rent system. They believe that if all the members and adherents of the church will give to the full extent of their ability upon the first day of the week, not grudgingly, but as God has prospered them, there will be no lack of funds to meet the current expenses of the church.


