**B I L L .**

An Act to authorize the Courts of Queen's Bench, Common Pleas and of Chancery, in the Province of Canada, to admit Edward Taylor Dartnell to practise as an Attorney and Solicitor therein.

**W**HEREAS Edward Taylor Dartnell, of the City of Preamble.  
 Toronto, hath, by his Petition, set forth that he, the said Edward Taylor Dartnell, had been duly admitted an Attorney of Her Majesty's Courts of Law and High  
 5 Court of Chancery in Ireland, and hath produced certificates of his having been duly licensed and practising as such; and whereas the said Edward Taylor Dartnell is now desirous to be admitted to practise the Law as an Attorney and Solicitor and Proctor at Law in this Pro-  
 10 vince; and whereas it is reasonable, under the circumstances of the case, that the Courts of Law and Equity in that Province should be authorized in their discretion to admit the said Edward Taylor Dartnell to practise as an Attorney and Solicitor: be it therefore enacted, &c.,

15 That it shall and may be lawful for the Courts of Queen's Bench and Common Pleas, in and for that part of this  
 Province which formerly constituted the Province of Courts of Q. B., C. P. and Chancery may admit E. T. Dartnell as an attorney, &c.  
 Upper Canada, in their discretion, to admit the said Edward Taylor Dartnell as an Attorney of those Courts;  
 20 and that it shall and may be lawful for the Court of Chancery in that part of this Province last aforesaid, in its discretion, to admit the said Edward Taylor Dartnell to practise as a Solicitor in the Court of Chancery, and for the said Edward Taylor Dartnell to practise as a  
 25 Proctor at Law in that part of the Province last aforesaid, any law or usage to the contrary notwithstanding. And he may practise as a Proctor.
