WHEREAS the Corporations of the County of Elgin and of the Preamble. the Town of St. Thomas, have by their petitions, represented that doubts have arisen since the incorporation of the said Town, respecting the right of property in, and the management and control of that part of the London and Port Stanley Gravelled Road, lying within the limits of the Town of St. Thomas, and have prayed for an Act to remove the aforesaid doubts, and it is expedient to grant their prayer: Therefore, Her Majesty, by and with the advice and consent of the Legislative Council and Assembly of Canada, enacts as follows:-
