PORK FACTORY FOR FAIRVILLE.

Dunn Bros., Given the Lease of Required Lands.

General Committee Ratifies Agreement With Dry Dock Company With Slight Amendments

The general committee of the common council appointed to consider the recommendation of the safety board with reference to the erection of a pork factory by Messrs. Dunn Bros., met this morning at eleven o'clock.

The communication of Dunn Bros. was read. It asked for five acres for the period of twenty-five years at the annual rental of \$200.

Ald. Millidge moved that a lease be granted of about five acres of land at \$100 rental.

Ald. Lewis seconded the motion. If the situation of the pork factory would not interfere with surrounding property he did not see what objection there could be to it.

Ald. Allen thought that Dunn Bros. had made a fair offer for the site and he did not think that it was a fair proposition to ask a rental greater than the land was worth. He moved in amendment that a rental of only \$50 be asked for the site.

Ald. Robinson thought that the council might very fairly meet this company, as the land could not be used for anything else. The city would indirectly reap a great benefit from it. He seconded the motion.

Ald. McMullin thought that Mr. Dunn would be willing to give more than he had at first offered, as the land was worth at least a substantial rental. A hundred dollars was little enough, considering the privileges there are.

Ald. Bullock said that this property was now bringing in \$50 rental, and he thought that in view of the purpose for which the site was wanted, the rental should be \$100.

Ald. Christie was of the same opinion, and thought that \$100 was not too much. If it were his own property he would not think of leasing the property for \$50 a year.

Ald. McMullin said that the people in the vicinity were anxious to have the industry.

Ald. Macrae thought if the rental were put at \$100, the limitations which it was intended to put in the contract with respect to improvements and exemption of taxation ought to be omitted. If \$100 is a fair valuation for the property it should be the ordinary rental.

Deputy Mayor McGoldrick said that that piece of land was not fit for any other purpose than that for which Messrs. Dunn wanted it. If the rental is made \$100 all privileges should go with it.

Ald. Macrae moved as an amendment to the amendment that an ordinary lease at a rental of \$100 be granted.

Deputy Mayor McGoldrick seconded the motion.

Ald. Tilley agreed with Ald. Macrae in reference to the decision.

Ald. Christie said that there was no doubt that Mr. Dunn would entirely recompense himself by leases of parts of the lot to tenants.

Ald. Macrae's motion was carried.

The agreement with the Imperial Dock Company was next taken up. The agreement was considered section by section.

Ald. McMullin asked if 520 feet would be a sufficient length for the dock.

Mr. Robertson said that room would be left for the extension of the dock if it were found necessary. The dock would be able to take in, at 520 feet in length, almost any craft afloat.

Ald. Bullock asked how long it would take to dock a ship.

Mr. Robertson said it would not take more than ten minutes.

Ald. Macrae moved that the agreement be referred to the common council with the recommendation that it be adopted with a few slight amendments.

A special meeting of the council has been called for Friday next to consider the dry dock agreement.

IAN HAMILTON COMING.

Famous Transvaal War General on Canadian Tour—Premier Seditious Proposal.

(Canadian Assn. Press.)

LONDON, Sept. 15.—Lieut-General Sir Ian Hamilton leaves this week for a tour of Canada.

Premier Seditious last budget speech contains an item not mentioned in the telegraphed summary. He suggested an early imperial conference of representatives of the colonies in consultation with Lord Roberts and the admiralty for the specific purpose of placing the defence of the empire on a more satisfactory basis.

Among the Canadian ladies present at the session of the Alaska boundary commission today were: Mesdames Sifton, Duff, Wade, Courtney and Hope. Many American ladies were also present.

ALASKAN TRIBUNAL.

Commission Beginning Session Today—Attorney General Opens Case For Great Britain.

LONDON, Sept. 15.—The first sitting of the Alaska boundary tribunal took place at the foreign office today in the large room in which deputations are received by members of the government. Commissioners and counsel were all present. The attorney general proceeded to open the case for Great Britain by describing the territory in dispute as being chiefly of value to Canada as affording access to the Yukon territory. He went on to say that the question of boundary had been in dispute since 1873. For more than thirty years it has been the subject of difference periodically between the governments, though but little known to the outside world.

NEW N. B. RAILROAD.

J. E. Stewart, of Perth, backed by several prominent business men, is seeking a charter for a railroad line to continue from the T. V. R. crossing the river at or near Three Brooks at Lincolnton to continue on up the Tobique to the Forks where to branch off through the country until it forms a junction with the new road now being built by Malcolm & Co. from St. Leonard's to Campbellton. It would also intersect the new G. T. P. if it is built as projected.

SNOW IN THE WEST.

CHEYENNE, Wyo., Sept. 15.—A heavy snow storm has been in progress here since Sunday and shows no indication of abating. From Laramie comes a report of a fall of eighteen inches of snow during the past twenty-four hours. Telephone wires and electric light wires were broken by the weight of the snow and last night the city was in darkness.

DENVER, Col., Sept. 15.—A storm has prevailed in the northern part of the state for the past twenty-four hours and in a number of places snow fell and the storm approached the proportions of a blizzard. In the mountains it has been snowing for several days.

FLLOUR GOES UP.

J. S. Harding received instructions last evening that on account of the serious damage done by the storms in Manitoba the price of Ogilvie's flour would be increased fifteen cents per barrel. Mr. Harding had no information as to the extent of the damage done.

BULGARIA WANTS WAR.

Tried to Provokes Turks to Massacre in Order to Induce Intervention.

BERLIN, Sept. 15.—The Tagblatt publishes an interview with a diplomatist who holds a position in Bulgaria in the course of which he is reported to have said: "Bulgaria wishes a war with Turkey. For this purpose the explosions on board the Hungarian line steamer Yaskapu were caused. They were intended to take place when the vessel was at Constantinople in order to bring about a massacre of the Bulgarians by the Turks, and it was hoped that this massacre would lead to intervention by the powers. The plan, however, failed, owing to the delay in the departure of the steamer from Varna."

In reply to the question why Turkey had not quelled the uprising in Macedonia, the diplomatist said: "The ammunition for the insurgents comes not only from Bulgaria, but also from Odessa, Russia. This fact is well known to Turkey, but she is undecided as to taking an energetic step against Bulgaria, because she fears that Russia will prevent her. Why should Turkey desire a successful war with Bulgaria, whenever the successful Greek war she was assured by the ambassadors that Crete was lost to her. Macedonia is not Crete, and it will not be easy to manoeuvre Turkey out of that province."

"TAKE ME BACK" WIFE PLEADS.

But the Injured Mr. Stoeger Spurns Her Entreaties

'I'm Just As Good As I Was When You Married Me,' She Said.

—A Sensational Case.

Most of the forenoon in the police court was occupied by the hearing of evidence in the preliminary examination against Lewis Stoeger and Mrs. Mary Stoeger, arrested on the charge of adultery. Augustus Stoeger, husband of the accused woman, was the only witness examined and at times his evidence was of a rather sensational nature. The magistrate forbade any display of levity by the crowd of spectators, and impressed upon them that the case was a most serious one, with a strong influence on the morals of the community.

Stoeger in his direct evidence told how his wife had tried to get him to go away. He had intended taking a holiday, but found that he could not get off. Mrs. Stoeger, however, managed that he should obtain leave of absence, and continually advised him to go. When he spoke of going she became good-humored, but when he spoke otherwise she was ill-tempered. He went away on Saturday morning and returned yesterday. Since marriage, Stoeger says that he and his wife have not lived in perfect happiness. For the first three years all was well, but since that time their home has been a hell on earth. They have quarreled frequently and sworn at each other. A short time ago Mrs. Stoeger was anxious to go to Bathurst, and although Stoeger did not approve of the people she was going with, he agreed to the trip for peace's sake. She did not go to Bathurst, but to Moncton, and wrote from there asking him for money. Since she cannot get him from Moncton, where she has been for eight days, there have been quarrels and no peace in the house. Stoeger says his wife did not act properly, and often used hard language to him.

On cross-examination by Mr. Mullin, Stoeger said that his father has been in the States for about four years and that his mother is living with her brother, William Bruckoff, in Carleton street. She was alone and he had there for purposes of prostitution. He afterwards met the woman at another house of ill-fame, where he had arranged to meet her. He married the girl about six or seven months after first meeting her.

Stoeger did not visit to his house in Carleton, but knew of persons who had visited his house. He refused to give the names of any of these as he did not wish them mixed up in the affair.

Mrs. Stoeger said she had some questions to ask her husband, but her words took on the form of a rather disconnected narrative of their home life. She told how Stoeger had sworn at her. He had frequently beaten her and sent for his mother to make peace. Mrs. Stoeger the elder came to their house on different occasions when the husband and wife had trouble. The questioner denied that she had intended going to Bathurst when she went to Moncton and said that Stoeger knew of this, as he had given her only eight dollars, which was not enough to buy a ticket to Bathurst. Stoeger denied most of the statements made by his wife.

A rather dramatic incident occurred when Mrs. Stoeger, who throughout the whole hearing had kept herself well under control, besought her husband "Will you take me back again and I'll be good. I'll try to lead a better life."

Stoeger seemed amazed at such a request and fairly shouted: "What? Take you back?—with the emphasis on the 'you'—Take you back? Never! I wouldn't dirty myself by going near you."

Mrs. Stoeger quietly pleaded: "I'm just as good now as I was when you married me," and this brought forth the violent denunciation: "You're not. You're a damned sight worse."

The magistrate put a stop to any further excited language.

Mr. Mullin asked that the prisoners be discharged on the grounds that the case was a frivolous one and that the evidence was not sufficient. Mr. Baxter objected and claimed that the matter was one of importance.

Magistrate Ritchie said that his idea throughout had been that such a case was of much importance as affecting the moral standard of the community. He considered that the careless treatment of such a matter would tend to wrongly influence people with regard to the sanctity of the marriage contract. Whatever may have been the life of the woman in the earlier years she would be protected after marriage and the husband should be the same. He could not agree with Mr. Mullin that the case was a frivolous one, and the evidence was sufficient to warrant a commitment. The prisoners were accordingly committed for trial at the next session of the county court, on the first Tuesday in November.

AN UP-TO-DATE MILL.

Murray & Gregory's New Mill Will Be One of the Best on the River

—Done Next May.

Murray & Gregory have now in course of construction a sawmill which, when completed, will be one of the most modern and up-to-date on the river. Quite a large gang of men are at work on the mill and the framework of the main building is well up. This building will be one hundred and sixty feet long by forty-six feet wide, with a wing twenty feet wide. It will be fitted with gang and band saws and a full plant for the manufacture of small lumber. In the old mill the capacity for long lumber was 100,000 ft., but the new mill will turn out only 75,000 or 80,000 ft. On the other hand the capacity for small lumber will be greatly increased so that the total output in the new mill will be greater than in the old.

Saws are to be put in for the making of clapboards and shingles, a new department for Murray & Gregory, and with the equipment for coarage stock and laths this mill will have about the largest output of small stock of any mill here.

The boilers and engines are being built by Flemings, and there will be some delay with these, which will prevent the completion of the brickwork in the power house until spring. Quite a number of masons are now preparing the foundations for the boilers.

All the lumber used in the construction of the new mill is being sawn by a portable mill now in operation. This mill is turning out about 24,000 ft. of long lumber and 14,000 ft. short per day.

Messrs. Murray & Gregory expect to have their new mill in operation by May next.

A BIG SUIT IN EQUITY.

Mineral Products Co. of Alberta County, Sued for \$90,400—Case Postponed.

Not much has been heard lately of the enterprises of the Mineral Products Company, which a few years ago had large schemes of developments in Alberta county. A suit in the equity court, now in progress, indicates that the hopes of the promoters have not been realized.

Hazen and Raymond, acting for the Capital Trust Company, of the City of New York are bringing action for the foreclosure of a mortgage against the Mineral Products Company and Barton E. Kingman. The bill sets forth that in 1897 defendant company, requiring money for the operations, issued bonds for \$84,000. These were taken by the plaintiff company, and were ultimately acquired by Chas. H. Harmon, Francis Hoyt and Richard H. Smith, all of New York, who hold \$20,000, \$15,000 and \$5,000 respectively. The bonds were secured by a mortgage on all the properties, and as the plaintiffs claim, on all the minerals and rights to minerals within the territory. Interest was paid until 1901, when default occurred. Plaintiffs now claim for principal and interest \$90,400.

In 1902, Barton Kingman obtained judgment against the Mineral Products Company for \$187,000. He is therefore joined in the defence.

Barnhill and Barton are acting for the Mineral Products Company. Kingman is represented by Hon. L. J. Tweedie, who claims that the mortgage to the Continental Trust Company does not cover the mineral rights. The cause was to have been heard in the equity court today, but in consequence of the illness of Mr. Tweedie, who was not able to appear at the hearing, was postponed.

In the case of Geo. S. Cushing v. The Cushing Sulphite Fibre Co., Ltd., a commission was granted to take the evidence of some witnesses residing at Bangor, Me. The hearing in this case will be resumed upon the return of the commissioners.

BAD NORTH END BOYS.

Nine-Year-Old James Lockhart Admits Theft—Other Police Court Work.

Two young boys, John Wilson, aged eleven years and James Lockhart, aged nine years, were arrested yesterday by the North End police on the charge of breaking and entering James McDonald's saloon on Main street and stealing three dollars. Preston, another boy was detained as a witness. Lockhart is a son of Mrs. McDonald and in court today he admitted stealing the money. He gave \$1.25 of it to his mother and with the rest treated four or five other boys. They went to a couple of places for beer and were on the street cars from five o'clock in the afternoon until eleven at night. This was all on Sunday.

It appears that Preston had taken his father's keys to go to the wood-house and while there some of the boys had taken the keys from his pocket. Through time Lockhart got hold of them and with one opened the door of the shop where he took the money. Earlier in the day Mrs. McDonald had missed five dollars from the house and she sent a number of boys to find her son. On two or three occasions they found him and were taking him home when some men interfered and Lockhart got away.

The magistrate this morning suggested that a good sound thrashing would be a beneficial surprise to Lockhart and might keep him from riding round on street cars for some time to come. He gave Mrs. McDonald an opportunity to see about getting her boy in the Silver Falls home and if this cannot be done Lockhart will be sent to the reformatory.

Two young men, named James McElhenney and Patrick Fry, kept several policemen on the jump for over two hours last night. They dodged about the streets shouting profanely but finally were caught. This morning they were fined eight dollars or thirty days each.

Tris D. Mosher, of Carleton, reported for using profane language, paid eight dollars.

MR. BORDEN APPRECIATED.

There is room for a gentleman, even in politics. Honor, courtesy, tact, gentleness will win friends even when conspicuous ability is absent. When a man of force and ability possesses also the finest attributes of a gentleman nothing can stand in the way of his success. Take R. L. Borden, for instance. The strength that, as a leader binds to him the close allegiance of his followers, he unites a spirit that wins the admiration and cordial friendship of even those who are politically most bitterly opposed to him.

This recent illness of his has brought strong proof of this. Following is what the Toronto Star, one of the most partisan liberal papers in Canada has to say about his recovery: "Both sides of the house will be glad to hear that Mr. Borden's health is restored, and that he will be able to resume his duties in parliament very shortly. As leader of a party Mr. Borden outdoes in assiduity his most diligent followers, and as leader of the opposition he has shown a splendid endowment of fortitude. "When he took the leadership there were many wounded ambitions to heal. He has healed them as far as man can. In some cases he has won over a faltering allegiance through his likeable qualities. He has the gift of friendship, and some who refuse to admire him as a party leader are attracted by his cordiality. Mr. Borden has accomplished a fair amount of discipline under circumstances in which discipline was difficult. His even temper and abiding courtesy have commanded respect from friends and opponents alike. The opposition leader observes the amenities of debate. He is so punctilious in this regard that some of the more violent partisans complain, comparing him with the robustious Sir Charles Tupper, who wherever he saw a head made a pass at it. But the house is fortunate in that it has as its leaders on both sides of the benches men whose unfailing courtesy tends to restrain rancor and to moderate discussion."

A CRYING INJUSTICE.

Though the session has already dragged its wearisome and expensive course to a record length and the members of both sides are longing for its close, there is much business yet to transact which must not be railroaded through. It would be a crime, for instance, if the conservatives should so far neglect their duty as to fail to present all possible opposition to the passage of that crying injustice, the redistribution bill, even if they had to keep the house open until Christmas. This bill is the last straw which a pledge-breaking government has laid upon the backs of the patient public. While in opposition nothing aroused the indignation of the honest-hearted liberals as did the redistribution bill of 1882. None of their promises were more often made than that pledging fairness in this regard when the opportunity came to them. The present iniquitous gerrymander which will make the country map of Ontario look as if a bomb shell had struck it, is the result. In their wildest flights of imagination the much maligned conservative gerrymanderers of the old days would have balked before the frank audacity of this plan. County lines are ignored and ridings are made to run criss-cross and crooked, any old way, so long as liberal constituencies are strengthened and conservative ridings weakened. No standard has been used but that of party advantage. The unit of representation has been utterly ignored. Liberal districts are allowed a representation wildly out of proportion to that given to those with conservative leanings. Confident in their machine majorities in both houses the administration laughs at the storm of protests coming from both parties in that badly mauled province.

It is a dangerous and short-sighted policy, this gerrymandering. By just as much as the conservative party overstepped the bounds of fair dealing in their redistributions, did they lose favor with the people. A man does not like to have his homestead or his county or his provincial lines meddled with and is apt to resent an arbitrary change which brings him into political contact with unaccustomed places and people, even if the change may be made to favor his own party. The government will find this out in Ontario even with the advantage which the gerrymander seems to give them. That 46 majority of theirs is just about rope enough. The hanging is not far off.

The Imperial government has done a rash thing in permitting the Jubilee presents to be taken to Ottawa. That G. T. P. contract is not passed yet and it isn't likely that Senator Cox's advance contributions have been sufficient to satisfy the prevailing hunger.

Reports from Ottawa now indicate that the government will not throw away a Sure Thing. Chances look bad for this fall and worse for next so

OPPOSITION FIGHTING.

Many Amendments Offered to G. T. P. Bill—Government Muzzling the Treasury Watch Dog.

OTTAWA, Sept. 14.—R. L. Borden was in his seat in the house of commons this morning for the first time for some weeks. His appearance was greeted with hearty applause and he was the recipient of many congratulations on his restored health.

Mr. Fielding introduced a bill to amend the consolidated revenue and audit accounts. Ostensibly intended to remove some of the difficulties which have arisen in the department of public accounts and to relieve the auditor general from undue responsibility, it really really tends to muzzling the interests of the public. It will deprive him of his present duties of examining and adjusting accounts and of enquiring whether there is a proper appropriation and whether proper vouchers have been paid. Auditor-General McDonough strongly protests against this proposition to deprive him of the power given him by parliament.

The national continental railway bill was then taken up. On clause seven, Mr. Barker insisted upon a provision being inserted in the bill by which the Grand Trunk shall be compelled to pay dollar for dollar for all Grand Trunk Pacific common stock. He protested against the government allowing the Grand Trunk to present themselves with \$25,000,000, under clause 11 of the G. T. P. bill.

Hon. Mr. Fitzpatrick claimed that the Grand Trunk would have to pay for its stock, inasmuch as the Grand Trunk Pacific would have to sell it in order to secure funds for terminal equipment and branch lines. He did not think there was any danger of the Grand Trunk getting something for nothing.

Mr. Borden pointed out that while Hon. Mr. Fitzpatrick contended that the Grand Trunk would have to pay full value for Grand Trunk Pacific stock, Laurier had explained most explicitly that it was intended to allow the Grand Trunk to get the stock at the lowest possible price. He quoted from Mr. Fitzpatrick's recent speech to show that the government viewed the Grand Trunk Pacific and the Grand Trunk at the same red-headed level. Under the Grand Trunk Pacific scheme the red-headed boy would dispose of \$25,000,000 of stock at a mere nominal figure. If Mr. Fitzpatrick was right in his contention, the full value will be paid for the stock, and Barker's amendment should be accepted without hesitation. It was important that the government should insist upon the Grand Trunk paying for all stock in order that security for fulfillment of the terms of the agreement in sight be secured.

Mr. Fowler and other members of the opposition spoke along the same lines. On the vote committee after dinner, Mr. Barker's amendment to compel the Grand Trunk to pay full value for stock, was lost 31 to 45.

Discussing the clauses of the bill which deal with the routing of freight, Mr. Borden asked if the Grand Trunk would find it in its interest to forward it over the eastern section of the Grand Trunk Pacific, or through Chicago, what the Grand Trunk Pacific would have to say in the matter. He warned the government that the Grand Trunk would divert its traffic to United States ports.

The leader of the opposition moved an amendment providing that the government shall not be compelled to carry out the terms of the contract until such times as the Grand Trunk shall purchase at par Grand Trunk Pacific stock to an amount not less

Tonight a man was on the roof but the flames burst out prematurely, so that before the salvage wagon, driven at breakneck speed, got to the scene the man's clothing was on fire. He was unable to jump and fell to the ground. His face, head and arms were burned, and the hospital ambulance was sent for. At the hospital it is stated that he will recover. The victim of the affair is George Huestis, a South African veteran. The grand stand spectators were almost in a panic and got more realism than was pleasant.

CHRISTIAN SCIENCE.

There were fully six hundred people at the Opera House last evening when Hon. W. G. Ewing of Chicago delivered a very interesting lecture on Christian Science. The lecture was given under the auspices of the First church of Christ Scientist of St. John. C. N. Skinner presided, and in introducing the speaker, heartily welcomed him to St. John. Judge Ewing said that the theory of Christian Science is understood by many. It is not in any degree inimical to the teachings of Christ. Christ's religion is a religion of works and the lame do walk and the blind do see just as they did walk and see nineteen hundred years ago. Continuing, Judge Ewing said: Christian Scientists have radically changed their thought of God; they no longer attribute to God qualities that no man among civilized people anywhere could acknowledge to himself, and not meet the ostracism he deserved. We no longer indulge the belief that God makes us sick, or lame, or blind for some mysterious purpose of His own. It is not within the range of a reasonable concept of an infinitely just, and infinitely good God, that He would deliberately hold in torture, and crush in despair a pure, sweet mother for the purpose of making some bad man better. Being infinitely just, if He were administering punishment for reform, and dispensing rewards for virtue, He would crucify the bad man, and enthroned the good woman. We believe that God is not only the embodiment of good, but that He is good; the "Great Physician," who heals all our diseases," who gives succor to sorrow, who literally wipes all tears away; and we confidently go to this infinite source of life, and strength, and joy for redemption from every ill that comes to humanity. I do not mean to say that Christian Science has made us better than you are, but I do mean to say that it has made us better than we were, and it will make you better than you are.

THE CANADA.

Arrival of a Molasses Schooner After a Tedious Passage. The Lunenburg schooner Canada, Capt. Conrad, arrived here yesterday and docked at the 504 pumphouse, 58 tierces and 90 barrels of molasses for L. G. Crosby. Capt. Conrad reports that he had calm weather all the way up, and the voyage was a tedious one, occupying no less than 24 days. The Canada is one of the best looking vessels of her tonnage which ever visited this port.

THE CONNOLLY FLEET.

Despatches received here yesterday located the two steamers which left here Sunday week with the dredge and two of the scows for Quebec. The Lord Kitchener with the dredge International, which left Port Mulgrave Saturday, reached Pictou Sunday afternoon between 7 and 8 o'clock and sailed at daylight yesterday morning. A heavy north wind prevailed at the time. The storm King, previously reported in trouble, was at Port Mulgrave yesterday afternoon. She must have effected repairs with despatch.

S. P. C. A. COUNCIL.

At the meeting of the council of the S. P. C. A., held yesterday afternoon at the City Hall, the Rev. H. H. Senneker, pastor of the First Baptist church, and Mr. E. B. Berr, president of the S. P. C. A., were elected an active and prominent part in the organization of the society and in recognition of his services he was elected an honorary member. The other business which came before the council was, it is understood, of the ordinary routine character.

BANK ASSESSMENTS.

There was a meeting at the City Hall yesterday afternoon of the assessment committee of the Common Council. Ald. Maxwell was in the chair, and there were a number of aldermen present along with some of the city officials. The representatives of the various banking institutions doing business in the city were in attendance, the intention of the conference being to get the bank men to state their opinions with respect to the assessment it was proper to make on the banks.

BRITISH CABINET.

LONDON, Sept. 15.—The ministers kept secret the discussions of yesterday's cabinet council so effectively that the speculation as to the result is almost nugatory, and the government press organs this morning offer the most conflicting accounts of what took place at the meeting. The Daily Telegraph, which is probably the best informed, asserts that the cabinet crisis was postponed until this evening, and the discussion of the fiscal question will be continued at the resumed meeting today, but that whatever may be the result, Mr. Balfour will neither resign, dissolve parliament nor summon an autumn session. The Daily Telegraph also asserts the idea of a royal commission being appointed to consider the whole fiscal question. The Standard, on the other hand, asserts equally positively that the fiscal inquiry was finished and that the adjourned meeting will deal with a foreign policy. It understands that the question of imposing a preferential tariff or of any innovation in Great Britain's fiscal policy has been shelved until an appeal is made to the country, and that during the existence of the present parliament the action of the ministers will be confined to discussion and inquiry. Amid these conflicting reports an agreement is found in the most authoritative quar-

THE DANGER GROWING.

Condition of St. John's Fire Alarm System is a Menace to the City's Safety.

The St. John fire alarm system is at present, as a system, absolutely worthless. It is not only no good, but because, under the supposition that it is in working order, citizens continue to put their trust in it. It is a source of great danger.

Since Saturday four alarms have been sounded and on not one occasion have the members of the fire department been able to ascertain from the bells where the fire was. At times one or two of the big bells ring, sometimes they do not sound at all. In the North End the gongs in the stations run away with themselves and strike any old number. The firemen are introducing guessing contests as to what will be the next combination of blows.

Two alarms were supposed to have been called in on Saturday. The second was from No. 5 station and this was the only place in the city in which the men were certain of the box number. Some time after the other alarm was called the men who had heard nothing of it were surprised to learn by telephone that there was a fire.

Yesterday the horses took position twice and then men tried to make some combination out of the blows being struck on the gongs. They got, in the North End 1, 3, 5, 4, 2, 2, 3, which was very interesting, but scarcely definite enough for action.

The circuit is rotten almost for its entire length and is continually breaking. These breaks are at times difficult to locate and frequently hours are spent in searching for them. With the coming of winter the snow and sleet falling on the wires will undoubtedly cause many more breaks than now occur. But the council is not hastening with the Gamewell contract.

NORTH END MONUMENT.

No Change Will Be Made in the Design.

Mrs. Bantley has received a letter from Edgington & Co., who are making the bronze figure for the North End monument, suggesting a change in the design. The letter states that the pedestal for such a monument as this should be ten feet high, while the figure will be seven feet and according to the ideas of the English manufacturers these figures should be reversed.

James Paton, of Charlottetown, who was in the city on Saturday, speaking of the Charlottetown monument, said that the pedestal there was considerably higher than the figure, but that the complete monument was all right and the figure quite prominent. No change will be made in the North End design.

Edgington & Co. also ask for a Canadian uniform and equipment to be used in making the design for the figure. It is believed that the uniform has been forwarded.

THE LOVE OF HAM CHING.

These warm September days with the balmy southern breezes are enjoyed by almost all persons in the city, but there are exceptions. Those citizens who live near the Orange street dump are not exactly carried away with pleasure when the hot wave strikes that district. The dump is getting in its work, and the air is almost cut. It is something vile down there, but the people have been complaining so long that they are now tired of the thing.

TO SHINE ELSEWHERE.

John de Angelis has gone. Henceforth he will be known as John de Angelis, a citizen of the United States and will shine as usual in a larger sphere, though perhaps not on longer boots, than was afforded in St. John. He has found that business here is so dull during the winter months that all his summer profits are eaten up, and there is not much satisfaction in that. John has secured a job in Boston and has taken his wife along to live with him. Meanwhile Antonio is doing business at the old stand.
