Through the infinite mercy of Divine Providence we have again been permitted to assemble together, to legislate in "Friendship, Love and Truth," for the welfare and advancement of our Noble

Order.

1.—It affords me much gratification to preside over your deliberations at this time, and to meet so many old familiar faces. But that pleasure is alloyed with sorrow, at the removal from this earthly encampment of those devoted and time honored Brethren, P.G. Master C. Yale, and P. D. G. M. Henry Sewell. While we mourn over their demise, let us hope that our loss is their everlasting gain, and that, though these pillars of Odd-Fellowship have been removed from this earthly Lodge, the memory of the good deeds they have done, will long be green and fresh in the memory of the Brotherhood. The loss of Bro. Yale is severely felt in the St. Catharines District, where he was regarded as a patriarch indeed, and a connecting link in the chain of our fraternal existence. Long and sincerely he labored to build up and extend the influence of Odd-Fellowship, and in the evening of his days, he had the proud satisfaction of seeing that his life long labors had not been altogether in vain.

2.—Since we last assembled our country has been subjected to an invasion by a horde of ruffians styling themselves Fenians, who endeavoured to render our homes desolate, and deprive us of that beneficient system of government under which we have been so abundantly blessed as a people; we have reason to feel proud of the spontaneous response given by all classes of the people, to repel the invaders and drive them back in disgrace from whence they came. How marked a contrast does there exist between the Fenian organization and our own, there is a fellowship in each, but while theirs is avowedly for exciting the worst of human passions, ours is calculated to cement together the kindliest feelings of our nature, to succor the widow and orphans to relieve the distressed, and so act under the divine providence of God, as to attain as nearly as possible the

summit of human happiness.

On a former occasion my predecessor had the pleasure of submitting to you a communication from Bro. Schuyler Colfax, of Indiana, through whom was transmitted an address to His Excellency Andrew Johnston, President of the U.S., referring to the assassination of Abraham Lincoln, late President of the United States. His reply was couched in very complimentary language, and dwelt upon the friendly and brotherly feeling expressed in our letter. I regret to state that I have since learned that this Brother has openly countenanced the Fenian organization, and thus placed himself in a position of antagonism to us, and also to the well known principles of our Order.

3.-On June 5th, in company with P. G., A; Purves, and according to arrangement with D. D. G. M., A. Frew, I paid a visit to Excelsior Lodge, No. 44, Hamilton. This Lodge is one of the

youngest in the jurisdiction, but the membership and representation show her to be in a flourishing condition. In Bro. Frew's report for July he says, "the prospects of our Order here are exceedingly encouraging, during the last term we have made 28 new members, conferred 92 degrees, and since the first of the month we have had eight applications for membership. I feel assured that if harmony continues to prevail among the members of Excelsior Lodge, she will take high rank in the Order, from her position in one of the first cities of the West. While visiting the above Lodge, the Minute Book of Burlington Lodge, No. 17, which had been recovered by the energetic endeavors of Bros. Baur and Frew, was handed to me. The last meeting held by this Lodge was in March, 1848, over eighteen years ago. The records contain matters of much interest, and will repay the curious who may give them a careful perusal.

4.—In the month of March I received a pressing invitation from D. D. G. M., John Taylor, to visit Brock Lodge, No. 9, to attend their anniversary supper. I could not at the time comply with their wishes. A short time after, while on a business journey to Montreal, I stayed over a few hours at Brockville, but was unable, from the short notice given, to obtain a special meeting. This was during the first Fenian excitement, and I found Bro. Taylor together with other Bros. "doing duty at their country's call," thereby giving practical evidence, that while we as Odd Fellows are "fraternal to our fellowmen," we are at the same time faithful to our Queen and country.

Brock Lodge in her old age is still healthy and vigorous.

5.—On Monday evening. July 16th, I visited Forest City Lodge, No. 38, London, a well filled Lodge and a bright glare of scarlet regalia greeted my eyes as I entered the room, thus reflecting on my mind the motto, "zealous in the cause, and well up in the Order,"—I took part in an Initiation, (and although early in the term) I was much pleased with the proficiency of the several Officers.—Seven Petitions were presented.

The following evening I visited the officers and members of Eureka Lodge, No. 30. The meeting to me was an interesting one, the work was prompt and correct, showing that this Lodge is a strong

pillar in the Temple of Odd Fellowship.

From among the warm hearted brothers of London, I took my departure to visit Samaritan Lodge, No. 35, Ingersoll; arriving there I found awaiting me our firm, tried and true Bro. D. D. G. M., A. Bristol; after an hours conversation with a few of the Bros. I proceeded to their Lodge Room, took my seat among them in due form, and the business of the evening went on. I am pleased to say that a more contented and happy family compact it never has been my privelege to witness. Samaritan Lodge during the early part of the year was in rather a precarious condition, in the D. D. G. M's Report, he alludes to the time when he saw but little hope of their

work 8. so und surviving long as a Lodge, but towards the close of the term he forwarded a most encouraging report.

I have met thrice with Union Lodge, No. 16, in an official capacity. I installed the officers of both terms, and also paid an official visit in June last. It would be unbecoming in me to eulogise my parent Lodge, I may, however, be pardoned tor the just pride that I cherish in hailing from one so honored and revered by all for her steadfast adherance to the principles of the Order. She is now as she has ever been—faithful and true.

6.—I regret to report that Long Point Lodge has been compelled to surrender her Charter. In a letter from Bro R. Thoroughgood, he deplores that such is the case, giving as a reason for their discontinuing to work, a lack of interest, and irregular attendance of the members. He enclosed me \$2.00 as per centage due Grand Lodge up to the time that the Lodge became defunct, and informed me that the Charter, W. Books, and a quantity of blank forms were in his hands, I instructed him to forward them to D. D. G. M. Lauterbach, in trust for Grand Lodge. This request has been complied with.

I have been supplied through the same source with a list of brothers names who are entitled to Cards of Clearance from the time Long Point Lodge became defunct. I would most respectfully recommend that said Cards be issued by authority of this R. W. G. Lodge, to the following brothers, viz:—Geo. Weatherly, John Wilson, Thomas Simpson, Geo. F. Counter, John Reid, George Werrett, Chas Damyon, Thos. Robertslaw, John S. Austin, Duncan M. Wilson, and Reuben Thoroughgood. I have to commend those brothers for their fidelity to their pledge of honor.

Imperial Lodge, No. 37, has also ceased to exist. I am in receipt of communications from Bros. Smith Mathews, H. Or Forsyth and others, tendering their effects and funds to Grand Lodge, with the view of joining Gore Lodge, No. 34, Brantford.

7.—During the early part of January I received a communication through the R. W. G. Secretary, from five Searlet members, praying for a Warrant to open a Lodge, under the name and title of Mount Zion Lodge, No. 46, in the Village of Newbury, C. W. / I issued said Warrant and commissioned the proper officer of that jurisdiction to institute said Lodge. He having declined, I instructed the R. W. Grand Secretary to proceed and perform that duty. He accepted the trust, and carried out the same on the 18th of January, in company with Grand Warden Beltz, D. D. G. M. R. Kirkpatrick, P. G. Anderson Chapman, and M. Dawson. The R. W. Grand Secretary informs me that since their institution he has paid them several visits, and that they are making daily improvement both in knowledge of the work and in point of membership.

8.—When I accepted the office of Grand Master at your hands, I did so under the impression that, selecting my own time, I could accom-

plish a visit to every Lodge in the jurisdiction; in this I have been disappointed. I have therefore been compelled to deny myself the pleasure of visiting the following Lodges, viz: Chatham Lodge No. 29, Eric Lodge No. 33, Gore Lodge No. 34, St. Mary's Lodge No. 36, Avon Lodge No 41, and Frontier Lodge No. 45. Nevertheless, I have been in constant correspondence with the different D. D. G. Masters of those districts (whose diligence I take pleasure in recording here) and from all, come the cheering intelligence, "We are increasing in membership, in wealth, and position." The powers of expansion exhibited in the "Infant" Lodge at Windsor are unprecedented; they, truly, are giants in latter days.

9.—Report of commission to Rond Eau Lodge is detailed in corres pondence of Bros. Bennett and Snyder, and also referred to in a letter marked A, from the R. W. Grand Secretary. A card of clearance, as ordered by the Grand Lodge, has been issued to Bro. Graham of the

late Thames Lodge, Mitchell.

10.—Points of law, submitted for my decision, are few in number, and as follows:—1st. Query—Is the junior P. G. of a Lodge eligable to be sent to Grand Lodge, when there are other qualified P. G's who are willing to attend? Answer,—A junior P. Grand is not directly speaking an officer of a Lodge, but may be elected a representative to G. Lodge. (Page 148, clause 5 of revised Digest.)

2nd. A person is proposed for admission by card, pays his fee \$5, and is appointed or elected to office. On the next night of meeting some of the members take exception to his standing in the community, alleging that he is engaged in an unlawful calling. A committee is appointed to make the necessaries inquiries in the case, report in due time to the Lodge that they are satisfied beyond doubt that the party in question keeps an unlicensed grogery. take action on the report, and recommend that the Five Dollars which the party had paid into the Lodge be given back to him, and that he be requested to consider his membership at an end. He ascepts the money, and there the matter .ested for, say two years and a half, there being a mutual understanding that no membership exists. The party now wishes to become a member of the same Lodge, not considering himself as belonging to any. The question is, how can it be done? Can he be received as an ancient Odd-Fellow; or is he actually a member, having been formerly received? Did the mutual understanding between him and the Lodge two and a half years ago, dissolve his connection, he having received back his fee; or is he still a member? If a member, must he pay his two and a half year's dues before he can be accepted as good on the books? If not a member, can he be proposed as if no former action had been taken? In short, what is his position in connection with the Lodge?

Answer given by referring to Digest, page 89, clause 19. "If a person be illegaly elected to membership through fraud or mistake,

(as to his health or otherwise) a majority of the Lodge can, previously to his initiation, order a new ballot; but if the fraud be not discovered until after his initiation, the party must be regarded as a member, and can only be expelled upon a regular trial." In accordance with the foregoing, I decided that the Lodge committed an error in returning the fee and coming to an understanding of the kind.—
If the Brother has not ceased to become a member from non-payment of dues, he can make himself good by paying all arrearage, or by compromise; yet the charge would still be pending.

11.—I have to acknowledge receipt of a copy of proceedings of the Grand Lodge of Kansas, U. S. In looking over it I find the following reference, "No action has yet been had in regard to procuring charters from the Grand Lodge of Canada West, for the same reason as assigned in a former report, viz: the high rate of exchange. The Subordinate Lodges are exceedingly anxious to have their charters, and would respectfully ask some definite legislation on the subject.

12.—According to resolutions passed at the last session of Grand Lodge, appointing the Grand Master and Grand Secretary as a special committee, to draft an address to be presented to Bro. John Peel, The committee have carried out their instructions. The address and Jewel was presented by Grand Rep. Jas. Smith, assisted by the R. W. G. Secretary at a meeting of Eureka and Forest City Lodges, and in the presence of P. G. Sire J. B. Nicholson. Bro. Peel made a most affectionate reply, and all present were delighted with the social reunion. A copy of the address is herewith submitted.

13.—P. G. Sire Nicholson's visit to Canada, were times of refreshing to all who had the privilege of hearing his lectures, receiving his instructions, and enjoying his social company. His institution of Harmony Encampment, No. 3, London, and Frontier Encampment, No. 2, Windsor, gave them a prestage otherwise unattainable.

14—REPRESENTATIVES,—In resigning again to your keeping the highest office in your gift, permit me to thank you for the uniform courtesy and assistance so freely extended to me in everything pertaining to my office. I am deeply sensible of my short comings, and regret exceedingly the many calls of my own private business would not allow to devote that attention I intended to bestow upon the duties pertaining to the Grand Master's chair.

'In conclusion, I have to congratulate you on the steady advancement and progress of Odd-Fellowship, both in Canada and the United States. And I retire from the chair with feelings of pleasure and pride afforded me by the prospect of still greater triumphs awaiting the Order in the future. May Providence have you all in his safe keeping, and let us earnestly invoke a continuance of those blessings which have been so abundantly showered upon us as individuals and as a Society. God bless you all.

On motion of Rep. Barr, the Grand Masters Report was referred to the Committee on Distribution.

The R. W. Grand Secretary and Treasurer submitted the following Report.

To the Most Worthy Grand Master, Officers, Representatives and Members of the R. W. Grand Lodge, Canada West.

In compliance with the Constitution of our R. W. Grand Lodge, I herewith submit to you a report upon the condition of the Order in this jurisdiction.

BRETHZEN.—The return of another Grand Lodge meeting should bring with it the solemn and peculiar feeling common to all of our race, who are alive to their instincts as children of one common parent, the lapse of another eventful year. And while its trials and sorrows are past, we cannot forget the manifold blessings and privileges with which we have been favored, how we are again permitted to associate ourselves together under the mild and benign banner of our Order, clasp each others hand in communion and fellowship, and unite to more closely develop the principles of Friendship, Love and Truth. Who that has a heart to feel, must not at this hallowed moment and under such gracious and favorable circumstances, thankfully render the tribute of gratitude to Almighty God for his kindness in sparing our lives and permitting us once more to meet in this Hall, consecrated to Friendship, Love and Truth.

Since our last annual communication, part of our jurisdiction has had a visit from Past Grand Sire, Bro. Nicholson, of Philadelphia, and speaking of that worthy Brother brings up joyous emotions. His visit to Canada will never be forgotten. Imbued with fervent charity to all men—long may the great Master of the universe space him to expound the gentle teachings and grand truths to which he gave utterance in the halls of St. Catherines, Brantford, London, and Windsor—may his shadow never grow less and immortality crown his earthly transit.

Immediately after the Session of this Grand Body, held at Hamilton, Canada West, I compiled the proceedings thereof, and according to a resolution of this Grand Lodge, caused 200 copies to be printed and forwarded to all Subordinate Lodges and Grand Officers of this jurisdiction; also, to all Grand Lodges and Encampments through the United States.

I have, during the past year, received the proceedings of the following Grand Lodges and Encampments, viz: From the Grand Lodges of Indiana, Kansas, California, Maine, Connecticut, Oregon, New Jersey, Pennsylvania, Nebraska, Wisconsin, Kentucky, Michigan, and Massachusetts, and from the Grand Encampments of Wisconsin, Indiana, Iowa, Pennsylvania, Ohio, New Hampshire, Kentucky, New Jersey, Massachusetts, and Illinois.

1. My correspondence for the past year will be laid before you for your inspection. But little of consequence has been received.

2. According to the report of the Committee on Correspondence at the last year's Session, and adopted by the R. W. Grand Lodge, (page 327,) I notified Javed M. Gleeson and Chas. M. Male, of Lockport, U. S., of the action of this Grand Body regarding their cards of cleanance from this Grand Lodge, and returned the one dollar "green back" which they forwarded for said cards.

5. On July 13th, 1866, I received a letter from Columbia, South Car: olina, dated July 6th. 1866, and signed by John Stork, enclosing 30 cents in scrip to forward 13 circulars to the different Lodges in this jurisdiction; said circulars have not yet arrived.

6. The semi annual returns for both terms have been duly received from all our Lodges, except Imperial Lodge No. 37, Burford and Long Point Lodge, No. 42, Simcoe. I received two dollars from the R. W. Grand Master, as sent to him from Long Point Lodge, being the amount due

Grand Lodge at the time of said Lodge breaking up.

7. Your Secretary, since his arrival in Brantford, received from Bros-Matthews and Findley the books, papers, funds, &c., &c., belonging to Imperial Lodge, with an Inventory marked B. The funds returned to this Grand Lodge by said Brothers amount to (\$40) forty dollars.

The communication received by our M. W. Grand Master, will explain

the position of Long Point Lodge No. 42, Simcoe.

8. On the 29th of November, 1865, I received from D. D. Grand Master, Bro. Snyder, and P. Grand Bro. J. Bennett, of Chatham Lodge, through express, property of Rond Eau Lodge No. 400 consisting of books, papers, &c., &c. On receipt of said property your Secretary caused an Inventory to be taken of the same by Grand Warden Bro. E. Beltz, of Forest City Lodge, and Bro. Craig of Eureka Lodge, London, C. W. The valuation of said property amounts to \$36.35. The Chatter and Seal of said Lodge are now in possession of this Grand Lodge.

9. A circular has been duly received from the R. W. Grand C. and R. Secretary of the Grand Lodge, United States, informing this Grand Body that at the next Session of the R. W. G. Lodge of the U. S., the revision of the work will come especially before the R. W. G Lodge for con-

sideration and final action.

10. A communication has also been received from the R. W. G. C. and R. Secretary of the Grand Lodge, United States, enclosing slips of the new forms of O. B. N., which I distributed to the different Lodges under this jurisdiction.

11. In accordance with the report of the Committee on Returns, (rage 327 of last year's Journal,) regarding overcharge of per centage to Erie Lodge, No. 33, by this Grand Lodge, which report was adopted. I credited

Erie Lodge with the amount overcharged.

12. At the Institution of Mount Zion Lodge No. 46, Newbury, C. W., your Secretary disposed of all the effects received from Rond Eau Lodge, except the Scal and Charter to Mount Zion Lodge, at the valuation of Bros. Beltz and Craig, and Rond Eau Lodge has been duly credited on the books of this Grand Lodge.

13. Your Secretary received communications from the Grand Lodges of New Jersey and Massachusetts, asking for all back numbers of the Journal of Proceedings of this Grand Body. There not being suf-

ficient numbers on hand, I could not comply with the request.

14. The account of the R. W. Grand Lodge of the United States is

15. The Income and Expenditure of this Grand Lodge for the past year is herewith respectfully submitted, which I hope will prove in every way satisfactory.

On motion of Representative Barr, the Grand Secretary and Treasurer's report was referred to the Committee on Distribution.

The Grand Rep. to the Grand Lodge of the United States submitted the following Report:

To the Right Worthy Graud Lodge of Canada West, I. O. O. F.

OFFICERS AND REPRESENTATIVES—It is with feelings of much pleasure that I, as your Representative to the Right Worthy Grand Lodge of the United States, have the honor to submit an abstract of the proceedings of the last memorable Session of that Grand Body, which convened in the Odd-Fellow's Hall, North Gay Street, in the City of Baltimore. on Monday the 18th September, 1865, and which continued in operation during the entire week.

Tongue could not tell, nor pen fully describe the unwonted wonted joy and unbounded felicity manifested throughout the membership during the whole period of that memorable meeting of the Brethren on that Mecca of Odd-Fellowship; nor was it indeed confined to the members, for citizens generally seemed to vie with each

other as to who would do the most for our noble cause.

To say that the meeting of 1865 was one of unusual interest, would be saying little indeed; but when cur good and present, noble Captain Isaac M. Vetch of the bark, Odd-Fellowship, took the helm, according to ancient custom, and kindly ordered his venerable mate,

James L. Ridgely, to pipe all hands. Joy knew no bounds, for after a voyage of four years spent in war, tumult, and trouble, five only of the jolly crew were found wanting, viz: the Representatives from North Carolina, Florida, Canada East, Arkansas, and Oregon; the last two were reported in good health, but from causes over which

they had no control, failed to answer to their names.

The report of our most Worthy Grand Sire is in itself a very able production, and one well calculated to promote harmony and love among the Brethren. Neither time nor space will permit me to here give it you word for word, but it is more than evident that he has spent a vast amount of valuable time in infusing new life and spirit into the Order generally, more especially those jurisdictions which were lagging by the way. Need I say that already he has reaped a rich reward, and to his untiring zeal in writing, speaking and visiting, may be attributed the fact (to a great extent) that our Order is now in its good and present prosperous condition. Among his many decisions during the past year, I have selected the following as requisite for submission in this report.

2nd. That a motion for a reconsideration of a ballot for an applicant for membership, who has been rejected, may be made at such time as the local law of a Lodge may specify; and in the absence of any local law on the subject a motion for reconsideration may be made at any time, provided such motion is made by those depositing

the black balls.

31d. If the local law so provides, a Lodge may go through its regular business, close in due form, and then open in and confer any

of the degrees.

4th. Where the law of a Grand Lodge or Grand Encampment provides that a Grand Representative is an elective Grand Officer thereof, he is to be recognized as such and entitled to the honors of

the Order when visiting a Subordinate officially.

5th. It is the duty of a Subordinate to obey the decisions of its Grand Lodge, which are final and conclusive, until reversed by the Grand Lodge of the United States upon proper application thereto. Pending such appeal, the Subordinate Lodge is not entitled to any privileges other than those accorded to it by its Grand Lodge, which may enforce its decision by demanding the Charter and effects of the Subordinate for non-compliance with the decision a pealed from.

6th. A number of Subordinate Lodges cannot legally establish a Union Degree of Rebekah Lodge, and hold regular meetings thereof for

conferring and working that degree.

7th. When a Grand Master and Grand Representative of the same jurisdiction, each at different times during the recess of the Grand Lodge instruct a Subordinate Lodge or a D. D. Grand Master, in the secret work of the Order and their instructions differ, the instructions of the Grand

8th. A candidate for membership in the Order, who has been elected in a Lodge where he resides, cannot be initiated in a Lodge located where he may temporary reside, upon the request of the Lodge electing himbat all initiations must take place in the Lodge in which the applicant is elected.

9th Societies of the Degree of Rebecca, composed of ladies in possession of that degree, the Regalia Room and the work of that degree used, are irregular, unauthorized, and in contravention to the legislation of the Grand Lodge of the United States.

10th. The law of the Session of 1864, prohibiting anniversaries, &c., without the consent of the Grand Master or Grand Patitarch, predicated upon the promises that no intoxicating beverage would be used, is not intended to prevent Lodges and Encampments from joining in a public procession in regalia, in connection with other organizations when invited to do so by the civil authorities; and permission for that purpose may be obtained from the respective jurisdictions under such regulations as they may prescribe.

These decisions of the Grand Master were severally confirmed by the Grand Lodge, except the 7th, which was modified by the R. W. Grand Lodge. (See page 3821, 3843, Journal G. L. U. S.)

The Report of our venerable and highly esteemed Brother, Grand Secretary Bidgely, is replete with a vast amount of information, and fully shows that our beloved Order never was in the same healthy condition as it now is; and what goes far to substantiate this is the fact, that the revenue also for the fiscal year-ending September 1, 1865, has far exceeded that of any previous year.

The Grand Treasurer's Report shows the finances of the R. W. Grand Lodge to be in a most satisfactory condition, the total amount to the credit for the period above mentioned, sums up \$31,224 02, while the disbursements during the same time was only \$17,425 02, leaving a balance in the Treasury of \$13,799 00.

The Report from the Finance Committee, and which is substantially as follows, was adopted.

Resolved,—That the Digest hereafter he sold at \$1.50 each, with a discount of 33½ per cent., when fifty or more copies are purchased at one time.

Resolved,—That the Grand Lodge of the United States hereby remits the tax of the Grand Lodges and Grand Encampments of Virginia, South Carolina, North Carolina, Georgia, Alabama, Mississippi, Lousiana, Texas; and of Grand Lodges of Florida, Arkansas, and Vermont, for the years 1861, '62, '63, '64.

Resolved,—That the notes of the Grand Lodge of Vermont, for Representative tax for said five years, and notes of Grand Encampment of North Carolina, given for taxes and supplies previous to 1861, be and are hereby cancelled.

Resolved, —That the Grand Secretary be, and hereby authorised to furnish upon reasonable credit to such institutions, whatever supplies he may deem necessary, during the current year,

same Lodge t work Grand The consideration of the last three clauses of this report drew cut a dissussion, in which many noble Brothers out poured the essence of their inmost souls, expressing sentiments hallowed by the purest principles of Friendship, Love, and Truth. Yes, men and Brothers of the Notth and South there met and gave utterance (breathings of peace and harmony) to such expressions as never before fell from human lips. Joy knew no bounds: All seemed to realize that beautiful passage in our Ritual, "That the wolf and the lamb were about to lie down together." Yes, and in reality a little child could easily have lead all assembled there, they were so impressed with the magnaminous, kindly, and brotherly feelings so beautifully pourtrayed during the occasion. All was peace and harmony.

The Committee on the state of the Order, gave decisions of law as follows: -

- 1st. Question-What is meant by the words, "Satisfactory evidence of former connection with the Order." They, the Committee, expounded.
- 1st. "That the evidence to be satisfactory, must come from the Lodge of which the person was formerly a member."
- 2nd. "If such Lodge be extinct, then from the Grand Lodge, under whose jurisdiction the Subordinate existed."
- 3rd. "In case the evidence can be procured from neither of these sources, then the party may be admitted into the order by initiation."
- 2nd Q. Upon a question as "to how a Brother expelled or suspended, whose Lodge has afterwards become extinct, may regain membership."—The interpretation of the law was to the following effect.
- "That a Brother who has been expelled for nonpayment of dues or crime from a Lodge which subsequently became extinct, can only regain membership in the Order through the Grand Lodge, to which the Lodge he belonged to was subordinate; and this rule applies also to the patriarchal branch of the Order."
- 3rd Q. Upon an inquiry as to whether members of Lodges and Encampments visiting other Lodges and Encampments in a body, and introduced by their cwn officers, are entitled to the "honours of the Order." The Committee submit.—
- "That officers and members of Subordinate Lodges and Encampments visiting other Lodges and Encampments in a body and introduced by their own officers, are not entitled to be received with the honors of the Order."

The following Report by the Committee on Legislation was adopted.

Resolved,—That Subordinate Lodges and Encampments of this Order shall vote by ballot upon all applications for final cards, made in accordance with existing laws; and the affirmative vote of a majority of the members present, shall be necessary to the granting of such card.

Resolved,—That upon such ballot, should a majority of the members present refuse their consent to the granting of a final card to an applicant therefor; such applicant upon payment of all dues and tendering a written resignation of his membership, and not otherwise disqualified,

shall be entitled to receive from the Secretary or Scribe, under seal, a certificate that he has resigned his membership, and such certificate shall be sufficient evidence that the Brother was in good standing at the time of his resignation, provided,—"That upon a refusal of a Lodge or Encampment to grant such withdrawal card, the member applying for the same shall have the right of appeal, to the Grand Lodge, or Grand Encampment of his jurisdiction.

Resolved,—That visiting and withdrawal cards, heretofore issued by any Southern jurisdiction, countersigned by the Grand Secretary and attested by the seal of the Grand Body is using the same, shall be taken and deemed to be as effectual as if the same had borne the counter signature, or face similie thereof, of the Grand Secretary of the Grand Lodge of the United States.

Resolved,—That from and after this date expired withdrawal cards may be received or deposited for applications for charts for Subordinate Lodges and for charts for Subordinate Encampments, where the holders of such cards are contributing members of Subordinate Lodges.

Resolved,—That the place designated in the charter is the seat of a State Grand Lodge, until properly changed. It is, however, the legal right of a State Grand Lodge to hold its sessions from time to time at such place within its own jurisdiction as may be determined upon at any preceding meeting.

The consideration of having an Honorary Membership attached to our Order, was referred to this Committee, who reported adversely; which re-

port, notwithstanding a strong opposition, was adopted.

An amendment to the Constitution, as follows, was adopted.

Amend Art. 16, sec. 4 of Constitution, by striking out all after the words "Provided however," and adding the following,—"That when it shall be satisfactorly represented to the Grand Lodge of the United States that the necessities of a State, District or Territorial Grand Jurisdiction require it, a resolution may be passed by a vote of three-fourths of the Representatives present at any meeting, granting to the particular State, District or Territorial Jurisdiction applying therefor the right to re-admit to membership within its jurisdiction, upon such terms as it may prescribe, suspended members of the Order residing in the same, who may have been suspended for non-payment of dues and who have not been under suspension for less than three years, and also the right to admit members of defunct Lodges not able to get a card—it being distinctly understood that so soon as the necessity requiring it, shall have passed away, this privilege shall be yielded up by the jurisdiction receiving it.

The By-Laws were amended as follows, viz :-

Strike out of Art. 22 of By Laws, in twenty fith line, Digest page B, the words "and aprons as above described," and add the words "trimmed with yellow lace, or fringe"; so that, so much of said By Laws as relates to the regalia of the Past Chief Patriarch, shall read as follows,—" Past Chief Patriarchs shall wear purple collars or sashes, trimmed with yellow lace or fringe."

is he revision of the secret work and ritual of our Order was, after a good deal of consideration, postponed until the next assembly of the Grand Lodge; Officers and Members having promised to report verbally to their several Grand Bodies, the main feature of the proposed alteration.

A resolution was adopted to this effect. "That the Grand Corresponding and Recording Secretary be and he is hereby requested to publish in the appendix to the revised Journal, the debate had in the Grand Lodge upon the report of the Committee on Finance, remitting the dues of the Southern Grand Bodies; and also to collect all the proceedings had on the occasion of the dedication of the Wildey Monument and connected thereunto, including the speeches made on the stand on the day of the dedication, at the banquet given by the Corporation of Baltimore, and by the merchants and business men of Baltimore, and that he has full power and discretion to omit any part of such proceedings, which, in his judgment, may be proper."

One of the most important items in the week's exercises was the dedication of the Wildey Monument, which took place on the 20th September last amid great eclat; only fancy, between fifteen and sixteen thousand members all clothed in regalia appropriate to rank, and displaying many new and elegant banners, marching in one grand procession, accompanied by numerous Military and other Bands of music, the sweet and melodious strains of which, enlivened and added much to the pagantry of the day.—Time nor space will not permit me to give a full and particular description of the monument and proceedings in connection therewith. That day will certainly form an epoch in the history of our beloved Order, sufflee it to say, that the sun has never shone on a day more memorable in the annals of the monumental city than the one on which was unveiled the figure of Charity, standing on the pillar erected to the memory of P. G. Sire Wildey, the pioner of Odd Fellowship on the American continent.

I cannot let this opportunity pass without mentioning two important attractions which added much to the grandeur of the procession. One was a large vehicle drawn by six magnificent horses, bearing the beautiful tent of the Grand Encampment, in which was seated the Grand High Priest wearing his gorgeous robes, on either side of which sat the Guards of the Tent, arrayed as became their position. The other was the "Jewels of our Order' otherwise the "Orghan children." some eight hundred or more of the State of Maryland. The girls were in five magnificent char: iots built expressly for the occasion, each drawn by six splendid horses led by coloured grooms attired in oriential costumes. (which had a very attractive appearance.) Each chariot was draped in colors representing the different Subordinate degrees, viz: 1st, white, 2nd, pink, 3rd, blue, 4th, green, and 5th, red. The occupants were very neatly attired and bore in their hands numerous decorated banners and shields, named after the different States and Territories. "Canada West" was well represented, as in each car I perceived some fair daughter of Eve upholding a banner with that endearing name thereon.

There was only one disappointment to mar the happiness of the day's proceedings, and that was the absence of his "Excellency, President

Johnson." It was fully anticipated that, that august personage would have been present; although the Committee made every effort to secure his presence amongst us on that important occasion, owing to previous Cabinet engagements, he was obliged very reluctantly to decline the invitation.

Not withstanding the above disappointment the day passed away most pleasantly. The programme as laid down, being fully carried out to the satisfaction of all, and to the glory and honour of Odd-Fellowship generally.

One of the most interesting, and at the same time beneficial laws, (especially to those more immediately concerned) carried into effect during the Session, was the consolidation of the Grand Lodges and Encampments of Northern and Southern New York, which had been separated for a period of more than fifteen years, causing to each jurisdiction a great deal of difficulty and annoyance during that time. The Legislative Committee, to whom the matter was submitted for consideration, submitted a report that the two Grand Bodies be united and consolidated; and they also reported a resolution to satisfy and confirm the enactment of those two Bodies to carry the union into effect, and directing that the Grand Sire issue a proclamation that such takes force from and after Tuesday following the third Monday in August, 1866. With the exception of one of the Representatives from the Southern Jurisdiction of New York voting in the negative, the above report was carried unanimously; as all the Officers and Representatives were too glad of the opportunity to have all differences existing in their Jurisdictions forever buried. Immediately on the Grand Sire declaring the resolution carried, a scene was enacted on the floor of the Grand Lodge, which will not be easily forgotten by those who had the pleasure of witnessing the proceedings. The Representatives from each district of Northern and Southern New York, arose and grasping each other by the hand, shook hands and embraced each other for several minutes, amid the greatest applause from those assembled.

Several resolutions of thanks were submitted to the Grand Lodge and each adopted unanimously, (for brevity sake I enumerate the parties without going fully into the resolutions) viz: to the Corporate authorities of Baltimore for a splendid banquet given by them in Druid Hill Park; To the merchants and business men of Baltimore for a similar extertainment in the new Assembly Rooms; to Mr. John T. Ford for an invitation to performances in his Theatre; to Artemus Ward, entertainment at the Concordia House; to Messrs. Porter & Dudley for the privilege of the Merchants' Exchange and News Room; to Henry Tyson, Esq., President of the City Railway Co., for tickets for the use of the members of the Grand Lodge; to the Trustees of the Peabody Institute; to the Superintendent of the House of Refuge; to the gentlemen of the State Tobacco Warehouse; to Messrs. G. W. Gail & Ax, and to all others whose desire to render the visit of the Grand Representatives pleasant and profitable, was manifested by invitations to visit institutions and to inspect objects of general interest.

In addition to the above, Rep. Stuart of the District of Columbia moved the following resolutions, which were adopted unanimously.

Resolved,— That the thanks of the R. W. Grand Body be and the same are hereby tendered to the R. W. Grand Lodge, and the R. W. Grand Eu-

campment of Maryland for the excellent collation furnished the members of this Grand Lodge during the present Session.

Resolved further,—That this R. W. Grand Body desires to express and does express its full appreciation of the consideration of fraternal kindness of our Maryland Brethren in their oft repeated and continual efforts to tcontribute to the pleasures and comforts of its members, while attending he annual Session in the hospitable "City of Monuments."

Officers and Brethren, my predecessors have heretofore reported to you of the magnaminous, generous, and fraternal kindness extended to them by the Brethren generally on their attending the different Sessions of the R. W. Grand Lodge of the United States. I have only to add that nothing could exceed the open hearted, courteous, friendly and brotherly manner in which I was received by the Officers and members, and not only by them but by all the Brothers and friends with whom I had the pleasure of meeting. All seemed to vie with each other as to who would do the most to make Canada, as they called me, feel at home and happy.

In drawing to a close, I beg hereby to tender my most grateful and and heartfeit thanks for the kindness evinced to me at all times by the Officers and members of this Grand Lodge; and also for the trust at present reposed in me. Hoping that our present Session may be one fraught with much good and that our deliberations may be the means of spreading the glorious and noble cause of Friendship, Love and Truth.

Your Committee, appointed to revise and correct the minutes of last session, as printed, submit the following:—

We find, on examination, many errors of minor import, but propose to

call attention to only a few of the most important.

On page 325—Report of Committee on State of the Order—answer "1" refers, we suppose, to question from Eureka Ladge on page 326. Answer (2) given, but the question does not appear. Answers (3) and (4) in same report evidently refer to questions on page 326 by Rep. Glover.

We also find a series of resolutions marked 1, 2, 3, 4, 5 and 6, commencing on page 325, which it seems to us can only refer to a Report of the same Committee on page 331. But a difficulty arises here, because two sets of resolutions will then appear on adoption of the same report, and somewhat conflicting. For instance, resolution (D) in the one set as printed is adopted, and in the other it is lost. On reference to the manuscript, we find that resolution (D) of this Committee on Grand Master's Report was lost. The fifth resolution, referring to clause 'E' of the same report is carried, according to the minutes as printed. The recollection of those members of this Committee who were present last session is positive that the fifth resolution of clause "B" was lost.

On reference to the Digest, page 69, clause "11, we find the decision of the Grand Master and the approval of that Committee as expressed in said clause and resolutions, are in direct conflict with the law, which more fully confirms the opinion of this Committee that the minutes are wrong

in this respect.

On page 335 in a Supplementary Report from the G. Secretary on Monument Fund, he reports \$6 balance due that Fund, whereas a careful examination of his main Report will show a balance of \$9.45 due from this Grand Lodge to the said fund at that time.

In conclusion, we respectfully submit the following .-

The undersigned Committee, appointed at the last Session of this Grand Lodge, held at the City of Hamilton, for the purpose of preparing and submitting to this Grand Lodge such legislation as in their judgment was necessary, to prevent the illegal distribution of the funds, regalia, furniture, or other property of Subordinate Lodges which had ceased to work, by the members of such Lodges submit.

Your Committee report that the amendments introduced by the Grand Lodge of the United States at their last Session, into the obligation to candidates for membership, and to the Officers and Subordinates at installation, covers the whole ground contemplated in the appointing of your Committee.

Your Committee would ask leave to introduce the following resolution, viz:-

That on any Subordinate Lodge in this Jurisdiction ceasing to work, any of its Officers or members illegally taking part in the distribution of any monies or property of whatsoever kind, belonging to said Lodge, or, not using all due diligence in preserving said property or monies and having the same sent to the Officers of this Grand Lodge, shall upon being found guilty of so doing, be expelled from the Order and published as such in every working Lodge in this Jurisdiction.

Resolved.—That whenever a Lodge in this Jurisdiction surrenders its Charter and other effects, that if there are any monies surrendered at the same time, that such money shall be kept as a separate trust for any number of the Brothers of said Lodge (five or more) who were in good standing at the time of the surrender of said Charter and effects, and may be paid over to the Lodge in this Jurisdiction; or such part or parts of said money (on resolution submitted to this Grand Lodge and carried,) to assist said Brothers in defraying the expense of again gaining active membership.

EULOGY BY REPRESENTATIVE BRO. WM. MOWAT OF AVON LODGE, No. 41, I. O. O. F.

MOST WORTHY GRAND MASTER, -- I learn from the very able address which you presented to this Grand Lodge, that it is the duty of the Repre sentatives of the districts of deceased members of this Grand Lodge to make a suitable eulogy on the character of deceased members. I regret, therefore, that it devolves upon me, as the Representative of Avon Lodge No. 41, I. O. O. F., to have to refer to the decease of our late Brother, Henry Sewell, who was a distinguished member of this Grand Lodge for many years past, and also an active and useful member of Avon Lodge. My regret is two fold in its character-first, that this Grand Lodge has lost one of its brightest ornaments-and second, that it has not been the lot of one more competent than I am, to do that justice to the memory of our deceased Brother which duty demands. Imbued with one of the kindest hearts, with an ardent and sincere temperment, with a disposition leading almost to an extreme in the dispensing of his Charity, and in the manifesting of the reciprocal duties of friendship Brother Sewell las left few equals, and I venture to say, no one more heartily devoted to the true legitimate interests of our Order. Having enjoyed a close intimacy with him for some 8 or 9 years I speak that which I know, and testify to that which I have seen, when I state that a more warm hearted friend of the cause has not been left in our ranks, for under whatever reverses, his zealous exertions to promote the welfare of our Order never once flagged. But it is not so much in this Grand Lodge as in the Subordinate Lodge to which he was attached, that his ever cheerful countenance will be most missed, for seldom indeed was there ever a meeting but he was there, however pressing his other engagements. But besides being an ardent friend of our Order he occupied several prominent and responsi ble positions in his lifetime. He took an important interess in fostering the Volunteer movement of our young country, and held the position of Ensign in the Stratford Infantry Company and I need not say that had he been spared in life he would gladly and cheerfully have responded to his country's call, to assist in rolling back the tide of invasion which

EULOGY ON THE DEATH OF PAST GRAND MASTER, CHAUNCEY YALE, PRESENTED BY P. GRAND MASTER, S. G. DOLSON, REP. UNION LODGE, NO. 16.

To the R. W. Grand Master, Officers and Representatives:—Death, relentless and inexorable, has made mournful breaches in our fraternal circle, during the past year, and forcibly reminds us that no manly virtues, no endearing and social qualities, no uprightness of character, can shield us from his unerrung shafts.

Brethren,—Let us pause a moment in our deliberations, and do honor to one who, when living, was ever ready to give a helping hand to the cause of Odd Fellowship.

Past Grand Master Chauncey Yale, so long and tavorably known to many of you is gone, he has been gathered to his fathers, his seat is now vacant, his voice is lost, his earnest pleadings is no longer heard, his silent vote is no longer to be seen upon our weekly records, his regalia is laid aside, like a cast off garment, and nothing remains but the treasured re collections of associations and intercourse, many of us have engaged with him, into his gravelet us deposit this covenant emblem, sweet memory. May his rest be that of the just, and his awakening be among those who shall be received by the Father of us all, into that Grand Lodge above, where meetings never end, and where the sublime principles of our order are fully recognized and approved.

Our departed betther was a good and tried Odd Fellow, the great interest he always took in the order procured for him the confidence of his brethren and elevated him to the highest position in our gift to bestow. He not only held the position of Grand Master of the Grand Ledge, but represented us in the Grand Lodge of the United States during the same time. He had the honor of being the second Grand Master in our jurisdiction, and was installed into his office by our departed and much esteemed brother, P. G. Master, Thomas Reynolds of Brockville, eight years ago, in this beautiful town, and in the presence of many familiar faces, I see assembled here again to day. How little we know whose turn may come next. Brethern, let us live, that when death closes up this earthly scene, we may be prepared to meet those worthy brothers who have gone be-
