Synod of Hamilton and London

—OF THE—

Presbyterian Church of Canada.

Synod met. At Brantford and within the First Presbyterian Church, the twenty-fourth day of April, one thousand eight hundred and ninety-nine years, at half past seven o'clock p. m., which day and place the Synod of Hamilton and London of the Presbyterian Church in Canada

Constituted. met according to adjournment, and, after devotional exercises and sermon by the retiring Moderator, Rev. F. McCuaig, of Welland, from Luke 24th Chapter and 44th verse, was duly constituted with prayer. The Moderator then stated that shortly after the death of the late Clerk he had requested Dr. Laing to fill the vacant office as "Acting Clerk" and prepare the business for the Synod. This Dr. Laing had done, and he with the approval of the Synod asked the the Clerk to call the roll. This was done and the attendance marked; and after a few changes had been made at the request of parties concerned, and by permission of Synod, the roll was adopted. The Synod desires to put on record its sense of the great loss which it has sustained since its last meeting in the removal by death of our venerable and venerated brother, Dr. Cochrane, whose works of faith and love in the Church have been so abundant and so varied.

Ever since the formation of this Synod, at the time of the Union of the Churches, Dr. Cochrane has performed the duties of Clerk, extending over a period of twenty-four years, and during all this time he commended himself to the most exacting judgment of the brethren, and was among them all "a brother beloved."

Further, this Synod hereby expresses its appreciation of the great and unceasing services which Dr. Cochrane was enabled to render the whole Church of which for thirty-six years he was a cherished member, and a most faithful Minister of the Gospel, and one who endeared himself, not only to his own ever increasing flock, who now fondly cherish his memory, but to the church at large which he served so long and faithfully.

Our departed brother had many and rare gifts which fitted him for a many-sided service in the Gospel ministry, and all of which he used without stint and to the utmost of human possibility. His influence has been felt in every department of the Church work and throughout the bounds of the Dominion. He has put the whole church under a debt of gratitude to the

Master who gave us His servant to labor so faithfully in his vineyard.

The Synod would make special mention of his invaluable services in connection with our Home Mission work, of whose committee he was the trusted Convener for 27 years. Here he showed a devotion seldom known among men, for his interest instead of flagging, grew in intensity with the growth of years.

His brotherly disposition and genial manner—so free and lively and unrestrained—endeared him to all to whom he ever stood in any relation.

We thank God for the distinguished place He was pleased to give our brother in the church, the rare endowments with which he was blessed, which made him a guide and a leader in our Church Courts, and one who helped to shape her policy.

We feel that our brother has left us who yet serve in the ministry a singularly noble example of devotion to duty, of untiring industry, of loyalty to the church of which he was an ornament, as well as his deep and abiding interest in those other questions that concern the welfare of our country and in all the institutions of our land that have for their object the welfare of our fellow men. As a citizen and a patriot no less than as a churchman we may well copy his life. We pray for a baptism into his spirit of self forgetful devotion and zeal in all noble works, and for efficiency in the Gospel Ministry, and that the Lord of the Vineyard may raise up other laborers into the harvest.

SIXTH SEDERUNT.

Constituted.

At Brantford, and within the First Presbyterian Church there, this twenty-sixth day of April, one thousand, eight hundred and ninety-nine years, at 2 p. m., the Synod of Hamilton and London met according to adjournment and was constituted, Mr. Haddow at the request of the Moderator leading in prayer.

Minutes read.

The minutes of the previous sederunt were read and sustained.

Church Life and Work.

The Synod resumed consideration of the recommendations in the report on Church Life and Work. After making certain changes, the recommendations as amended were adopted as a whole, on motion of Mr.

Recommendations adopted.

Drummond, seconded by Dr. Johnston. The recommendations are—

1.—That this Synod having heard of the large measure of success attending the various departments of church life and work in the congregations within her bounds during the past year, expresses her profound gratitude and thanksgiving to God; heartily commends the spirit of willing service that has moved so many of her people to give of their time and money; and earnestly prays that, guided by God's Holy Spirit into all truth, she may so read and understand the signs of the times and may so initiate and carry forward methods of work as will hasten the coming of her Master's Kingdom.

2.—That inasmuch as the answers received by the Presbyteries' Conveners indicate that the replies to Assembly's questions have been prepared by one or two individuals, frequently by the Minister alone, the Synod would suggest that the questions be answered in a full meeting of the Session and that the answers be afterward read at a meeting of the congregation,

3.—Remembering the Sacred and All-powerful in-

fluence of home and early religious instruction and noting with apprehension the grave danger to which our present industrial, social, educational and ecclesiastical conditions expose us, this Synod urges that continued and increased diligence be exercised by Ministers, Elders and heads of families in enlarging and deepening the spirituality of the family religious life, giving special prominence whenever occasion offers to the beauty and blessing of the family altar.

4—Believing that a day of weekly rest and opportunity of public worship is a possession of priceless value to the sons of toil and all others, especially in our busy age, this Synod exhorts all, to whom its words come with any degree of authority, to heartily support by vote and the influence of precept and example, all efforts at guarding the sanctity of our Sabbath, and preserving it for the future, free from the inroads of unnecessary labor, pleasure-seeking and gain.

5—In view of the fact that all men are only Stewards of what God has given them power to acquire, and of the further fact that, even though the sense of stewardship is growing and with it systematic and increased giving for God's cause, open doors at home and abroad are inviting the Church into which she cannot enter because she has no funds; in view of the uniform testimony of the reports that worldliness is the great hindrance to our Church life and work, this Synod would press upon the anxious and prayerful consideration of all members and adherents within her bounds these facts; would urge Sessions and Teachers in our Sunday School to lay upon the intelligence and conscience of those in their charge their opportunity and obligations in the use of God's gifts; and upon all who have charge of the financial affairs of our congregations diligent use of such literature and methods as may tend to develop an intelligent, sympathetic and practical interest in all Christian work.

6—This Synod heartily commends the Press for her generous help in publishing Church news, reports of sermons, and communications on moral and religious questions, and expresses the hope that the day may be far distant when for any cause our Canadian press will pander to the unhealthy craving for the sensational, the brutal and the scandalous.

7—We note with great hopefulness the admitted

decrease in intemperance, and inasmuch as our country has voiced its opinion by the plebiscite, and the Government has given its answer thereto, we would urge upon our people a more hearty and active enforcement of the laws already upon our statute books; the practice of total abstinence on Scriptural, philanthropic, moral and scientific grounds, an honest and unpartizan exercise of the franchise on the true line of advance if we are ever to secure the legal prohibition of a traffic that is inimical to social well-being and contrary to the Spirit of the Gospel of Jesus Christ our Lord.

Report to be printed.

It was agreed on motion of Dr. Johnston, seconded by Dr. Hamilton, that the report on Church Life and Work be printed and sent out with the Minutes of Synod. Also that ministers be urged to bring the important matters contained in the report before their congregations. On motion a vote of thanks was tendered Mr. Drummond for his most excellent report.



Report of Committee

on

Church Life and Work

1898.

At Brantford and within the First Presbyterian Church this twenty-sixth day of April, eighteen hundred and ninety nine, the Synod of Hamilton and London met and was constituted.

Inter Alia.—Mr. D. R. Drummond presented the report on Church Life and Work. The report was, on motion, received and its recommendations considered. After making certain changes, the recommendations as amended were adopted. It was agreed, on motion of Dr. Johnston, seconded by Dr. Hamilton, that the report on Church Life and Work be printed and sent out with the minutes of Synod ; also that ministers be urged to bring the important matters contained in the report before their congregations.

To the Reverend, the Synod of Hamilton and London,

MR. MODERATOR, FATHERS AND BRETHREN :

TEXT.—I Tim. 6 : 10. "The love of money is a root of all kinds of evil."

Your Committee desire to report as follows : Carefully prepared reports have been received from the various conveners on Church Life and Work in every Presbytery within our bounds. We wish (1) to present you with two or three general considerations ; (2) to seek to justify the choice of our text as indicating the point of weakness and of special danger, but also of splendid opportunity in our church life and work.

I. (CONDENSED).

(a) Abundant reasons for thanksgiving to God for many blessings.

(b) The General Assembly's Committee ask questions dealing with, (1) The Home ; (2) The Congregation ; (3) The Sabbath ; (4) Social Questions.

Summarizing the replies it would seem that as regards (1) The Home Religious Life. While the majority refuse to admit decline family worship is at the best irregular and by no means universal, and the teaching of the children is too much delegated to Sunday School and strangers.

(2) The Congregation. Sabbath and communion services are well attended but prayer meetings are very slimly attended ; workers can be readily secured ; giving for the Schemes is not yet up to the mark ; Presbyterians take high rank for integrity in business, and good behaviour in social relationship.

(3) The Sabbath. Well kept but with a tendency decidedly strong against its reverent observance, owing to the bicycle, the love of pleasure and the hope of gain.

(4) Social Questions. We rejoice in a clean, high-toned press, in the main on the side of morality and religion, but with a tendency, for money's sake, to the sensational and culpably prying. The

amusements of the people we leave strictly alone, trusting to the educated conscience of our people, as we ought, to guide them as to the influence for good or evil which their example will exert, and the indulgence which is therefore legitimate.

It is cheering to know that everywhere intemperance is decreasing. In one village a former bar is now a circulating library. And yet when one remembers that there is probably not a single congregation within our bounds in which the sin of intemperance is not a decided hindrance to Christian work ; that there is far more than one session of which the same is true ; that church members on every hand are giving money over the bar for drink, which our reports show is needed to carry forward our mission work at home, or to evangelize the heathen abroad, surely there comes a loud call for sustained, vigorous fight until this giant evil is cast out—root and branch.

(c) But in the midst of hopefulness and just thankfulness for large success from end to end of the Synod, if you listen attentively you hear an undertone of dissatisfaction and apprehension. In an attempted interpreting of this the balance of our report will consist.

II.

We wish to approach by the following consideration :

The Presbyteries of Huron, Bruce, Maitland and Stratford, chiefly rural, present the most cheering report of progress and satisfactory condition, and evidence their truth by their good works. Every congregation in Huron had enough interest in church life and work to send in a report : every congregation but one in Maitland.

But as we come further south and east, into the district in which our larger towns and cities with their competition and strain are to be found, through which our busier railroads pass, and upon which a greater influence is exerted from across the Line in these we find a less general response, 8 or 10 or 12 congregations in a Presbytery not reporting. At the same time a less hopeful note is struck and a greater apprehension is manifest as to the satisfactoriness of conditions prevailing.

The longer your Committee pondered the replies sent in and the facts thus brought to light the more convinced were they that our text for to-day, "The love of money is a root of all kinds of evil,"

indicates the point of weakness and of special danger, but also points the direction of great possibility for church life and work in our Synod. Let us illustrate our thoughts by reference to the four main divisions of our Church Life and Work questions.

(a) THE HOME.

While a number very justly lay the blame as a hindrance to family religious life upon mid-week meetings in church and other societies, and another suggests that at least three nights a week should be spent at home, the great majority find the chief difficulty in the competition and struggle of life for money.

The percentage of rural population to city population is greatly diminishing, and even in rural districts conditions are so changed that the old customs are not so easily followed. The increased stock-feeding and the growth of dairying, necessitating early morning work to catch morning trains for the cities, or the preparing for cheese or butter factory nearer home, make imperative demands upon the morning hours just when a family might gather for worship.

A growing percentage of our people find employment on the rail; come and go at all hours of day and night, Sunday or Saturday, and all that breaks in upon the family worship and religious training, while the employees in machine and other shops are up and away in the morning too early, in many cases, for the family to gather.

Thus at both ends of the day, by reason of new industrial and social conditions, families see less of each other and have less opportunity *in the old way* for the development of the family religious life. We must devise methods and lay it upon the conscience of our people to regulate family life to meet the new industrial and other conditions. Why *e. g.* should not many a family have family worship at noon when the children are home from school, the parents from work, and thus together acknowledge the giver of life's blessings and of all true family joys?

By use of prepared prayers for family worship (the publishing of such a book by the church deserving great consideration—a copy of which, one session suggests, might be given to newly married couples); by placing in every family the *Children's Quarterly* to supply daily readings and cement the older and younger members

of the congregation more fully ; by every possible means let us aid parents in their duty. If we can convince our people that our age makes severer demands upon high manhood and womanhood than any age that has past and that these things that make family worship in the old way difficult, are the very best proof of the need of family religious life, we will develop in them a desire for it. When once there is a will in every home there will be found a way and time.

We are not implying at all that it is not a Christian thing for the heads of families to be up and away to the shop or by rail and thus miss meeting the other members of the family or be otherwise active, late and early, to succeed in life's legitimate labor. We are merely wishing to point the fact which we believe cannot be successfully denied, that our great danger lies in this direction, and that the love of money—money that we must have and that it is right we should have if we use it right—may unconsciously and insidiously be *the* root as well as *a* root of all manner of evil to our home religious life.

(b) THE CONGREGATION.

Sabbath services, when people have nothing else to do, are well up to the mark ; but stock-feeding, railroad and other work begins, to tell in some quarters. But for mid-week meetings we have another tale. The great percentage of our members do not take the prayer-meeting seriously, and back of all reasons we believe that it will be found that it is not time that is wanting ; that it is not the quality of the meetings—the most regular goers are most ready to acknowledge blessing received, it is the pre-occupation of the life by the things of the world—things that may be right in themselves but which, receiving undue space in the life, become roots of all kinds of evil.

It is in another direction, however, that we wish to show the bearing of our text, viz : The givings of the people.

It is quite gratifying to believe that Presbyterians, "God's silly sheep," lead all Canadian churches in their giving, both as to its readiness, amount and spirit ; but none the less, the judgment of our sessions as a whole is that we have not yet attained the necessary liberality.

It is probable that the day of the old style evangelism is gone, and that the next great revival, for lack of which

the Christian church is losing ground with God and men, will be along the line of converted pocket-books, bringing forth fit works in a missionary Christian socialism. Many a Christian is throttling to death his new-born life by too tightly drawn purse-strings. One report says with too much truth, "Christians refuse to take risks on God's promises."

In spite of all the methods followed, envelopes, weekly, monthly, quarterly ; half-yearly and yearly offerings, supplemented by young people as collectors, old people, or even the minister as collectors, and all manner of devices it is evident that the information and organization have not yet resulted in the much-needed consecration of our people's wealth.

Men are offering to go abroad and the church cannot send them. Fields are crying out for men at home and the church cannot send them. Our committees cut and carve to make ends meet, and all the time the church has in the hands of professing Christians enough and to spare would they but put it out to the service of Jesus Christ.

Men can expend on social functions and political excitement, and out-rivalling of neighbors in coat or carriage or calves, sums that if given under their name or through their congregations for the Schemes the church would so electrify their fellow-members and point the standard of duty that hundreds and thousands of dollars more would come in.

And, again, we are not implying that these social functions and expenditures are wrong. If they were Christ would never have sat at the feast in Simon's house and have defended the wasteful woman who poured out her costly nard with wanton hand. But this we do imply, and pray that the church in all her membership may soon come to believe that if professing Christians spend all or even the greater portion of their gifts in these selfish ways they are untrue to the Spirit of the Lord who bought them by the pouring out of His life, and said to the disciples, "as the Father has sent Me into the world even so have I sent you. Herein is My Father glorified that ye bear much fruit, so shall ye be My disciples."

It is worthy of the church's serious thought that the only miracle of cursing our Lord ever performed was in withering a fruitless fig tree, not because it produced poisonous, dangerous fruit, but because

its show of leaves—its profession of worth—was not backed up by corresponding fruit.

Brethren, there is not a Presbytery; there are only a few congregations in all our bounds, in which these reports do not prove that we have not imbibed and imparted such a controlling sense of stewardship as will lay upon the altar all needed monies. The love of money *overcome* would offer our church her grandest possibility.

Your Committee would humbly suggest that the time has come when our theological colleges should have at least this much of a course in Applied Christianity that some level-headed, practical, consecrated business man, lay or clerical, should give a short course of lectures on the Christian meaning and purpose and use of money or other possession; the Schemes of our church, their number, origin, purpose and accomplishment; the missionary activity at home and abroad; how much money we expend; how and at what cost; so that when our young men go out into harness they may know whereof they speak and may have a sympathy for our church's work as distinguished from merely parish congregational effort.

Failing such a course some, if not all the young men, and old, would do well either before or after, preferably before, advocating the Schemes or other money matters to consult with some sympathetic but shrewd Christian business man who, with his hard-headedness and good sense, will point out the weakness or sentimentality or worse of our attempts in finance, and thus give to our utterance both sound and sense.

The Presbytery of London has commenced a campaign of education on Bible giving. A committee drafted a statement which was discussed in Presbytery very fully before reaching final form. This is being published in pamphlet form under the direction of the Convener, Rev. Alex. Henderson of Appin, for distribution among all families of the Presbytery.

There is practically but one answer from all our congregations as to the great hindering cause to Christian work: Worldliness, worldliness, worldliness; the love of money in converted men and women; and conversely we may hold that if, as a church, we were delivered from this sin of sins, gracious quickening everywhere would come and blessing descend upon our labor.

(c) THE SABBATH.

The same thought reasserts itself in connection with Sabbath Observance. The value of a quiet Sabbath in making church attendance possible and removing a depressing, benumbing atmosphere only those rightly appreciate who are deprived of it. How the whole tone of spiritual life in the home and congregation and world is lowered when every day is alike, and work and toil and the annoying things keep us from the house or worship of God.

Fortunately we in our Province do not suffer as some do, but love of money in those who cater to the love of pleasure in others; love of money in large corporations is taking from not a few their day of rest, and is dulling the public conscience about a matter of supremest moment to individual character, church activity and national well being.

Eternal vigilance is the price of liberty. We cannot give this matter too early or too earnest heed. We cannot show too much sympathy with the Lord's Day Alliance. By denying ourselves our rights, e.g. chaining up some "bikes"; by standing firm for the rights of others whose injustice ^{in order to} ~~may~~ minister to our selfishness (e.g. employees of railroads, etc.); ^{household servants} ~~keeping~~ before our people and the public the necessity of rest and of worship in the laws underlying our physical, mental and spiritual nature, especially in these days of rush and strain, we may curb a little the fearful and ever active strength of the commercial spirit of our commercial age, and keep for our country and people its richest possession—one day in seven in which not to forget the responsibilities and duties of our common days but to learn their deeper significance and revive the strength in which to face them worthily and well.

(d) SOCIAL QUESTIONS.

Under the fourth head nothing need be said more than to emphasize the same thought. If we had in our hotels men who wished to minister merely to a legitimate social instinct and would therefore refuse to sell to the incapable and underserving; if the love of money did not determine the whole affair, we might rest easy about the whole temperance question. But when we know that to most in the business love of money is more than love of souls, sense of honesty, comfort of homes or rights of helpless wives and

children, we must arm ourselves for a continued, long, hard fight till this giant evil is worsted and cast out.

So of the press and reading of the people. Papers and books are primarily business enterprises. As a printer said to me talking on this very matter the other day: "We must make the business pay or burst." Sensational things sell; details of horrible murders; prize fights; the sewer sides of private and public life sell because the people, including church members, buy and buy greedily and read. These buyers are the ultimate cause of the success of such stuff in the press. None the less the press and caterers to amusements are largely responsible for discovering and revealing to the people their own bad taste and yielding to its evil demands.

We are not condemning the press more than its best friends condemn it. In the main it is pure, high-toned, and its columns open to church notices, sermons, letters on religious and moral questions. We are merely noting the point of dangerous temptation against which we need to educate our people and against which Christian editors and newspaper men need to set their faces like a flint.

RECOMMENDATIONS.

Your Committee desire to present the following recommendations:

1. That this Synod, having heard of the large measure of success attending the various departments of Church Life and Work in the congregations within her bounds during the past year, expresses her profound gratitude and thanksgiving to God; heartily commends the spirit of willing service that has moved so many of her people to give of their time and money, and earnestly prays that, guided by God's Holy Spirit into all the truth, she may so read and understand the signs of the time and may adopt such methods of work as will hasten the coming of the Master's Kingdom.
2. That inasmuch as the answers received by the Presbyteries, conveners and transmitted to this committee indicate that the replies to the Assembly's questions have been prepared by one or two individuals, frequently by the minister alone, this Synod would suggest that the questions be answered in a full meeting of the Session, and be afterward read at a meeting of the congregation.

3. Remembering the sacred and all-powerful influence of home and early religious instruction and noting with apprehension the grave dangers to stated family worship and religious instruction in the home, to which our present educational, industrial, social and ecclesiastical conditions expose us, this Synod urges that continued and increased diligence be exercised by ministers, elders and heads of families in enlarging and deepening the spirituality of the family life of the people giving special prominence, as occasion offers, to the beauty and blessing of the family altar.

4. Believing that a day of weekly rest and opportunity of public worship is a possession of priceless value to the sons of toil and all others, especially in our busy age, this Synod exhorts all to whom its words come with any degree of authority, to heartily support by vote and the influence of precept and example all efforts at safeguarding its sanctity and preserving it for the future free from the inroads of unnecessary labor, pleasure seeking and gain.

5. In view of the fact that all men are only stewards of what God has given them power to acquire, and of the further fact that, even though the sense of stewardship is growing and with it, systematic and increased giving for God's cause, open doors at home and abroad are inviting the church into which she cannot enter because she has no funds ; in view of the uniform testimony of these reports that worldliness is the great hindrance to Christian work, this Synod would press upon the anxious and prayerful consideration of all members and adherents within her bounds, these facts : would urge sessions and teachers of Sunday Schools to lay upon the intelligence and conscience of those in their charge their opportunity and obligations in the use of God's gifts ; and upon all who have charge of the financial affairs, diligent use of such literature and methods as may tend to develop an intelligent, sympathetic and practical interest in all Christian work.

6.
