An Act to amend the Act for incorporating certain Charitable, Philanthropic and Provident Associations.

**W**HESEAS by the Act 13 and 14 Vict., cap. 32, intituled *An Act for incorporating certain Charitable, Philanthropic and Provident Associations, and for the effectual protection from fraud and misappropriation of the funds of the same*, no provision or requirement is made for an instrument of incorporation of the several societies or associations contemplated by the said Act, or for the publication of the By-laws governing the same; Therefore Her Majesty, &c., enacts as follows:

I. In order to the incorporation of any such society, after the passing of this Act, it shall be lawful and necessary for not less than ten of the persons composing the said society, to subscribe the instrument of association, in which shall be set forth the object and purposes of the said society, and the name or title by which the same shall be known; and the said instrument shall be filed in the Office of the Registrar of Deeds of the County or Registration Division in which the said society is formed and maintained, and a fee of *twenty-five cents* shall be paid for the filing thereof.

II. By-laws, rules and regulations for the government of the said societies or associations, not repugnant to the laws of this Province, nor for the furtherance of any political or seditious purpose, shall be made and passed by every such society, and a copy thereof, and of all alterations and amendments that may from time to time be made to the same, shall be filed in such Registry Office as aforesaid, on payment of a like fee of *twenty-five cents*, before the same shall be valid or take effect; and if such By-laws are not so made and filed, within *three* months after the subscribing of the instrument of association, the corporation shall *ipso facto* be dissolved.
