**AMENDMENTS TO THE CONSTITUTION  
PASSED BY THE ANNUAL MEETING  
(CALGARY, 1920)**

That whereas every Chapter must be considered **Vote** to be present at an Annual Meeting in the person of the representative:

Be it resolved, that the vote on all notices of motion, amendments and resolutions, must be the registered votes of delegates and the vote on emergency resolutions only be an individual vote.

Whereas, all correspondence, reports and **Filing of Documents** documents received by the National Executive are the joint property of the Order and are placed in custody of the members of the National Executive as trustees:

Be it resolved, that all such correspondence, **Filing of Legal Opinions** documents, and reports, be placed on file and be accessible to all members of the National Executive during office hours to inspect or make copies therefrom or to order such copies to be made by any responsible deputy, if unable to attend in person, and that all legal opinions upon which the National Executive bases rulings or actions, must be brought to the National Executive in writing and signed by such legal advisers, and placed upon the file, as the justification of such rulings or actions taken by the National Executive, and as a guide to those who may follow the present incumbents in that office.

**Special Meeting**

Whereas the calling of frequent meetings of short session involves great expenditure of time, energy and money to Councillors living at a distance who wish to attend:

Be it resolved, that all Regular Monthly Meetings be adjourned from day to day until all business is completed, and that any meeting called between the regular Monthly Meetings must state on the notice the purpose for which such Special Meeting is called, and that such meeting be competent to consider only such special business as indicated upon the notice:

**Order of Procedure**

Be it resolved, that in all matters of procedure the Order should acknowledge and be governed by the rules laid down in Bourinot, which is the recognized authority for all organizations, societies and orders in Canada.

**Confirmation of Minutes of Annual Meetings**

Be it resolved, that at the National Annual Meeting the Minutes of each preceding day be submitted for correction and confirmation, either at the close of the day's session, or at the opening session of the following day, and that the form of these Minutes be confined strictly to that laid down for Minutes as is customary in other organizations.

**Credentials Committee**

That a Credentials Committee, to take charge of receiving the credentials of delegates at each Annual Meeting, be formed, composed of the National Secretary and National Treasurer, and one member from each Province, to be elected, by

such Province (and in the unorganized Provinces under the system recently adopted by the National Executive, to elect members for the Committee on the Constitution).

That the list of those Chapters entitled to vote, with the number of votes in each Province, be handed by the National Treasurer to the respective members for the Provinces, on the Committee, who shall receive the Credentials of the delegates from their own Provinces.

That this Credentials Committee shall post up for the information of the Meeting from time to time the following:—

1. The number of votes pollable,
2. The Chapters represented,
3. By whom the Chapters are represented,
4. The number of votes carried by each delegate and in what capacity,
5. Any further information which the meeting may require.

#### ARTICLE II.—Sec. 4.

In Article 2, Section 4 (see Page 4) of the Constitution, the words, "to promote in the Motherland and in the Colonies the study of the history of the Empire, and of current Imperial Questions," be

changed to read, "to promote throughout the Empire the study of its history and of current Imperial Questions," thus eliminating the word "Colonies" which is objectionable to a great many Canadians.

That Section 5 of Article 4 (see Page 7) be entirely eliminated, individual members not being necessary at any annual meeting, due representation having been given all Chapters.

It was decided that this measure should not be retroactive—present individual members remaining in the Order.

## ARTICLE VI.—Sec. 12.

The Officers of the Chapter shall be elected by ballot at the Annual Meeting, by the members comprising the Chapter for the coming year; such election to take place immediately before the adjournment of the meeting. Retiring Officers of Primary Chapters, who have not been re-elected, are not entitled to vote at such election; a newly-elected Regent, or in her absence a Vice-Regent, may pass the vote of a Chapter. If the Regent or Vice-Regent are not present, the vote of the Chapter may be passed by a representative who is a member of such Primary Chapter and is duly appointed in writing, identified by the signature of the Regent, Vice-Regent or Secretary of the Chapter appointing her.
