An Act respecting *La Banque Jacques Cartier*, and
to change its name to *La Banque Provinciale du
Canada*.

WHEREAS *La Banque Jacques Cartier* has, by its petition, Preamble.
prayed that it be enacted as hereinafter set forth, and it
is expedient to grant the prayer of the said petition: Therefore
Her Majesty, by and with the advice and consent of the
5 Senate and House of Commons of Canada, enacts as follows:—

1. *La Banque Jacques Cartier* may, by by-law, after the Treasury Board has issued a certificate approving of the increase of the capital stock of the said bank to the sum of one million dollars, change its name to *La Banque Provinciale du 10 Canada*, but such change in name shall not in any way impair, alter or affect the rights or liabilities of the said bank, nor in any wise affect any suit or proceeding now pending or judgment existing either by, or in favour of, or against the said bank, which, notwithstanding such change in the name of the said 15 bank, may be prosecuted, continued, completed and enforced as if this Act had not been passed.
- Power to change name by by-law.
Existing rights preserved.

2. Such by-law shall have no force or effect until it has been published in *The Canada Gazette*.
