


Reply to Answer of United States of America

In reply to the answer of the United States of America to the claims of His Britannic Majesty's Government on behalf of the Schooners Jessie, Thomas F. Bayard and Pescawha, the allegations set out in the said claims are repeated, and it is submitted:

That the answer of the United States is merely a traverse of the allegations made in the memorial of His Britannic Majesty's Government.

That the statement that the masters of the vessels in question intended to proceed to the Russian Islands for sealing in the month of July, is erroneous. The fact is that the said vessels were, as already alleged, especially fitted out and manned for sea otter hunting, the owners being induced to do so on account of the operations of the two preceding years and the growing success of Japanese hunters on the same and neighbouring hunting grounds.

In this connection, attention is directed to the returns of sea otter captured, killed or taken by Japanese vessels, according to statistics taken from the official records at Tokio, for the years under-mentioned:

The answer of the United States contains an accusation of fraudulent misrepresentation and concealment of material facts. This is denied, as the sources of information on which the facts stated in the memorial were based, were equally open to the United States. Further, it is denied that the masters made any such statement of their intention as alleged in the answer. On the contrary, the fact is, as indicated on oath by the masters, that the vessels were ordered to remain on the otter hunting grounds, where they were molested by the United States Revenue Cutter Bear, until the opening of the sealing season in Behring Sea, or longer if the results of the otter hunting proved favourable. This decision was arrived at on account of the results of the two previous years' hunting by the Casco, Vera,

Jessie and Bayard, and also by the operations of Japanese sealers on our coast. The *Vera*, which took 20 skins in 1907, was owned or chartered by some of the owners of the Jessie, and it was the success of the *Vera* which prompted or indeed the owners of the Jessie to pay especial attention to otter hunting after 1907.

It is admitted that the vessels proceeded to the Russian Islands instead of returning home after the unauthorized and illegal interference with their operations. The masters were placed *in terrorem* by the threat that if found in the vicinity they then were, their vessels would be seized. Therefore, they made the best of the circumstances and crossed the Pacific Ocean. The fact that they may have obtained seal skins out of that venture is no answer to the illegal interference which the masters suffered, and the threats made to them.

It is further submitted, in support of the claim preferred on behalf of the vessels in question herein, that the facts and figures brought forward in the answer are justification enough in themselves of the claim made.

The memorial frankly puts forward the earnings, expenses and profits of the vessels, and it is again submitted that whether the vessels made a profit for the season is no argument in favour of or justification for their being driven away from following a lawful occupation and forced to the alternative of returning to port and lying idle and unprofitable, or taking the risk of crossing the Pacific Ocean to hunt on a foreign shore and in foreign waters.

To put a hypothetical case: Supposing all three vessels, having been interfered with and threatened with seizure if they remained, had been lost with all hands in crossing the Pacific Ocean, would not such a result be reasonably attributable to the unlawful action of the United States officer, acting presumably and to all appearance with the authority of his Government?

Attention is directed to the special agreement in the ship's articles of the three vessels for 1909, dealing with the price to be paid by the owners to the hunters for sea otter skins, as shewing the intentions of the owners in the premises.

His Majesty's Government, therefore, repeats and presses the allegations and claims in the memorial, and denies those in the answer of the United States of America, save insofar as the same confirm or agree with or support those set forth in the memorial.

2. That the said Company has at present a claim pending before the Commissioner appointed to hear and take evidence upon the claims of the pelagic sealers for compensation on account of the stoppage of pelagic sealing in the North Pacific Ocean and Behring Sea.
3. That as such Treasurer, and in support of the claim of the said Company before said Commissioner, I caused to be procured from the official records in Tokio, Japan, the statistics or particulars set forth in the table hereto annexed and marked "A."
4. That I believe the said statistics or particulars to be true and accurate, but I am now engaged in correspondence with ~~new~~ to having an official certificate verifying the said statistics.
5. That I know, from information obtained by me in my capacity as Treasurer of the said Company, that when the Japanese sealers ascertained that British and American vessels were interfered with in hunting, the said Japanese sealers patrolled and hunted the sealing grounds unhampered by any rules, regulations or prohibitions.

And I make this solemn declaration conscientiously believing it to be true and knowing that it is of the same force and effect as if made under oath and by virtue of the Canada Evidence Act.

I, Vietor Jacobson, of the City of Victoria, in the Province of British Columbia, master mariner, do solemnly declare:

1. That I am the owner and master of the British Schooner Eva Marie, registered at the Port of Victoria, British Columbia.
2. That the said schooner is the same vessel as is referred to in the answer of the United States of America to the memorial of His Britannic Majesty's Government in support of the claims of the owners of the British Schooners Jessie, Thomas F. Bayard and Pescawha for compensation for illegal interference with and prevention from pursuing their lawful occupation on the high seas.
3. That my said vessel was also equipped and manned for hunting sea otter in the same way as the said Schooners Jessie, Thomas F. Bayard and Pescawha, and I hunted in company with them until the evening of the day before they were molested by the United States Revenue Officers of the Bear as alleged, when, having caught sight of the United States Revenue Cutter, I decided to leave that vicinity and accordingly put out to sea.
4. My decision to leave was not founded on any idea that I had no right to be where I was, or that I was breaking any law, rule or regulation, international or local, in being there, but with the

knowledge and recollection of the experience which other owners of vessels have had in asserting their legal rights in similar circumstances in the past, considered it would not be advisable to jeopardise my vessel and run the risk of losing my entire season's hunting by remaining and asserting my absolute right to be where I then was.

5. I say then that the only reason why the Revenue Cutter Bear's officers did not board my vessel was because they failed to see me before I left.

6. My Indian hunters reported varying numbers of otter in sight at the time, but for the reasons hereinbefore stated, I deemed it not advisable to continue hunting for them.

And I make this solemn declaration conscientiously believing it to be true and knowing that it is of the same force and effect as if made under oath and by virtue of the Canada Evidence Act.
