The Sheriff shall, immediately upon receipt of his copies, cause one of them to be posted up in a conspicuous place in the Court House; the Clerk of the Peace, upon receipt of his copies, shall cause one of them to be posed in a conspicuous place in his Office; every Public or Separate School Head master or Mistress shall in like manner put up one on the door of the School House; and every Postmaster shall post up one of his copies in his Post Office.
