# Trinity University.

TRINITY University was constituted by a Royal Charter bearing date 15th July, 1852, and was thereby endowed with all such powers of conferring degrees in the various Faculties as are enjoyed by the Universities of Great Britain.

The fundamental object of the University is to supply to the people of the Province an academic education of the highest kind, in which secular instruction shall not be dissociated from religious teaching. The University is under the control of the Church of England, but open to all whodesire to avail themselves of its advantages.

#### GOVERNMENT OF THE UNIVERSITY.

By the provisions of the Royal Charter, the government of the University is vested in the Corporation, which body, by an Act of the Legislature of the Province of Canada (15 Vict. ch. 32), is composed of: 1. The Bishops of the six dioceses into which the original Diocese of Toronto has been divided; 2. The Trustees (three in number); 3. The Council.

The Council is made up of the following classes of members :

#### EX OFFICIO MEMBERS.

The Chancellor and Ex-Chancellors of the University, the Provost, the Dean of Residence of Trinity College, and the Registrar of the University.

#### MEMBERS NOMINATED.

By the Synod of each Diocese of the Province of Ontario, two clergymen and two laymen.

By the Bishops of Toronto, Huron, Ontario, Niagara, and Ottawa, four members each, representing their respective diocesses, or, if the Synod of the Diocesse elects members, then two only shall be nominated by the Bishop.

By each Medical, Musical, or Theological College affiliated with the University, one member.

#### MEMBERS ELECTED.

By the College Committee, one of the Professors.

By the Graduates in Arts and Divinity who are Members of Convocation (see below), eight members, to hold office for four years, two retiring annually.

By the Graduates in Law, two members, to hold office for two years, one retiring annually.

By the Graduates in Medicine who are Members of Convocation, two members, to hold office for two years, one retiring annually.

By the Associate Members of Convocation (see below), two members, to hold office for two years, one retiring annually.

By the whole Corporation, nine members, elected for four years, of whom at least two shall be engaged in educational work in the High School system of the Province.

#### CONVOCATION.

By the provisions of the Royal Charter, and in accordance with the practice of the English Universities, the Convocation of the University consists of (in addition to the Chancellor, the Provost, and Professors of Trinity College), all Graduates in Divinity, Law, or Medicine, and all Graduates in Arts of the standing of M.A., who from the time of their admission to these degrees have paid annually the sum of five dollars fowards the funds of the University.

All degrees must be passed by Convocation before they can be granted by the University, and the Supplicats for each degree must have been previously approved by a Committee of Convocation called the Caput.

Convocation has also been placed by the Corporation in the position of a Standing Committee of that body, so that its members are in this way enabled, through their representatives, to formally lay their resolutions before the governing body of the University. Convocation is represented by fourteen members on the Corporation. (See above.)

An annual meeting for the transaction of business and granting degrees is held every year in Michaelmas Term.

Other meetings for granting degrees are held : for Degrees in Medicine and Dentistry, in May; for Degrees in all Faculties, in October.

Graduates not qualified as above to become members of Convocation, and other friends of the University, may become Associate Members of Convocation by the same annual payment of five dollars. All candidates for associate membership must be approved by the Executive Committee of Convocation.

Associates have the right of speaking, but not of voting, at meetings of Convocation. They also elect annually a member of the Council. (See above.)

Local Associations of Convocation have been formed in the chief centres of Ontario. Members and associates have equal privileges in the government of the Local Associations. Each Local Association elects one member to represent it upon the Executive Committee of Convocation.

There are at present about 250 members and associates of Convocation.

The Chancellor of the University is elected for a period of five years by the members of Convocation in good standing.

The Provost of Trinity College is ex officio Vice-Chancellor of the University.

The Caput consists of the Vice-Chancellor and four members of Convocation, to be elected by Convocation at the annual October meeting for conferring degrees.

The Degrees of the University are open to all persons without any religious test, except in the case of Degrees in Divinity, candidates for which are required to subscribe to a declaration of membership in the Church of England, and to the three Articles of the XXXVIth Canon.

Subjects of Her Majesty are required to make a declaration of allegiance before proceeding to their degrees.

Boards of Study in the different Faculties, consisting of *ex officio* and elected members, advise the Corporation. through the Executive Committee, as to the nomination of Examiners, changes in the Curriculum, etc., in their respective departments.

## fees for Tuition and Board.

Although residence within the College buildings for Students in Arts is not in all cases compulsory, it is strongly recommended. The common Collegiate life, after the pattern of the Colleges of the English Universities, is in itself a training of great importance. A new residence containing two lecture rooms, and accommodation for two Professors and twenty Students, was opened in October, 1894, the accommodation previously existing being found altogether inadequate.

Students in Arts are ordinarily required to reside in College, but those whose parents live in Toronto are exempted from such residence, and the same privilege is granted by the Executive Committee in other cases on sufficient cause being shown. See page 70, second paragraph.

The Tuition Fees are \$50 per annum.

The charge for board of Resident Students in Arts is \$120 per annum, and for Students in Divinity \$90 per annum.

These fees are payable for Arts Students in three instalments, and for Divinity Students in two instalments, terminally, in advance, and on payment being made during the first fortnight of term a discount of 10 per cent. is allowed. The rent of College rooms varies from \$5 to \$18 per term.

The Laboratory Fees are \$2.50 per term for Chemistry, \$1 per term for Physics, \$2 per term for Natural Science Pass Students, and \$3 per term for Natural Science Honour Students.

The Steward's account for fuel and extras averages \$15 per annum. Students have to provide their own bedding, carpets, etc.; the heavy furniture being snpplied by the College. They will also require a cap and gown and a surplice for use in Chapel.

The rooms in College will be assigned to resident Students on the first day of Michaelmas Term, beginning at 9 a.m. Letters received by the 'Dean after September 20th, will be taken into consideration, but it is recommended that Students should be present on October 3rd, to look after their own interests. Each Student will be held responsible for damage done to his rooms; all damage to the College premises other than Students' rooms will be charged to an account and assessed on the Students generally. If, however, any Student who has done such damage reports it to the Bursar it will be charged to him and not to the common account.

The fees for Occasional Students are \$1 per term for each pass lecture per week, and \$2 for each honour lecture per week, the minimum to be \$5 per term, and any Occasional Student taking more than six lectures per week to pay the full tuition fee.

Students on admission to College are required to make a deposit of \$10 with the Bursar, which will be refunded when their final account is settled.

### Proceedings in Arts.

#### MATRICULATION.

The Examination in July will be that conducted for the Universities by the Education, Department, and will begin on July 5th, 1900. The Examination will be held at Trinity College, Toronto, and at the various Collegiate Institutes and High Schools of the Province. Candidates for this Examination, if they propose to write at a High School or Collegiate Institute, must notify the Inspector and pay him the fee before May 23rd, and should at the same time send notice to the University Registrar, on a form which will be supplied on application. Candidates proposing to write at Trinity College must send the required notice to the Registrar by May 23rd, accompanied by a certificate of good character and the fee. A second Examination will begin at Trinity College on September 21st. Notice for this Examination, together with the fee, must be sent to the Registrar by September 1st, on a form which will be supplied on application. A Candidate who failed partially in July and desires to complete the Examination in September and who did not write at Trinity College, must send a copy of the marks obtained in the July Examination, certified by the Head Master of the school where he wrote, on a form which will be provided by the Registrar. In July the fees will be \$2 for Part I., \$5 for Part II., \$5 for Parts I. and II. taken together, for Candidates completing the Examinations \$2 for not more than four subjects, \$5 for more subjects than four. In September the fee is \$5 if one department is taken, and \$10 if more than one department is taken. The Candidate for Matriculation must have entered on his sixteenth year.

#### REGULATIONS FOR 1900-1902.

Candidates for Junior Matriculation must produce satisfactory certificates of good conduct, and of having completed the sixteenth year of their age.

All Candidates for Junior Matriculation shall take the following subjects of the Pass Course :—English, Latin, History, Mathematics, and any two of the following :—Greek, French, German, Experimental Science (*i.e.*, Physics and Chemistry).

The Examination may be divided into the following two parts, which may be taken in either order and in a different year:—(I.) Arithmetic, English Grammar, Physics, and the History of Great Britain and Canada; (IL) Greek, Latin, French, German, English Composition, English Literature, Ancient History, Algebra, Geometry, and Chemistry.

Divinity may be substituted for Physics.

The percentage for Pass shall be thirty-three and onethird per cent. on each paper of the Examination taken by the Candidate.

The marks for sight-work on each of the "Authors" papers shall constitute not more than thirty-three and onethird per cent. of the whole of the marks for the paper.

Candidates failing in one or more subjects of either part may take at any one subsequent Examination held for that part the subject or subjects in which they have failed.

Second Class teachers' or Junior Leaving certificates will be accepted *pro tanto* at both Part I. and Part II. of the Pass Matriculation Examination, but Candidates who desire to compete for scholarships or relative standing will not be granted this exemption in the case of "Part II.

#### ELEMENTARY EXPERIMENTAL SCIENCE (PHYSICS).

Use of metre rule; use of calipers and vernier for more accurate metric measurements (e.g., diameters of wires, thickness of glass, plates, etc.); numerical calculations in the metric system.

Specific gravity, by specific gravity bottle and hydrostatic balance, of liquids and of solids.

Boyle's law; barometer; diffusion of gases.

Use of Fahrenheit and Centigrade thermometers ; determination of zero and boiling point ; boiling point dependent on pressure.

Specific heat; latent heat; easy numerical examples. Transmutation of matter; indestructibility of matter. Solution, precipitation, crystallization and evaporation.

#### LATIN.

Translation into Latin of English phrases and easy sentences to illustrate Latin accidence and the common rules of Latin syntax.

Translation into Latin of easy narrative English based upon the first twenty-five chapters of the prescribed Caesar.

Translation at sight (with the aid of vocabularies) from some easy prose author.

Translation from prescribed texts, with grammatical and other questions naturally arising from the extracts set for translation.

In order to pass in this subject, legible writing, correct spelling and punctuation, and proper construction of sentences are indispensable. The candidate should also give attention to the structure of the whole essay, the effective ordering of the thought, and the accurate employment of a good English vocabulary. About two pages of foolscap is suggested as the proper length for the essay; but quality, not quantity, will be mainly regarded.

and when 'not; transmission of pressure; Bramah's press; equilibrium of liquids of unequal density in a bent tube; the barometer; air-pump; water-pump, common and force; siphon.

ELECTRICITY: Voltaic cells, common kinds; chemical action in the cell; magnetic effects of the current; chemical effects of the current; voltameters; electroplating; astatic and tangent galwanometers; simple notions of potential; Ohm's law; shunts; measurement of resistance; electric light, arc and incandescent; current induction; induction coil; dynamo and motor; the joule and watt; electric bell; telegraph; telephone; elements of terrestrial magnetism.

#### CHEMISTRY.

Chemical Theory. The study of the following elements, with their most characteristic compounds, in illustration of Mendelejeff's Classification of the Elements: Hydrogen; Sodium, Potassium; Magnesium, Zinc; Calcium, Strontium, Barium; Boron, Aluminium; Carbon, Silicon, Tin, Lead; Nitrogen, Phosphorus, Arsenic, Antimony, Bismuth; Oxygen, Sulphur; Fluorine, Chlorine, Bromine, Iodine; Manganese, Iron. Elementary Qualitative Analysis.

A practical examination shall be held in connection with this subject, a pure salt will be sent out for qualitative analysis, and the candidate shall be allowed the use of an analytical table.

#### BIOLOGY.

1. ELEMENTS OF ZOOLOGY: Thorough examination of the external form, the gills, and the viscera of some common fish. Study of the prepared skeleton of the same. Demonstration of the arrangement of the muscular and nervous systems and the sense-organs, as far as these can be studied without the aid of the microscope.

Comparison of the structure of the frog with that of the fish. The skeleton of the pectoral and pelvic girdles and of the appendages of the frog, should be studied, and the chief facts in the development of its spawn till the adult form is attained should be observed.

Examination of the external form of a turtle and a snake.

Examination of the structure of a bird.

Study of the skeleton, and also of the teeth of a cat or dog.

Study of the crayfish as a type of the Arthropods.

Comparison of the crayfish with an insect (grasshopper, cricket, or cockroach); also with a millipede and a spider.

Examination of an earthworm.

Study of a fresh-water mussel.

The principles of zoological nomenclature as illustrated by some of the common fresh-water fish, such as the sucker and herring, bass and perch.

Study of an amœba, or paramœcium as a type of a unicellular animal.

The modifications of the form of the body in vertebrates in connection with different methods of locomotion. The natural hibits of the various animals examined.

2. ELEMENTS OF BOTANY: The examination will test whether the candidate has practically studied representatives of the flowering plants of the locality in which the preparatory school is situated, and representatives of the chief subdivisions of cryptogams, such as a fern, a lycopod, a horsetail, a liverwort, a moss, a lichen, a mush-room, and a chara.

An elementary knowledge of the microscopic structure of the bean and the maize. Attention will be given in the examination to drawing and description of parts of plants supplied, and to their classification. Comparison of different organs, morphology of root, stem, leaves and hain parts of the flower, reproduction of flowering plants, pollination, fertilization, and the nature of fruit and seeds.

A practical examination shall be held in connection with this subject. The material for examination will consist of two plants, a microscopic section and an animal.

#### BACHELOR OF ARTS.

#### GENERAL REGULATIONS.

All Candidates for this Degree must be Matriculated Students of Trinity University, and have kept nine terms. They will be required by the University to pass the Primary, Previous, and Final Examinations.

No change in the Curriculum shall affect any Student who has registered before March 1st, in the year in which such change is announced in the Calendar, but Students who degrade into a lower year shall come under the regulations affecting the year into which they have degraded.

Students may be admitted to College by the Provost without Matriculation; but if they have not written in the Supplemental Matriculation Examination they must pay a fee of \$5, and they cannot be registered with the University or receive a certificate of registration until they have passed the Primary Examination.

In order that a Student may keep a term, he must attend seventy-five per cent. of the Lectures delivered in the term by each Professor or Lecturer whose Lectures he is required to take'; and, if resident in College, attend sixty per cent., if living in lodgings, fifty per cent. of the Chapels of the term, and if residing at home, sixty per cent. of the morning Chapels of Sundays and Holy-days.

Students attending Lectures in Trinity College will not be allowed to present themselves at the Primary, Previous, or Final Examinations, unless they have passed the Christmas College Examination, held at the end of the Michaelmas Term, on the work read in Lecture during the Term, or the Supplemental Examination, held at the end of the Lent Term, on the work read in Lecture during Michaelmas and Lent Terms, of the First, Second or Third Year respectively. The marks obtained in this Examination by Candidates in the First and Second Years, are also reckoned in the awarding of Scholarships in June, in case of equality in the June Examination.

In the Primary, Previous and Final Examinations for the Degree of B.A., the Candidate must obtain thirty-three per cent. of the marks assigned to each paper, and forty per cent. of the total marks of the Examination he is required to take.

The Examination of Form IV. of the Department of Education will be accepted *pro tanto* for the Primary Examination.

#### SPECIAL REGULATIONS.

The keeping of terms may be dispensed with in individual cases, in which application to that effect shall have been made to the Executive Committee, and the grounds assigned by the applicant unanimously approved by the Committee. In such cases the applicant must not be less than twentyfive years of age, and will be required to matriculate and to pass the Primary, the Previous and the Final Examinations, at intervals of not less than those which are prescribed in cases of Resident Students. The Executive Committee is, however, empowered to accept equivalent Examinations for the Primary and Previous Examinations. The fee for each June Examination will be \$15.

Students attending any Divinity School in connection with the Church of England, will be admitted to the Degree of B.A., on condition of passing the usual Examinations, viz., the Matriculation, the Primary, the Previous, and Final Examinations, at the accustomed time, the Candidate producing on each occasion the necessary certificate from the authorities of his Divinity School, viz., at the Matriculation Examination, that he has been admitted as a Student of the School, and at the Primary, Previous, and Final Examinations, that he has kept at least the requisite number of terms, and that he is in good standing. Students who do not reside for so long a period as three years may be admitted to the Degree of, B.A., on condition of keeping at Trinity College the rest of the terms required, and of passing the necessary Examinations. Or they may make, severally, applications to the Executive Committee to be allowed to

avail themselves of the Statute under which Candidates are admitted to the Degree of B.A., by examination only. Candidates who hold the certificate of S. Augustine's College, Canterbury, will be exempted from the Matriculation Examination.

Students-at-law of Osgoode Hall, or Students of any Medical College, may be admitted to the Degree of B.A., if during their Course of Law or Medicine, respectively, they have kept three terms in Trinity College, and have passed the Matriculation, the Primary, Previous, and Final Examinations for the Degree of B.A.

Undergraduates of other Universities may, at the discretion of the Provost, be admitted *ad eundem statum*, up to the end of the Second Year, provided they have kept their terms by attending Lectures and passing Examinations, the fee for admission being \$5.

Students proposing to attend the Supplemental Examination are required to pay a fee of \$5 if one department only is taken, and \$10 if more than one are taken, which fee, together with a notice of his intention to present himself for examination, the Candidate must present to the Registrar, on or before September 1st.

Candidates taking the whole Examination in September as a Supplemental cannot be allowed the Examination unless they pass in all the subjects thereof.

# HONOUR EXAMINATION AT B.A.

Candidates may take the Degree of B.A. with Honours in the following departments: (I.) Classics; (II.) Mathematics; (III.) Theology; (IV.) Mental and Moral Philosophy; (V.) Physical and Natural Science; (VI.) Modern Languages and Literature; (VII.) Modern History; and (VIII.) English. The results of these Examinations will be published in the College Hall, in three classes; the order of merit in each department being determined by the number of marks obtained in this Examination.

The standard for Honour Classes is for First Class sixtysix per cent., for Second Class fifty per cent., and for Third Class forty per cent.

The Examiners in Mathematics may, at their discretion, add a Fourth Honorary Class to their Honour List, consisting of those who, not being Candidates for Honours, have highly distinguished themselves in the Mathematical part of the Pass Examination.

Candidates for Honours who shall have claimed exemption from any part of the Final Examination though they have failed to obtain a class in Honours, may be granted the Degree of B.A. on the recommendation of the Examiners.

Candidates who desire to take two Honour Courses may, after completing the first course at the end of nine terms as at present, take one or two years for the second course, if they wish it.

Honour Courses shall be divided into two groups :---

A. Classics, Mathematics.

B. Theology, Philosophy, History, Science, Modern Languages, English.

When a course in group A. is selected it must be completed before any course in group B. that may be selected. When both the courses selected are in one group the order is left to the option of the Candidate.

Fourteen papers will be set, six translation papers from the prescribed Authors, and one paper on each of the following subjects : Latin and Greek Grammar, Latin Prose Composition, Greek Prose Composition, Greek History, Roman History (to include both general questions and the selected period), Latin and Greek Unseen Translations, Greek and Latin Philology.

### SPECIALISTS' CERTIFICATES.

The Education Department of 'Ontario accepts the Honour Degree of Trinity University, Toronto, in Classics, and Mathematics, obtained on the courses specified in the Calendar of this University, as the non-professional qualification for a Specialist in the departments of Classics, and Mathematics, respectively.

In the case of other Candidates for the non-professional qualification of a Specialist in these departments, the Education Department will accept, until the regulations in force in 1894 are rescinded, the Examinations of this University, held on the specified courses; provided the Candidates make one-third of the marks assigned to each paper, and sixtyseven per cent. of the total of marks for all the papers, and provided the papers be taken at one regular Examination (not a Supplemental) or at not more than two such Examinations.

### MASTER OF ARTS.

The Candidate for this Degree must be a Bachelor of Arts of one year's standing. He must send to the Registrar notice of his intention of proceeding to the degree, together with the fee, at least three days before the Convocation.

In addition to the above, a Scholarship in Mental and Moral Philosophy will be awarded at the end of the Second Year, entitling the holder to one years' free tuition.

### GENERAL REGULATIONS.

Candidates competing for the Scholarships offered at Matriculation, except the Pettit Scholarship, are required to write in the July Examination.

The Scholarship in any Department will be awarded to the Candidate who obtains the highest marks in Honours in the Department or Departments for which the Scholarship is offered, provided that he has passed the Matriculation Examination, Part II., of the year in which he is competing, and has been awarded a First Class in Honours in his Department, or, if there be more than one Department, a First Class in Honours in one Department and a Second Class in another.

Note.—The Bishop Strachan Scholarship in Classics and the Burnside Scholarship in Mathematics will be given to the Candidates who obtain the second highest aggregate marks in these Departmentsand comply with the other conditions.

In order to hold the Scholarships in the Second and Third Years, Candidates must retain the positions in their Departments which they have won at Matriculation.

Nore.—A Candidate obtaining the Wellington Scholarship in Classics, the Dickson Scholarship in Modern Languages, or that in Physical and Natural Science, must obtain the highest place in the First Class in Honours in his Department in order to retain the Scholarship in the Second and Third Years. The same applies to the Bishop Strachan Scholarship in Classics except that the second highest place in the First Class in Honours in that Department is reaquired.

A Candidate obtaining the Burnside Scholarship for English and History and Geography, will be required to obtain the highest place in the First Class in Honours in Modern-History or in English in the subsequent years.

A Candidate obtaining the Pettit Scholarship for Divinity will be required to obtain the highest place in the First Class in Honours in Theology.

Should the holder fail to satisfy the above requirements in any year, his Scholarship will pass to the Student who has so done.

The holders of Scholarships are ordinarily required to reside in College, but when they reside with their parents or guardians, by permission of the Provost, they will be allowed free tuition when such is the whole or part of the emolument of their Scholarship.

In addition to the above, the following Prizes are annually competed for, being open to all Students attending Lectures.

The Prince of Wales' Prize \$18 for First Class Honours in Classics.

Prize of \$15 each for the highest First Class Honours in Theology, Science, Philosophy, Modern Languages and Modern History in the Final Examination.

# Eroceedings in Divinity.

## DIVINITY CLASS.

The course of work in the Divinity Class comprises both theoretical and practical work, such as the composition and preaching of Sermons, reading the Liturgy, Sunday School work, Mission work, etc.

Special importance is attached to the building up of the devotional life. Short services of Instruction, Meditation, or Intercession are held regularly in the College chapel.

The following persons may be admitted to the Divinity Class, provided they have obtained the approval of the College Committee :---

(1) Graduates in Arts of Trinity University or of other Universities in which classics form a part of the course required for the B.A. degree, being of the full age of twenty years, who are admitted into the second year of the Class, but are required to take at the April Examination, in addition to the second year work, the first year work of the Class in English Church History, General Church History, Hooker and Elementary Dogmatics.

(2) Undergraduates of Trinity University and of such other Universities aforesaid, being of the full age of twenty years, who have attended the Lectures of the Arts Course for one year, and have passed the Examination at the end of the first year of such course. They are admitted into the first year of the Class.

Graduates of Universities other than Trinity University, must pass an Examination in all Divinity subjects required in the Final Examination for the Degree of B.A. in Trinity University, and undergraduates of such Universities in those required in the Primary Examination in Trinity University.

Before his admission each student must subscribe to the Thirty-nine Articles.

The period of study will be three years; and no certificate in the Theological Department can be granted within this time except as otherwise provided; and unless the Student has attended Chapels and Lectures as required by the Statutes. All members of the Divinity Class are required to reside in College, a portion of which is set aside for their exclusive use.

A Graduate in Theological Honours (who has not previously taken Honours in some other Arts department) will not be granted his letters Testimonial for Holy Orders, until he shall have passed at an Examination of the Divinity Class in the year's work of the Class in Doctrine, Apologetics, Pastoral Theology, and Homiletics, having attended one complete year's Lectures in those subjects after having completed the Theological Honour Course. A graduate in Honours in any other Arts department who is a Candidate for Theological Honours may attend these Lectures and pass this Examination during his Theological Honour Course.

The course of study in the Divinity Class extends over three years, each year terminating about April 15th. Instruction is given by the Professors and Lecturers in the following subjects :--

## FIRST YEAR.

Scripture History. Selected Old Testament Books. Elementary Hebrew. New Testament Introduction. General Church History. Elementary Dogmatics. Patristics. Hooker's Laws of Ecclesiastical Polity, Book V.

New Testament, Selected Books in Greek. Elocution.

#### SECOND YEAR.

Biblical Knowledge. Selected Old Testament Books in Hebrew. Old Testament Introduction and Selected Books in English. Gospel of St. John in Greek.

Selected New Testament Books. English Church History, First Period. Dogmatics. Patristics. Apologetics. Pastoral Theology. Homiletics. Elocution.

#### THIRD YEAR.

Biblical Knowledge. Selected Books in Hebrew. Old Testament Theology. New Testament Theology. Selected New Testament Books. New Testament Canon. Patristics. Apologetics. English Church History, Second Period. Liturgics. Homiletics. Pastoral Theology. Elecution.

Students may substitute for Hebrew such work as may be prescribed.

The standard in the Divinity Class Examinations is for Honours, seventy-five per cent.; for First Class, sixty-six per cent.; for Second Class fifty per cent.; and for Passing, forty per cent. of the whole marks of the Examination, and thirty-three per cent. of the marks of each paper.

Members of the Divinity Class will be required to take such Pastoral work as may from time to time be assigned to them by the Provost.

Any member of the Divinity Class who may be nominated or appointed as an Exhibitioner or Scholar or receive any other financial assistance from the University or College shall be required to give a bond to the College in double the amount of the assistance to be received conditioned to serve in some Diocese of the Church of England in Canada for one year for each year he may have received such assistance, or to repay a year's instalment for each year of default of such service.

# LICENTIATE IN SACRED THEOLOGY.

The Candidate for this Degree must have kept nine complete terms. He must (1) have passed the Primary Examination for the Degree of B.A., and three April Examinations of the Divinity Class; or (2) have taken the Degree of B.A. and passed two April Examinations in the Divinity Class; or, (3) have obtained Honours in Theology, and passed at an April Examination of the Divinity Class in the year's work of the Class in Doctrine, Apologetics, Pastoral Theology, and Homiletics, having attended at least three terms' Lectures in these subjects.

Candidates for this Degree if in Priest's Orders may be admitted to the Degree by examinations only, without attendance at lectures. They will be required to matriculate in Arts, pass the Primary Arts Examination and the three examinations of the Divinity Class at the regular times. Priests may also be admitted to the examinations of the Divinity Class, and on passing any examination will be given a certificate to that effect by the Registrar, but will not be eligible for the Degree of Lic. Th.

#### HAMILTON MEMORIAL PRIZE.

The family of the late Mrs. John Hamilton, of Hawkesbury, have founded in her memory, an annual Prize of \$22.50, under the following regulations :---

I. The Prize to be called the HAMILTON MEMORIAL PRIZE, is to be awarded according to the result of the following papers :----

(a) A paper or papers on a selected book or selected books illustrative of Scripture History, Antiquities, and Interpretation.

(b) A paper on general Scripture History to be sent in the April Examination of the Divinity Class.\*

II. All Students belonging to the Divinity Class, as well as all others who have passed through their Theological Course, and have not attained three years' standing from B.A., shall be eligible as Candidates.

III. The Examination in the selected book or books shall take place towards the end of the Lent Term in each year, and the marks obtained shall be added to the marks of the April Examination.

IV. The Examiners shall be empowered to withhold the Prize if no Candidate is found worthy.

The Examination for the Hamilton Memorial Prize will be held at the same time as the Supplemental Divinity Class Examinations.

#### JUBILEE SCHOLARSHIP.

These two Scholarships were founded by the Society for the Propagation of the Gospel, from the Jubilee Fund of (the year 1851, of the annual value of \$120, tenable for two years. One of these Scholarships is awarded yearly to the most deserving Bachelor of the year, who has obtained at least Second Class Honours in Classics or Mathematics. On admission to the Scholarship, a declaration must be signed by the holder that it is his purpose to complete the Divinity Course in Trinity College, and to present himself as a Candidate for Holy Orders, and should he fail to do so, he will be held bound to refund to the College such proceeds of the Scholarship as he shall have received.

Candidates for Honours in Theology who have previously graduated with Honours in some other department, will be allowed to compete for the Sermon Prize, the Hamilton Memorial Prize, and the Reading Prizes, in each year of their Course in Theological Honours, but those who have not previously graduated with Honours will be allowed to compete only in the year following their graduation.

### DEGREES IN DIVINITY.

Candidates for these Degrees resident in the Ecclesiastical Province of Canada, other than Candidates for the Degree, *jure dignitatis* will, for the future, be required to proceed in accordance with the Canon on Divinity Degrees passed by the Provincial Synod of Canada in 1889. For copies of these regulations application should be made to the Provost. The following regulations apply to Candidates residing

outside the Ecclesiastical Province.

#### BACHELOR OF DIVINITY.

The Candidate for this Degree must be a Graduate in Arts of the University of three years' standing, or in the case of a Graduate admitted "ad eundem statum" of at least three years' standing from his first Degree. The requirement that the Candidate shall be a Graduate in Arts, may, however, be dispensed with by the Corporation, on special application having been made to them, in the case of Clergymen who have been in Priests' orders for at least six years, but such Candidate shall be required to pass the Matriculation Examination of Trinity University.

Except in the case hereinafter provided for, the Candidate must pass two Examinations, to be called the First and Second Examination for the Degree of B.D., and at least one year must elapse between these Examinations.

Graduates who have completed the Divinity Course in Trinity College, and have passed the regular Examinations of the Divinity Class, obtaining at least a Second Class in each Examination, shall be exempted from the First Examination for the Degree of B.D.

The Examination in Divinity will begin on September 25th, 1900, and Candidates for any Examination must send notice to the Registrar not later than April 1st, specifying, where necessary, the group for which they intend to present themselves.

#### FIRST EXAMINATION FOR THE DEGREE OF B.D.

The subjects for this Examination shall be as follows :---

(1) General Paper on the contents and subject matter of the Books of the Old and New Testament.

(2) Selected portions from the Historical, Poetical and Prophetical parts of the Old Testament. (Questions in Hebrew will be set, but are not obligatory for the Degree.)

(3) A selected Gospel and Epistle or Epistles from the New Testament in Greek.

(4) One selected Greek and one selected Latin, Ecclesiastical Writing.

(5) The Outlines of the History :

(a) Of the Christian Church to A.D. 451.

(b) Of the English Church.

(6) A selected work on Dogmatic Theology.

(7) A selected work on Apologetic Theology.

(8) A selected work on Christian Ethics.

(9) A selected work on Pastoral Theology.

### The selected works for 1900-1902 are :----

(2) 1 Samuel ; Psalms, Bk. I. ; Isaiah, I.-XXXIX. ; Micah.

(3) The Gospel according to St. Matthew ; Epistle to the Romans.

(4) St. Athanasius, "De Incarnatione :" St. Anselm, "Cur Deus Homo."

(5) Books recommended :

(a) Wordsworth's or Robertson's Church History.

(b) Perry's English Church History or Wakeman's History of the Church of England.

### SECOND EXAMINATION FOR THE DEGREE OF B.D.

The Candidate may select for Examination one of the five following groups of subjects :

- (a) The Hebrew Scriptures, with special reference to selected Books ; also selected Books from the Septuagint version.
- (b) The History of the development of the Kingdom of God during the Old Testament Period, with special regard to its relation to the Christian Church, and also to the History and development of Messiac ic prophecy.
- (II.) NEW TESTAMENT :
  - (a) The New Testament in Greek, with special reference to selected Books.
  - (b) The History and Constitution of the Christian Church during the Apostolic period.
  - (c) The History of the Canon of the New Testament, and of its Text, its Inspiration and Contents.

(III.) PATRISTICS AND ECCLESIASTICAL HISTORY.

- (a) The History and Constitution of the Christian Church during the Apostolic period, and to the death of Leo the Great, with selected Christian writings of this period.
- (b) The History of the English Church, special regard being had to the history and doctrinal position of religious bodies which have separated from her.

(IV.) LITURGIES AND DOGMATIC THEOLOGY.

- (a) The ancient Liturgies and their relation to the various Eucharistic Offices of the Anglican Church.
- (b) The Creeds and Illustrative Documents.
- (c) The History of some selected Doctrine.

### (V.) APOLOGETICS.

- (a) Positive grounds of faith, embracing the several lines of thought by which the mind is led :---
- (1) To the conviction of the existence of God.
- (2) To the conviction of the truth of Christianity ;

and including selected works on each of these subjects :

(b) Selected ancient Christian Apologies.

(c) Relation of Christianity to various Philosophical and Ethical systems, including selected works.

#### DOCTOR OF DIVINITY.

The Candidate for this Degree must be a Bachelor of Divinity of three years' standing.

### EXAMINATION FOR THE DEGREE OF D.D.

The Candidate may select for Examination one of the five following groups of subjects, and will be required to write a Thesis on the corresponding subject specified below :---

(I.) OLD TESTAMENT.

- (a) The Old Testament in Hebrew and Chaldee grammatically, critically, and exceptically considered.
- (b) Foy Thesis: Some selected subject connected with the relation of the Old Testament Scriptures to contemporary Ethnic faiths, or with the authenticity, doctrinal position, or other kindred questions, of selected portions of the Old Testament.

(II.) NEW TESTAMENT.

- (a) The New Testament in Greek, grammatically, critically. and exceptically considered.
- (b) Patristic and other Schools of Interpretation, with select commentaries.
- (c) For Thesis: The authenticity, doctrinal position, or other kindred questions of selected portions of the New Testament.

(III.) PATRISTICS AND ECCLESIASTICAL HISTORY.

(a) Selected Latin and Greek Ecclesiastical writings.

- (b) Selected Historical periods, from Ancient, Medizval, and Post-Reformation Ecclesiastical History, with selected writings of the Period.

### BACHELOR OF CIVIL LAW.

The Candidate for this Degree must be a matriculated Student of Trinity University, but if he be a Student at-Law who has been matriculated by the Law Society of Upper Canada he will be admitted to Matriculation in the University without further examination.

The Candidate must be of the standing of three years from the date of Matriculation, and of the full age of twenty-three years, but the latter condition may be dispensed with in the case of Students-at-Law, of Osgoode Hall, who have kept three complete Terms in Arts, and passed the Primary Examination.

The Candidate will be required to pass three Examinations, separated by intervals of not less than a year, to be called the First, Second, and Final Examinations in Law. If, however, the Candidate produces a certificate of his having been called to the Degree of Barrister-at-Law by any Law Society in Her Majesty's Dominions, and be a Graduate in Arts of Trinity University, or of any recognized University, the first two Examinations may be dispensed with, and the Degree of B.C.L. may be conferred after the Candidate has passed the Final Examination only.

The Examination in Law will begin in 1900 as follows: The First and Final on June 12th, and the Second on June 15th.

Candidates for any examination are required to give notice to the Registrar by June 1st, on a form which will be furnished on application, together with the Examination Fee, and in the case of the Final Examinations, with the Degree Fee also.

### DOCTOR OF MEDICINE AND MASTER OF SURGERY.

The Candidate for the Degree must have matriculated in the Faculties of Arts or Medicine.

The \*Medical Matriculation Examination will be held twice in the year in Trinity College, beginning on the second Friday in March and October respectively.

Notice must be sent to the Registrar of Trinity University, together with the Examination fee of \$5, at least one week before the Examination, on a form which will be supplied on application.

The standard for passing is 25 per cent, on each paper and 33 per cent, on each department,

Candidates who pass in two departments may, at the discretion of the Examiners, be allowed to take the remaining subjects at a subsequent Examination, a fee of \$5 being required for each Examination.

No change in the Curriculum shall affect any Student who has registered in the University before March 1st in the year in which such change is announced in the University Calendar, except that any change in the requirements for the Final M.D., C.M. Examination shall apply to all Students who have not passed their Primary Examination at the time of the issue of the Calendar containing notice of such change, provided also, that Students degrading into a lower year shall be bound by the regulations affecting the year into which they have degraded.

The Candidate for Degrees in Medicine or Surgery must be of the full age of twenty-one years.

He must furnish certificates of having attended four Winter Sessions at some Medical College recognized by the University, except he be a Graduate in Arts or Science, when attendance at three Winter Sessions will be accepted.

Before admission to the Primary Examination in Medicine, he must have attended in some recognized Medical College the following courses of Lectures :---

Two courses of eight months each on

Descriptive Anatomy. Practical Anatomy. General Chemistry. Materia Medica and Pharmacy. Physiology. Histology.

And one course of four months on Practical Chemistry.

Toxicology.

Before admission to the Final Examination, he must further have attended two courses of Lectures of eight monthseach in some recognized Medical College on

Theory and Practice of Medicine. Principles and Practice of Surgery. Midwifery and Diseases of Women and Children. Clinical Medicine. Clinical Surgery.

And two courses of four months each on

Medical Jurisprudence. Therapeutics and the art of prescribing.

And one course of four months each on

Applied Anatomy. Sanitary Science.

Practical Pathology.

General and Special Pathology (taken in the Third Year).

He must have attended for at least *eighteen* months the practice of some general Hospital, and, during two sessions, Olinical Lectures on Medicine and Surgery.

He must have attended for at least six months the practice of a Lying-in-Hospital, or must give satisfactory evidence of having otherwise enjoyed equivalent advantages of gaining obstetrical knowledge, with a certificate of attendance upon at least six cases of labour.

He must have passed two University Examinations, called the Primary and Final Examinations in Medicine.

Before admission to the Primary Examination, he must produce a certificate that he has passed the First Year's Examination in some recognized Medical College.

#### PRIMARY EXAMINATION IN MEDICINE.

This Examination may be passed at the end of the Second Year. The subjects are: Descriptive Anatomy, Practical Anatomy, Physiology, Histology, General Chemistry, including Chemical Physics, Practical Chemistry, Materia Medica and Pharmacy, Toxicology.

The Primary Examination of other recognized Universities, or that of the College of Physicians and Surgeons of Ontario, Quebec, or Manitoba, will be accepted in lieu of the University Primary Examination, provided that the Candidate shall in all cases pay the full fee for the Degree, but if any of the subjects of the Primary Examination do not form

part of the Examination allowed, the Candidate shall be required to take such subjects together with his Final Examination.

Graduates of any recognized University will not be required to take such subjects of the Primary Examination as they have already passed in their University Examinations.

### FINAL EXAMINATION IN MEDICINE.

Candidates for this Examination will be required to furnish proof that they have passed an Examination at the end of their Third Year in such subjects as the Faculty of the Medical College or School they may have attended may require.

In cases where this has been unavoidably, as from illness, omitted, an equivalent Examination must be passed prior to going up for the Final Examination.

The Final Examination shall take place at the end of the Fourth Year. The subjects are: Theory and Practice of Medicine, Principles and Practice of Surgery, Clinical Medicine, Clinical Surgery, Midwifery, Gynæcology, and Diseases of Children, Medical Jurisprudence, Sanitary Science, Therapeutics, Applied Anatomy, Practical Pathology, General and Special Pathology, including Bacteriology.

In order that a Candidate may pass in either of these Examinations, he must obtain thirty-three per cent. of the marks assigned to each paper, and fifty per cent. of the total marks of the Examination. Candidates who satisfy the Examiners will be arranged in three classes in order of merit; the standard for the first and second class respectively being seventy and sixty per cent. of the total marks of the Examination.

Candidates who fail in more than four subjects in the Primary, or more than five subjects in the Final Examination of the Faculty of Medicine shall be deemed to have failed altogether in the Examination. Candidates who fail in not more than four subjects in the Primary or five subjects in the Final shall be allowed to take these subjects at the Supplemental Examination, or at the next Annual Examina-

tion, provided that a Candidate shall not be given credit for any portion of the Examination unless he shall have obtained at least thirty-three per cent. of each paper and fifty per cent. of the total marks of such part of the Examination. A Candidate who does not complete the Examination as above will be required to take the whole Examination again.

Candidates in the First Class of the Final or the Primary Examination in Medicine, shall be awarded Certificates of Honour, provided they obtain at least seventy-five per cent. of the marks of the Examination.

The Primary and Final Examinations may be taken together at the end of the Fourth Year.

Supplemental Examinations will be held, beginning for Final Candidates on September 21st, and for Primary Candidates on September 27th.

### MEDALS IN MEDICINE.

A Gold and a Silver Medal are annually awarded to the Candidates who are first and second respectively in the Final Examination, and two Silver Medals to the Candidates who are first and second in the Primary Examination for the Degree of M.D., C.M., provided that a Medal shall not be awarded to any Candidate who obtains less than seventy-five per cent. of the total marks of his Examination.

All Candidates for the Final Medals must have taken the Primary Examination in this University; and if they have not already done so, they may take it at the same time as the Final Examination.

In case of equality for the Final Medals, the Gold Medal shall be awarded to the Candidate who obtained the greatest percentage of marks at the Primary Examination. It shall be open to any Candidate who desires to do so to take the Primary Examination a second time with the Final, and in this case the Primary marks so obtained shall be those counted for the Medal.

The Candidate for this Degree must pass a Matriculation Examination, consisting of the English and one of the Languages, Latin, Greek, French or German of the Arts Matriculation Examination held in July or September. See pages 23-27. He must also furnish

(i.) A certificate of character in the following or some equivalent form :—

(ii.) A certificate that he has employed five years in the study and practice of Music.

The Candidate will be required to pass three Examinations in Music separated by intervals of not less than one year, to be called the First, Second, and Final Examinations in Music, and he must also send to the Registrar an original Composition for voices on a sacred or secular subject, consisting of four movements at least. These movements shall be (1) a chorus, or solo and chorus, in five part harmony, (2) a solo in cavatina or aria form, (3) a trio or quartette, unaccompanied, and (4), a fugue in four parts, (1), (2) and (4) to have an accompaniment for a string band. The movements may be in any order preferred, and the whole must occupy from fifteen to twenty minutes in performance. This Exercise must be approved of by the Examiners.

# PRIMARY EXAMINATION IN DENTISTRY.

This Examination will be held at the end of the First The subjects are : Anatomy, Special, Dental, and Year. Practical; Primary work in Physiology, Histology, Chemistry, and Materia Medica.

The Primary Examination of other recognized Universities, or that of the Royal College of Dental Surgeons, will be accepted in lieu of the University Primary Examination, provided that the Candidate shall in all cases pay the full fee for the Degree, but if any of the subjects of the Primary Examination do not form part of the Examination allowed, the Candidate shall be required to take such subjects together with his Final Examination.

Graduates in Arts of any recognized University, shall not be required to take such subjects of the Primary Examination as they have already passed in their University Examinations.

### FINAL EXAMINATION IN DENTISTRY.

This Examination will be held at the end of the Final Year. The subjects are:

Operative Dentistry, Oral and Dental Pathology, Dental Anatomy, Dental Therapeutics, Prosthetic Dentistry, Physiology, Histology, Chemistry, and Materia Medica.

Students will be required to produce satisfactory evidence of pr ficiency in Practical Dentistry. The certificate of the Royal College of Dental Surgeons will be accepted.

The Primary and Final Examinations may be taken together at the end of the Final Year.

Candidates may take Anatomy and Chemistry of the Final Examination at the end of the Second Year, and complete the Examination the following year.

Notice must be sent to the Registrar on a form which will be furnished, together with the fee for registration, examination, and degree, by March 1st.

The Examination in 1901 will begin on April 9th.

# Proceedings in Pharmacy.

## BACHELOR OF PHARMACY.

The Candidate for the degree of Phar. B. must have (a) passed the Matriculation Examination in Arts, Medicine or Dental Surgery of this or some other recognized University, or (b) the Departmental Non-professional Examination (with Latin) for a first, second or third class Teacher's Certificate.

The Candidate must be twenty-one years of age, and before examination must furnish to the Registrar of Trinity University satisfactory evidence of his having attended courses of lectures on Pharmacy, Chemistry, Materia Medica, and Botany, including their collateral branches, together with laboratory work, for at least six months in some recognized College of Pharmacy or Medicine; and, also, of his having passed a practical course of instruction for at least four years under the direction of a qualified Pharmacist.

The Examination will be held in May of each year, and will embrace the following subjects :--

Pharmacy, Theoretical and Practical. Chemistry, """ Materia Medica, """ Botany, including Microscopy.

### DOCTOR OF PHARMACY.

The Candidate for the degree of Phar. D. must be a Bachelor of Pharmacy of at least three years' standing, and must have passed the Examination hereinafter specified, which will be held in May of each year.

The Candidate shall be at liberty to select for special study two of the following Departments, of which Pharmacy shall always be one.

- (a) Assay of the organic drugs official in the British Pharmacopœia.
- (b) Methods of preparation of the official galenical compounds, and detection of impurities and adulterations.

(c) Dispensing methods, including the subject of incompatibility.

CHEMISTRY.---Advanced work in one or more of the following :---

- (a) Volumetric Analysis as applied to official chemicals.
- (b) Analysis of Potable and Mineral waters and Urinary Analysis.(c) Plant Analysis.

MATERIA MEDICA.—Advanced work in one or more of the following :--

- (a) Principles of Pharmacognosy. (Fluckiger's Manual must be carefully studied.)
- (b) Therapeutics of official drugs.

The applicant for a degree must send notice to the Registrar at least ten days before the date of the Examination on a form which will be furnished, and which must be returned, together with the fees for registration, examination and degree.

The Examination in Pharmacy in 1900 will begin on May 9th.

# Admission to Ad Eundem Degrees.

Ad eundem degrees in Divinity, Arts, Law, or Music, are granted to Graduates who are resident in the Dominion of Canada, of Oxford; Cambridge; Trinity College, Dubliny; King's College, Windsor, Nova Scotia; the late King's College, Fredericton, New Brunswick; Bishop's College, Lennoxville, Quebec; or the late King's College, Toronto, on their paying the fee of the degree, and making the declarations required.

Clergymen of the Church of England, resident within the Dominion of Canada, being graduates in Arts of three years' standing of any chartered University in Her Majesty's Dominions shall be admissible to *ad eundem* degrees as soon as they shall have complied with the conditions requisite for the Degree of Bachelor of Divinity, or of Bachelor of Music.

The Professors of Trinity Medical College and of the Woman's Medical College, Toronto, are in all cases admissible to ad eundem degrees.

Application for *ad eundem* degrees not provided for in the foregoing regulations are considered by the Executive Committee, but no such degree can be granted unless the Candidate has taken the degree at his own University in course.

The fee for an *ad eundem* degree is the same as for the degree taken in regular course.

If a Candidate for any Examination fails to send the notice and pay the fee by the date prescribed in the Calendar, the Registrar may at his discretion accept the notice, but he shall in all cases require the payment of an additional fee of one dollar.

Candidates for the First Degree in any Faculty may be admitted to such Degree *in absentia* by permission of the Executive Committee on payment of an additional fee of \$10. Candidates for Higher Degrees may always be admitted to the Degree *in absentia*.

Candidates taking the First Degree in any Faculty at a Convocation other than the April of October Convocation must pay a fee of \$5 in addition to the ordinary fee.

The annual payments made by Bachelors of Arts to Convocation will be credited in payment of the fee for M.A.

### Library.

### Librarian, A. H. YOUNG, M.A. Assistant Librarians, {E. P. S. SPENCER, B.A. A. L. LANCEFIELD.

The University Library contains about 10,000 volumes, 600 of which were a gift from the Society for Promoting Christian Knowledge.

Members of the Staff and non-resident Graduates may not have in their possession more than six volumes at a time, and Students not more than three volumes.

Books, except books of reference and text books, may be retained for a fortnight by residents of Toronto and Students not resident in Toronto, and for a calendar month by Graduates not resident in Toronto.

Undergraduates in Medicine or Law shall pay 25 cents per volume for each book taken out or, if they prefer it, a Library fee of one dollar per term during the time that they use the Library, and shall be subject to such rules of the Library as are applicable to them:

All books must be returned to the Library on or before June 24th and December 24th.

Any person retaining a book beyond the time allowed or after the two days mentioned in the preceding paragraph will incur a fine of two cents a day till the return of the book.

Non-residents of Toronto must prepay the charges for the carriage of books both ways.

Loss of books or damage done to books must be made good by the person in whose name the book is taken out.

### Museum.

The vestibule of the present building has been fitted up for the temporary reception of a Museum of Natural History, towards which many Mineralogical, Geological, and other specimens have been contributed.

In November, 1884, a very complete collection of specimens illustrating the geological formations of Canada was presented to the Museum by Professor Selwyn, Director of the Geographical and Natural History of Canada. The Museum has been classified and re-arranged by Mr. Montgomery.

The Curators will be glad to receive specimens from Graduates or other friends of the University.

#### COLLECTION.

A large and valuable collection of minerals, fossils and other geological specimens, the property of Henry Montgomery, M.A., has been deposited in suitable glass cases in a room in the west wing of the College. Nearly all the Provinces of Canada and States of the Union, as well as most other foreign countries, are represented in this collection. Some of the specimens are of extreme rarity, and all may be profitably used in the study of the various branches of mineralogy and geology.
