Boston, Sept. 19.  
Sir Frederick Bruce, British Minister, died of apoplexy this morning about two o'clock, at Tremont House in this city. He arrived last evening about 9 o'clock and was taken suddenly ill.

As a mark of respect to the memory of the deceased all the United States Offices and Public Buildings are closed, and flags lowered to half mast, by order of the Mayor.

The troop ship "Himalaya" which sailed on the 4th with the 69th rifles on board is reported detained at Quanaque Islands from the prevalence of Asiatic cholera.

Toronto, 20th.  
Dr. Blackburn, of Yellow Fever, not only left Canada for New Orleans yesterday, having obtained permission to return under the late amnesty proclamation.

London, Sept. 20.  
Capt. Osborne, one of the Fenian prisoners, made his escape from the jail in Chelmsford last night. He was not recaptured at noon to-day, though the jail guards started immediately in pursuit. The police are searching for him in every part of the surrounding country, where it is supposed he is concealed.

Washington, 19.  
Mr. Howard of the British Legation proceeded to Boston this morning on reception of the news of the death of Sir Frederick Bruce. The Government and the British Legation communicated the intelligence to London. Arrangements for interment are deferred waiting instructions from London. Orders have been issued to pay all proper honor to the remains of the deceased at Boston. The flag of the State Dept. is half-mast. The death of Sir Frederick Bruce in view of the present relations with Great Britain is looked upon as a serious calamity.

Quebec, Sept. 21.  
The Mercury, Ministerial organ, this evening says:—It is expected that at the meeting of the Privy Council, which will be held at Ottawa on Tuesday, when Lord Monck and all the members will be in attendance, departmental arrangements of the Dominion will be completed, and the time fixed for convoking the Parliament of Canada. It is thought the session will commence on 24th October, the anniversary of the first British Parliament, and that it will last a month, when after organization, appointment of committees, and passage of supplies, adjournment will take place till after Christmas holidays.

During the recess of Parliament the Local Legislatures will meet probably at the end of November.

Canvassing is being briskly carried on by those gentlemen who are offering for the seats in the local Legislature, recently vacated by Judges Stevens and Chandler. That each Candidate has his personal friends cannot be denied; and indeed the ballot box, which will decide the fate of the aspirants for Legislative honors, will prove the truth of this statement.

One of the candidates, Mr. Stevenson, says in his Card, that there is—"No political question at issue in this Election."—it will consequently be a choice of men, and the Electors in their preferences, we trust, will select those who will discharge the responsible duties of Representatives for the benefit of their constituency.

We have always been of the opinion, that the less promises made, the better for both people and representatives, simply because no man however talented or faithful to his duties, can accomplish all he promises; true, he may be sincere, but unless he can by argument and facts convince the members, he is as liable to be defeated as he is to succeed. At the present juncture able men are required—men who will fearlessly and independently perform their duty—men who go to the Legislature to advance the interests and develop the resources of the Province, and not for personal aggrandizement. The electors should remember that the law and record, recognizes no section or locality, but a constituency, usage however, and custom has given some localities certain privileges; fair as this may appear to be, it has led us to say to local jealousies and sectional animosities, it should not be, but we regret to say it is so, and we trust the day is not distant when the interests of localities and Counties may be one. There is a scriptural illustration which aptly demonstrates the dependence of the parts, and which may be read with profit by those who from interested motives would create jealousy.

FISH CULTURE.—We learn from St. John papers, that our old friend Dr. Fletcher, of New Hampshire, has been appointed Commissioner by Massachusetts, Connecticut and New Hampshire to restock the Merrimack and Connecticut rivers with Salmon. The Doctor visited the Miramichi last year, and obtained the ova which he impregnated with the milk of the male fish, which were deposited in gravel and moss. About 90 per cent was hatched and the specimens shown by the Dr. exhibited the fish in the various stages of growth, from one month up to eight. Several of our rivers in this Province may be restocked in the same way.

One of our contemporaries who is fond of calculations states that the Ottawa House of Commons will be composed of 181 members, and that out of that number there have been elected in the several Provinces 133 supporters of the Government and others have since followed, leaving the Union Government a clear majority of over 60 members. Nova Scotia not having the question of Confederation submitted to the people, has elected 18 Antis and 1 Confederate.

ARREST OF BURGLARS.—Three persons have just been arrested at Portland, charged with burglary in Westbrook, Lewiston, Auburn, Augusta, Bath, Bangor and other places in Maine, and even in Massachusetts. The Portland Press contains a description of three of the robbers arrested, and of their modes of operation. The Press says of the parties:—

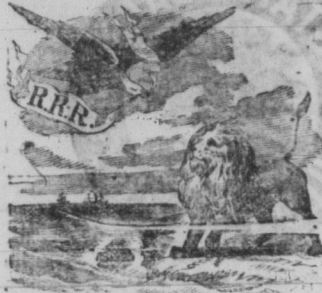
