WHEREAS an Association hath existed for Preamble. several years in the Village of Industry, in the County of Berthier, under the name of "Les Clercs Paroissiaux ou Catéchistes de 5" Saint Viateur," for the instruction of young persons in the sciences, and in the elements thereof; and whereas the Members of the said Association have, by their petition, prayed to be incorporated, and, in consideration of the 10 great benefits which must arise from the Institution, it is expedient to grant their prayer:

Be it therefore enacted, &c.: and it is here- The present by enacted by the authority of the same, that Members, and those who the Rev. François Thérèse Lahaye, Priest, shall hercafter 15 Etienne Champagneur, Augustin Fayard, become such, incorporated. Louis Chrétien, Abraham Jacques Duhaut, Paschal Lajoie, Louis Langlais, Joseph Vadeboncœur, Octave Gaudreault, Godfroy Lacas, and Gilbert Joly, the present officers and mem-20 bers of the said Association, and such other persons as shall hereafter become members of the said Association according to the Rules and Regulations thereof and the provisions of this Act shall be, and they are hereby consti-25 tuted and declared to be a body politic and corporate, in deed and in name, by the name of "Les Clercs Paroissiaux ou Catéchistes de Corporate " Saint Viateur," and by that name shall have name and powers. perpetual succession and a common seal, and 30 shall have power, from time to time, to alter, renew, or change such common seal at their pleasure, and shall, by the same name, from time to time, and at all times hereafter, be able and capable to purchase, acquire, hold, possess

Act to be a Public Act. VII. And be it enacted, That this Act shall be deemed to be a Public Act, and shall be judicially taken notice of as such by all 25 Judges, Justices of the Peace, and other persons whatsoever, without being specially pleaded.
