

An Act for incorporating certain Charitable, Philanthropic and Provident Associations, and for the effectual protection from fraud and misappropriation of the funds of the same.

7 HEREAS large and increasing num- Preamble. bers of all classes of the community have for some time past associated themselves together under the name and style of "Odd 5 Fellows," for the purpose of making provision for themselves and families, by contributing subscriptions or otherwise, against sickness, misfortune and death, and for the relief of the widows and orphan children of 10 deceased members, and whereas, the accumulated funds of such Associations (owing to the absence of legal protection,) have been subjected to great and serious losses from frauds and defalcations; and whereas, it is 15 expedient to encourage habits of providence and forethought amongst all Her Majesty's subjects: Be it therefore enacted, &c.

- And it is hereby enacted by the authority of Any number the same, That it shall and may be lawful for of persons may associate for 20 any number of persons to unite for the pur-pose of making provision, by means of con-mutual assist-ance in case of tributions, subscriptions, donations or other-death, sickwise, against the several contingencies of ness, &c. sickness, unavoidable misfortune or death,
- 25 and for relieving the widows and orphan children of members deceased; and it shall and may be lawful for the members and officers of such associated body or Society, from time to time, to establish and maintain
- 30 branches thereof, for and at the convenience of the respective members, but for so long only as the business transacted at the Meet-

ings of such Society, or any of the branches thereof, shall be confined exclusively to the objects herein set forth.

II. And be it enacted, That it, shall and and make By- may be lawful for the Members of such 5 Societies so constituted as aforesaid, to nominate, choose and appoint proper persons as Trustees, Treasurers, Secretaries or other Officers, for conducting the business, discipline and management of such Societies, and 10 to meet together from time to time to make, alter, rescind or frame laws, rules or regulations for the necessary government of, and for conducting the business of such Societies Proviso · as to or any branches thereof: Provided that 15 such laws, rules and regulations, shall not contain any matter or thing contrary, repugnant to, or in violation of the laws, statutes or customs of this Province, or be directed to the furtherance of any political or sedi-20 tious object whatsoever.

III. And be it enacted, That it shall and may be lawful for the Members of each of extent, and to such Societies or Lodges in its locality, by whatsoever name, designation, number or 25 description, such Society or Lodge may be. known, in the name of such Society or Lodge. or in the name of the Presiding, or other Officer or Officers thereof, to acquire and take by purchase, donation, devise or other- 30 wise, and to hold for the use of the Members of such Societies, and according to the rules and regulations as aforesaid of the said Societies, all and every kind of personal property and also real property in the Pro-35 vince of Canada, not exceeding five acres, and to sell and alienate the same, whether acquired before or after the passing of this Act, and to purchase and acquire in the stead and place thereof any other real 40 estate, not exceeding the quantity before mentioned; and that each of the said Societies shall have a common seal, and may change and alter the same at their will and

- IV. And be it enacted, That it may be law- They may take 10 ful for such societies to require, and for the security from their officers. officers, secretaries, treasurers and trustees to give security for all such sums of money, or other the property of any such Society, as
- 15 may from time to time be placed in the hands of or under the control of such Officers, Secretaries, Treasurers and Trustees in trust for and on behalf of the objects of such Society, and all such securities being in writing, shall
- 20 be deemed good and valid security and admissible as evidence in any of Her Majesty's Courts of Civil and Criminal Judicature.

V. And be it enacted, That if any Officer, Punishment of Secretary, Treasurer, Trustee or Member of Members and Members em-25 any Society constituted in accordance with bezzling funds, this Act shall obtain undue possession of, «c. misappropriate, embezzle or withhold from the other Members, Officers or other persons entitled to demand and receive the same, the

- 30 whole or any portion of the funds, moneys, or other property of such Society, and shall continue to withhold such property after due demand shall have been made for the restoration and payment of the same by some one
- 35 or more of the Members or Officers duly appointed by and on behalf of the said Lodge or Society, every such offender shall be guilty of a misdemeanor, and being convicted thereof, shall be liable at the discretion of the
- 40 Court to be imprisoned at hard labour in the Provincial Penitentiary for any term not exceeding three years, or imprisoned in any other prison or place of confinement for any term not exceeding two years, or to

suffer such other punishment by fine or imprisonment, or by both as the Court shall award.

What shall be evidence in proceedings or Members of the Association.

VI. And be it enacted, That in any proceedings to be hereafter commenced or taken 5 against officers under the provisions of this Act, in and before any Court of Civil or Criminal Jurisdiction, against any Treasurer, Trustee, Secretary, Officer, or other Member of such herein recited Charitable and Benevolent So-10 ciety, or Provident Association, for obtaining undue possession of, or withholding, embezzling or misappropriating the whole or any portion of the funds, moneys, or other property of such Charitable and Benevolent So- 15 ciety, or Provident Association, it shall and may be lawful to receive in evidence the printed or written rules of such Society, Lodge or Association, for the time being, in force, and the appointment of any Officer, Secretary, 20 Treasurer, Trustee, or enrolment of any Member, certified under the hand of the Presiding Officer for the time being, and the Seal of the said Society, and the Books, Minutes and other documents of such Asso-25 ciation, relative to any portion of the matter then in question.

Public Act.

VII. And be it enacted, That this Act shall be a public Act, and as such, shall be judicially noticed by all Judges and Justices 30 of the Peace, and others whom it may concern, without being specially pleaded.
