The Grand Master read his Report for the past year.

NANAIMO, B. C., February 14th, 1894.

*To the Officers and Members of the Grand Lodge of British Columbia,
I. O. O. F.:*

DEAR SIRS AND BROTHERS,—It is with pleasure that I extend to you a cordial greeting on the occasion of the Twentieth Annual Session of this Grand Lodge, and to be able to present to you a report for the year which is most gratifying. Although the membership has not increased numerically as it did in the previous year, I am pleased to be able to report that two new lodges have been instituted, and a gain of 200 in membership, which speaks very highly for our order throughout the Province.

The Insurance Association in connection with our order in this Province, has met with one death during the year, and it was very pleasing to learn that in the short space of four months there was enough money on hand to meet the claim of \$1000. I advise that this Grand Lodge appoint an agent to canvass the jurisdiction, which, in my opinion, will increase the membership to a greater extent than by having local agents.

I am very pleased to report, after having visited nineteen Subordinate Lodges and two Rebekah Lodges, that peace and harmony exists within our borders, and that wherever the Team Work was employed it appeared to increase the interest felt by the members in lodge work, which it was a pleasure for me to witness.

I trust that this session of our Grand Lodge will be of a harmonious nature, that the legislation effected will tend to the advancement of the Order, so that the Representatives when they return will be in a position to report some good effected for the Order in this jurisdiction.

I received the usual Proclamations from the Grand Sire relative to the observance of the Anniversary of the Order and Memorial Day, in consequence of which, I issued the following Proclamations to the Lodges, subordinate to the Grand Lodge of British Columbia.

GREETING,—In accordance with custom, and in compliance with the Proclamation of the Grand Sire, I, James Crossan, Grand Master of the Grand Lodge of British Columbia, I. O. O. F., do hereby request the Subordinate Lodges of this jurisdiction, to take appropriate action for the

due commemoration of the twenty-sixth day of April next, the Seventy-fourth Anniversary of our Order, by suitable exercises, and inasmuch as certain Lodges may desire to appear in Regalia, I do hereby grant permission to all Subordinate Lodges in this jurisdiction to wear the Regalia of the Order upon this occasion, subject to such restrictions as are prescribed by our law.

GREETING :—The Grand Sire having issued his Proclamation, requesting all Subordinate Lodges of the Order to observe the 13th day of June next as "Memorial Day," now, therefore, I, James Crossan, Grand Master of the Grand Lodge of British Columbia, I. O. O. F., do hereby request the Lodges subordinate to this Grand Lodge to assemble at their respective Lodge rooms on the day above mentioned, or on such other day as the Lodges may deem more convenient, and to engage in suitable exercises in memory of their deceased members.

And inasmuch as some Lodges may desire to appear in Regalia, permission is hereby given to all Subordinate Lodges to appear in public in Regalia on this occasion, subject to the restrictions of the laws of the Order in that behalf.

APPEALS.

On April 1st, 1893, I received from J. E. Phillips, retiring Grand Master, an appeal of Bro. J. Wriglesworth, P. G. M., against the action of Dominion Lodge, No. 4, in refusing him benefits on two occasions. I have no hesitation in coming to a decision in regards to the first specification of the appeal, my opinion being that Bro. Wriglesworth was out of standing and not entitled to benefits for the first seven weeks; also that there was no default on the part of the Secretary. In regards to the second specification, there was not, in my opinion, sufficient evidence adduced to decide as to whether Bro. Wriglesworth was really well and attending to business during the alleged three weeks convalescence, and I therefore requested both parties to forward me additional evidence, if any, on this point.

After having looked carefully over all the evidence produced, as to the second sickness of Bro. Wriglesworth, it appears that Bro. Wriglesworth's attendance at business during the three weeks in April, 1892,

was only such attendance as would be given by a partially sick person, and that the trip to Vancouver and New Westminster was practically a voyage for health rather than pleasure or business. Further, even admitting, for the sake of argument, that Bro. Wriglesworth's partial attendance to business could be construed into recovery, he failed to cause himself to be so reported, which in his case (being out of standing at the commencement of his illness) he should personally have attended to, either by a visit to the Lodge or by letter, the General Law not making it incumbent on any particular officer to report a Brother well, and the by-laws of Dominion Lodge, No. 4, being silent on the matter. I am of opinion that the duty fairly devolved on the convalescent Brother. Taking into consideration the evidence adduced, the surrounding circumstances, and the absence of any law on the subject, I feel that the neglect of Bro. Wriglesworth to report himself well, is fatal to his demand for benefits for what he contends is the second portion of his illness. The action of Dominion Lodge, No. 4, is therefore sustained. After giving my decision on the case I received on July 19th, 1893, a communication from Bro. J. Wriglesworth, P. G. M., stating that he had given notice of appeal to the Grand Secretary, and it has accordingly been laid before the Committee on Appeals. Bro. M. Duffie resigning from said committee I appointed Bro. H. Waller, P. G. M., to fill the vacancy.

DECISIONS.

November 24th, 1893, I received a communication from Bro. James Mathie, Secretary of Selkirk Lodge, No. 12, asking me for my decision on the following questions, viz. :

1st. Can a Brother receive the Third Degree, or any other, and be considered on the sick list? Answer—Yes; but only entitled to the benefits appertaining to the degrees obtained before becoming sick.

2nd. Is a certificate certifying that a Brother is going to be sick for three months, or any other length of time, good for benefits? Answer—No. The certificate must be for a period of past actual sickness and not for prospective illness.

3rd. Is a Brother entitled to Third Degree benefits from the night he receives the Third Degree, or has he to be a member of the Third Degree six months before he can claim Third Degree benefits? Answer—He must be a member of the Order six months to receive benefits, the amount to be regulated by the Degrees taken at the time.

May 10th, 1893, from Ashcroft Lodge, No. 23 :

Can we pay the hotel bills of Brothers who assisted at the institution of our Lodge, constitutionally? Answer—No.

May 23rd, 1893, from Union Lodge, No. 11 :

Can an outsider play the organ at the public installation of the officers ? Answer--Yes.

July 15th, 1893, from Vancouver Lodge, No. 8 :

Is it necessary to notify each and every Lodge in this jurisdiction of the suspension of Brothers for non-payment of dues ? Answer--Yes. See Art. VII., Sec. 6, Constitution, governing Subordinates.

July 18th, 1893, from Kootenay Lodge, No. 16 :

Is it imperative for officers of a Lodge to wear jewels, according to their respective rank and station ? Answer--Yes. See page 333 of White's Digest.

July 29th, 1893, from Ashcroft Lodge, No. 23 :

Is it constitutional for us to hold an election of officers for the July term, our Lodge being instituted on the 30th March ? Answer--Yes. See page 239, No. 983, of White's Digest.

May 1st, 1893, to New Westminster Lodge, No. 3, to hold an excursion to Nanaimo on the 24th May.

May 13th, 1893, to Cloverdale Lodge, No. 15, to hold their annual ball on June 8th.

May 23rd, 1893, to Black Diamond Lodge, No. 5, and Centennial Lodge, No. 20, to appear in regalia on the 24th of May to meet the Brothers from New Westminster.

May 27th, 1893, to Union Lodge, No. 11, to hold a public installation of officers.

June 5th, 1893, granted permission to New Westminster Lodge, No. 3, to confer the three degrees of Odd Fellowship on Bro. Wm. Bartlett in less time than the law provides.

June 19th, 1893, to Centennial Lodge, No. 20, to wear their regalia in open Lodge in connection with their first anniversary.

July 27th, 1893, to Victoria Lodge, No. 1, Columbia Lodge, No. 2, Dominion Lodge, No. 4, and Acme Lodge, No. 14, to hold an excursion from Victoria to Seattle on the 12th August.

August 8th, 1893, to Royal City Lodge, No. 13, to hold their annual picnic on August 15th at Ladner's Landing.

August 8th, 1893, to Vancouver Lodge, No. 8, to hold their annual excursion and picnic on the 17th August.

September 21st, 1893, to Vancouver Lodge, No. 8, to initiate and confer the three degrees on five gentlemen from Lulu Island for the purpose of starting a new Lodge.

September 25th, 1893, to New Westminster Lodge, No. 3, and Royal City Lodge, No. 13, to appear in regalia on the 27th September.

September 25th, 1893, to Centennial Lodge, No. 20, to appear in regalia on the 27th September.

November 16th, 1893, to Gold Range Lodge, No. 22, to hold their annual ball in the name of the Order, on December 5th.

November 11th, 1893, to Cloverdale Lodge, No. 15, to hold their meetings on the ground floor, there being no other place convenient.

November 19th, 1893, to Excelsior Lodge, No. 7, to appear in regalia to attend Divine service on Thanksgiving Day.

December 1st, 1893, to Columbia Lodge, No. 2, to hold a concert and ball in the name of the Order.

December 17th, 1893, to Excelsior Lodge, No. 7, to hold a public installation of officers.

December 11th, 1893, to Vernon Valley Lodge, No. 18, to hold a public entertainment in the name of the Order.

December 29, 1893, to Kootenay Lodge, No. 16, to have a supper and ball in the name of the Order, on January 11th, 1894.

SPECIAL PERMISSIONS.

June 16th, 1893, I received a communication from the General Relief Committee of Fargo, North Dakota, asking for permission to solicit the fraternity in this jurisdiction to aid them in caring for Brethren rendered destitute by a fire in their city. Considering the appeal worthy of our assistance and Brotherly Love, I granted the permission.

November 8th, 1893, I received a letter from J. C. Murphy, N. G. Cloverdale Lodge, No. 15, stating that they had met with a very serious loss by the burning of their Hall. I received communications from different parts of the jurisdiction suggesting that as this Lodge had lost everything it would be advisable to appeal to the Lodges of this jurisdiction to aid them in their time of need, I therefore issued the following appeal :

NANAIMO, 28th November, 1893.

To the Officers and Members of Lodges, I. O. O. F.:

DEAR SIRS AND BROTHERS, I very much regret to inform you that on the evening of Tuesday, the 7th instant, the Hall of Cloverdale Lodge, No. 15, I. O. O. F., Cloverdale, B. C., with all the books, regalia and paraphernalia of the Lodge, was totally destroyed by fire, involving a loss of about \$3000.

This is such a serious disaster to a young Lodge that I deem it of sufficient importance to solicit, not only the sympathy, but the fraternal assistance of the Lodges of this jurisdiction, on behalf of this unfortunate Lodge in its hour of need, in full confidence that the appeal will meet with a liberal response.

May I ask, therefore, that you will forward whatever sum you are disposed to contribute, to Bro. F. Davey, Grand Secretary, at as early a date as possible, for transmission to Cloverdale Lodge.

Brothers, as my term of office is now expiring, and I am about to

give up its responsibilities to another. Let the work of beneficence in which we are engaged go on, and let our legislation be marked with Friendship, Love and Truth. In considering my official actions, I have only this to say, I have tried to do my duty, and I have done my best; if I have not given you satisfaction, I hope you will pardon my unintentional mistakes. May each succeeding session produce increased prosperity, and may it more firmly cement the bonds of fraternal love which now unite and bind us. Again, thanking you one and all. I submit this report for your favorable consideration.

April 13th, Victoria Lodge, No. 1, submitted the following questions for my official opinion :

1st. Are all members of the Third Degree entitled to have the Degree of Rebekah conferred on them free of charge? Answer—All Third Degree members in good standing are entitled to have the Degree of Rebekah conferred on them free of charge. (Section 1183 Digest.)

2nd. If so, who must confer the same? Answer—The Degree of Rebekah shall only be conferred by Degree Lodges of the Daughters of Rebekah, except in compliance with Sect. 1166 Digest.

3rd. Is it imperative for elective officers of Subordinate Lodges to be in possession of the Degree of Rebekah prior to their installation into office? Answer—It is not necessary for elective officers of Subordinate Lodges to be in possession of the Degree of Rebekah prior to their installation into office. (Sect. 1007 Digest.)

May 17th, Columbia Lodge, No. 2, asked for a dispensation to hold their second nomination night on May 31st, being election night, as May the 24th was a legal holiday. Granted.

July 3rd, installed the officers of Victoria Lodge, No. 1, in regular form.

July 5th, installed the officers of Columbia Lodge, No. 2, in regular form.

July 6th, installed the officers of Dominion Lodge, No. 4, in regular form.

July 10th, installed the officers of Acme Lodge, No. 14 in regular form.

July 12th, Columbia Lodge, No. 2, submitted the following for my official decision :

Is it absolutely necessary that the name of a Brother "who has ceased membership for non-payment of dues" be entered in the "Black Book"? Answer—No.

September 25th, Acme Lodge, No. 14, asked for a dispensation to confer the second and third degrees on Bros. Campbell and McKenzie in less time than required by law. Granted.

October 9th, Columbia Lodge, No. 2, asked for a dispensation to confer the three degrees of our Order upon Bro. L. M. Congers in less time than required by law. Granted.

November 27th, Victoria Lodge, No. 1, asked for a dispensation to elect a Scarlet Degree member to the office of Noble Grand, as the Vice Grand declined the nomination, and no other qualified members offered themselves for that office. Granted.

Can the Noble Grand of a Lodge of the I. O. O. F. be elected to the position of Trustee of same Lodge, or can a member be elected to two offices in the same Lodge? Answer—A member cannot be elected to two offices in the same Lodge, except Recording and Permanent Secretary, the elective officers of a Lodge of the I. O. O. F. are Noble Grand, Vice Grand, Recording Secretary, Permanent Secretary and Treasurer. Trustees are not officers of the Lodge in the sense it is used in Article 7, Section 1, of the Constitution of Subordinates for reference. See Digest, Article 1507, 944, and page 498.

Owing to circumstances over which I had no control, I was prevented from conducting the installation of the several Lodges in this district for term commencing 1st January, 1894, and I accepted the kind offer of Bro. H. Waller, P. G. M., to do the work for me, which was done in good style. The Lodges in this district have been progressive this last year, as will be seen by the reports.

DEAR SIR AND BROTHER.—Your communication of the 29th ultimo was handed to me on the 5th instant. This communication asks for my "opinion on the meaning of the following sentence in Article 20, Section 1, of your By-Laws": "And no brother shall be entitled to benefits until he shall have been a member six months." You then stated the case and asked for a decision as follows: "A brother was admitted a member of this Lodge *by card* on April 13th, 1893, and died May 24th, 1893. Is his widow entitled to widow's benefits and funeral expenses?"

As to the first point I do not think it would be within my duty to give an opinion or determine what the *intent* is under the section of your by-laws above quoted. I cannot speculate or conjecture as to the intentions of those formulating the by-law, but must be bound by what the law in plain terms declares.

I understand the contention to be that the words "a brother" meant to imply "a brother of the Order," but the by-law referred to is not a general law of the Order, it is a by-law of Western Star Lodge, and can therefore only apply to a member of that Lodge. In the case above referred to in which you asked, "Is a widow entitled to widow's benefits and funeral expenses," I would say that under the first paragraph of Section 4, Article 20, of your By-Laws, the payment of funeral expenses is *conditional on the brother being entitled to sick benefits*, the said section reading, "On the death of a brother entitled to benefits a sum not exceeding sixty (\$60.00) dollars shall be appropriated and paid by the N. G. towards defraying his funeral expenses." The question of payment of funeral expenses therefore devolves on the entitlement of the brother "to benefits" and your by-laws state in plain language, "No brother shall be entitled to *benefits* until he shall have been a member six months." The deceased brother, as stated by you, became a member of

your Lodge on April 13th, 1893, and died May 24th, 1893, he, therefore, not being in membership for the required six months, the Lodge is not liable for funeral expenses incurred. Your by-laws make quite a distinction between *funeral expenses* and *widow's benefits*, and while the Lodge is not liable for funeral expenses the widow of the deceased is entitled to receive widow's benefits. Article 29 of your By-Laws reads as follows: "The widow of any deceased *bona fide* member of this Lodge who was not in arrears at the time of his death shall receive from the Widow's and Orphans' Funds of this Lodge an amount equal to one (\$1.00) dollar per member in good standing at the time of his death." In this by-law there is no time stated of necessary membership to entitle to widow's benefits. It appears to me that the law is very clear, "any deceased *bona fide* member not in arrears." The deceased brother was a *bona fide* member, he was in good standing (*i. e.* not in arrears), and there is no proviso in this by-law to debar his widow from widow's benefits.

DEAR SIR AND BROTHER,—Herewith I beg to present, for your approval, a report of my official acts, &c., as your Deputy for District No. 10, I. O. O. F., comprising Cloverdale Lodge, No. 15.

My duties have been light and always of a pleasant nature. The Brethern of this district being imbued with an intensely law abiding spirit, consequently I have had no knotty questions to unravel.

As will be observed by reference to the semi-annual reports, Cloverdale Lodge has managed to hold her own, in regard to membership; several Brothers have been suspended, and several have been added to our numbers. Within the year our Brethern have been very much scattered, Cloverdale Lodge having representatives in New Brunswick, Ontario, Manitoba, North West Territories, the States, South Africa, &c.

Granted dispensation to Cloverdale Lodge, No. 15, to confer three degrees in one night on Bro. William Frampton.

Granted dispensation to Cloverdale Lodge, No. 15, to confer three degrees on Bro. G. McKinley in one night, it being impossible for the Brother to be but seldom present in Lodge,

July 7th, 1893, assisted by Past Grand, Bro. E. Julian, of New Westminster Lodge, No. 3, I installed the officers of Cloverdale Lodge, No. 15, in regular form.

On the evening of November 7th, 1893, the fine new Hall, together with all its contents, Lodge furniture, regalia, &c., books, records, &c., was completely destroyed by fire. This unfortunate circumstance was a very serious blow to Cloverdale Lodge.

But right here the fraternal aspects of our beloved Order shone forth. Royal City Lodge, No. 13, immediately upon receipt of the information, by resolution appropriated \$50 toward assisting the burnt out sister Lodge. Our Worthy Grand Master issued an appeal to the Lodges in the jurisdiction, also on their behalf, which resulted in the sum of \$649.50 being subscribed by the Brethern for the relief of Clover-

dale Lodge. For this very opportune assistance I desire to express the thanks of Cloverdale Lodge, No. 15, to yourself, the Grand Secretary, and the Brethern throughout the jurisdiction.

Although the success of the past year is not equal to that of the preceding one, yet I think we can congratulate ourselves on making fair progress, despite the many adverse circumstances which have operated against almost every undertaking during the year.

There has been a gain of two Subordinate and one Rebekah Lodge, and an increase of 200 in membership.

The details of the work of the year are set forth in the following abstract of the reports of the Lodges, from which it will be seen that in many important points the results are satisfactory. There has been a reduction in the average amount of sick benefits paid per member, and, on the other hand, the average amount of available assets has materially increased. The amount disbursed for current expenses is, however, still high, being about 38 per cent. of the gross receipts. This is a matter which should receive the serious attention of the Lodges :

The sum of \$90 deposited with P. G. M. Phillips by Dominion Lodge, No. 4, pending its appeal against his decision in the case of the General Relief Committee, Seattle, Wash., has been remitted to the said committee and its receipt obtained.

The instructions of last session respecting bond of Grand Treasurer have been complied with, and the agreement of the London Guarantee & Accident Co. for \$1,000 for the past year is on file.

An appeal has been received from Bro. J. Wriglesworth, P. G. M., against the decision of the Grand Master on his claim for sick benefits from Dominion Lodge, No. 4, and handed to the Committee on Appeals.

I am in receipt of an appeal from Bro. George Fraser against the action of Vancouver Lodge, No. 8, in expelling him from membership in that Lodge for contempt, but as the papers bearing on the case have not yet been received from the Lodge I have been unable to forward it to the Committee on Appeals.

The annual report from "Ruth" Rebekah Lodge, No. 4, Chilliwack, has not yet come to hand, and as Bro. Peers, D. D. G. M., District No. 5, informed me in July last that this Lodge had not held a meeting during the preceding term, and might be regarded as defunct, I would suggest that the Grand Lodge take such action as it may deem proper to recover the Charter and other property of the Lodge if there is no prospect of its working in regular order again.

An application was received from the Odd Fellows' Relief Association of Canada in May last addressed to the Executive Officers, asking for

recognition in order to carry on its work in this jurisdiction, but as a similar application was refused by the Grand Lodge at its session of 1891 your officers were unable to concede the request, and the Association was advised to renew its application to this session. I beg to present a communication from Bro. Meek, the Secretary, on this matter:

I beg to point out that by the legislation of the last session of the Sovereign Grand Lodge it will be necessary for this Grand Lodge to appoint a Standing Committee of three members for the purpose of collecting statistics from the records of this jurisdiction on matters relating to dues and benefits.

The rules adopted last session for this Association were duly revised by the committee appointed for this purpose, registered and distributed; a form of policy was also adopted and brought into force, as per copy attached, at as early a date as possible after the adjournment of the Grand Lodge.

Agents were also appointed in almost every Lodge of the jurisdiction, but many of them, I regret to say, appear to have taken but little interest in the work, it will be necessary, I think, to appoint a suitable person as special agent to supplement the efforts of the local agents.

The required report was furnished the Sovereign Grand Lodge, the necessary fee of \$10 paid, and a certificate obtained to permit the Association to work under the law respecting insurance societies passed at the session of 1892. By an approved decision of the Grand Sir last session associations such as this are exempt from the provisions of the before-mentioned legislation, and do not now require to be licensed by the Sovereign Grand Lodge.

The first assessment under the new Rules was levied on 1st July last, since which date they have been regularly levied bi-monthly.

Only one death has occurred during the year. Bro. Wm. Steele, P. G., of Victoria Lodge, No. 1, who died on the 1st September last, and the maximum amount of insurance, viz.: \$1000 being on hand, an order was drawn for this sum and duly paid to the beneficiaries of the deceased at the time specified in the Rules. Bro. Steele was a member of the association from the date of its formation and had paid 13 assessments aggregating \$23.25. We have thus been able to realize on the first occasion, after the reorganization of the association the object for which the change was made, viz.: to be able to pay an Insurance of \$1000, and it rests entirely with the membership of this jurisdiction whether this desirable feature shall be perpetuated or not. The members of the Association, who are the most interested parties, should not forget that it is a mutual organization, that each must do his part, and that very much of its success depends on their individual efforts, they should, therefore, introduce and recommend it to their friends, endeavor to bring in new members, encourage those who are wavering and not expect the officers of the Association to do all the work.

H. Waller, P. G. M., presented and read the Report of the Grand Representatives, which was ordered to be received and printed with the proceedings of this Session.

VANCOUVER, B. C., February 14th, 1894.

To the Grand Master and Representatives of the Grand Lodge of the Province of British Columbia, I. O. O. F.:

Your Representatives to the Sovereign Grand Lodge, ask leave to submit, for your approval, their report as follows :

The Sixty-ninth Annual Session was held in the City of Milwaukee Wisconsin, opening on Monday, September 18th and closing on Saturday, September 23rd.

The Grand Marshal, having declared all the Representatives present duly qualified, the Grand Chaplain, Bro. Rev. J. W. Venable, offered prayer, and the Sovereign Grand Lodge, was declared duly opened for business by Deputy Grand Sire J. W. Stebbins.

The Grand Sire, Cl. T. Campbell, as usual, was courteous, affable and kind to all, and his ability for that honorable position, was fully demonstrated by the able manner in which he gave his decisions on all points of law submitted to him, and the quick dispatch of the business of the Session.

We submit, for your perusal, the most interesting portions of the Grand Sire's Report :

REPRESENTATIVES—I welcome you to the Sixty-ninth Annual Session of the Sovereign Grand Lodge, in this beautiful city, by the inland seas of America. After a year of labor in your own jurisdictions, you have re-assembled for mutual counsel; to review the work of the Order; to overlook its situation; to regulate its operations; to meet the requirements of its future.

Never before have you met under happier auspices; never before have you been greeted by brighter prospects. Only a short distance from this city, the nations of the earth are engaged in friendly rivalry, as they display the choicest products of their energy and enterprise. The labor of the husbandman; the skill of the artisan; the genius of the artist; the patient industry of the student, have combined to show the highest mental and manual development of the human race. With less ostentatious parade you are here uncovering to public gaze a grander exhibition of man's moral and social development through the educative influence and practical operations of Odd Fellowship. As the representative parliament of this great Order your annual assembling emphasizes the vast extent and beneficent power of this association, organized for mutual helpfulness, and for the cultivation of those virtues that alone can raise humanity out of barbarism, and lift it nearer to its most holy pattern. And while the magnificent exposition in Chicago reveals the intellectual capabilities of our race, the work of the Order whose destinies you direct illustrates the grand possibilities that lay dormant in

the human heart until the Spirit of Altruism breathed into it the breath of a diviner life, and awakened its sublimest aspirations. Humanity may well be proud of the revelations of the fairy palaces of the White City on the Lake; but no less cause for pride have they whose labors have erected the stately temple of Odd Fellowship, wherein the noblest works of Friendship, Love and Truth stand radiant with beauty and with blessing.

The report of your officers presented to day, with their accompanying statistics, show that

THE STATE OF THE ORDER

is eminently satisfactory. A net increase in our numbers during 1892 of over 50,000—unprecedented in our history—has given a membership at the close of that year, in the jurisdictions reporting directly to you, of 747,295; making, with the estimated number under the independent Grand Lodges of 26,136, and the 96,312 Sisters in the Rebekah branch, a grand total of 869,743. So far as can be learned, the increase this year is still greater than in 1892; but even at the same rate our total membership to-day, male and female, will be over 900,000. An association that has attained such vast proportions, with an annual revenue of eight and one-half millions of dollars; increasing rapidly each year in wealth and numbers, may well be proud—not of the rank and position these elements of strength may bring—but of the opportunities that are thus brought within its reach of accomplishing the great objects of its existence—the relief of human suffering and the advancement of the human race. Scarcely can the magnitude of its work be estimated. To say that the subordinate branches of our Order expended last year nearly three and one-half millions of dollars for the assistance of those in need; to point to the many towns on this continent where comfortable homes are maintained as refuges for the young and for the old, who might else be homeless; to enumerate all the educational and charitable institutions conducted under our auspices might give some tangible evidence of the beneficent work of Odd Fellowship. But a still greater work remains untabulated in the silent and unobtrusive influence exerted on society through the operations of our 15,000 subordinate branches, wherein, week after week through all the year, are taught those lessons of morality, charity and fraternity which our members carry into practical effect in their intercourse with each other and the world at large.

While Odd Fellowship has become so widespread, carrying on its operations in Europe, Asia and America under the flags of not less than fifteen nations, and almost encircling the civilized world with its chain of Lodges, it is in the United States and Canada that it has attained its greatest power, and has become a recognized factor in the development of civilization. Exceeding all other secular societies on this continent in numbers, so far as can be ascertained, it acknowledges no superior among them all in the vast extent of its benevolence. Yet, though its prosperous condition in North America is more familiar to us, and its career more noticeable, the fact must not be overlooked that

its work is no less satisfactory, when surrounding circumstances are considered. While its growth may not be as marked as with us, yet it has been sufficient to be encouraging. In Australasia depression in trade and financial disturbances may affect our Order as it does all other organizations; but there is no reason to be alarmed for the future of Odd Fellowship, which is too firmly planted in those distant lands, and well able to battle successfully with adverse circumstances.

From the continent of Europe we have most cheering reports through our Special Deputy, Grand Representative Block. (Off. Doc. C.) The appointment of our esteemed brother to the position he now occupies was the outcome of a wise policy, as is evidenced not only by the steady progress the Order has been making in the jurisdictions which he has been visiting, but also in the letters which I have received from leading Odd Fellows in Europe, who all speak in the highest terms of our Deputy, and gratefully acknowledge the valuable assistance they have received from him. At first some doubt was felt in Germany lest the appointment of a Special Deputy for Europe might have been prompted by a fear on our part that irregularities existed in that jurisdiction in the management of Odd Fellowship, which required correction. Of course this was a mistaken idea. The appointment was not intended as a reflection on the zealous and enthusiastic brethren who have been so successful in carrying on the work of the Order in Germany for the past twenty years. But, with a number of jurisdictions in Europe, it would have been an invidious distinction to have selected some as the special objects of our Deputy's attention, and to have excluded others. And while some parts of the continent might have needed a supervision from which others could have been relieved, yet all would be benefited by having near at hand an experienced brother with whom they might take counsel, and who would serve as a vital connecting link between the S. G. L. and the various bodies to whom we have given a *quasi* independence. I have reason to believe, however, that our brethren now thoroughly understand the situation, as the cordial reception they have tendered Bro. Block amply testifies.

THE REBEKAH DEPARTMENT.

No branch of the Order has made more gratifying progress than this. The enthusiasm which woman has shown and the energy she has brought to bear on her work have made her department an unqualified success; and justifies her claim to the fullest recognition as an essential element in Odd Fellowship. The special committee appointed at your last session will doubtless submit a codification of the laws governing Rebekah Lodges, which is referred for your sanction.

OUR RELATIONS WITH THE CATHOLIC CHURCH.

During the year I was informed that the authorities of the Roman Catholic Church had appointed a committee of Bishops to inquire into the character of benevolent and other organizations, with a view to deciding whether Catholics might be allowed to apply for admission therein. And a letter was written by one of the committee, in which he asked permission to examine our books and Rituals. The letter and my reply are submitted. (Off. Doc. E.) While advising that all possible information be given the committee, I, of course, declined to allow them a perusal of our Rituals—a privilege belonging solely to those who have taken the obligations of the Order.

I have heard nothing further on this subject, and have made no inquiry. The matter is one which does not materially concern us. Our doors are open to Catholics as well as Protestants, if they are properly qualified. With disputed questions of creed we have nothing to do. If the authorities of the Catholic Church forbid their adherents seeking admission to our Order, the loss is theirs. The position Odd Fellowship occupies renders it unnecessary for us to seek the recognition of any particular sect or party, though we will be pleased, at all times, to have the support of all good men, of whatever race, or creed, who reverence God and seek the advancement of humanity.

IN CONCLUSION,

Representatives, I invite your serious attention to the duties of the high offices you fill. Grave, indeed, are the responsibilities resting on those who occupy seats in the Supreme Legislature and Court of Last Resort for Odd Fellowship. It is for you to redress personal grievances, to harmonize divergent views, to devise sound laws. From all over this broad continent, and from many distant lands, 800,000 men look to you for judgment and for direction. Unmeasured is the power you may exert to make or mar the association, whose interests you have in charge. May Divine Wisdom so inspire and guide you that your work may be a blessing, and be blessed.

REPORT OF THE GRAND SIRE'S DECISIONS.

1. In any conflict between the "Floor Work" and Ritual or law, the latter must govern.

2. The obligation to a candidate must be administered by a V. G. or P. V. G. Where the instructions in "Floor Work" say that "positions on a staff are to be governed by the question of fitness," it means fitness within the limitations of law.

3. Where a Lodge (Subordinate or Rebekah) has organized a competent staff, all the members being legally qualified for their positions, the officers of the Lodge must vacate their chairs to the *pro tem.* officers of the staff, when degrees are being conferred.

No. 3 disapproved.

4. A. P. G. should wear a P. G.'s collar in Lodge (if obtainable), and should neither enter, leave nor remain in a Lodge when open without it.

5. It is optional with a P. G. M. when visiting a Lodge to announce himself as P. G. M. or P. G.

6. During the absence of a N. G. the V. G. shall perform all the duties devolving upon the N. G. which require to be performed at that time. The immediate filling of a vacancy in an appointed office during a temporary absence of the N. G. might not be necessary, and would not, therefore, devolve upon the V. G. unless the Lodge so instructed him.

7. When the officers of a Lodge or Encampment under the S. G. L., being duly elected and properly qualified, are installed by the D. D. G. Sire, or other person authorized by the Grand Sire, and have taken the obligations of office, such installation is valid, although there may have been certain irregularities connected with it.

8. A member of a lodge acting as counsel for a Brother under trial has the same right to vote on the penalty that he would have were he not counsel.

9. When charges against a Brother has been referred to a Committee on Trial the committee cannot allow the accuser to amend the charges by introducing new specifications, not contained in the original charge. Supplemental charges might be preferred in the Lodge and referred to the committee.

10. The Minimum Benefit Law of 1892 being practically a repeal of the law of 1891, revives the powers of Grand Bodies, which were abrogated by the latter. On and after January 1st, 1893, the powers that were withdrawn from subordinates in the matter of benefits by the legislation of 1891 may be exercised by them to the same extent as prior to January 1892, except in so far as they may conflict with the requirements of the Minimum Benefit Law—that is to say, the payment of not less than \$2 per week for the first year of continuous sickness, and not less than \$1 per week during the further continuance of the same sickness.

11. The requirement of the Minimum Benefit Law that not less than one year's benefits shall be paid before the amount can be reduced below \$2 per week, is substantially fulfilled by the payment of benefits for fifty-two weeks.

No. 11 amended thus: "Fifty two consecutive weeks."

12. If a Lodge does not pay benefits for the first week of sickness, the reduction in the amount of weekly benefits does not take place at the end of a year's disability, but only after a year's benefits have been paid.

13. When a Lodge has been paying a sick member continuous benefits for several years, it will now be required to pay him not less than \$1 per week, commencing with the 1st of January, 1892.

14. Whether or not a Lodge may provide by its by-laws for the payment of a larger weekly benefit to sick Brothers who are confined to the house than it does to those not so confined, is a matter for local legislation, provided that under no circumstances it pays less than the minimum benefit required by general law.

15. Where a Lodge provides for "night watchers" for sick members, this is to be considered as a form of "attentive benefits," and any expense incurred in payment of such watchers is altogether apart from the sick benefits due under the general or local law. But when provision is made for hiring a nurse, the local law may also provide for a reduction of sick benefits during the time such nurse is engaged, on condition that the aggregate amount paid for nurse hire and benefits shall not be less than the sum to which the sick Brother is entitled under the Minimum Benefit Law.

No. 15 amended, by striking out all after "local law" in fourth line.

16. It is not legal for a Lodge, with or without the consent of its Grand Lodge, to have a by-law providing for the initiation of persons over 55 years of age as, "non-beneficial members;" or changing the status of one already a member of such Lodge from a beneficial to a non-beneficial member on reaching a certain age. Members in good standing are entitled to benefits irrespective of age—the only exception permitted by general law being in the case of aged Odd Fellows re-admitted to membership.

17. A Lodge having knowingly admitted a non-resident member to membership in violation of its Constitution, and having received his fees and dues, cannot, when he becomes ill, refuse him benefits, and declare his membership void, on account of its illegality. The Lodge cannot take advantage of its own violation of law to escape payment of its debts.

18. A lady elected to membership in a Rebekah Lodge, but marrying a person not an Odd Fellow before she has received the degree, is not entitled to admission, and ceased to be eligible on the date of her marriage.

19. In a jurisdiction where Rebekah Lodges have yearly terms, the T. P. W. may be for the year, or there may be a P. W. for each half year, at the option of the Grand Lodge.

20. A Brother who has received the Rebekah Degree in a Grand Lodge or in a Rebekah Lodge, is eligible to be an applicant for a Charter for a Rebekah Lodge, or to be admitted to membership in such Lodge after its institution, on a favorable ballot, provided he is in good standing in his Subordinate Lodge, and is not a suspended or expelled member of a Rebekah Lodge.

21. A State or Provincial Rebekah Convention has no power to impose a tax on the Rebekah Lodges of the Jurisdiction for any purpose. But the Grand Lodge of the Jurisdiction may impose a tax on its

Rebekah Lodges, collect the same, and pay the amount over to the Rebekah Convention, for its maintenance.

22. When a Grand Master, in the exercise of his supervisory powers, suspends a Lodge for violation of law, he has power to restore it without waiting for action by his Grand Lodge, unless the Constitution or instructions of his Grand Lodge limit his authority in this respect.

23. A Grand Master has the right to appoint a P. G. in good standing, who is in possession of the Rebekah Degree, as his Deputy, to institute a Rebekah Lodge.

No. 23 amended thus: A Grand Master has the right to appoint a Past Grand who is also a member in good standing in a Rebekah Lodge as his Deputy to institute a Rebekah Lodge.

24. The interpretation of the Constitution of a Grand Body during its recess, is vested in its principal officer, subject to a review by such Grand Body at its session following; and it is the duty of such officer to administer the local law according to his conscientious interpretation thereof. He may seek the Grand Sire's opinion thereon; but such opinion, if given, is not necessarily mandatory. The responsibility of interpreting and executing the local law rests on the Grand Master and Grand Patriarch.

25. Subordinates have a right to make By-Laws for their internal government. A Grand Body cannot make By-Laws for its Subordinates, but has the right of supervision, and may approve or disapprove. It may frame a model code of By-Laws, and recommend the same to its Subordinates, but cannot compel its adoption. It can, however, enact a uniform Constitution, and may therein regulate the matter of benefits so far as the general law allows; and the By-Laws of Subordinates must conform to such Constitution.

26. A committee of a Grand Body appointed to supervise the By-Laws of its Subordinates has no right to make new laws for them, or to disapprove By-Laws which are not in conflict with law; and it can only amend a by-law in so far as may be necessary to make it conform to the general or local law.

27. In petitioning for a Charter for a Grand Lodge, there is no limit to the number of members who may sign the petition, provided they are Past Grands in good standing who have been authorized to act by vote of the Subordinates in which they hold membership. As soon as instituted, the Grand Lodge can proceed to adopt a Constitution, and fix its basis of representation.

28. When a Grand Lodge is instituted, all Past Grands in good standing in the jurisdiction become entitled to the exercise of their rights, which are, voting for Grand Officers and eligibility to office; but all legislative work in the newly-instituted Body is confined to the Charter members, that is, to those who have been chosen by the several Lodges to apply for the Charter, and who have been present and have taken the obligation at the institution of the Grand Lodge.

No. 28 amended thus: The Charter members have power to admit all Past Grands in good standing to participate in the legislative work.

29. The only qualification necessary for a P. G. to be a candidate for election as Representative of his Lodge in its Grand Lodge, is that he should be a member of his Lodge in good standing.

30. Executive officers of Grand Lodges have no option, but must grant licenses to Odd Fellows' Insurance Associations making application therefor, who have complied with the requirements of law, except in a jurisdiction where the Grand Lodge has decided not to license such Bodies.

31. An insurance organization, to be permitted to use the name of

the Order, or to receive the certificate of the S. G. L., must be one that confines its operations to Odd Fellows exclusively.

32. The right of a State Grand Body to organize and operate through its officers an endowment association has not been withdrawn; and such an association does not require any certificate from the S. G. L., or other license, so long as it does not go out of its own jurisdiction.

33. Voluntary associations of members of the Order in a town or city for purposes of mutual aid, whose operations are confined to their own locality, having no paid canvassers, and not doing a general business, do not require to take out an insurance certificate.

The Grand Secretary, as usual, submitted a very lengthy, able, and elaborate report, covering 107 closely printed pages of the proceedings, a perfect history of Odd Fellowship, for one year.

We simply reproduce for your perusal a small portion of his Report:

Generally, from the year 1873, when the present occupant of the position of Grand Secretary came into the office as Assistant Grand Secretary, it has pleased him to submit gratifying statements of the work of the several years. In a few instances a diminution of members was noted, but the depression was of a temporary character. He points with pride to the grand total of 747,295 members December 31st, 1892, contrasted with the 385,097 December 31st, 1872, showing that the membership has been nearly doubled in twenty years. The benefactions of the Order have, of course, been greatly increased, and a large amount has been added to the treasuries of subordinates, the revenue of the year 1892 amounting to nearly nine million dollars.

The numerous tables, which have been compiled with great care, and are herewith presented, state the situation so clearly that any elaboration seems useless. Words cannot add anything to, or emphasize in any respect, the brilliant array of figures showing the magnificent work performed in 1892. Under the circumstances now existing in financial circles we cannot reasonably expect to submit as favorable an exhibit for the year 1893; but we hope that if our gain in membership does not prove as great as in 1892 we may, at least, show that there has been no diminution in our present membership.

The Grand Sire in his report suggested that the S. G. L. should supply sufficient clerical assistance to the Grand Secretary, and not expect its officials to do more than would be demanded from the employes of any respectable firm.

The following resolutions were adopted:

1st. *Resolved*, That in addition to the salaries of Grand Secretary, and Assistant Grand Secretary, as now provided by law, there be allowed to the Grand Secretary for clerk hire, etc., in his office, per annum, the following amounts:

For additional work made necessary by devolving upon the Grand Secretary, the duties of Adjutant General, the sum of.....	\$1,000 00
For Stenographer and Typewriter.....	800 00
For Janitor, including duties of Porter.....	600 00
For Reading Clerk at Annual Session.....	30 00

2nd. *Resolved*, That the resolution found on page 5,482, Revised Journal of 1872, which authorizes the Grand Secretary, from time to time, as he may deem it necessary to do so, to appoint and remove such temporary assistants as may be required by him, be, and the same is hereby repealed.

3rd. *Resolved*, That the Chairman of the Finance Committee of this Grand Lodge be, and he is hereby directed to visit the office of the Grand Secretary once in each quarter, approve and countersign all orders drawn upon the Treasurer for the payment of bills necessary to be paid during recess, or when this Grand Lodge is not in session.

LEGISLATION, ETC.

One half of the sessions were taken up with framing a new Code of Laws for the Patriarchs Militant, this no doubt effects a very great saving in the expense of managing that branch of the Order compared with the old system, but it is a very radical change indeed, and let us hope it will work well.

After finishing the work of the P. M., the Representatives became very conservative, the various committees reporting adversely upon almost everything involving change referred to them and the S. G. L. adopting the same without comment, with few exceptions.

The special committee on Dues and Benefits, rendered a very lengthy and able report, accompanied with a suggestion that the Representatives copy the same in their reports. But this report covers 20 pages of the Proceedings, and we did not deem it necessary especially as the Grand Secretary is directed to have the report printed, and mail a copy to each Subordinate Lodge in Canada and the United States, so that the S. G. L. can obtain an expression of opinion from all the jurisdictions on this important question. We submit the concluding remarks in their report:

1st. That as a man grows older, his yearly average of sickness increases, and as a Lodge grows older, its proportion of old men increases and its payments for benefits increases.

2nd. That the average expectation of sickness and mortality must form the basis of any estimate of the proper relation of dues to benefits.

3rd. That a lodge should calculate what it is likely to be called on to pay in benefits when it has attained to full maturity, say the age of thirty-five, and not what it is paying during the early years of its existence.

4th. That a system of dues and benefits, to be perfectly fair and equitable, must recognize the comparative liability on account of the different ages of its members, and must charge them dues according to age when admitted.

5th. That no other form of benefit except sick and funeral should be provided without a proportionate increase in dues; and that all additional aid to members should take the form of a special relief to an extent dependent upon the circumstances of the case and the ability of the Lodge.

Your committee believe that the amended form of returns from Grand Bodies, provided for by change of the by-law on that subject at the last session, will furnish this committee and all members seeking information on the subject of dues and benefits, the cost of maintenance of Lodges, etc., great assistance in the study of the question. As yet it is not in practical operation.

LEGISLATION RECOMMENDED.

In view of the conditions hereinbefore fully set forth; realizing the

importance of our Order maintaining its position of systematic benevolence; absolutely certain from the experience of the older Lodges, and many jurisdictions that some action is necessary to secure to the membership the benefits required by this Grand Body to be paid to all members in good standing, your committee present the following and recommend their adoption:

1st. *Resolved*, That the minimum rate of dues in all Lodges immediately subordinate to this Grand Body, shall be ten cents per week, or \$5.20 per annum.

2nd. *Resolved*, That the sick benefits to be allowed in such Lodges per week, shall not exceed one-half of one year's dues—and the funeral benefits shall not exceed five times one year's dues.

3rd. *Resolved*, That Subordinate Grand Lodges be, and they are hereby directed, to so legislate as to provide a minimum of ten cents per week dues, or \$5.20 per annum, from all members.

4th. *Resolved*, That Subordinate Grand Lodges be, and they are hereby directed, to so legislate as to provide that not more than one-half year's dues shall be allowed for one week's sick benefits, and that a funeral benefit shall not exceed five times one year's dues.

Provided, However, That Grand Lodges may make such provision as they deem expedient for considering as dues, receipts of Lodges from safe, permanent investments.

5th. *Resolved*, That this committee be continued, and that the Grand Sire fill any vacancies therein.

The Sovereign Grand Lodge adopted the first and second resolutions, to govern all Lodges under their immediate jurisdiction, and referred the further consideration of the report to the next session.

The following Report from the same committee was adopted, and which we submit in full under instructions:

Your Special Committee on Dues and Benefits, believing that the membership generally of the Order should have information regarding sickness, deaths, expense of management, receipts from all sources, and all expenditures by subordinates, to the end that necessary legislation may be ultimately enacted, either by Subordinate Grand Lodges, or by this Grand Lodge, so regulating dues and benefits as to secure the permanency of the fundamental principle, that substantial benefits must be paid, we submit the following, and recommend its adoption:

1st. *Resolved*, That all Grand Lodges be, and they are hereby requested, to select a committee of three members, whose duty it shall be to consider the subject of dues and benefits in their respective jurisdictions, and, for the purpose of securing uniformity in the information to be collected and disseminated, we recommend that said committees examine the returns from Subordinate Lodges for the past ten years, and report to their several Grand Lodges the following, for each of said years:

- 1st. Members.
- 2nd. Number sick.
- 3rd. Weeks benefits paid.
- 4th. Deaths.
- 5th. Amount paid for sick benefits.
- 6th. Amount paid for funeral benefits and funeral expenses.
- 7th. Amount paid for widowed families.
- 8th. Amount paid for relief and education of orphans.
- 9th. Amount paid for special relief.

- 10th. Amount paid for total relief.
 11th. Average sickness per member.
 12th. Average cost per member for total relief.
 13th. Average cost per member for current or working expenses of Lodges.
 14th. Current, or working expenses of Lodges.
 15th. Total cost per member for all Lodge expenditures.
 16th. Receipts for dues.
 17th. Receipts from initiations and degrees.
 18th. Receipts from rent of property, and other investments.
 19th. Total receipts of Lodges.
 20th. Net increase, or decrease in value of real estate, at fair cash value, and of good securities and cash.
- 2nd. *Resolved*, That Grand Lodges be further requested to maintain such Committee on Dues and Benefits, and to the facts suggested to be collated for the past ten years, said committee likewise tabulate like facts for succeeding years.
- 3rd. *Resolved*, That Representatives report this action to their several Grand Lodges.
- 4th. *Resolved*, That this committee be continued, and the Grand Sire fill any vacancies.

Sec. 672 White's Digest, amended so as to apply to Rebekah Lodges, as well as Subordinate Lodges and Encampments.

That members can apply for affiliation on a visiting card.

That Section 91 of White's Digest (1889) be and the same is hereby amended so as to read as follows:

Resolved, That the only persons who are the beneficiaries of a funeral benefit are the widow, orphans under the age of twenty-one years, or dependent relatives of the deceased, or relatives upon whom the deceased was dependent at the time of death. Dependent relatives are relatives who were members of the family of the deceased and were dependent upon the deceased for support at the time of death.

APPEALS.

There were twenty-five appeal cases altogether, and we submit for your perusal two of the most important:

Your Committee on Appeals having fully examined and considered the record on appeal in the case of Franklin Lodge, No. 23, I. O. O. F. vs. the Grand Lodge, I. O. O. F., of Massachusetts, respectfully report:

STATEMENT OF FACTS.

W. T. Plaisted, P. G., a member of Franklin Lodge, residing in Somerville, Mass., was sick and under the care of Oasis Lodge, of that place, during the entire year 1892.

Oasis Lodge, deeming it necessary, employed watchers to attend Bro. Plaisted until September 10, 1892, at which time, on the report of a committee from Franklin Lodge which visited Bro. Plaisted, and at the request of Franklin Lodge, Oasis Lodge withdrew the watcher. Bro. Plaisted's son (Mr. H. F. Plaisted) protested to Oasis Lodge, on behalf of his father, against the withdrawal of the watcher.

On October 5th, Mr. H. F. Plaisted (who is not a member of the Order) finding that he could not give proper attention to his father and attend to his daily employment in the city, "decided to employ a nurse himself."

It does not appear from the record that a nurse was *in fact* employed by Mr. Plaisted, unless it may be inferred from the subsequent presentation of a bill for "furnishing watchers for his father, for fifty, nights, at \$2.00, \$100.00.

It does not appear that Mr. Plaisted consulted either Oasis Lodge or Franklin Lodge about his decision of October 5th to employ a nurse, prior to November 18th, on which date Franklin Lodge ordered Oasis Lodge to again employ watchers for Bro. Plaisted. This Oasis Lodge did on November 23rd.

Mr. H. F. Plaisted then presented a bill to Franklin Lodge for \$100.00 "for furnishing watchers for his father from October 5, 1892, to November 23, 1892, inclusive, fifty nights, at \$2.00."

Franklin Lodge refused to pay the bill, claiming that it was not correct, as it covered the time when the watcher was withdrawn by their order.

From this action of the Lodge, Bro. W. T. Plaisted appealed to the Grand Lodge of Massachusetts. The Grand Lodge ordered Franklin Lodge to pay the entire amount of Mr. Plaisted's claim.

From this action of the Grand Lodge, Franklin Lodge appeals.

DECISION.

We are of the opinion that Franklin Lodge is not legally liable for any expenditure made by Mr. H. F. Plaisted, for nurse hire for Bro. W. T. Plaisted between the 5th of October and the 18th of November, 1892.

The necessity of employing a nurse for a sick brother must, in the first instance, be determined by the Subordinate Lodge to which the sick brother belongs, or by the Lodge in whose care he is at the time. The determination of that question can never be left to the judgment or caprice of a person who is not thereto authorized by the proper Lodge, whether he be, or be not, a member of the Order.

"The matter of benefits, pecuniary and attentive, is delegated by this body to subordinates." White's Digest, 1889, 117.

Under the circumstances, the expenditure, if any, made by Mr. H. F. Plaisted in the premises, from October 5th to November 18th, 1892, must be regarded as voluntary.

For the six days, from November 18th to November 23rd, both inclusive, the expenditure, amounting to \$12.00, being authorized by Franklin Lodge, should be paid.

We therefore recommend the adoption of the following:

Resolved, That the appeal of Franklin Lodge, No. 23, from the decision of the Grand Lodge of Massachusetts, requiring said Franklin Lodge to pay the claim of H. F. Plaisted, for the sum of \$100.00, be sustained, and that said decision of the Grand Lodge of Massachusetts be and is hereby modified by striking therefrom the following words: "The full amount of his bill \$100.00," and inserting in lieu of said words the following: "The sum of twelve (12) dollars."

Your Committee on Appeals submit the following report on the appeal of Myerstown Lodge, No. 358, from the action of the Grand Lodge of Pennsylvania. The history of the case is as follows, viz.:

Bro. Daniel Diehl, a member of said Lodge, died in June, 1890. For six years prior to his death he boarded with his son-in-law, Isaac S. Lehman, and paid his board regularly. Bro. Diehl was sick sixteen weeks prior to his death, and his daughter, Mrs. Lehman, gave him attention and necessary nursing. He left surviving him three daughters, including Mrs. Lehman, and also two sons, none of whom were dependent upon him, neither was he dependent on either of them. The

funeral of Bro. Diehl was held at the house of Mr. and Mrs. Lehman and the Lodge paid the expenses of the funeral, amounting to \$102.61 and Lehman then claimed the balance of the funeral benefit provided by the laws of the Lodge, and amounting to \$197.39, as attorney for the heirs of the deceased brother, and this balance of funeral benefit the Lodge refused to pay, and Mrs. Tillie S. Lehman, wife of said Lehman, took an appeal to the Lodge and a Commissioner was appointed to take testimony. The report of the Commissioner embodying the evidence taken was filed, and the Lodge considered the same, and by resolution refused to pay the claim of Mrs. Lehman, "for the reason that she had failed to prove that she was dependent on Bro. Daniel Diehl, deceased, or that he was dependent upon her at the time of his decease." From this action Mrs. Lehman appealed to the Grand Lodge of Pennsylvania, and this appeal was referred to the Committee on Appeals for benefits of that body.

This committee reported in favor of sustaining the appeal of Mrs. Lehman on the ground "that the appellant is a relative upon whom the brother (meaning the deceased Bro. Diehl) was dependent." This was approved by the Grand Master, whereupon Myerstown Lodge, as provided by the law of Pennsylvania, appealed to the Grand Lodge on the ground "that Mrs. Lehman was not a dependent relative of Bro. Daniel Diehl, deceased, and it was a misapplication of law on the part of the Committee on Appeals to apply that term to her, nor was Bro. Daniel Diehl dependent on his daughter, Mrs. Lehman." The Lodge assigned this finding by the Committee and its approval by the Grand Master as error. See printed appeal, page 4.

This appeal of the Lodge was then regularly referred to the Committee on the State of the Order who reported that "the appeal does not raise a question of law, and therefore the grounds of the appeal are not proper and legal, and the same cannot be considered by the Grand Lodge."

The Grand Lodge adopted the report of the Committee on the State of the Order as above, and permission was given the Lodge to appeal to the Sovereign Grand Lodge.

Your committee have carefully considered the questions raised by the foregoing appeal and conclude that the appeal of the Lodge did raise a question of law, to wit: Whether under the undisputed evidence in the case Mrs. Lehman was, under the law of the Order and of that jurisdiction, a relative on whom the deceased brother was dependent so as to entitle her to the funeral benefit. We regard it as a safe rule and good practice not to interfere with or disturb findings on evidence where there is either a substantial conflict in evidence or in cases in which the finding is not strongly and decidedly against the weight of evidence, but it is quite a different thing to construe the application of law to a case in which there is no material conflict in the evidence, as in the case before us.

The evidence in this case will be found on printed appeal, pages 7 to 16 inclusive, from which it appears that Mrs. Lehman herself did not testify that her father was dependent on her and her husband testified in effect that he was not thus dependent. (See printed appeal, page 10.) Indeed it is inferable from Lehman's evidence, on page 9 of printed appeal, that the deceased had an estate, the extent or nature of which was not gone into by the evidence. Your committee further conclude not only that the case should have been considered, but that the appeal of the Lodge should have been sustained. As it appears to us there was an entire failure of proof going to show either that Mrs. Lehman was dependent on the deceased or that deceased was dependent upon her

and the latter was the only basis of her claim. We therefore recommend the adoption of the following resolution :

Resolved, That the appeal of Myerstown Lodge, No. 358 be sustained and the action of the Grand Lodge of Pennsylvania be reversed.

The question of admitting members into the Order at 18 years of age was again defeated by 96 nays to 80 yeas.

REBEKAH LODGES.

At the session of 1892, a special committee of five Representatives was appointed to frame a Code of Laws, for the government of the Rebekah branch of the Order, but a mistake was made in selecting them. One was selected from New Hampshire, one from Salt Lake City, one from Minnesota, one from Pennsylvania, and one from Ohio, and without great trouble and expense to themselves it was impossible to meet in recess. The following was therefore adopted:

Resolved, That a new committee be appointed under the above named resolution, with instructions to meet in Chattanooga, Tenn., one week prior to the stated session of this Sovereign Grand Lodge, and that the committee be allowed the usual per diem.

The report of the Committee on the Petition of David Green, was adopted.

REPORT.

Your Committee on Petitions, to whom was referred the petition and papers accompanying the same of David Green, formerly a member of Dominion Lodge, No. 1, of Victoria, B. C., beg leave to report that, after a careful examination of said petition we find a serious discrepancy in the statements there presented, and your committee, having no opportunity to ascertain the facts, would respectfully recommend that the Grand Secretary be and is hereby instructed to forward said petition and papers connected therewith to the Grand Lodge of B. C. with instructions to look into the case, so that all parties connected therewith may have a proper hearing, and the case determined accordingly.

The question of modifying the Regalia of the Order was referred to the next session of the S. G. L.

Under instructions from this Grand Body, we submitted a resolution which was referred to the Legislative Committee, and their report on the same was adopted.

REPORT.

Your Committee on Legislation, to whom was referred the resolution of Representative Waller, of British Columbia, to wit :

"That a brother taken sick remote from his Lodge, and failing to report himself within a reasonable time (after he is taken sick) to the Relief Committee or Lodge of the place where he then resides, said Relief Committee or Lodge shall not pay him any benefits without first referring the case to his own Lodge for instructions,"—would report that the law on the subject is now substantially in accord with the resolution offered, and therefore we ask to be discharged from its further consideration.

MISCELLANEOUS.

Bro. Rev. J. W. Venable was presented with a veteran's jewel by the

Kentucky Representatives as a small token of their appreciation of his valuable services as Grand Chaplain of the S. G. L. for twenty-five years.

The Odd Fellows of Milwaukee and Wisconsin presented P. G. Sire James G. Sanders with a magnificent jewel on the jubilee of his initiation into the Order.

Representative Macguire, of California, moved the following, which was unanimously adopted :

Resolved, That upon the retirement of General John C. Underwood from the command of the Patriarchs Militant, this Sovereign Grand Lodge desires to place upon record its grateful appreciation of the ability and untiring energy displayed by General Underwood in the organization and command of the Patriarchs Militant and of the personal sacrifices in connection with his services.

Resolved, That the flag, desk and chair of the Commander-in-Chief, heretofore used by General Underwood in connection with his office, be presented to him as souvenirs of his official connection with the Patriarchs Militant.

HEAD QUARTERS OF THE S. G. L.

The special committee appointed last session to select a proper and suitable office for the Grand Secretary, were authorized to purchase the premises now occupied by him, for the sum of \$25,000.

The amended Constitution of the Grand Lodge of British Columbia, was approved.

The Representatives from British Columbia were honored by being placed on the following committees:

Rep. Quennell, on Patriarchal Branch of the Order.

Rep. Scoullar, on Grand Bodies, not represented.

Rep. Waller, Chairman on Correspondence.

CONCLUSION.

We cannot close this report without referring to the admirable arrangements made by the Brothers and Sisters of Milwaukee and Wisconsin, for the reception and entertainment of the Officers and Representatives of the S. G. L., and their lady friends, they were untiring in their efforts to make their visitors feel at home, and more than verified the promises made by their Representatives last session.

On Saturday, we were taken by train to White Fish Bay, accompanied with a brass band, where a sumptuous Banquet was provided.

On Monday, we were escorted from the Plister Hotel, to the Davidson Theatre, where Bro. Silber delivered the Address of Welcome. Mayor Koch, tendered the freedom of the city; the Governor of the State extended a cordial welcome. The Grand Patriarch, Grand Master,

and Sister Hutchinson, the President of the Rebekah Convention, gave cordial addresses of welcome.

The Grand Sire made a general response in his usual, able and eloquent manner.

The Officers and Representatives then marched to their place of meeting, and proceeded to business.

On Tuesday afternoon there was quite a large parade of Odd Fellows, with the Representatives and Ladies in carriages. After the parade, we were driven to the Soldiers' Home, a beautiful place situated in a park of four hundred acres. And all through the week our lady friends were handsomely entertained by the Brothers and Sisters of Milwaukee.

In Chicago, the Parades, Banquets, Steamboat Rides on the Lake, and coach rides were continued, only on a more elaborate scale, and will no doubt be ever remembered by those who had the extreme pleasure of participating in them, as being one of the most enjoyable pleasure trips in their lives. Finishing up with a couple of weeks at the White City, one of the grandest (if not the grandest) sight in the world.

Such an opportunity for entertainment and delightful pleasure, for the Grand Representatives, may never again be presented, and as it was through your votes we were enabled to enjoy all this pleasure,

We return our sincere thanks for the honor conferred.

The last portion of paragraph two, Section I., Article XVIII., commencing with the words "In all cases," should be struck out, and the wording of the last paragraph of Section II., Article IV., Constitution of Subordinate Lodges, governing benefits in cases of continuous sickness, should be substituted therefor. The present wording of the section in question disqualifying a member from receiving full benefits until after he has recovered from any sickness (no matter however short in duration) for six months.

Section V., of Article XVII., is incomplete (evidently a typographical error) and we recommend that the Lodge be called on to furnish the missing portion for the consideration of the committee, the date of the meeting of the Grand Lodge not allowing us time to communicate with the Lodge and obtain an answer.

Your committee would recommend that a standing resolution be passed requiring Lodges to submit all by-laws and amendments thereto in duplicate, so that one copy could be kept on file in the Grand Secretary's office and the other returned to the Lodge when approved.

We are informed by the Grand Secretary that Lodges invariably require the return of the manuscript copies submitted for the printer's use, and that they are rarely returned, so that there is nothing to show what this Grand Lodge has approved.

VICTORIA, B. C., February 13th 1894.

To the Grand Master, Officers and Representatives of the Grand Lodge of the Province of British Columbia, I. O. O. F.:

DEAR SIRS AND BROTHERS,—Your Committee on Appeals to whom was referred the appeal of Bro. J. Wriglesworth, P. G. M., from the decision of the Grand Master, J. Crossan, in sustaining the action of Dominion Lodge, No. 4, I. O. O. F., in refusing him benefits on two separate occasions.

Beg to submit our report as follows:

Having carefully examined all the documents and evidence in the case of the first sickness, we are satisfied that the decision of the Grand Master thereon is correct, and we, therefore, fully confirm the same.

In the matter of the claim for the second sickness, the Grand Master appears to have touched on all the points bearing on the case before him, and then gives the following decision :

“The General Law, not making it incumbent on any particular officer to report a Brother well, and the By-Laws of Dominion Lodge, No. 4, being silent on the matter, I am of the opinion that the duty fairly devolves on the convalescent Brother.”

“Taking into consideration the evidence adduced, the surrounding circumstances and the absence of any law on the subject, I feel that the neglect of Bro. Wriglesworth to report himself well is fatal to his demands for benefits for what he contends to be the second portion of his illness.”

“The action of Dominion Lodge, No. 4, is therefore sustained.”

Your committee take exception to this decision, on the following grounds :

First—That there is nothing in the laws making it compulsory on a sick brother to report himself well.

Second—That there is a By-Law in Dominion Lodge, No. 4, clearly defining the duties of the Visiting Committee (one officer to visit each day) from the time that a brother is reported sick to his Lodge until reported well again, immaterial whether a brother is entitled to pecuniary benefits or not.

Third—That Bro. J. Wriglesworth did report himself to one of the Visiting Committee as attending to his business.

The following is an extract from the written statement of Bro. H. W. Green, one of the Visiting Committee of that time:

“I remember calling upon him (meaning Bro. Wriglesworth) and inquiring as to his health (it being Lodge night I wished to make a report) when the brother told me in substance, that he was feeling much better, but if his work was laborious he would not be able to be around.”

The above statement shows most conclusively that Bro. J. Wriglesworth was attending to some kind of work, and also, that he did so report himself to Bro. H. W. Green.

There is nothing, however, in the evidence before us to show that Bro. Wriglesworth did report himself or was reported sick to Dominion Lodge after recovering from his first sickness.

We find it an impossibility to arrive at an intelligent decision with such discrepancies in the dates and such contradictory statements by the brothers of the same Lodge, in regard to the second sickness.

Bro. J. Wriglesworth, in his appeal from the decision of the Grand Master, claims that most of the above mentioned statements were made without giving him an opportunity to defend himself against them, and that he is prepared to refute them.

As it is the duty of this Grand Body to mete out impartial justice to all, whether individual members or Lodges, we offer the following:

Resolved, 1st. That the decision of the Grand Master in regard to Bro. J. Wriglesworth's first sickness be confirmed, but the decision on the second sickness be not sustained.

Resolved, 2nd. That the appeal committee be empowered to call before them all persons connected with this case, and also (in conjunction with the Secretary of Dominion Lodge, No. 4), to examine the minutes of the Lodge, to elicit all the facts in the case, and submit them at the next regular session of this Grand Lodge.

Report read from Special Committee appointed last session to prepare and submit form of policy for Odd Fellows' Insurance Association, &c.

To the Grand Lodge of British Columbia, I. O. O. F. :

We, the undersigned, a special committee appointed at the last session of this Grand Body to prepare and submit to this session of the Grand Lodge a form of policy to be substituted for the certificate of membership then in use by the Insurance Association of this jurisdiction, beg leave to present for your approval the form of policy as hereto attached.

Your committee were also empowered to make any necessary corrections that, in their opinion, might be required to remove any inconsistencies occurring in the new rules prior to their being reprinted.

We concluded that the power vested in us under the resolution only warranted "a correction" where necessary, and not an alteration of the substance of any rule or rules. And while we deem the present by-laws of the Association contain serious defects and require extensive remodelling to make them workable, we have refrained from altering them to any extent, simply inserting a few words in order to have the different sections harmonize.

In presenting this form of policy for approval we desire to call your attention to the fact that we have endeavored to so word this policy that it is a contract of an Odd Fellows Insurance Association and not a contract of the Grand Lodge of British Columbia, but we are strongly of the opinion that the by-laws as they now stand might, in case of an epidemic throughout the Province and a heavy death rate among the members of the Association, seriously jeopardize the funds of this Grand Lodge.

The management of this Association is at present vested in the Officers of this Grand Lodge, the Grand Master is required to sign the certificates, the Grand Treasurer has charge of the funds, and the Grand Secretary is therein stated to be entitled to receive such remuneration as this Grand Lodge may vote, thus making him an employe of this Grand Lodge, all of which might legally constitute the Insurance Association and the Grand Lodge identical, and the funds of this Grand Lodge liable for claims.

While therefore the form of policy which we submit carefully avoids any reference to this Grand Lodge or its Officers, yet if taken in conjunction with the present By-laws it might possibly be construed to form part and parcel thereof, and commit the Grand Lodge to serious loss.

We therefore recommend a change in the wording of the present rules of this Association by which the Association may be regulated on an independent basis, and all reference to Grand Officers as such excluded.

Several minor changes are also recommended, such as providing the levying of extraordinary assessments monthly, instead of bi-monthly, when there is not \$1,000 on hand, so as to remove any cause for complaint that that sum is not at present guaranteed.

The present rule respecting reinstatement is, in our opinion, altogether too arbitrary, and unless changed will work detrimentally to the Association's interests.

I hereby give notice that to-morrow I will move the following amendments to the Rules of the Odd Fellows' Insurance Association of British Columbia:

(1.) Page 2—Name and objects—Add the following words: "But it is to be distinctly understood that the funds of the Grand Lodge of British Columbia, I. O. O. F., nor of any of its subordinates shall be held responsible in any way for the fulfilment of any contracts or engagements of this Association"

(2.) Page 4—Membership—Line 3 after the word "certificate" insert the words "on the form provided for that purpose." Line 4, after the word "health" insert the words "the cost of which must be paid by the applicant."

(3.) Page 4—Duties of Officers—Line 1, after the word "shall" add the words "act as President of the Association and"

(4.) Duties of Deputy Grand Master—Strike out the 4 lines referring thereto and insert the following: "The Deputy Grand Master shall act as Vice-President of this Association and in the absence of the President shall preside at all meetings of the Executive Committee and perform all duties appertaining to the office of President."

(5.) Duties of Secretary—Line 1, after the word "Secretary," add the words "shall act as Secretary of this Association and"

(6.) Page 6—Duties of Treasurer—Lines 1 and 2, strike out all the

words to the word "Association" and insert the following: "The Grand Treasurer shall act as Treasurer of this Association and shall have charge of its funds."

(7.) Duties of Finance Committee—Line 4, strike out the words "Grand" where they occur. Line 5, strike out the words "with respect to" and insert the word "of"

(8.) Pages 6 and 7—Fees, Dues and Assessments—Strike out the whole of this article and insert in lieu the following:

"Applications for admission to membership must be accompanied by the sum of \$2.50 as an entrance fee, which sum will be returned if the applicant is not accepted. New members must pay the amount of one assessment within sixty days from the date of the issuing of the certificate of membership in accordance with the following scale for the age of the member."

"Assessments in accordance with the scale provided herewith for the age of the member at the time of his admission to membership shall be levied on the members bi-monthly on the 1st day of January, March, May, July, September and November, but in the event of there not being \$1000 in the Endowment Fund whenever proof of death of a member is filed, the Executive Committee is empowered to levy an assessment at the usual rate on the first day of each month succeeding until the requisite \$1000 is raised, after which the assessments shall be levied bi-monthly as before provided. All assessments must be paid within thirty days from the date of their being levied otherwise the delinquent member will be suspended from benefit.

"Each member shall pay as dues the sum of one dollar and fifty cents per annum.

"Any member owing 12 months dues and failing to pay the same within three months thereafter shall be suspended from benefits.

"A member suspended from benefit for non-payment of assessments or dues, may be reinstated within one month after the date of suspension by the payment of all assessments and dues owing by him but when one month has expired he cannot be reinstated except by the payment of all assessments and dues owing and the production of a medical certificate of health on the form provided for that purpose. After the expiration of three months from the date of suspension from benefit if he fails to be reinstated the member shall be suspended from membership and he cannot again be admitted to membership in this Association, except in the same manner and by the payment of the same rate of assessment as a new applicant of the same age."

(9.) Page 9—"Funds"—Line 1, strike out the words "Grand Master" and insert the word "President."

(10.) Line 2, strike out the word "Grand."

(11.) Page 9—Benefits—Strike out the word "Grand" where it occurs in this article.

(12.) Strike out lines 10, 11, 12 and 13; also the word "Fund" in line 14.

(13.) Page 9—Nominations—Strike out the word "Grand" where it occurs in this article.

I hereby give notice that to-morrow I will move to amend Section I., Article V., of the Constitution of Subordinate Lodges as follows:— Strike out the words "four weeks" in the first line and insert in lieu thereof the words "one week." Strike out all the words after the word "emergency" in the eleventh line and insert in lieu thereof the following, "when by a two-third vote of the members present the three degrees may be conferred at the same meeting."

The following notice was given to amend the constitution of the Grand Lodge, which was laid over under the rule.

We, the undersigned, hereby give notice that at the next annual meeting of this Grand Lodge we will move the following amendments to the Grand Lodge Constitution, Article VI., Section 3, where the word "three" is used in the first line, the word "five" be substituted in lieu thereof, so as to read :

Section 3. The Committee on Credentials shall consist of five members, who shall be appointed by the Grand Master who is holding over, or the incumbent of the chair at the time of opening of the session, and whose duty it shall be to examine and report to the Grand Lodge on the credentials and certificates of members.

Section 4. Where the word "three" is used in the first line, "five" be substituted in lieu thereof, so as to read :

Section 4. The Committee on Finance shall consist of five members whose duty it shall be to examine and report on all accounts and claims against the Grand Lodge ; to examine the accounts of the Grand Secretary and Grand Treasurer, annually, and report the result of their examination, and the condition of the finances immediately thereafter to the Grand Lodge ; to ascertain and report at the commencement of each annual session the amount required for the expenses of the Grand Lodge for the ensuing year, and suggest such measures of finance as they may deem expedient.

Section 7. Where the word "three" is used in the first line, "five" be substituted in lieu thereof, so as to read :

Section 7. The Committee on Petitions shall consist of five members, whose duty it shall be to examine all applications for charters referred to them, and report to the Grand Lodge such action thereon as may be proper.

Section 8. Where the word "three" is used in the second line, "five" be substituted in lieu thereof, so as to read :

Section 8. The Committee on the State of the Order shall consist of five members, who shall examine the reports of the District Deputy Grand Masters and reports of Subordinate Lodges and such other matters as may be referred to them, and report thereon to the Grand Lodge, and they shall annually present to the Grand Lodge an exhibit of the condition and progress of the Order under this jurisdiction, and recommend such measures for the good of the Order as from time to time they shall judge proper.

Section 9. Where the word "three" is used in the first line, "five" be substituted in lieu thereof, so as to read :

Section 9. The Committee on Legislation shall consist of five members, who shall examine and report on all proposed amendments of the Constitution, By-Laws, Rules of Order and Resolutions governing this Grand Lodge, and such other matters as may be referred to them by the Grand Lodge, or Grand Master.

Section 10. Where the word "three" is used in the first line, "five" be substituted in lieu thereof, so as to read :

Section 10. The Committee on Printing shall consist of five members, of which the Grand Secretary of this Grand Lodge shall be one, and shall be chairman thereof. They shall decide all matters of Printing, and none of the proceedings of this Grand Lodge shall be given to the public press without having first received the sanction of a majority of said Committee.

Section 11. Where the word "three" is used in the first line, "five" be substituted in lieu thereof, so as to read :

Section 11. The Committee on Judiciary shall consist of five members, whose duty it shall be to consider all questions in relation to the construction of the Laws of the Order and the decisions of the Grand Master upon questions of law.

Section 12. Where the word "three" is used in the second line, "five" be substituted in lieu thereof, so as to read :

Section 12. The Committee on Mileage and Per Diem shall consist of five members, whose duty it shall be to examine and report the amount each Officer and Representative is entitled to receive for attendance upon the sessions of the Grand Lodge.

Also Article IV., Section 5, be amended by inserting after the word bonds in the eleventh (11) line, "in some security company to the amount of three thousand dollars (3,000), the Grand Lodge paying premium for same," and strike out all the words after "British Columbia" in the thirteenth (13) line, so as to read as follows :

Section 5. The Grand Treasurer shall receive and take charge of the moneys of the Grand Lodge, pay all orders drawn on him by the Grand Master, under the seal of the Grand Lodge; make such investment of the funds as the Grand Lodge may direct; keep his accounts in such a manner as will exhibit the resources and amount of receipts, and by whom paid, the purposes and amount of disbursements, and to whom paid; have his accounts closed up on the Saturday preceding the second Monday in June, annually, and submit them to the Finance Committee, and transmit by the Grand Secretary, annually, to the Subordinates, an exhibit of his accounts. He shall attend all regular sessions of the Grand Lodge; he shall, previous to installation, give bonds in some security company to the amount of three thousand dollars (\$3,000), (the Grand Lodge paying premium for same to) the Grand Lodge of Independent Order of Odd Fellows of the Province of British Columbia.

I hereby give notice that to-morrow I will move the following amendment to Section 4, Article IV. of the Constitution for Rebekah

Lodges: Strike out the word "shall" in the first line and insert in lieu thereof, the word "may;" also insert after the word "months" in the second line the words "or one year" so as to make the section read as follows :

"All Officers may hold their offices for six months or one year except the Financial Secretary and Trustees, who shall hold office as provided "in the By-Laws."

The following notice was given by Reps. Holdnall and Dailey, No. 5, but the consideration of same was ruled out of order by the Grand Master on the ground that it was of a religious character, and therefore not permissible under the laws of the Order.

No. 3. Question from Vancouver Lodge, No. 8. Is it necessary to notify each and every Lodge in this jurisdiction of the suspension of brothers for N. P. D.? Answer—Yes. (See Art. VII, Sec. VI. Con., governing subordinates.)

No. 4. Question from Kootenay Lodge, No. 16. Is it imperative for officers of the Lodge to wear jewels according to their respective rank and station in the Lodge? Answer—Yes. (See page 333 Whites' Digest 1868, Journal 4131.)

No. 5. Question from Ashcroft Lodge, No. 23. If it was constitutional for us to hold an election of officers for the July term, our Lodge being instituted on the 30th of March? Answer—Yes. (See page 239, No. 983 Whites' Digest.)

We recommend that the above quoted decisions be approved. We would further recommend that the action of our Grand Master and his deputies in granting or refusing dispensations and in the interpretation of by-laws referred to in their reports be approved.

To the Grand Lodge of British Columbia, I. O. O. F. :

DEAR SIRS AND BROTHERS,—Your Special Committee on Insurance Association have had under consideration the alterations proposed by the Grand Secretary to the Rules of the Association, and also the alterations submitted by Bro. C. F. Yates to remove the Association from the management of the officers of this Grand Lodge, and the constitution of a Board of Management consisting only of members of the Association elected annually by the members at the annual meeting of the Association, but retaining the G. M., D. G. M., and G. W. as *ex officio* members of the Board.

The main question involved in the above named documents for the Grand Lodge to decide, is, whether the alteration in the management before mentioned shall take place or not. If the Grand Lodge decide this question in the negative we recommend that the amendments to the Rules proposed by the Grand Secretary be adopted; but in the event of the question being decided in the affirmative then we recommend the adoption of Bro. Yates' suggestions attached hereto with the addition of the alterations proposed by the Grand Secretary, numbered 2, 8 and 12.

If the Grand Lodge agree to the proposed change in management we would suggest that an hour be set aside during the present session so that the members of the Association could meet and elect the first officers and directors for the ensuing year and any other business that may be necessary to start the Association on its new basis.

AMENDMENTS TO RULES OF ODD FELLOWS INSURANCE ASSOCIATION.

Paragraph 1. Name and objects.

Insert after the word "Columbia," in the second line, the words "and its principal office shall be in the city of Victoria."

Strike out all of page four from the word "thereof," in line ten; all of page five and all of page six, except that portion that relates to fees, dues and assessments, and insert the following:

MANAGEMENT.

The management of this Association shall be vested in a Board to be known as the "Board of Management," which shall consist of a

President, Vice-President, Secretary-Treasurer and four Directors, who shall be elected annually by a majority vote of the members of this Association, and the Grand Master, Deputy Grand Master and Grand Warden of the Grand Lodge of British Columbia, who shall be members of the Board of Management *ex officio*; and no one shall be eligible for any office unless he be a contributing member and in good standing in the Association, except the *ex officio* members before mentioned. The Officers and three of the Directors must be residents of the city in which the principal office is located.

Six members of the Board of Management shall form a quorum for the transaction of business.

DUTIES OF OFFICERS.

The President shall have a general supervision of the workings of this association, preside at all meetings of the Association and of the Board of Management when present, and in case of the votes being equal shall give the casting vote; sign all certificates of membership and all orders on the Secretary-Treasurer for the payment of monies. He shall have power to call special meetings of the Managing Board when in his opinion requisite, and shall also call special meetings of the Board on the written request of two of the Directors. In the absence of the President the Vice-President shall preside at all meetings, and transact such business as the President is herein empowered to do.

The Secretary-Treasurer shall attend all meetings of the Association, keep accurate minutes thereof, write all communications, keep correct accounts of all monies received and disbursed, in the manner prescribed in these rules and furnish the Association at its annual meetings with a statement of the same, a copy of which shall be sent to every member of the Association and the Grand Lodge of British Columbia, I. O. O. F. He shall deposit all monies belonging to the Endowment Fund at interest in a Chartered Bank as soon as possible after his receipt of the same. He shall prepare, sign and issue certificates of membership on the form provided to all members on their admission to membership. He shall keep a register of all certificates issued, and suspensions or renewals as they occur. On receipt of the proof of the death of a member of this association, he shall at once inform the President, or in that officer's absence the Vice-President, and shall without delay call a meeting of the Board of Management. He shall prepare and dispatch notices to members when required calling for the payment of assessments, and shall notify members in arrears for dues, and promptly inform them of their suspension from benefits or membership from any cause. He shall receive for his services such sum as the members of this Association may at their annual meeting vote for that purpose. Before entering upon his duties in connection with this Association, he shall furnish a bond of a Chartered Guarantee

Company in the sum of \$— for the faithful performance of his duties, and the cost of such bond shall be provided for out of the Management Fund of this Association.

At each annual meeting of this Association there shall be elected a Finance Committee of three, whose duty it shall be to examine and report on the accounts of the Secretary-Treasurer, and on other matters connected with the fiscal concerns of the Association that may be referred to them.

The Managing Board shall have power to appoint solicitors throughout the Province to obtain applications from members of the I. O. O. F. desirous of becoming members of this Association, and such solicitors shall be paid out of the Management Fund, such sum as the Board of Management shall from time to time decide.

The annual meetings of this Association shall be held on the *second* day of the annual session of the Grand Lodge of B. C., and at the same place as the Grand Lodge assembles, at which all members of the Association in good standing at the time are entitled to vote. Members unable to attend can be represented by proxy, but notice of such proxy must be given to the Secretary-Treasurer on such forms as shall be provided for that purpose. Thirty members, either in person or by proxy, shall form a quorum for the transaction of business. No one member, however, shall hold the proxy of more than five absent members. If no quorum be present the annual meeting can be adjourned from day to day at the discretion of the President.

It shall be the duty of the Secretary-Treasurer to send a notice convening the annual meeting of the Association to each member two weeks prior to the date of meeting, which shall contain the business to be brought before the meeting.

Strike out the words "Executive Committee" where they occur on pages 3 and 9, and insert the words "Board of Management."

Strike out the titles "Grand Master, Grand Secretary and Grand Treasurer" where they occur on pages 8 and 9, and insert the titles "President, Vice-President and Secretary-Treasurer."

Strike out the word "Treasurer" on page 3, and insert the title "Secretary-Treasurer."

Strike out the first three lines on page 9 after the word "bank" and insert the following: "In the name of the Association, and no moneys shall be withdrawn therefrom, except by an order or cheque signed by the President and Secretary-Treasurer, or in the absence of the President by the Vice-President."

Strike out all of the paragraph headed "Alterations" on page 10, and insert the following:

"These rules shall not be altered, added to or annulled except by a two-thirds vote of the members at an annual meeting, and any alteration, addition or correction shall not come into force or effect until submitted to and approved of by the Grand Lodge I. O. O. F. of B. C."

"No alteration shall, however, be made except notice of same be sent to the Secretary-Treasurer three weeks prior to the date of the annual meeting, and it shall be the duty of that officer to notify the members of such proposed alteration by printed slips, on which the member may vote aye or nay to such proposed amendment."

Strike out the word "adopted" on page 12, and insert the word "approved."

It was moved, seconded and carried, that in the opinion of this Grand Lodge it is advisable that the Odd Fellows' Insurance Association should be managed and operated by its own members on the lines suggested by Bro. Yates, P.G.
