Extract from "The Ontario Voters' List Act, 1889."

The Sheriff shall, immediately on receipt of his copies, cause one of them to be posted up in a conspicuous place in the Court House ; the Clerk of the Peace, upon receipt of his copies, shall cause one of them to be posted up in a conspicuous place in his office ; every Public or Separate School Head Master or Mistress shall, in like manner, post up one of his or her copies on the door of the School House, and every Postmaster shall post up one of his copies in his Post Office

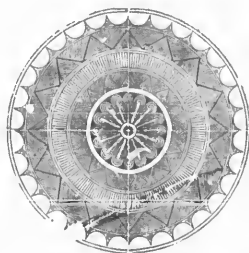
