## BILL.

An Act to confirm the Navigation Property and Income of the Grand River Navigation Company, in the Municipal Corporation of the Town of Brantford, and transfer to, and vest in the said Corporation all the rights, powers, privileges and immunities, which were conferred upon the said Company by its charter.

Received and read, first time, Friday, 2nd May, 1862.

An Act to confirm the Navigation property and income of the Grand River Navigation Company in the Municipal Corporation of the Town of Brantford, and transfer to and vest in the said Corporation all the rights, powers, privileges, and immunities which were conferred upon the said Company by its charter.

WHEREAS under the authority and provisions of an Act of the Preamble.

Parliament of this Province, passed in the thirteenth and fourteenth years of Her Majesty's Reign, chapter 151, and entituled "An 12, 14 Vic...

Act to authorize the Grand River Navigation Company to raise by way cap. 15.

5 of loan, a certain sum of money, and for other purposes therein mentioned," the Town of Brantford in the corporate capacity did, on the
thirtieth day of December, A.D. 1851, loan its credit to the said Company by issuing and delivering to it, debentures in such sums as had
been agreed upon between the said Company and the said Corporation,
to the extent and for the sum of Forty Thousand Pounds, bearing
interest at six per cent per annum, such interest being made payable
semi-annually, and the principal sum within twenty years.

And whereas, for the accurity of the said Town of Brantford against loss by its so loaning its credit, the said Act of Parliament enacts and 15 declares that the said debentures shall have the same effect as a mortgage upon all the property and income of the said Grand River Navigation Company, as by reference to the said Act will more fully and at large appear.

And whereas, the said Grand River Navigation Company not only 20 misapplied the said debentures of the said Town of Brantford, contrary to the provisions of the said Act, but neglected to pay the interest thereon as it became due according to the terms thereof, and the said Town of Brantford has been called upon to pay and has paid large sums of money on account, and in satisfaction of such interest, and has also at the instance of the said Company redeemed of the said debentures, 25 to the amount of £16,500, leaving the balance of the said £40,000, still outstanding against the said Town of Brantford.

And whereas, the said Town of Brantford seeing no reasonable or probable prospect of the objects for which the said Act was passed, and the said credit loaned, being observed and carried out by the said Grand 80 River Navigation Company, and being desirous of protecting its rights and interests against loss by its having so loaned its credit as aforesaid, on the twenty-third day of August, A. D. 1859, caused a Bill of Complaint to be filed in the Court of Chancery for Upper Canada, against the said Grand River Navigation Company upon the said mortgage 35 security, and such proceedings were thereupon had in the said Court, that by its decree subsequently granted the said Company and all

persons claiming under it, have been absolutely foreclesed of all right and equity of redemption, of, in and to all the said mortgaged premises of the said Company, and the same have thereby become absolutely vested in the said Town of Brantford, both in law and equity.

And whereas, the said Town of Brantford has by Petition, prayed 5 that an Act may be passed confirming the said decree, and conferring upon and vesting in it, in its corporate capacity, all such rights, powers, authorities, privileges, and immunities as shall, or may be requisite and necessary, effectually to enable the said Town of Brantford in its said corporate capacity, efficiently and properly to manage, maintain, keep 10 up and carry on the said Navigation, and generally to deal with, and use, and enjoy the same and everthing connected therewith, or in any manner appertaining thereto, in as full and ample a manner and to the same extent that the said Grand River Navigation Company might and could do, if the same had still continued the Navigation and property of 15 the said Company.

Therefore Her Majesty, by and with the consent of the Legislative Council and Assembly of Canada, enacts as follows, that is to say:

1. All the property, works, and income of the said Grand River Navigation Company as the same existed at the time of the granting of the aforesaid decree, and in so far as the rights and interests of the 20 said Grand River Navigation Company were concerned, or thereunto extended at the time of the granting thereof, shall be, and the same are hereby declared to be from that time and henceforward the property, works, and income of the Corporation of the said Town of Brantford, and that from an lafter the passing of this Act, the said Corporation of the 25 Town of Brantford shall have, possess, exercise, and enjoy all such rights, powers, authorities, privileges, and immunities, as shall or may be requisite and necessary, fully, and effectually, to enable the said Corporation of the Town of Brantford to manage, maintain, keep up, and carry on the said Navigation, and generally to deal with, and use, 30 and enjoy the same and every part thereof, and all, and every matter and thing connected therewith, or therewith used and enjoyed, or in any manuer appertaining thereto, or to any part thereof, in as full and ample a manner and to the same extent as the said Grand River Navigation Company under its Act of Incorporation, or otherwise might and 35 could do if the said Navigation property, and income still remained and continued vested in the said Grand River Navigation Company.

2. The Municipal Council of the said Corporation of the Town of Brantford, shall from and after the passing of this Act, supersede for Directors, and be substituted for the Board of Directors of the said Grand River 40 Navigation Company, and such Municipal Council as lawfully constituted from time to time, and at all times shall have the same and all the powers and authorities in the control and management of, and the dealing with the said Navigation property, and income of the said Grand River Navigation Company, as were given to and vested in, and which 45 might and could be employed and exercised by such Board of Directors, if the said Navigation property and income of the said Company still remained vested in it: Provided always, that the said Corporation of the Town of Brantford, in, through and by its said Municipal Council shall, and do exercise and employ such powers and authorities in the 50 control and management of, and the dealing with the said Navigation, property, and income in the same manner as by law, the said Corporation

of the Town of Brantford is now, or hereafter may be required to manage, conduct, administer, and carry on the Municipal Government and affairs of the said Corporation of the Town of Brantford.

- 3. All such By-law or By-laws, Rules and Regulations as were By-Laws, &c., 5 enacted, passed and adopted by the said Board of Directors of the said of Company Grand River Navigation Company, and were in force at the time force. the said Navigation property and income became vested in the said Corporation of the Town of Brantford, in manner aforesaid, in so far as the same may be found and deemed needful and proper by the said 10 Corporation of the Town of Brantford, touching the control, management, and disposition of the said Navigation property, and income and the appointment, duty and conduct of its officers, clerks and servants, and all such other matters as shall or may appertain thereto, shall remain and continue in full force and effect until the said Corporation of 15 the Town of Brantford shall repeal, alter, or amend the same, or enact, pass, and adopt others instead thereof.
- 4. The Tariff of Tolls as established by the said Navigation Company Tariff to reand as now in force, shall continue and remain the Tariff of Tolls to be main in force. levied, raised, and collected upon the said Navigation until such time 20 as the same may be altered, amended, or repealed by the said Corporation of the Town of Brantford.
- 5. All leases of hydraulic or other rights, powers, or privileges Leases, &c., which were granted by the said Grand River Navigation Company, to continue, and are now subsisting and unexpired, shall continue in full force and to belong to 25 effect according to the terms and conditions thereof, and for the unex-Corporation. pired periods thereby created, unless otherwise agreed upon between the said Corporation of the Town of Brantford and the said Lessees, the said Corporation being and the same is hereby declared to be the Lessor, and entitled to the rents and profits secured by the said leases, 30 and to the exercise of all such legal rights and powers as are thereby created.
- 6. The said Corporation of the Town of Brantford shall have full Corporation power and authority to mortgage the said Navigation property and may sell or income, or any part thereof, or to sell and dispose of the same, or so vigation pro-35 much thereof as it may from time to time find requisite and necessary perty; for the promotion of the rights and interests of the said Corporation, in so far as those rights and interests may be affected thereby: Provided always, that in the exercise of such power and authority the said Corporation shall take care that the benefits, advantages, and usefullness of 40 the said Navigation as it now exists are in no way impaired or injured.
- 7. In case of any such sale of the said Navigation property and Butsubject to income, or any part thereof, such sale shall be deemed to have passed, certain duties as regards the and shall pass the said Navigation property and income, or such part or navigations. parts thereof as may be so sold, to the purchaser thereof, with all the 45 rights, privileges, and appurtenances, and subject to all the duties and obligations which the Act of Incorporation of the said Grand River Navigation Company gave or imposed, with reference to the maintaining, keeping up, managing, conducting, and carrying on the said Navigation, whilst the same continued the property of the said Company.
- 8. Notwithstanding any thing herein contained, it shall always be Her Majesty's lawful for Her Majesty, Her Heirs and Successors to assume the posses- rights to resion of the said Navigation, and of all the works and dependencies paired.
