CURATIVE MAGNETISM.

(Front view.)

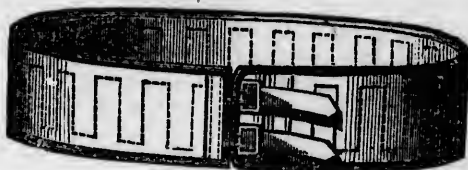


LUNG INVIGORATOR.
