




## OBJECTS OF THE CHURCH MEN'S SOCIETY.

(a) To band together the men of the Church in a united effort to promote the glory of God and the increase of His Kingdom.

(b) To promote and deepen the spiritual life among the men of the Church. This may be done by men's meetings, men's Bible Classes, corporate Communion for men, special services for men, and in any other way deemed helpful.

(c) To promote opportunities for social intercourse among the men of the Church, especially by bringing into close relationship with each other workers whose particular spheres sometimes seem to be widely apart.

(d) To provide for the commendation of members of the society when removing from one parish to another.

## RULES OF THE CHURCH MEN'S SOCIETY.

I. TO PRAY TO GOD EVERY DAY.

II. TO DO SOMETHING TO HELP FORWARD THE WORK OF THE CHURCH.

The following ways of discharging the rule of work are suggested:

To readily and punctually perform some Church Office, as Churchwarden, Sidesman, Synod Delegate, Organist, Member of the choir or member of some church Committee.

To conduct or assist in a Bible Class.

To teach in the Sunday School.

To engage in Temperance work.

To engage in Purity work.

To manage Sick or Friendly Societies in connection with the Church.

To take part in the work of a Men's Club, Boys' Club, or Church Lads' Brigade.

To help in keeping parish accounts.

To act as Librarian.

To promote Men's Services or Special Missions for Men.

To play in an orchestra for Men's Services.

To serve on a working committee for the purpose of making known Church work by personally distributing notices, or otherwise.

To take an interest in some two or three young men.

To pray for, subscribe to, and assist in the Mission Work of the Church, whether Diocesan, Canadian or Foreign.

To take a personal share in the religious education of our own children.

#### MEMBERSHIP

Membership in the society is open to all Churchmen above the age of sixteen, who are willing to carry out the society's rule of life.

#### BADGE.

A white St. George's Cross on a crimson ground.

#### MEMBERSHIP FEES.

A per capita tax of 25 cents in advance is to be paid yearly to the Diocesan Branch, and parochial branches are allowed to fix such dues as they may deem necessary to carry on the work of the branch, the committee recommending, however, that these should be kept as low as possible.

#### AFFILIATION OF EXISTING MEN'S ORGANIZATIONS.

All existing parochial organizations for men, such as Bible Classes, missionary committees, men's clubs, etc., are invited to affil-

iate themselves with the Church Men's Society, and thus be given a wider interest than the purely parochial one.

## SUGGESTED CONSTITUTION FOR PAROCHIAL BRANCHES.

1. **Name.** The name of this society shall be the\* (St. George's) Church Men's Society.

\*Here shall be marked the name of the parish.

II. **Objects.** (a) To band together the men of the Church in a united effort to promote the glory of God and the increase of His Kingdom.

(b) To promote and deepen the spiritual life among the men of the Church.

(c) To promote opportunities for social intercourse among the men of the Church.

(d) To provide for the commendation of members of the Society when removing from one parish to another.

III. **The Rules of the Society are**

1. To pray to God every day.

2. To do something to help forward the work of the Church.

IV. Membership Fee shall be a year, 25c of which is to be paid to the Diocesan Society on or before January 1st of each year.

(The membership fee should be sufficient to cover anticipated local expenses and the fee to the Diocesan Society.)

VI. The Officers of the Society shall be an Honorary President, who shall be the rector of the parish, and

A President, Vice-President, and Secretary-Treasurer.

The Executive shall consist of the officers, and three additional members.

The Officers and Executive shall be elected at an annual meeting of the Society to be held in October of each year.

VII. Meetings of the Branch shall be held—

(The ideal is once a week, the minimum once a month.)

1. Opening Service.
2. Roll Call.
3. Minutes.
4. Admission of New Members.
5. Reports of Committees.
6. Reports of Work.
7. Assignment of New Work.
8. The program, for the carrying out of which a program committee should be appointed at the annual meeting, the duty of which would be to arrange for lectures, appoint leaders for discussions, etc., etc.

Suggested programs include,

- (1) Bible Study.
- (2) The Prayer Book.
- (3) Church History.
- (4) Living Church Topics.
- (5) Social Problems.

## A SERVICE FOR USE AT MEETINGS OF THE SOCIETY.

(Or other suitable hymn.)
