REPORT

OF THE

COMMITTEE OF MANAGEMENT FOR THE YEAR 1875.

The Committee of Management in retiring from office beg to present the following Report of the past year's operations.

Owing to the dullness of affairs throughout the country during the year, and the consequent scarcity of employment, the demands upon our Society have been more than usually numerous. We have granted relief in one hundred and thirteen cases of distress, comprising about one hundred and forty-three persons in all; 94 men, 19 women, 6 boys or young men, and indirectly 24 children. The total amount expended in charity is \$835.21, details of which will be found in the Report of the Sub-Committee of charity.

There have been two interments in our lot at Mount Hermon Cemetery, during the year.

The Treasurer's Report affords full information as to our financial affairs.

Our arrangements with the Finlay Asylum and Ladies'. Protestant Home continue to give satisfaction; our acknowledgments are due to the Quebec and Gulf Ports S. S. Co., for kindly reducing their fares for all the passengers we have sent by their line; and we are also indebted to the gentlemen of the Shipping Office for several favours received, in finding opportunities of working their passage home for nearly a dozen unemployed men whom the Society by its rules could not undertake to help homeward (they being healthy and able bodied) but who, nevertheless, through the Society's influence, and the Shipping Master's co-operation, have, we have reason to believe, long ago reached their homes in safety.

Our thanks are due to our physician for gratuitous professional services, and to our clergy for visiting sick persons, and assistance cheerfully rendered the Committee in various ways.

fesons, George's eve, and an excellent sermon was kindly preached by the Right Reverend the Lord Bishop,—the Rev. G. V. Housman, Rev. M. M. Fothergill, and Rev. C. W. Rawson, Chaplains to the Society, also taking part in the service. Mr. Ed. A. Bishop, organist to the Cathedral, ably conducted the musical portion of the service, and to him and the ladies and gentlemen of the choir, and others who kindly lent their assistance, the Society is very much indebted. The collection in aid of the Charitable Fund amounted to \$100.

On the evening of St. George's Day the members and their friends dined together at the St. Louis Hotel, and this celebration of the day was a marked success in every respect.

During the year four of our members have been removed from us by death—Mr. William Judd, an Ordinary member, who had only just joined us; Mr. William Wood, an Ordinary member; Mr. James Sealey, a Life member since 1843; and Mr. George Thompson, a Life member, elected in 1867. Both of the latter gentlemen were for a number of years on the Committee of Management, and took a great interest in the affairs of the Society. Six new members were added to our list during the year—five Ordinary and one Life.

We have also to acknowledge with thanks a donation of £5 sterling, transmitted to our Treasurer by Col. B. Smith, of London, England.

A peculiar feature of the past season has been the number of men, most of them able, strong-looking fellows, who have come here as to a common centre, from all parts of Canada and the United States, and who all seemed to expect the St. George's Society to pay their passage to England. Our only resource, in such cases as these, is to send the parties back to the places whence they came. Several we did so send back, and a number of others would have had to follow, had they not been fortunate in getting opportunities of working their passage home.

One subject which has engaged the attention of your Committee very prominently is the fact that applicants have

been very often sent to Ontario, when they might have been sent, at less cost, to an equally promising or perhaps more promising field, in the Eastern Townships, at our very doors. During last summer deputations from the St. Andrew's. Irish Protestant Benevolent, and our own Society, met together to see if these Societies could not unite in some plan by which applicants for assistance, and especially newly arrived immigrants, needing advice, might be directed to profitable employment in that locality. Our Society afterwards addressed a circular to the Mayor of every municipality in the Townships, asking what kind of employment, and how much could be had in his neighborhood. From the answers received it may be stated that the Eastern Townships afford an excellent field for labour, fully equal to most parts of Ontario, but there is not so much demand at present for tradesmen as for farm labourers. The scarcity of the latter is often very much felt, and as nearly all the immigrants come out ticketed direct for Ontario, there would seem to be little hope of mending matters in that respect, unless there were some one at Home, charged with the duty of sending out emigrants specially for the Townships. In the meantime, it is satisfactory for us to know, that applicants, especially farm labourers, can be well placed in the Townships, and that Mr. Lanigan, Immigration Agent at Sherbrooke, will have pleasure in providing for any number that can be sent up. For any one with a little capital good land can also be had there at moderate prices.

In conclusion, your Committee would suggest, that it would be well if there were in this city and elsewhere, Labor Bureaux, by which employers and unemployed could be brought into contact, and the difficulty of finding one another when wanted, obviated.

The officials of the shipping office kindly interested themselves in obtaining vessels in which some ten of the above worked their passages home.

Of those partially assisted home, one case was that of a widow and family, who having lost their means of support, were anxious to get home to their friends; another case, a former commissariat officer, so much reduced by drink as to be in danger of perishing in the streets; a third was a family consisting of a man named Hebbens, his wife, and child, desiring aid, who had wandered together over the greater part of Canada on foot in search of work, and were in a ferrible plight. We contributed \$20 in this case, and the balance was made up by subscription. Then there was a boy too sickly to live in this country, and three distressed seamen recommended to us by Capt. Russell, Shipping Master, to be sent home at reduced fare.

Among those getting weekly or monthly allowances was one family in deep distress, owing to the illness of one of its members, and the father being out of work. Our aid was very timely.

John Dore, native of England, aged 60 years, was buried in our lot on 6th April, and an infant child of Joshua Spicer, on the 1st October.

A bright looking boy who, according to his own tale, had been turned out of his home in London, England, by a drunken

father, and had made a couple of voyages to this country, but was desirous of remaining ashore, was sent to Miss McPherson's Home, in Knowlton, and when last heard of was doing well. A great many very deserving cases have been relieved: others have been refused, as they evidently belonged to the class of *Tramps*, and were travelling over the country at the expense of the various national and other societies. This latter class are not anxious for work, even when it is to be had.

Many interesting details are to be found in the minutebook, which is open to all members.

The Right Revd. George Jehosaphat Mountain, D. D., D. C.L., Lord Bishop of Quebec, was the second son of Bishop Jacob Mountain, the first Anglican Bishop of Quebec. He was born 27th July, 1789, at Norwich, England, came to Canada with his father, 1793, and died after a brief illness at Bardfield, his country seat, on 5th Jany., 1863. He was nineteen years Rector of Quebec, and was consecrated Bishop 14th February, 1836. He was a diligent visitor among his flock. And in the dreadful visitations of cholera in 1832 and 1834, he literally lived night and day among the dying and the dead, while in 1847, when the province was visited with the plague of typhus fever, and the poor emigrants were dying by thousands at the Quarantine station, the Bishop took his turn at Grosse Isle regularly with the rest of the clergy; and again when the cholera visited Quebec, in 1849 and 1854, he was diligent in visiting the hospitals. During many years and up to the time of his death, Bishop Mountain, besides his life membership, contributed regularly to the Society a donation equal to four annual subscriptions, and at all times he took a great interest in its proceedings
