# Athletics in Ganada and the Golleges' Relation Thereto.

ANADA is an athletic nation. Her climate is particularly favorable to the development of splendid winter sports. What a beautiful sight to witness the snow shoe clubs tramping across the snow clad hills, or the toboggans speeding down their precipitous sides. One catches his breath as the daring ski-er leaps high into the air and clears a vawning chasm or a road upon the mountain side. What merry laughter, what wholesome fun, what abounding enthusiasm characterizes the skating parties, the cross-country runners and the boys upon the hockey courts. All through Canada the chromatic hues of toques, sweaters and cloaks against the snowfield of white produce a pleas ing effect upon the eye. Then, too, the tang and thrill of quickened blood, the wind-kissed cheeks, the sparkling eye all give vigor and vitality to the par ticipants.

This opportunity for healthful recre ation is one of Canada's great assets. It provides the opportunity for the development of strong bodies, tense muscles and large hearts and vigorous lungs. These games produce hale and hearty young men and women. They are a great social factor, they add good cheer and wholesome social relations. They allow for national expression. Canada's winter sports reveal her na tional traits just as gymnastics reveal the stolid German characteristics or Gaelic football the Irishman's impetu ous nature.

Canada's sports should be conserved. They should be honorably administer ed and carefully safeguarded. Every Canadian patriot should fight to the last to keep them from being commercialized, of letting other motives than sport for sport's sake creep in.

Sport should be socialized, not specialized. Every one should have a playground and every one should be a player. That type of athletic sports should prevail in which health is the

The College has been, in North Am ary and incidental.

But already the mercenary sport pro moter is trying to get his hands upon the sports of Canada, and use them for personal gain. Already so-called ath letic clubs are offering young menand often boys in their teens-"induce ments" of money and special privi leges to play on their star teams. Some larger athletic organizations depend their gate receipts from hockey and other games to pay expenses. Already some athletes with ability are asking "what is there in it for me to play?" Let us remember Greece and Rome, when in their sports, the ideals which characterized their athletes in the days of their supremacy, and made her great, were later forgotten.

Canada's sports are her treasure. They should be kept pure and whole some. Canada's games are character builders, they must be conserved. The best men in the Dominion, the most influential agencies in the land should seek to make and keep them whole some, amateur, democratic. They should be for the participation of the many, not for the exploitation of the few. Their aim should be to make men, ruddy-hued, clean-limbed, well knit, muscle-toned men, not for the development of skilled athletes whose motive is the prize or whose aim is mercenary-though there is a place for honest athletic competition.

This effort for clean amateur sport is on. The crisis is upon us. Shall Canada's competitive sports be ama teur? The Colleges should help to set tle the problem. It is exceedingly worth while. In fact, viewed from the standpoint of its effect upon young men it is imperative.

The College has been, in North Am erica, the leading factor in athletics. Here teams have set the type of sports and the spirit which governs in them. Unfortunately, they have not always been pure and amateur. The contrary is only too true with many. But the reaction has come. Strict eligibility rules are being established, freshmen frequently are ineligible to participate on representative teams, a scholarship standing is required and competition is limited to three years. are interesting themselves and are tak ing a hand in the administration of college athletics. All these are helping greatly to purify sport and make them truly amateur.

But the College is too local in its operation. It is too exclusive in its relations. It has in the past been too self-centered, concerned only in its own athletics irrespective of the interest of sport at large; as it affects the community or the nation.

The influence of the Colleges is need ed in the play life of the nation and they should join their efforts for the common welfare. Some time ago the Young Men's Christian Associations of Canada, by uniting together, and en tering the old Canadian Amateur Union, in company with other agen cies, rejuvenated and energized that latent agency, and made it a potent force for amateur sport, which it had not been heretofore. Some of the athletic clubs unfortunately wanted to employ athletes on a salary so as to get skilled ones, and withdrew from the reform body. While it caused divi sion, it separated the purely amateur organization from the so-called semi professionals. This had its good effect in drawing a sharp line between the organizations that stood for strictly

amateur sport and those that did not.

The new Canadian Amateur Athle tic Union immediately flourished, and to-day is the most vigorous, and most purely amateur organization that has ever existed in Canada. It is growing stronger each day, and is constantly adding to its constituency the best ath letic elements in the Dominion. The Canadian Amateur Athletic Union is a sort of federation of all amateur bodies, rather than an autocratic organ ization that seeks to dictate athletic policies, and this is the most reasonable form of athletic administration.

Unfortunately, through misunder standing, the Amateur Athletic Union of the United States severed its alli ance with the Canadian Amateur Athle tic Union.

In the meantime the athletic clubs favoring the use of the paid athlete on the same teams with the amateurs, formed an organization known as the Federation. Strange to say this body was received into an alliance with the Amateur Athletic Union of the United States. In making this alliance, how ever, it presented a very interesting amateur statement. This refers only to its track and field sports and basket ball. Indeed the Federation was will

ing to agree to an amateur proposition from an athletic body outside of Cana da, which it refused to make with a truly Canadian body, and strange to re cord, showed anti-Canadian loyalty in the Olympic games of London. How ever, we believe, that even the friends of the Federation were not sympathetic with this attitude.

Now, where are the Colleges in this struggle for clean sport? Theirs is largely an attitude of neutrality. Some disregard both organizations. support the Canadian A. A. U., a few play Federation teams. The Colleges and Universities should, because of a strong national spirit, thrust them selves into the game and help to score results. The Canadian A. A. U., to gether with the Colleges and Universi ties of the Dominion can, if they are in terested in conserving what is best in Canada's sports, and purging what is bad, bring about those conditions where the play life and athletic sports throughout the land will make for health and physical power, will develop skill and make for character and truly exalt the nation.

These are the conditions in Canada's athletics. What shall be the Colleges' relation thereto?

## The Swimmin' Hole on the Farm

PEOPLE who work hard all day should have a reasonable amount of fun and relaxation. The non recognition of this has driven thous ands of farmers' sons and daughters to the city.

If a stream run through your farm, be it ever so small, keep it clear and free from refuse of every kind, then select in it a favorable spot, and en large it so that it can be used for the purpose of swimming. A good swim after a hard day's work in the hay field is more refreshing than a sleep. But do not confine the privilege to the men and boys; encourage the women and girls to engage in the sport. They who have their farms bordering on a swift flowing river are fortunate, for there is no better fun than to run up the grassy bank for a distance, then to dive in and swim down with the current. To the average person un acquainted with the art, the vast possi bilities of swimming and diving are not even thought of. For instance from a low spring board sixteen differ ent dives, or head first entries into the

water can be performed, and in a full exhibition I demonstrate thirty meth ods of swimming.

One of the great drawbacks to swimmers, is the oft-attempted broad stroke-on-the-breast, as an elementary stroke. Instead of this I would advise the beginner to secure a pair of water wings, place them about the middle of the abdomen, then work the arms in a manner similar to that of a person paddling a canoe with a double-bladed paddle. The arms should work alter nately, while the feet thrash the water like the strike of a fish's tail. The illustration shows the crawl stroke with the swimmer's head in the water, but this position as a rule is adopted for racing purposes only, and it is not at all necessary that the beginner im merse his head. Also note that the body is in a horizontal position, for this is very essential to fast, easy swim ming. By lowering the head and filling the lungs with air, the feet will rise, and thus the body will be driven through the smallest possible displace ment of water. The crawl stroke orig

The left arm, which is out of sight, is supposed to be pushing the water back, while the right arm is reaching forward to be dipped into the water. Notice that the legs are never bent at the thigh, but at the knees only. Also note the position of the ankles, the feet always pointed like a ballet dancer's. Breathe in through the mouth, snap the feet together.

On account of a freak of the camera, the length of the arm is exaggerated, but this clearly shows the position of the wrist in gripping the water. Place the hand in the water gently, and then use the force in pushing back the water. The left hand has just left water with a kick which swings the arm forward, and saves the work of lifting it forward. Breathe out here through the nose when under water.

inated in Australia, and is one of the healthiest forms of exercise known. As a means of strengthening the lungs, and straightening the shoulders and spine it has few equals.

It is essential also if one is to reap the greatest possible benefit from this exercise, that he pay attention to the time he takes his accustomed plunge, and to the temperature of the water he is entering. Swim always before rather than after meals, and never bathe in water that is cold, as it has a decidedly weakening effect. Water that is comfortably warm is the best, for then one can stay in long enough to accomplish something really profit able.

Many of the drownings that are at tributed to cramps, are simply caused through the inability of the swimmer

to breathe properly when in the water, and this important phase of the art of swimming, can be learned only by care ful and consistent practice. Should a non-swimmer be suddenly thrown into the water, or should he wade beyond his depth, dog-paddle to safety instead of throwing the hands out of the water, and making no attempt whatever to keep afloat. This can be done, and has to my positive knowledge saved the lives of many persons who had never before learned to swim. The common practice of bathers, when in trouble, to shout all the air out of the lungs, and to struggle wildly is a dangerous one, and many accidents could be averted if those who get into difficulties would just keep cool and at least make the endeavor to swim. The wisest plan though is to learn to swim now, then

The hands push the water back and should not go too deep. The feet snap together. Note position of thumb and little finger of the hand that is in the water; thumb is always down, and little finger up; keep the hand similar to the blade of an oar always. Breathe out here through the nose. Let the beginner use only the arms at first, supported by wings.

you will be prepared for difficulties when they do arise. If shallow water is convenient learn to keep afloat there first, then venture to the deeper places; if you have only a deep pond at your disposal use the water wings, and you will be surprised to see how

quickly you improve. Learn to be a swimmer somehow or somewhere, for it is not only one of the most enjoyable forms of sport to be found, but it is an accomplishment that no one can afford to be without.



THE CRAWL ON THE BACK.

Alternate overarm on back. Right arm recovering out of water, left arm pushing the water back. The legs give a short scissors kick with each arm stroke. Hook the wrists and reach the hands far back on entering the water. Do not slap the hands in, but dlp in and then put on the pace,

## The Awakening of China

IN order to appreciate what the awakening of China means, we must review the situation in which that great empire-once the proudest in the world-finds herself to-day. For some years past the European powers have looked upon China, in her enfeebled and handicapped condition, as their private and peculiar play ground, in which they have indulged, so to speak, in a kind of international tug-of-war, the prizes being portions of territory, trading rights and conces sions which have been disputed, fought for and wrangled over with a fine dis regard for the lawful proprietors. Long and loud have been the discus sions, the reproaches and recrimina tions between the contending parties; but to China herself-the householder whose mansion has been so ruthlessly broken into, the proprietor whose gar dens have been trampled and dese crated-no consideration whatever has been shown. Her feeble attempts to make her claims heard have been ignored; her timid suggestions that she, and she alone, has the right to dispose of her own territories, have been met with derisive contempt; and she has been forced, not once but many times, to eat the bitter bread of humiliation, until in her very shame, she finds the courage to turn and as sert herself. For it is impossible to believe that a nation of such ancient and mighty traditions will forever tamely submit to the dictates of every aggressive "foreign devil" who may desire a share of her rich territories. "A worm will turn," and he who reads

the signs can have no doubt but that China has already commenced the "turning process; only, in this case, the worm has assumed the proportions of the largest of pythons, and the turn ing is likely to be fraught with danger ous consequences; for China, awak ened from her long sleep, China, con scious of new strength and a vast fund of reserve power, is a force to be reckoned with; and it is scarcely prob able that she will look with the kind est of feelings upon those, who, in the time of her weakness, trampled her in the dust and heaped the ashes of humiliation upon her head.

Let us consider, for a brief moment, the character of the Chinaman in order to see whether he possesses the qual ities essential to national greatness, whether he is worthy of more consider ation than has been shown him in the past. Unfortunately we are but poor ly informed with regard to the native of China. We know him only through the porcelain on our tables, with its lawless perspective, through the tea chest with its marvellous and incom prehensible hieroglyphics; at best we are familiar only with the lowest type of his nation; and hence we have but a degraded and incorrect view of a country, where the virtues of honesty, filial piety and politeness have been for centuries the basis of all moral and social upbringing, where the doctrines of Confucius, a man of blameless and absolutely unselfish life, are held in as great reverence as the Bible among Christians, as the Koran among Mo hammedans. It is only those men who

have lived in the midst of the Chinese, who have been the recipients of those little courtesies of life which seem so trivial, but which mean so much, it is only these men, the missionaries, merchants and engineers, and the vari ous European officials of the Imperial customs, who can have any true idea of the character of the native of China; and these men are unanimous as to his industry, his shrewdness, his determina tion and his exceptional honesty. In our mixed colonies in the Far East it is the Chinese who are the commercial backbone of the communities, who are the most loyal to their foreign associ ates, and the most amenable to govern ment discipline. Are the tenets handed down from generation to generation, the reverence of parents, the obedience to superiors, the lofty ideals of litera ture and art, the sacred obligations of friendship so carefully instilled, the teachings of emperors and sages, are all these to be supposed never to have borne fruit? And because the view of life taken by a native of China differs at first sight from our own, are we to consider him as lacking utterly in all those qualities which go to the making of a man and a gentleman? Some years ago the Chinese were guilty of the un paralleled offence of calling the repre sentatives of the proudest and most supercilious of civilizations, "outside barbarians." This was, of course, an unpardonable calumny; but such a weakness is excusable when we remem ber that at the time when our ancestors were naked savages, without arts, let ters or written speech, China rejoiced in an ancient, complicated and refined civilization-was rich, populous and en lightened-had invented gunpowder, printing, the mariner's compass and the sages' "Rule of Life"; and had

grappled vigorously with that same problem of existence which Emmerson found as insolvable in modern times as it was then.

Recent struggles in the Far East have rudely shaken from their lethargy the Chinese, hitherto a nation of schol ars rather than warriors. Close upon the heels of the "Boxer" uprising, which witnessed that unspeakable horror, a foreign occupation of the Sacred City, came the struggle be tween the mighty armies of the Bear and the Rising Sun, during which China was forced to stand aside, an agitated spectator of the despoiling of her territories, unable to lift a finger to protect them. Here was a state of affairs to make even the most bucolic of her subjects pause and consider whether a government which permit ted such things were worthy of the name! And when Japan forced the great Russian Bear to his knees, then every Chinaman knew that, without speedy reform, his country was doomed. It was Japanese success, rather than European aggression that first aroused China to a sense of her duty to herself; for China has never leved Japan, formerly despised her, and now fears her. Hence it comes that, having taken a leaf out of her enemy's book and realizing that, in order to endure, it is necessary to pro gress, she is steadily and constantly Westernizing herself. Militarism is predominant; education has been revo lutionized, and China is learning from her own enemies, how to fight them with their own weapons.

It is perhaps hard to believe that these four hundred millions of people, wrapped for untold ages in the mists of superstition, cradled in the bosom of ignorant conservatism, should sudden-

ly, and to such good purpose, set about the work of their own reform; but the chance introduction of steam and elec tricity has made possible what years of bitter experience seemed unable to accomplish. Those provinces which have been hitherto separated by the barrier of distance from the heart of the Empire, are now being drawn closer and bound together by the iron bands of telegraph and railway. Those famous old viceroys, who turned them selves into miniature emperors, who formed an "imperium sub imperio," and defied the emperor's decrees, are now powerless in the grasp of a central power; and where formerly flourished the many-headed monster, Anarchy, a determined and long-armed govern ment now distributes justice to the furthest boundaries of the Empire. Small wonder, then, that we hear of Chinese graduates in the great colleges of Europe and America; small wonder that far-seeing governments are hasten ing to proffer friendship, to obtain a place in the councils of the Empire. Great and powerful as Japan has be come, China will be yet greater, for hers is a nation of thinkers and her great men can rank with the great men of the world.

The reality of the progressive move ment cannot for a moment be doubted. For the first time, in the history of the Empire, the central authority has been enabled to enforce its decrees; for the first time the Provinces are activly and whole-heartedly engaged in furthering the Imperial policy, in anticipating the Imperial pleasure; China is beginning to "think imperially." She is knitting her disintegrated Provinces with iron rails and electric voices; she is extending the hand of friendship to modern education and religious freedom, and

she is building up her army and navy on the most approved European models. What a vast field, what limit less possibilities seem to open up be fore a nation like this; an extent of a million and a half square miles, shelter ing over four hundred millions of in dustrious people, producing and con suming three staples of food and cloth ing, wheat, rice and cotton-and three staples of luxury and comfort, silk, hemp and tea. When we mentally re view this picture, when we think of China's myriads of toiling people, her unequalled area of fruitfulness, her vast resources hitherto practically "un tapped," we can dimly conceive the effect on the balance of the world when this great force, hitherto inert and dormant, shall thrust its bulk into the delicately adjusted mechanism of our international and commercial system. One nation, exceeding in population the whole continent of Europe, com prising one-third of the population of the entire globe, composed moreover of people who have shown themselves the industrial equals of any upon earth, united by one common bond of na tionality, the servants of one common emperor, and acuated by one common impulse, to raise their country to the front rank among the nations. Were we possessed of the magic carpet, and able to fly into the future and there, from some lofty, solitary pinnacle, re view the world and all the nations of the world, what should we see? On the one side the nations of the West, powerful, proud, but isolated in their jealousy, each suspicious of her neigh bour, each working for her own ends. On the other China, an awakened, elec trified China, strong, alert, united, her people unweakened by internecine strife and international jealousy, sum

moning her multitudes to the great battle for supremacy. Then will be the time for the white nations, if they would keep their place, to put aside their bickerings and selfish intrigues, and, joining in one common bond of brotherhood, make head against the menace of the Yellow Man. Let skep tics say what they will, let them stig matize such prophecies-if a process of reasonable deduction can be called a prophecy-as visionary nonsense. It is this very attitude of serene confid ence in his own security that consti tutes the greatest danger to the White Man. We are apt to forget, we, the strong ones of the earth, that the term of another may come; hitherto we have shown to the Oriental only our "seamy side," our greed and avarice; arrogant in our strength we have displayed our selves to him as violent, taking with the strong hand, trampling the weak. Can we blame him for calling us bar barians? In any case we should re

member that he is a man like our selves, capable of human achievements and human emotions. In the words of Kipling, the man of many sides, we find a key to the situation:

"Oh, east is east and west is west, and never the twain shall meet

Till earth and sky stand presently at God's great judgment seat,

But there is neither east nor west. border, nor breed, nor birth,

When two strong men stand face to face, tho' they come from the ends of the earth."

What matter what color he be, black, yellow, white? What matter under what sky he was born, what tongue he speaks? He's a strong man and worthy the respect of strong and weak alike all the world over. Let us learn to be on our guard against him as a possible foe, even to understand him as a pos sible friend. We must not, and indeed we cannot despise him.



## Farm Management

The readers of the O. A. C. Review may be interested to know something of the work done in the office of Farm Management in the U. S. Department of Agriculture. So many of the agricultural colleges of this country go to Guelph to get teachers that, I have no doubt that a good many of your students will, in the future, be co-workers with us in the States. This is all the more reason why they would be interested in our work.


The Office of Farm Management re sulted from the recognition of the fact which forced itself more and more up on us-that the farmers of this country have, in the main, worked out the prin ciples involved in farm practice and that the better class of farmers, even sometimes without recognizing the fact, really have uncovered funda mental principles relating to the suc cessful conduct of the farm which would be of great value to others if they could be made common property. The early work of the Office of Farm Management was therefore the study of farm practice, and this is still the leading feature of our work. We di vide the country up into districts and place one man in each district, whose duty it is to ascertain what types of farming prevail, which of these types are most successful, what effect they have on the fertility of the land and on the standard of living and their rela tion to markets, labor supply, capital required, etc. Especial attention is paid to the crops which thrive best un der different conditions in a district, and to the methods used by the most successful farmers who are

following each of the types of farming which seem to be best adapted to the region.

Most of the bulletins we have thus far published are merely descriptions of a few of the best farms we have found. These bulletins do not give a general idea of our work. It is as if we were developing a gold mine, and had not yet gone far enough to outline the pay streaks, but in our prospecting we have found a lot of fine nuggets, which have been carefully described. We are getting now nearly to the point where we are ready to show the public where the pay streaks lie. That is, we shall soon be publishing a series of bulletins that will give the results of our more general studies.

We are getting from some fifty farms a detailed account of every quar ter hour's work done upon them. We are making careful surveys of these farms, and are plotting the fields, and are getting a detailed statement of their equipment and the capital involved in the various phases of this equipment, including the land, buildings, fences, implements, live stock, etc. From such data we hope to be able to work out the cost of all kinds of farm operations, the cost of producing crops, of handling live stock, and to ascertain what the profits are. Such facts will be exceed ingly useful in planning the work of the farm.

Perhaps, I may in future numbers of The Review be able to give your read ers some idea of some of the best farms we have discovered, and, perhaps, some more general ideas of farming in this country.



[Editorial Note.—Our request to Prof. M. Cumming, Principal of the Nova Scotia Callege of Agriculture, for a contribution to our columns, found him too busy to prepare an article especially for the Review. We publish below, his letter in which he speaks of the progress of his work in Nova Scotia, and to which the appends an extract from a report he is issuing, which we believe will be of interest to our readers.]

#### Mr. Editor:

You have asked me to contribute something to the columns of "The Re view." My interest in the College at Guelph and its official publication, "The O. A. C. Review," prompts me to comply with your request. No paper which comes to my office is read with greater interest than the "Review," and I am pleased to note that in every way the editors are maintaining the high standard which has been set for this publication.

Our College at Truro is making splen did progress. Four years ago we com menced with an attendance at our regular course of seventeen; now we have currolled forty-eight. Then we had at our short course sixty-eight, and at our 1939 short course we had a regularly enrolled attendance of 221, with an intermittent attendance of over 300. These figures in regard to the College may, I think, be taken as representing the general spirit of progress which is now manifest among the farmers of the Maritime Provinces.

As you are probably aware, the farm

ers of these provinces have, through diversity of employment, limited their farming operations, the same man at different seasons of the year being sometimes a farmer, a fisherman, a lumberman, or it may be, a miner. Hence, things agricultural have not pro gressed as they might have. Gradu ally, however, a new spirit, has been coming over the farmers of the Mari time Provinces, and a greater confid ence in farming as a means of making a livlihood has been catablished. We. at the College, are endeavoring to our utmost to encourage this most desir able movement toward up-to-date farming. Progress is our word and building on the solid foundation which we had so strongly impressed upon us when studying at Guelph, we are en deavoring to enforce the fact that "In livestock lies the salvation of Mari time agriculture." This month we are issuing a report, bearing on the live stock industry of the province in which we state our confidence in the cow as a means through which our farms shall be emancipated. In this we have tried to pen a brief tribute to her and we submit it to you under the title of—

#### A Nova Scotian's Tribute to the Cow.

We have sung of a man and his ach evements-of the poet, the orator, the statesman, and those who, in their lot in life, have done their duty. We have sung of our country-its re sources, its beauties, its grandeur. We have written of the throngs of the city and have idolized the life 'midst green fields and by running waters. We have thrilled at the song of the bird and the speed of the swift limbed horse. We have wondered at the in stinct of the beasts of the forest, the field, and the air. These things terres trial have filled our minds. But who, that has pictured the brute creation, the noble horse, the mighty lion, or the songful bird, has stopped to think of her, who of all man's animal friends, is the greatest-the cow.

Remove her from this globe and think what we will take. Old Eng land's roasts of beef, the food of her valor and solid achievement, those smoking steaks-we'll take them. That mug of milk by yonder high chairwe'll snatch it from the eager hands of that rosy-cheeked child. That plate of yellow butter, that pot of cream, that cheese-we'll take them and leave you to give thanks over dry bread and tea and strawberries unmellowed by these toothsome products of the cow. Those boots and shoes that save you from the snow and rain-we'll take them. And more too, for stop to think of what we owe the cow. From her head to her tail, there is not a thing but is used to minister to man's wants. Our milk, our cream, our but ter, our cheese, all come from the cow. Her flesh is the food of all nations.

Let her cease and half the world's commerce is at an end. Think of a Den mark, scarce two-thirds the size of Nova Scotia, exporting, through the medium of the cow, one hundred mil lion dollars worth of produce. Think of a Holland vieing this. Think of what she might do for this province by the sea.

Grand and noble brute—of all man's friends the best. Where'er enthroned prosperity rules. We pay our tribute to you. And he that would abuse you, would fail to care for you and feed you as he ought, we would remove from his table all that you have placed upon it. We would exalt you in our province. We would plead your rights, for in doing so we plead for everybody; the smiling babe, the loving mother, the aged grandparent, the merchant and the laborer, the pauper and the million aire—yes, for humanity itself.

## Personal Reminiscences

THOUGH it was not my fortune to have met Bakewell, he was with out doubt the greatest improver of live stock that Britain ever pos sessed. I was born within a few miles of Dishley; reared on a farm reeking with evidences of the former occupant—a member of the Bakewell Club—and the very soil was saturated with the memory of Bakewell.

The ordinary sheep of the country were ill-feeders, scraggy, maturing at three years, and not much better than the range sheep to be found at the Stock Yards in Chicago. Yet Bakewell within his lifetime regenerated these nondescript rent losers into hoggets that at one year old, if fat, were almost useless for the table. They, however, put the guinea stamp upon every Long Wool sheep in Britain. Lincolns espe cially were benefitted and the breeders thereof are to be congratulated, that while they retained the volume of wool they recognized the necessity of earlier maturity. Nowhere can such a display of mutton sheep be found as at Lincoln April Fair, some 25,000 hoggets in their fleeces, just over one year-such a sight can never be seen elsewhere, and Bakewell did it. Do we not read that four Lincoln breeders paid \$5,000 for one Bakewell ram? Henry Dudding's father was one of the quartet. We cannot dwell, but we must not leave this unique personage without mention of his work with other stock than sheep. The Long-horns owe much to him. Their popularity has survived longest in the neighbor hood of Dishley, where occasional

herds may be found at the present time. Then the Shire horse, what we have to-day has been built upon the foundation laid by him; with Yorkshire swine his work is ever present. The personality of the man was distant and secretive. His works remain and while I cannot claim knowledge of the man I can recollect some of his apostles.

I must leave Bakewell and get to Robert and Charles Collings who were students of Bakewell's methods, im provers of the Shorthorn, while not originators like Bakewell. Their A. B. C. had been provided. They simply took up the task as left to them by the earlier worker. They availed them selves of the material supplied to their hands. The roung clay model was provided, all they had to do was to put the master's hand upon the clay and then polish. What our breeders have been doing up to date is simply perpet uating what has been. Here might be mentioned the names of earlier work ers but all students can easily supply the same.

After Bakewell the line of thought led to Collings. Mason must not be forgotten, for he was a candidate for honors that were competed for by Bates and Booth. He was a true disciple of Bakewell for he liked his cat tle to be fat as the Dishley Leices ters—as one of England's breeders pro nounced them "carrying fool's fat"—hence from Mason follows Captain Barclay, who bought at Mason's sale, and there is not a Scottish herd to-day but what is saturated with Barclay

blood, the earliest and most pro nounced Scottish breeder until Cruik shank Brothers used the best at their hands, wise men, but not inspired breeders, they were wise enough to secure what was at hand for them and use it to best advantage. But oh, those "neeps" and the intelligent way in which the herds were managed. No better feeders or better feed can be found than in Aberdeen.

Before leaving Shorthorns, and I know nothing else, I admire other breeds like them, and acknowledge their usefulness, but I cannot bend the knee and worship them. Sir Charles Knightly must not be passed by. He absolutely ran his own herd to his own satisfaction, ignoring both Booth and Bates. What he wanted he was able to buy. He would insist upon milk as the main adjunct of his cows. With the milk instinct came the feminine face, fore quarter and the swinging milk vessel. But what dairy cows they were. To Hustrate my apprecia tion, the first Shorthorn I ever bought in England for my own use was a Knightly Garland. As a landlord, as a genial companion, with his hunting friends, his name will never be for gotten.


We must leave the Shorthorns, though the subject is only approached, and away to the Sussex Down. What Bakewell was to the Long Wool sheep John Ellman, of Glynnde, was to the medium wooled sheep. His work, like

that of Bakewell, was the regeneration of the sheep of his native downs, which as a result of breeding for generations from ill-grown, mis-allianced parents had become so inferior that none but an enthusiast would have undertaken the work. It was attempted, it was consummated in the one man's lifetime, with the aid of the Duke of Richmond. (for reference see Arthur Young's "An nals of Agriculture").

While Bakewell was a "clam" with few friends, John Ellman was a power in the land besides his sheep worship. He was recognized as a pioneer in sheep husbandry, but that is another matter requiring other investigation.

But, while Bakewell was basking in his selfish mood Jonas Webb was wel coming the crowned monarchs of Eu rope, no show place was so often visit ed or so great a welcome extended. While Bates was weighing his butter, Jonas Webb was entertaining potent ates. My feeling goes out to him for did I ever spend more week ends than at Henry Webb's? Nor did I ever meet a more charming family; nor could any stranger get more near like home than Mrs. Webb's kindly recep tion; and then to the Village Church for the weekly service makes one of those red-letter days in one's life never to be forgotten.

I can write no more for the reason that I cannot personally record the his tory of Herefords or Angus cattle, nor of Hamps or Oxfords.



[Editor's Note.—All undergraduates of the O. A. C. are required to conduct original investigation work. This work is usually performed during the summer of the Junior Year. The results and summaries of which are printed in thesis form, bound and submitted to a committee for examination. After examination the theses are placed on file for future reference. The following are summaries of a few theses submitted in 1909.]

## Investigations re. Concentrated Feeding Stuffs

THE composition of any feeding stuff is of interest to all intelli gent feeders of farm animals, for as long as the live stock industry is of paramount importance, so long must the question of feeding farm animals be the next in significance. This means that the farmer should know more about the relative value of foods in order not only to feed them intelli gently, but to estimate their value up on the market. At the present time the prices asked for cattle foods in Canada bear little relation to their ac tual food value. Foods are retailed at so much per ton, regardless of their composition or suitability to supple ment the ordinary farm foods.

In the United States where breakfast foods are more largely used and the by products sold as cattle foods, under nu merous and often meaningless names, the government has been compelled to give the matter serious consideration. As a result some of the states most affected have passed laws known as the Feeding-Stuff laws, whereby all manu facturers are required to secure a license, and provide a guarantee as to the per cent. of protein, fat carbohy drate and fiber, and to state specific ally what the component parts of the feeds are. With the ever-increasing population in Canada the demand for breakfast foods will undoubtedly grow, as well as the demand for concentrated

foods for animals. It is generally un derstood that foods sold by cereal man ufacturers are of little value, being very low in food value, high in fibre, and of little use for feeding stock. Un doubtedly in a great many cases this is true. It is quite apparent to the aver age reader that oat-hulls, for instance, as a concentrated food, would be of little use even for a maintenance ra tion, yet oat-hulls can be used very ad vantageously to give bulk to a food such as cotton-seed meal. In this con nection we must also remember, that there are many by-products of a very high feeding value. For example, in the manufacture of starch from corn, we have what is known as gluten meal. This is often as high as 25 per cent.

in protein, and is used to a large extent by cereal mills to raise the nutritive value of their foods. This being true, it does not seem unreasonable to sup pose that by intelligent use of these different by-products, that foods could be mixed suitable for almost any class of stock.

The writer carried on a series of digestive experiments with four compound foods, viz.: Molac Dairy Feed, Schumacher Feed, Banner Cattle Feed and Victor C. & O. Feed, in order to estimate their relative value upon the basis of digestibility.

The following table includes the chemical analysis and digestive coefficients of the four feeds in question.

In examining the above table we find that the first three feeds compare very favorably with oats, in composition. Molac is somewhat higher in protein, this being due undoubtedly to the addition of cotton-seed meal. The fat content has been raised in the same way. It is generally noticed in studying foods that those high in fibre are proportionately low in digestibility. This, however, does not always prove true, especially when a number of the ingredients which make up one food and one of the number happens to be a highly digestible nutrient, such as

cotton-seed, or gluten meal. This is clearly demonstrated in the above table where Molac, although possessing the highest fibre content, nevertheless shows a greater digestibility than the other foods under consideration.

Owing to the fact that Molac and Schumacher are used largely as dairy foods, and that the others are more general purpose foods, it will simplify matters, if they are compared under these heads.

From the above table we find under the head of protein, that Molac posses ses 14.78 per cent. of which 80.70 per

cent. is digestible. Schumacher Feed contains 12.31 per cent. protein, 81.48 per cent. digestible. Calculating from these figures, Molac possesses 240 pounds of digestible protein in a ton, whereas Schumacher shows 206 pounds, a difference of 34 pounds per ton in favor of Molac. In considering the other two feeds we find that Banner possesses 11.35 per cent. protein, as compared to 9.91 per cent in Victor; of this 77.25 per cent. is digestible in Banner, and only 57.25 per cent, in Victor. This gives in one ton of each food 175.8 pounds prtein for Banner, and 114.5 pounds for Victor, a differ ence of 61.3 pounds in favor of Banner. It will be seen at a glance that Banner exceeds Victor in all desirable consti tuents, being higher in both total and and digestible content. Space will not permit a further discussion of the table. but this should be sufficient for the reader to understand the table and study it for himself.

It can readily be seen from the fore going data that there is quite a difference in composition between these four feeds, and shows the necessity of feeders knowing something of the relative value of foods of this nature before buying them to supplant the ordinary farm foods, or as an addition to a ration. Even our most common foods—wheat bran for example—has become so adulterated that many feeders have stopped using it. Not many years ago wheat bran contained about 13 percent. digestive protein, while to-day

it is not unusual to find it as low as to per cent. In the writer's opinion it is high time for the farmer to have pro tection in this matter. It is under stood that a committee has been formed to petition the government re garding laws governing the sale of mill foods. This is a move in the right di rection, and should receive the support of every intelligent feeder of stock.

#### Part II.

In connection with the above article a brief note might be added concerning two of the feeds therein mentioned, viz.: Molac and Schumacher.

During the winter of 1907 a practical feed test was made of these foods, by the writer, to ascertain their value as compared with bran and oats for milk and butter production.

The test was run for three months. It was made with six cows, two from each of the three breeds represented in the College herd, being Holstein, Jersey and Ayrshire.

The cows were fed a definite and constant amount of roughage, consisting of clover and timothy hay, silage and roots. Both feed and milk was carefully weighed and an accurate account of each kept.

The following tables give in brief the results as obtained, estimating the amount of grain required to produce one hundred pounds of milk and fat.

Experiment No. 1. Molac versus Oats, mixed with bran.

In consulting the preceding table we see that Molac proved somewhat su perior to Oats when mixed with bran. The amount of bran fed in both cases was the same. We note that there was 42 pounds more of the oats fed than of the Molac. The Molac produced three pounds less milk, but .274

lbs more fat. While it took 3.39 lbs. less to produce 100 lbs. of milk and 88.5 less for 100 lbs. of fat.

### Experiment No. 2.

Oats versus Schumacker, mixed with bran.

About the same comment can be made on this table as on the preceding one. The amount of bran in both ra tions was equal. The total amount of milk and fat was less from Schu

macher, but the amount for 100 lbs. of each was less.

In the above table Molac makes a very good showing compared with Bran, when mixed with Oats. There was equal weight of Oats in each ration.

In the above rations equal weights of Molac and Bran were used and also equal weights of Oats and Schumach er. It might be expected from the re sults of the foregoing experiments that Molac and Schumacher would prove superior to the Bran and Oats, but such is not the case, although the two rations are almost equal. As the table indicates Bran and Oats produced 14.3 lbs. more milk, and practically the same amount of fat. There is only a little over one-half pound difference in the amount it took for 100 lbs. milk and only 2.3 lbs. difference grain for 100 lbs. fat, but what there is favors Bran and Oats.

This would almost go to show that

although Molac and Schumacher mix well with Bran or Oats, they are not any better than Bran and Oats when mixed together, yet compare very favorably with them.

With this data in view we may con clude by saying that as long as these foods are sold at a reasonable price and consistently mixed they will prove to be a very profitable way of dispos ing of much of the by-products of our cereal mills.

## The Ash Constituents of Oats

The mineral substances which enter into the composition of plants consti tute the ash or that portion which re mains after all that will burn has passed away. These ash constituents, though slight in amount, stand in a peculiar and interesting relation to the life processes and living structures of plants. They have received less at tention in the past than their import ance deserves. Their functions are so complicated and important as to con stitute a wonderfully interesting field for investigation by the scientific ag riculturist. This is a field in which the chemist, the agronomist, the physiolog ist and the average farmer find a common ground of interest for these ash forming substances, constituting the ash of plants, come from the soil,

through the plant and thence to the animal,

The mineral substances of food stuffs are present in four conditions, in solution in the plant juices, as crystals in the tissues, as incrustations in cells and in chemical combination with the living substance.

The ash content of any species of plant varies considerably as affected by the character of the soil, the manuring, the season, the date of maturity, and the variety grown. The varieties in the following analy sis were grown under similar and natural conditions. Hence, we may assume, to some extent at least, that the factor, variety, does exert an influence in the composition of oats.

Some definite knowledge of the char acter and distribution of the ash con stituents in the grain and straw of oats is revealed in the above tables. The straws of these three varieties contained, in each instance, a higher per centage of ash than was found in the grains. Another marked difference ex isting between the ash of the two parts of the crop is noticed in the fact that the mineral matter held within the grain is a more constant quality.

The compounds of phosphorous, potassium and calcium are prominent in the composition of the oat plant. These three elements, besides being important constituents, are quite as important plant foods, and therefore demand very prominent consideration.

From the above tables the ash of the oat grain is thus seen to be composed largely of silica, potash and phosphoric acid, while silica, potash and calcium form the bulk of the mineral matter of leaves and stem.

The percentage of K2O in the straw exceeds in each case that found in the grain. However, the results show that it is quite evenly distributed throughout the oat plant. A point of not a little importance is brought out

in the above figures in that potassium occurs in the entire plant in the largest proportion of any of the essential ash elements.

We notice that a very large per centage of the phosphoric acid re moved from the soil in a crop of oats is found within the grain. It is apparent from these figures that nearly the whole of the P2 O5 of the plant had been accumulated within the seeds at the time of ripening. Phosphorous is one of the two essential ash materials which was found to be present in larger quantities in the grain than in the straw, at the time of maturity.

The percentage of calcium is much higher in the straw than in the grain. This element does not accumulate in the seeds to such a great extent, as for example P2O5. Only about one quarter of the total quantity of lime removed in a crop of oats is in the grain.

These analyses show that as between different varieties of the same kind of plant the ash content and its composition varies quite widely. Variety, is then, one of the factors which influences the variation in composition of vegetable materials.

# The Outlook for Apple Growing in the East

IN TWO PARTS-PART I.

PPLE growing in the North East ern United States, and in Can ada is a much discussed indus try at the present time. It seems prob able that to-day is a transition period in the history of the apple industry in this section of North America. Will intensive methods of apple culture re place the haphazard methods so long productive of but low average profits? Will spraying become the rule and not the exception in the East? Will the box package replace the barrel? Must we find cheaper gift packages than bar rels or boxes or must some method of returning or disposing of such pack ages be devised? Will the East ever supply as fancy a fruit trade as the far West, or must Eastern apples become merely a standard for cooking, evapor ating and cider stock, while the far West grows our dessert fruit? Pro vided the East fails to produce so fancy an apple as the far West, will the ad vantage of proximity to market and ex port points more than compensate for the difference in quality of fruit? Will apple growing in the East pass out of the hands of farmers into those of spe cialists who will rent farm orchards, plant and grow large commercial orchards. establish cold storage

houses, and generally take over the business of apple production and marketing? Will co-operative apple growers' and shippers' as sociations save the situation or help solve the problem of successful apple growing in the East? These are ques tions and conditions that confront the student of the apple situation in the North Eastern United States, and in Ontario, Quebec and the Maratime Provinces in Canada.

The factors which make for the pro fitable culture of any crop are, of course, the determinants of the outlook for that particular branch of agricul ture. The questions which are cited in the previous paragraph are answerable, pro and con, according as the business of apple growing in the East conforms or fails to conform to certain basic principles. If the factors which in fluence the apple producing business in the East are correctly determined and duly valued, the question of the profit ableness of the industry and the man ner of conducting it can be answered; and the whole matter can be settled with mathematical nicety.

But the factors that make for the profitable culture of no crop can be determined with absolute accuracy.



THE DEMAND IS GOOD.

Therefore, it is necessary for every in dividual to study his own conditions, and situations, with the utmost earnest ness and foresight, if he is to determine with approximate correctness the ultimate success of a venture in commer cial apple growing. In this article the writer has endeavored to analyze some of the conditions which prevail in the Eastern apple growing sections, to in dicate the possibilities of the industry, and to some extent point out the direction of its line of development.

Among the factors of prime import ance in apple growing are suitable con ditions of climate and soil. Are the conditions of soil and climate in the New England States, Ontario and the Maritime Provinces of Canada favor able for apple culture? Let the experi ence of two hundred years and of thou sands of successful orchards in every section of these regions be a clinching argument. Count the number of suc cesful apple nurseries in operation in these districts and compare them with other states and provinces. Compare the total and average production of On tario, Nova Scotia or the New Eng

land States with similar areas else where, and you will be convinced that however, much their prestige in the apple-realm may have fallen in the world of print, there is nothing in the market reports to give one a pessimis tic outlook on Eastern apple orchard The region under discussion ing. offers the widest possible range of soils and possesses every variety of slope and exposure favorable for specific pur poses or varieties. It possesses a suffi cient yearly rainfall to make irrigation unnecessary, on the whole has remark ably favorable blossoming periods, and has a wide choice of cleared land suit able for apple growing at prices much more reasonable than are demanded for orcharding lands in the far West.

Of equal importance with suitable soil and climate in successful commer cial apple growing is a suitable market. Without the latter the most excellent soils and climates in the world will not be sufficient to bring profitable returns from the orchard. Are the markets open to New England, Ontario, and the Maritime Provinces able to take at good prices enough first-class apples to compensate the growers of these re gions? The conditions in Canada are somewhat different from the conditions in the New England States, though both have points in common. The Bri tish export market is open to both, an ever growing market capable at all times of taking care at paying prices of every first-class apple that either country may send. The possibilities of the apple market in Great Britain have never been realized. The mother land takes only a moiety of the fruit which it will take when every British town and city has been organized to use and taught to rely on the American supply of apples. The continent of



Apples form the standard filling for pies. Apple pies made by students of the Macdonald Institute are particularly recommended,

Europe is slowly but surely becoming a customer for our apples, and the ex port trade will expand more and more rapidly in that direction as the years go on. Ontario and the Maritime Pro vinces have open to them a fair, though not a remarkable, home market. New England is rich in an urban popula tion capable of using unlimited quan tities of apples. Here is the opportun ity to organize special trades, to supply private customers, to save expensive transportation charges and car refriger ation. Here is an opportunity to de velop growing, specialized marketing, and a high type of fancy apples.

To the writer's way of thinking, the market outlook for the apples of On tario, Nova Scotia, and New England is dependent on the growers and not on the consumers. The demand is good. The prices are almost always remunerative, and often they are exceptionally so. During the present winter first-class Baldwins have sold

in the Boston market throughout the months of January and February for six dollars per barrel. Ordinary sound Baldwins of good cooking quality have not brought less than three dollars per barrel. Twice during the month of January the writer was unable to buy Northern Spy on the Boston market at any price.

Every standard variety of apple has been proportionately high this winter. The demand at the moment of writing is not nearly equalled by the supply; and, while this condition does not ob tain every year, a careful study of the trade for several successive years shows a fairly constant and relatively high price from December to March. in all our leading home and foreign markets. Even during the season of 1907-1908, when the dealers lost hea vily on the apple speculations, the prices obtained for stored fruits were sufficiently high to have netted hand some profits to all parties in a normal

year, and the growers received prices higher perhaps than were ever obtained before.

There is less fluctuation in the ac tual demand for apples than one might suppose. The many uses to which this fruit is put are factors that steady the call for apples. It has come to be a sign of a true farmer to want ap ple sauce two or three times a day throughout the season. Apples are the standard filling for pies. Baked apples are upon the menu cards of every res taurant and café worthy the name in Canada or the Northern United States. Apple butter, apple cider, apple vine gar, and dried apples are standard pro ducts of the crop which forms our sub ject. All these products are being used in greater quantities every year. One of the accompanying illustrations shows a dining-table centerpiece in which apples take their place with oranges and grapes for decorative pur poses.

Now-a-days the successful market

ing of perishable products is frequently dependant on transportation and stor age facilities. Is the region under con sideration well equipped in these re spects? Certainly the East is nearer the export markets than the West. In lower freights it has always an advant age of first importance. In respect to quick marketing of perishable varie ties, it must necessarily have an even greater advantage, for besides the say ing effected in time by nearness to market there is a large say ing in cost of packing, in waste of slightly over-mature but immediately marketable fruit, and in icing charges. In special cases the Eastern grower may ship by express, whereas the West erner must, on account of the exces sive cost of this means of transporta tion, rely wholly on the slower freight service. In faster freight schedules and number of trains the preponderat ing advantage is in favor of the East. The accommodations rendered by the eastern railroads leave much to be de

sired, but unquestionably they are as yet superior to those offered in the West.

Our storage facilities are not ideal. Nevertheless we are better furnished with these than are most of our neigh bors and competitors. Ontario has

been particularly energetic in the erec tion of storage houses. New York State growers long ago learned the ad vantage of winter storing of apples and practiced it to such an extent that the dealers in our large city markets rely largely upon New York apples during the months of February and March. The New England States have not developed the home storage idea to any appreciable extent, but the growers here use the commercial plants of the city freely. No other apple re gion offers the same opportunities for cheap storage. The two natural refrig erants, cold air and ice, furnish cheap means of preservation. Wood, per haps the cheapest and most effective constructive insulating material, is lower in price here than in any other apple growing region except the Paci fic Coast, where artificial refrigeration must be resorted to. The problems of refrigeration in transit are being earn estly worked upon and will be duly solved. In view of these facts, there fore, the writer sees no reason why the East should view pessimistically the transportation or the storage factors in fruit growing.

We speak of it as a responsibility since it is largely upon the judgment of the students that the success of each so ciety and association for the ensuing year depends. The majority of col lege men do not look upon the matter in this light, and many do not even consider it necessary to attend a meet ing which has for its purpose the elec tion of officers. If dissatisfaction is after wards shown as to the men in whose hands has been placed the administra tion of the affairs of a certain society. it is generally the students who have taken no interest in the elections who evince it. In all justice to the various associations, to the officers, and to the students themselves, it is highly neces sary that each student as far as pos sible should exercise his influence in choosing the best men to act upon the various executives and committees. Careless choice and careless voting is sometimes manifest, though happily in most instances the danger is over ruled by the more level-headed ma jority. Too often men who have be come popular through various achieve ments are nominated by their admirers for positions entirely unsuited to them. Some men are nominated because they are good fellows generally, execu


tive ability scarcely being considered. Then there are those students who be come overloaded with work of this na ture. It is not uncommon to find a man holding two, three, or even more offices on different committees and ex ecutives. Such a man is generally a student of exceptional ability, and may be capable of accomplishing the work of each office satisfactorily, but too often he is almost forced to accept one or more of these appointments against his will. There appears to be a natural

law that if a person is willing to as sume a certain amount of responsibility, the more he finds himself called up on to undertake; but there is a limit for every human being in his capacity for work. It is not fair to overload in dividual students with responsibility of this nature, since often it necessit ates undue neglect of very important work of the course. Therefore in electing officers for the executive boards of the various college associations, choose widely as well as wisely.

The Barton-Hamer medal was pre sented by Professor G. E. Day, and he wished the recipient, Mr. N. D. Mac Kenzie, who stood *highest* in our team at Chicago, prosperity and success in his chosen line of work.

The critic's remarks by Rev. W. G. Wilson, were brief, but valuable, and the meeting closed by singing "God Save the King."

## Public Mock Parliament.

On February the twentieth, the hon orable members of the Legislature (students assuming parliamentary of fices) assembled in the gymnasium for a session. The gymnasium was filled with an attentive audience, who expected to see legislators in action, and they were not disappointed. The Address from the Throne outlined the measures for consideration of the House. The address was adopted and the House proceeded to business. According to the Opposition the Government did not have very much business, and many took the opportunity to enlighten the legislature on several interesting facts, both national and personal.

A bill respecting the taxation of bachelors was introduced, and several minor bills received a reading.

Professor Reynolds spoke one even ing on the Niagara Conference Cam paign, dwelling upon the advantages of such a student gathering and urged all who could possibly make necessary arrangements to be present. Professor Reynolds conducted a Bible Class there last summer, and he knows ex actly what is to be obtained at this conference, held in June at Niagara-on the-Lake. The retaining of this confer ence on Canadian soil rests wholly with Canadian students. It is neces sary to be represented by a large num ber, and we desire that everyone should go, if it is possible. The Association will assist to a certain extent in de fraying expenses.

friendly contest. It will be remem bered by our readers that College took part in the competition at Toronto in February, and met with rather indif ferent success. On this occasion our boys gave a very much better account ming and plain diving there was not so much to choose between the two teams, but in fancy diving the visitors had it on our boys easily, and it was in the latter events that they made most of their gains.

Shortly after three o'clock Announc er McFayden called upon the contest ants in the "50 yards dash" to take their places. In the first heat Ryan represented College, and pitted against him was McKenzie. After giving a few instructions as to the methods he would use in starting the contestants, and a warning not to plunge till the pistol had been fired, Dr. Reed gave the word and away they went. Mc-Kenzie got off to a fine start with a lead of six feet, which Ryan could not quite overcome. In the second heat Shaw was just a little too fast for Treherne, and this also went to Varsity. The winner's time in both heats was 36 seconds. The "plunge for distance" went to College, after an interesting contest. Johnson appeared to be the winner until the last dive, when Harries snatched it from him in a great plunge of 47 ft. 7 in. In the "50 yards three styles," Ryan fully re deemed himself for his defeat in To ronto, winning a great race, his time being 41 2-5 seconds. McPhedren got second place in this event. In the "dives for form," Varsity took both first and second places. They attempt ed difficult dives and executed them with a degree of perfection that one does not often have the opportunity of seeing. Keith, Canada's finest gymn ast, won first place, with Corrie a good second. The "100 yards race" also went to the visitors, McKenzie win ning in 1 min. 25 2-5 sec. In the "tub race" Rogers and Powell, both of Col lege, again battled for supremacy. Powell led for a length and a half, but then met with difficulties, and Rogers triumphantly passed him and landed the race by a few feet. Follow ing this was the "50 yards back swim," which Varsity won in 47 seconds. The

last event, the "relay race," went to College on a foul that was just as un intentional as it was unlucky. Varsity had slightly the better team, and cer tainly were unfortunate to lose the race in the way they did.

The polo game which followed the swimming and diving competition was a fast one while it lasted. College started out on the aggressive, and after a few moments' play shot a goal, but it was disallowed by the referee. Varsity then took a hand in the game, and by some pretty combination work succeeded in notching the first. On the change of ends, College again be gan to press hard. They kept the ball almost entirely in their own hands, and rained shot after shot on Varsity's goal, but they either went wide or were blocked by the goal tender; at last Keegan secured the ball and by a pretty shot from close range, tied the score. The third quarter had just nicely opened when one of the Varsity players was seized with cramps, and as they had no one to replace him, and were pretty much exhausted by their heavy day's work, they decided to de fault. College was playing a strong game when it ended, and from a spec tator's point of view appeared to well merit the victory.

#### Inter-Year Polo.

Owing to the non-entry of the fourth year polo team to the inter-year series, the championship this year was left to be decided between the three junior years. This, however, did not in the least degree lessen the interest taken in the game, and it may well be said that the series was one of the best ever held at the College. A double schedule was played, and as the second year have gone through the season

without a defeat they are the undis puted champions. They are perhaps one of the strongest teams representa tive of a single year that the College ever possessed. Every member of the team is a good swimmer, and they use splendid judgment in passing and shooting, which is just as essential a feature in water polo as in hockey or football. Altogether they are a well balanced team, and merit fully the dis tinction they have attained.

February 19th—First and second years played the opening game of the season, and as the score indicates it was a walkover for the Sophomores. They swam all around their opponents, piling up the huge score of nine teen goals, while the Freshies were un able to negotiate a single tally.

February 23rd.—The Freshmen met their second defeat, this time at the hands of the third year. They were not, however, so completely outclassed as in the previous game, but it was quite evident from the start that they could not win. Faulds easily handled their long shots, and nearly every at tempt they made to carry the ball close to the third year goal before shooting was broken up by Harries, whose well directed return shots kept the opposing goal tender guessing all the time. The score was 7—3.

March 1st.—The second year gave the Freshies another bad drubbing, the latter being saved from a whitewash by the narrow margin of one goal, while their conquerors rolled up an unlucky thirteen. There was nothing to it but that the second year were the better all-round team, and won as they pleased, although it may be said of the Freshmen that they showed im proved form from their first game, and need only practice to develop a first rate polo team, for they have among their number many really good swim mers.

The remaining game between sec ond and third years has no bearing on the championship, but will decide which of the said teams is to have the honor of second place.



### Boxing and Wrestling Tournament.

The annual boxing and wrestling tournament, held on Saturday, March 13th, provided an excellent afternoon's entertainment for the students, and the few visitors who gathered in the gymnasium to witness our amateur pugilists and grapplers perform. Some good bouts were pulled off, and some new material brought to light, both in the boxing and wrestling.

There were just two classes in the boxing, under 145 lbs. and over 145 lbs. In the former class were entered Whyte, Petch, Unwin, and Pillsworth, and in the latter Beckett, Kelso, Fain and Palmer. There were no knock out blows, in fact hard hitting was not indulged in to any great extent, most of the boxers being content with jabs to face and body that counted points,





but that did not inflict serious punish ment.

The opening bout was between Whyte and Pillsworth. Whyte had all the science, and easily outpointed his opponent. Petch and Unwin were the next to clash and they furnished a spectacular bout. Petch was speedy and reached Unwin with long swings, while Unwin could not very often con nect with his more agile opponent. In the final between Whyte and Petch, Whyte showed excellent generalship; he kept well out of reach of Petch's swings, and led out only when he saw a good opening. As a result of this not many blows were struck, but the majority were credited to Whyte. In the heavyweight class Beckett easily handled his smaller opponent Kelso, and Palmer in his engagement with Fain, broke his thumb and was forced to retire at the end of the first round. which was slightly in his favor. Beckett in the deciding bout with Fain won handily. He had the advantage both in height and reach, and Fain found it almost impossible to get in on him.

The wrestling established new champions in every class. Sorley cap tured the 125 lb. class, and Fraser, in the 135 lb., overcame Clark, last year's champion, after three strenuous bouts. Peart and Trethewey (145 lbs.) had a hard tussle, but Trethewey was the cleverer of the two, and in a mix up while both were down, secured an arm

hold and gradually forced his oppon ent over. Miller, who competed last year, carried off the honors this year by throwing Baldwin in the finals of the 158 lb. class. There were but three entries in the heavyweight class, Moore house, Kennedy, and Beckett. In the first round Kennedy and Beckett came together. They were evenly matched and neither had a distinct advantage until Kennedy secured a body hold, and threw Beckett suddenly to the floor, on his shoulders, where he held him. In the deciding contest Moor house and Kennedy battled for several minutes before a fall was secured. Moorhouse was fresh, and strong, and had the better of the bout, although Kennedy squirmed out of many tight corners before both shoulders finally touched the mat."

### A Progressive Move.

The Athletic Association has for some time past been severely handi capped in its endeavors to raise ath letics to the high standard they should hold at an institution of magnitude such as ours. True we have progressed rapidly in the past, but when we compare our present state with that which we might have attained

had we but had the means to carry out many proposed plans, we must admit that we have failed to live up to the opportunities that were quite within our reach. Nothing in the way of im



provement can be done without money, and the lack of this is the im portant factor in college athletics that has so hampered the Athletic Executive in its efforts to improve up on existing conditions.

For many years the students have felt the need of, and have been call ing for a football coach; basket ballers have been making just demands that a team be placed in some league; base ballers have been clamoring with equal right, for a similar privilege; the lovers of soccer football feel that more attention to their line of sport is due them; a second hockey and foot ball team placed in a league would be very much in the interests of those games; the gymnasium is constantly needing additional apparatus; more of our representatives should be sent to compete in the various athletic meets held in Toronto and elsewhere, if we are to maintain our good standing among the colleges; in short the ex penditures that we should make are more than double the amount of our receipts.

After careful thought, and an investigation into the manner in which



other colleges dealt with such problems, the Executive decided that the only solution of the difficulty was to obtain from the students an increased fee. A student body meeting was called, and when it was proposed that the constitution be changed, and that hereafter four dollars be the regular fee, there was a unanimous vote in favor of the proposal.

Such an attitude on the part of the students, is surely a sign that they have every confidence in our Athletic Executive, and that they are willing to stand by them to no mean extent, in their endeavors to achieve greater things than have been done in the past. It shows their truly loyal spirit towards athletics, and with such whole hearted support as the students are willing to give we may reasonably expect better things in the future.



# To What Extent Should a Student Enter Athletics?

According to his physical and ner yous makeup, the student may enter the realm of athletics, and there is no rule that will guide all, except that a man is to take that exercise in quality and quantity to be equivalent to a day's work. And a day's work will be enough of vigorous movements to cause that exchange of tissue so that nature will work out her own laws and bring to the student that feeling of well being and fitness which in itself gives balance and poise, a steadiness to the eye and strength to the muscle which united with an educated mind demands a purpose in the life. The student should not take athletics seri ously, but should, like the English sporting man, enter for the sake of the game. The championships should

not be his class of sport, but rather that kind of game which has the most recreation in it for him without the mental and nervous strain which is bound to follow a hard game and in capacitate him for close study for several days.

And yet if we circumscribe a student with reference to his athletics there is a danger that we may rob him of just that bit of spice without which he would be willing to forego most of the games.

So it will resolve itself into a question of each man making a study of his own desires, and his own needs. Every man hopes to live that life which will count for most. Therefore to attain the greatest efficiency the student must be at his best in mental and physical

fitness to grasp that knowledge which his opportunity is giving to him.

Most of the athletics now held un der college jurisdiction counts as a very important factor in the develop ment of character, and this coming to a man in his transition period surely is a part of his college work.

To play the game, to be one of a team that will meet an equal or greater force in an equal number of opponents, and yet by superior physical fitness, individual headwork, or better generalship, win a victory; is a test which in itself makes character, and without character there is no man hood.

There is therefore a place in the life of every student for some form of re creation and competitive athletic work properly supervised.

The kind of work each should adopt can only be decided after the student has consulted the Director of Physical Work, and has had a thorough examin ation. Then according to his age, his strength physically, and lastly and most important of all his nervous con dition with the advice of the Director, commence systematic athletic work to accomplish a three-fold purpose.

1st. To attain a place on a college team for its social and man-making qualities.

2nd. To work that he may be put to the test and develop a strong character.

3rd. That he may take the regular exercise which will keep him best fit ted to accomplish a year in study with out that loss of vitality which leaves so many men wrecks at the end of their college career.

Therefore let every student put systematic, recreative athletic exercise in some form into his college time table and make it a part of his college life,

and keep the time thus set apart in proper bounds.

His time will be profitably spent. He will accomplish more from every stand point, and he will reach a higher point of efficiency in his public or private life, in business or in a professional career.

Any man that does not take exer cise must take time to be sick.

Be regular in your exercise.

Have stated periods for field or gym nasium work, and never miss it at those times.

Be interested in your work and en joy everything that you do.

Take a short vacation every day and use it for exercise.

Exercise will do for the body what the intellectual training will do for the mind.

Educate and strengthen it.

One especially good exercise is swimming; it brings all the muscles into play and afterwards there is a relaxation which means perfect rest.

Out of doors, deep breathing exercise while walking is good; it will in crease the circumference of the chest.

Regular exercise followed by cold baths and simple diet will wonderfully help men to live clean lives.



# Our Old Boys

Professor John A. Craig, of Texas, who has accepted the position of Direc tor of the Oklahoma Experiment Sta tion at Stillwater, is the originator of a system of live stock instruction by score card and actual judging of live stock in agricultural colleges. He is the author of "Judging Live Stock," and of many bulletins written when he was at the Wisconsin, Iowa and Texas Experiment Stations. He was instrumental in assisting Professor Henry, of Wisconsin, in establishing the first short course in agriculture. At Ames, Ia., he carried on with Pro fessor Curtiss the first school in live stock judging which was the forerun ner of corn judging schools. He has judged live stock at the leading state fairs and important expositions.

Professor Craig was born in Ontario, attended the Ontario Agricultural Col lege at Guelph, completing a two-years' course. On graduation he became managing editor of the "Canadian Live Stock and Farm Journal," filling this position for three years. He was then engaged to fill the Chair of Animal Husbandry in the Wisconsin College of Agriculture, which he held seven years, when he resigned to become senior member of the firm of Craig & Stevenson, owners of a 1,350-acre farm in Wisconsin and breeders of Shorthorns and Shropshires. For three years he was Professor of Animal Hus bandry and Vice-Director of the Iowa Experiment Station. He resigned to become editor of the "Iowa Home stead." Later he became Director of the Texas Experiment Station and re mained three years, when he purchased a small stock farm adjoining San An tonio, Tex., and has engaged in stock farming during the past two years.

Billy Munro, B. S. A., 'o6, who has been till the present time District Rep resentative of the Ontario Depart ment of Agriculture at Morrisburg. has resigned from his position to ac cept that of Manager of an Experi mental Farm at Rosthern, Sask., un der the Dominion Department of Agri culture. The principal line of work followed will be experimenting with fruits, to find out varieties suitable to the rigorous climate of the prairie pro vinces. Although the farm will be chiefly a fruit experiment station other work will by no means be neglected. as experiments with field crops will be carried on and we may predict that re sults will be obtained that will be of inestimable value to the farmers of Saskatchewan.

R. M. Winslow has accepted a position under the Horticultural branch of the Department of Agriculture of British Columbia, his duties commencing April 1st. "Windy" is a graduate in horticulture, and while at College became an ardent admirer of our sister province that lies beside the Pacific, and gives such promise of leadership in horticulture. We wish him every success, and trust that not for long

will he tread alone the long and stormy path of life.

Previous to his acceptance of his present position he represented the Depart ment of Agriculture at Picton, where he was very successful during the short time that he held his position. He will be succeeded at Picton by A. P. McVannel.

# Winter Mail Service in Prince Edward Island

PART II.

Despite the apparent hazardous na ture of the crossing, comparatively few accidents have occurred, and these in almost every case might have been prevented had good judgment been ex ercised. In 1831 a boat with three men and a passenger was overtaken by a storm and forced to lie out all night. After suffering severely the men were rescued by a party from Cape Egmont P. E. I. In 1843 ten persons were out part of two days and a night, 36 hours in all. They suffered severely, some of them being badly frozen, but they finally reached the island shore. In 1855 three passengers with a crew of four men left Cape Tormentine for P. E. Island. When near the island shore a blinding snow storm set in, and they encountered the dreaded lolly. The boat was turned up on the ice for a shelter, and there, in a bitter frost, for two days and three nights, they suf fered untold agony from cold and hun

ger. On the third day they killed and ate a dog belonging to one of the pas sengers, and revived by this food, after throwing out their trunks and other baggage, they struggled on toward the nearest shore, the coast of Nova Scotia. The start from New Brunswick was made on Friday morning, and on Mon day evening one of the passengers, a Mr. Haszard, died. On Tuesday morn ing the survivors landed near Wallace, Nova Scotia, all badly frozen. The last accident happened in 1885. In January three boats with fifteen men and seven passengers started for New Erunswick under very unfavorable cir cumstances. A storm came on with blinding snowdrift. Towards evening they encountered lolly and drew up their boats on the ice. One of the boats was broken up, and with the wood and newspapers taken from the mail bags, they succeeded in making a fire. The relief obtained by the heat

was more than counterbalanced by the effect of the smoke on their already in flamed eyes, and by the melting of the snow which saturated their clothing. The night was extremely cold, and next morning the drift was unabated. Toward afternoon they found them selves near the island shore, about fif teen miles east of the point from which they had started. After being thirty six hours on the ice, they succeeded in making their way to land, where they were very kindly treated. Most of them suffered severely from frozen

service at the Capes instead of the tri-weekly boats which hitherto had sufficed for the needs of the Province, and with making an effort to run a totally unsuitable wooden steamer be tween Georgetown, P. E. I. and Pictou, N. S. In the winter of 1870-77 a steam er, which had been built for ice service on the River St. Lawrence, was brought to P. E. Island, and the first real attempt made to solve the problem. This boat, the "Northern Light," in spite of many failures, due mainly to her construction, showed that much

limbs which in some cases had to be wholly or partly amputated.


When, in 1873, Prince Edward Island annexed the other provinces of the Dominion to herself, one of the provisions of the marriage bond was that the Dominion Government should maintain continuous steam service be tween the island and the mainland win ter and summer. This obligation, so far at least as the winter was concerned, sat lightly upon the minds of the Cabinet. They contented them selves with establishing a daily iceboat

could be done, at least to improve conditions. In 1889 the Government had the S. S. "Stanley" built in Scotland, specially for this service. The "Stanley" is a ship of 914 tons gross, and of 300 nominal horse-power. Her success was marked, and in 1901 she was reinforced by a larger and more powerful steamer, the "Minto." By means of these boats navigation is kept up with very considerable regularity between Georgetown and Pictou. but in the view of Islanders the promise of Confederation has not been kept, and there

are annual demands made by the Provincial Government upon the Domin ion for the "pound of flesh nominated in the bond."

The worst stoppage in the history of these steamers occurred in 1903, when, the Stanley, in attempting to establish a new route from Summerside to Cape Tormentine, (a distance of about nine teen miles) was caught, January 12th, in an ice floe, and carried helplessly down the Strait, where she drifted, hopelessly imprisoned. Even dynamite

perience. So long as there is open water in sight they can generally make their way ahead. By means of water ballast the stern is depressed, and the bow thrown up so that when the steamer strikes heavy ice she runs upon it and breaks it down by her weight, long cracks running out in all directions. Often it is necessary to back in order to get headway and to charge again and again upon the mass before it parts. At times the boat wedges fast and can neither advance

failed to make any impression on the icy barrier which held her. The "Min to" in proceeding to her rescue, was jammed, and on February 28th, in an encounter with heavy ice, stripped every blade from her propeller. Both ships drifted up and down as the ice carried them, until, after an imprison ment of 64 days, the Stanley got clear, and with the disabled "Minto" in tow, succeeded in reaching port.

A trip on the winter steamers is to most people a novel and exciting ex for retreat. Then all hands are ord cred out on the ice, and with boat hooks, axes, etc., the ice is broken and pushed or pulled away till the steamer is freed and can steam ahead or astern once more. Field ice two feet thick is frequently handled without much difficulty, ice rafted cake upon cake to a height of from eight to fourteen feet is frequently encountered, but so long as west and northwest winds prevail pas sages can be effected with wonderful regularity. (The distance between

Georgetown and Pictou is about thirty five miles). When the wind sets in from the east and northwest the heavy ice becomes jammed between Pictou Island and the bight in which Pictou lies, and the nine mile passage be comes a solid mass. If this occurs with a high tide the ice masses, piled one upon another, are forced into shoal water, and at the ebb tide ground on the bottom. Then all hope of reach ing Pictou must be abandoned until a southwest gale dislodges the barrier. It is doubtful if any ship can be built that will cope with these conditions, and in all probability continuous com munication can never be kept up on this route. Various other lines have been suggested, each of which has its own advocates. It should be men tioned that both steamers are equipped with the Marconi Wireless Telegraph, and thus they are in continuous com munication with the two shore stations at Cape Bear, P. E. I. and Pictou, N. S.

The Dominion Government is now

engaged in building a third steamer, larger and more powerful than either of those at present on the route. It is hoped that by this means much better results may be obtained. Meantime the Island's bill against the Dominion for breach of the Confederation con tract is steadily mounting up, and if no redress is obtained the Treasury may find itself unable to meet the claim. A tunnel, costing anywhere from ten to twenty-five millions, is put forward by enthusiastic individuals as the only final settlement, but in face of a popula tion of less than 100,000, and with little prospect of increase, the Dominion hesitates to incur such a large expense for the benefit of so few, the result of such a step being largely problematic al. Meantime it is more than likely that for some years to come Prince Ed ward Island will be able to treat her winter visitors to the really delightful experience of a passage through our floating ice-fields in our staunch winter steamers.

# A Winter Holiday in Guba

In Cuba as in Canada a holiday fall ing on Monday or Saturday is doubly welcome. So in '08, while Cubans cele brated on February 24th, the opening of the Revolution of —, we hailed the opportunity for a long talked of ride into the Trinidad Mountains, and a visit to the famous Hannabonilla Falls.

The prospective party diminished to six—all Canadians—with two Cuban guides and a boy in charge of the pack mule. Incidentally the latter soon earned the sobriquet of "Calamity

Jane." Saturday evening saw us at a road-construction camp, about eight teen miles from Cienfuegos, where we were hospitably entertained by the American manager.

Having mastered the art of prevent ing starched and polished pillow-slips and sheets from skating about, on or off the narrow cots, we found it impossible to sleep because of the cold! Almost incredible to a Canadian, but even three heavy blankets would not pre vent aching toes, with the mercury never below 46 degrees. Five o'clock found us all astir in the grey of dawn, and after hot coffee, and our host's good wishes, we set out, the start enlivened by the unexpected bucking exhibition of one of the horses.

A few miles riding brought us to Cumaniyagua, a typical Cuban country town, with its fonda (hotel), thronged with idlers and dogs, its cafes, bake shop, tiny stores, and narrow, rocky streets swarming with goats, dogs, pigs, and children of all shades, be tween white and black, assuredly lur ing "the simple life," as regards cloth ing, at least. Some of the houses are of wood with red-tiled roofs, others are guama-thatched (palm-leaves), and still others of mud pressed into shape like cement. Having arranged for ac commodation here for the night, we pushed on; and a few miles more put us among the foothills.

Here the track became a bridle-path, past scattered tobacco farms, with their fields of deep green, and little clusters of thatched buildings. The hills be came steeper, small streams had to be forded in the valleys, stretches of woods intervened, and the farms were succeeded by pastures with herds of cattle and sheep. The increasing

height of the succession of cone-shaped hills lured us with the strongest fascin ation, and we pushed to the top, only to see a higher range across the valley, until the deep purple of the furthest mountains made a jagged line against the sky.

Some of the valleys broadened into a most pleasing prospect, of green fields and bright streams, beautified by the stately palm, or spreading umbrel le-like, agaroba.

Our guide enlivened the way by tales of some of the bloodless battles of the insurrections, as we crossed the sites, where twenty-odd thousand rounds of ammunition were fired.

Sometimes we were warned by jing ling bells to find a place and get our horses out of the track, while a train of loaded pack-mules passed on their way to the city.

At noon we halted to rest a little from the heat, at the home of a Span iard, who is trying his fortune at stock raising here. The house, on the peak of one of the cones, was of the cement like mud, with doors and casings of the beautiful Spanish cedar. The earth en floors contrasted sharply with the mahogany wardrobe and modern sew

ing machine; and the immaculate starched muslins of the women and children were a marvel to the feminine half of the party. Mark the distinction between Spanish and Cuban! We were graciously entertained, the ever present black coffee served, and speed ed on our way with good wishes, though one of the young ladies confided in us that centennes (gold pieces) at every turn would not tempt her to take the ride.

We pondered what life could be like, with the solemn hills on every side, and saddle and pack-mule the only means of transport to the city thirty five miles away.

Another hour and a half, with steeper climbs and narrower trails brought us in sight of the falls! A succession of five cascades, yarying from ten to seventy feet in height—masses of foamy white, swallowed in the wonderful green of the deep pools below, the

stream winding away between great cliffs clothed with limitless variety of foliage—palms, cacti with gorgeous bloom, orchids, ferns, and vines in won derful profusion.

But it was eight hours since the early coffee, and even this scenery could not banish appetite, so all hands set to work unpacking provisions, or making fire, and preparing lunch. This over, two hours or more was spent in climbing, exploring, admiring, and making pictures, which after all do scant justice to the beauties of the scene. Repeated calls of our captain bring a reluctant party together.

Oh! for a week to camp in this ideal spot! But horses are saddled, and the homeward ride is more quietly taken, the mystery of the hills in the sunset light, with the deep purple of the valleys having a subduing effect upon all. But we need to hasten to reach the broader track before darkness falls—there is scarcely any twilight here—and eight o'clock found us again in the little town. The proverbial sauce, hunger, is a very necessary one to the enjoyment of a meal in that fonda.

For sheer drowsiness, we were scarce able to accept civilly the attention of our Spanish hostess, in whose house the ladies were to spend the night. Apologizing for the smallness of the room, she said that "if it were not very commodious, neither could it hold much cold." But this we were compelled to doubt before morning, despite our own extra blankets. The men, I believe, found tramping about preferable to attempting sleep, in the (apparent) zero weather of the fonda.

The Cuban custom of having coffee in bed, seemed to us very good the next morning, and the ministrations of our little hostess most grateful. Surely nowhere is exceeded the hospitality of these people,

A few hours more riding brought us again into the regular routine, with

the determination to revisit at our earliest opportunity, with equipment for a week's camping, the beautiful falls of the Hannabonilla.

# POINTERS ON SOIL FERTILITY

### Amount of Manure Required
