

GOOD FRIDAY IN THE CITY

The Weather Man Was a Little Tardy in Manufacturing Desirable Elements.

CHURCHES ALL WELL ATTENDED

Boats Running to the Island—All Theatres Crowded—A Glorious Afternoon.

Yesterday morning did not promise a liberal diffusion of solar rays or warmth of atmosphere—dark, low-hanging clouds overcast the sky until the middle of the afternoon, making outdoor going about so pleasure as all and the holiday one which offered no opportunity for excursions.

In the churches the usual Good Friday services were held, when the crucifixion of the Saviour was the theme for many able discourses, the music being in keeping with the solemn occasion.

This is Holy Week. The week in the Catholic Church, is known as "Holy Week," and is the last of ecclesiastical mourning. It is the last of the Lenten season, which begins more and more solemn as it approaches Good Friday, and then reaches its climax.

Yesterday the usually solemn services of the Catholic Church were given more than on any other day. The sacrifice of the mass, which is celebrated every other day of the year on this one is not permitted, but instead a service known as the mass of the premisses is held in the morning in the afternoon the Stations of the Cross are gone thru at 3 o'clock; and in the evening the Tenebrae is sung, after which there is a sermon. But from the depth of mourning Easter Sunday morning will see the church burst forth in jubilation and joy.

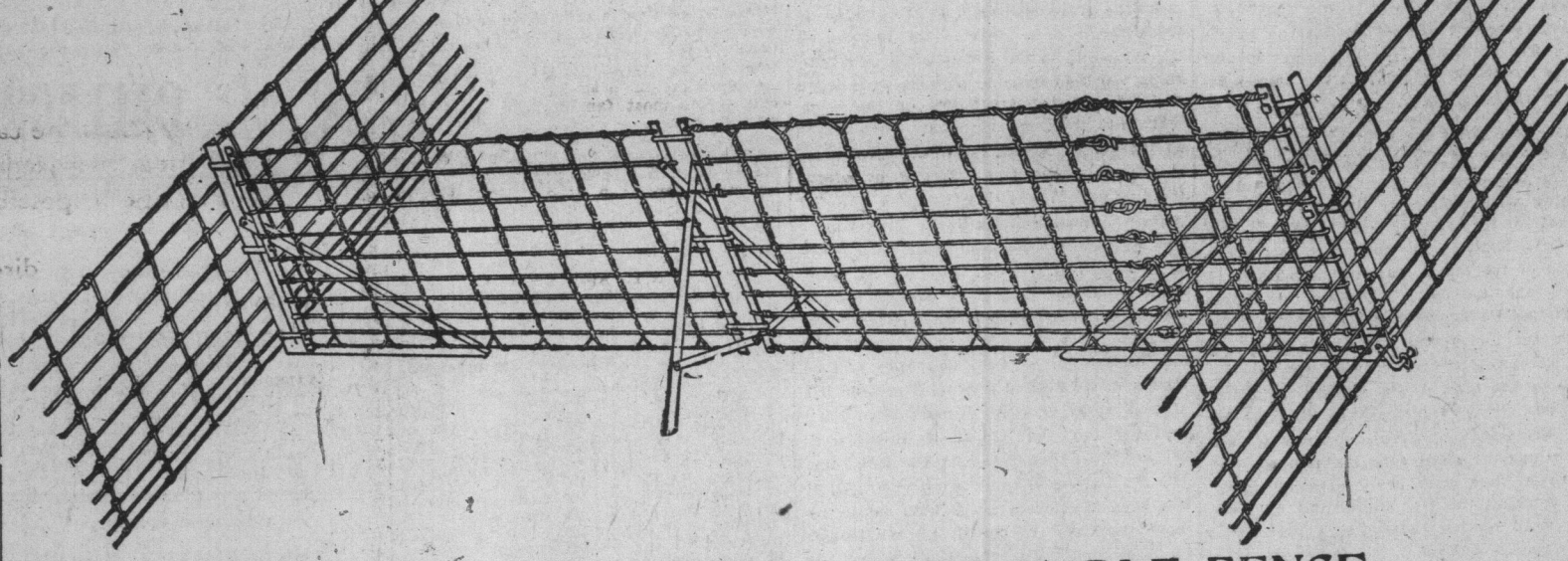

THE CITY INTER-MUNICIPAL RAILWAY POLICY.

The traffic over the Toronto Street Railway system may be divided into three groups: (1) Passenger traffic from any one point within the city to any other point within the city.

The time has apparently arrived when the city should arrange the terms and conditions under which the traffic coming under sections 2 and 3 shall be carried on.

Our answer to the Metropolitan Railway and the Legislature is that the city is prepared to pay for the traffic which is to be carried on the line.

The next point we wish to emphasize is that the city of Toronto is the owner both of the line and of the franchise.

Under the scheme we have outlined we secure these advantages: (1) The franchise for all kinds of traffic within the city limits by the city of Toronto and the Metropolitan Railway.

(2) The city receives its full percentage of receipts for freight and passengers.

(3) Passengers and freight are conveyed without transfer from country terminal to city terminal and vice versa.

(4) All the conveniences to interchanges are secured by the Metropolitan Railway on behalf of outside municipalities are secured by the city.

(5) The scheme is comprehensive and embraces traffic originating from future as well as existing lines.

(6) There can be no dispute as to overlapping franchises, because no other company has any right within the city limits of Toronto except the Toronto Railway Company.

Before the Legislature compels us to accept the imperfect, monopolistic and dishonest agreement put forward by the Metropolitan Railway, we ask it to show wherein the policy outlined above is defective, or wherein it fails to meet the necessities of the case in any particular.

PHILIPPINES AND CUBA Are to Come Into the Postal Money Order Arrangement With U. S.

Washington, April 5.—In addition to the arrangement already effected with Canada, it is expected that a reduction of the postal money rate between the United States and the Philippines and Cuba will be put into operation on July 1 next. The arrangement just signed between the post-administrators of the United States and Canada will take effect on that day, and negotiations are now in progress with the Philippine government, which are expected to be consummated in time for all three arrangements to be effective simultaneously. This means a reduction on all money orders business between the United States, Canada, the Philippines, and Cuba, from one per cent, to three-fourths of one per cent, with the domestic rate.

BOTH'S LETTER TO KITCHENER

It Expresses a Desire to End the Strife, But is Non-Committal.

London, April 5.—The letter of Gen. Botha, the Boer commander-in-chief, to Lord Kitchener, commanding the British forces in South Africa, preliminary to the recent peace meeting, casually referred to in Lord Kitchener's report of the negotiations, and from which the opposite side has been taken, has been published. The letter is dated at the commandant's quarters in Cape Town, and is addressed to the British High Commissioner, Lord Kitchener. It contains a reference to "the verbal message from Your Excellency." Concluding the letter, Botha says: "I have the honor to inform Your Excellency that no one desires more than I do to see the end of the strife, and I would also very much like to meet Your Excellency in the immediate future. The subject of the consultation was not discussed, although the remainder of the letter, of course, suggests a place of meeting and arrangements for the guarantee of safe conduct."

TOOK LINGERIE FROM HAREM

Charge of Looting Against American Soldiers at Pekin.

Washington, D.C., April 5.—W. D. Hofman of Canton, Ohio, who accompanied the Americans in their march on Pekin, was a passenger on the steamer Japan, which arrived in the United States yesterday. He made the following statement: "The day after the Americans looted the 'Harem' in Pekin, and that the officers of the American army should have gone home with their loot. PROVENCHER ELECTION PETITION

Judge Bain Decides That the Preliminary Objections Against the Petition Are Not Good.

Winnipeg, April 5.—(Special.)—In the Provencer case judgment was delivered this morning by Judge Bain on the preliminary objections filed against the petition presented heretofore. The principal objection was that the petitioners had no right to vote at the election, nor was either of them a person who might by law present a petition such as was presented in this matter. The copy of the list of voters, with the names of the petitioners, was produced in evidence. It was found that the names of the two petitioners, who had been put in evidence, were not on the list of voters. The judge therefore overruled the preliminary objections. J. S. Tupper applied to the judge to stay proceedings, pending an appeal to the Supreme Court, as it was of great importance to the respondent not to be put to the great expense of an election trial on account of an official appointed not opening the poll where it had been fixed. It was suggested that a motion stay should be a substantive one, and should be made subsequently.

Objections Dismissed.

St. John, N.B., April 5.—In the election case of St. John City and County, before Judge McLeod to-day the preliminary objections filed by counsel for the respondent, J. J. Tucker, were dismissed with costs.

CABLEGRAM FROM CHAFFEE.

Asks Instructions as to What Course He Shall Take.

Washington, April 5.—General Chaffee has cabled the War Department from Pekin that the military commanders representing the foreign powers there are now considering the question of disposing of the Chinese fort and establishing fortified posts at proper intervals along the route from Pekin to the sea. General Chaffee seeks instructions for his guidance in the conference.

Preparing to Withdraw Forces.

Meanwhile the War Department is pushing its preparations for the complete evacuation of China by American forces, save only the legion guards, and it is now expected that everything will be in readiness to embark General Chaffee's army at Taku for Manila on May 30.

REV. JOHN KELLER ABOUT WELL.

Barker's Victim Has Lost One Eye, But the Other is Well.

New York, April 5.—The Rev. John Keller of Arlington, N. J., who was shot by Thomas G. Barker in February, has so far improved that there is talk to-day in Arlington of his officiating at the Easter services. Mr. Keller has fully recovered, the sight of his left eye, and is improving physically, but still refuses to allow him to take out-of-door exercise while the present illness is set for next week.
