The Grand Master then submitted his Report in print, and on motion it was received without being read, and referred to the Committee on Distribution :

GRAND MASTER'S REPORT.

To the Grand Lodge of Manitoba, I. O. O. F.

REPRESENTATIVES AND PAST GRANDS:

I congratulate you that we are privileged to meet in Annual Session in the progressive city of Brandon, where, instead of the few canvas tents of six years ago, we are greeted with the pleasing sight of stately churches, commodious schools, substantial business blocks, comfortable homes, and beautiful streets—evidences alike of the enterprise of its citizens and of their faith in the resources and development of the district of which it is the intellectual and commercial centre. May its growth be as steady and peaceful as the river which gently flows past its borders; its moral and social foundations as firm as the hills on which it is built; and its influence for everything pure and noble, as broad as the almost limitless prairies by which it is surrounded.

While there are many in the Grand Lodge to-day who were present

at its organization four years ago, and who have attended each Annual Session, we are greatly reinforced and strengthened by the introduction of new members, whom we glad y welcome to share our counsels and join in our deliberations. We meet, not merely for enjoyment and to renew old and form new associations, but to consult together and legislate for the good of Odd Fellowship in this jurisdiction. I trust, therefore, we may wisely and harmoniously consider and determine those measures which may be submitted for our attention, "keeping in view that philanthropic principle by which we hail each other as brothers," so that our deliberations may be pleasant and their results beneficial. The depression which has prevailed along all the lines of business agricultural, industrial and commercial, has tended to try the stability of our Lodges, and test the confidence of our members in the ability of our Order to fulfil its moral and pecuniary obligations. Notwithstanding this depression, every claim on our funds has been fully met; the great command of our Order "to visit the sick, relieve the distressed, to bury the dead and educate the orphan," has been obeyed, whenever and wherever circumstances have required; we have more than held our own as regards membership, and have considerably increased our reserve funds to meet future contingencies, so that our present position is very satisfactory, and our prospects for growth and influence most encouraging. Therefore, with devout thanksgiving to Him who is crowning the year with His goodness, may we enter upon the labors and duties of this our fourth Annual Session.

When, one short year ago, by your generous confidence and support, was committed to me the important trust of presiding over this Grand Lodge and guiding the destinies of our Order in this jurisdiction, I resolved, so far as my time and abilities would permit, to faithfully discharge the duties devolving upon me; but now, in giving back to you that trust, I realize how far short I have come of fulfilling the resolutions and expectations then formed, and I ask your fraternal forbearance, assuring you that no known duty has been willingly neglected. My intercourse and correspondence with thy colleagues, District Deputies and Lodges, have been uniformly pleasant and courteous, and every matter which has come before me has been impartially considered, and, I believe, satisfactorily disposed of. No Appeals or Grievances arising out of my actions will come before you, and, so far as I know, peace and harmony prevail among the brethren. It now devolves upon me, as. require account of gene

required by our Constitution and Ancient Usage, to lay before you an account of my official acts, and such other matters as seem to me to be of general interest.

Condition of the Order.

In addition to what has already been stated, I am thankful to report from personal observation and correspondence with my Deputies, that Odd Fellowship in this jurisdiction is fulfilling its mission, and justifies its claim to rank first among those moral agencies which, by the dissemination of the principles of our cardinal virtues, Friendship, Love and Truth, tend to hasten the day when

"Man to man the world o'er Shall brothers be for a' that ;"

for let it ever be remembered that Odd Fellowship is something incomparably more than the mere almoner of the contributions of the many to the necessities of the few.

By constitutional provisions and long established custom, admission to our Lodges is carefully guarded, but it is left for Committees on Character to carefully and conscientiously perform their important duty, and to members, by a wise discrimination in the use of the ballot, to preserve our Order free from the unworthy. I believe that in the main this discretion is judiciously exercised by our Lodges, and where, perchance, the unworthy is found, rigid discipline is applied and enforced. I am further led to believe that, while the Ritualistic portions of our work are fairly well rendered, a desire exists throughout our Lodges for improvement in this respect, which should be met on the part of this Grand Lodge, by providing for the holding of Lodges of Instruction in as many of our subordinates as may be practicable; a portion of the expense to be borne by the Grand Lodge, and the rest by the Lodge or Lodges benefitted thereby. It should be the aim of this Grand Body to see that the ceremonies of the Order are rendered in a becoming and dignified manner, free of everything partaking of the ludricous, so that the sublime teachings of the Initiatory and other Degrees may be conveyed to the candidate in a way calculated to make a favorable and lasting impression. Subordinate Lodges, of course, can aid in this by seeing that brothers elected or appointed to office are thoroughly competent for their respective positions. The training of Degree Teams, to share the

work with the Officers of the Lodges so popular in many jurisdictions, and being tried by a few Lodges in this, has done-much to raise the standard of Floor work, and in my opinion is well calculated to revive the interest which the old, and ofttimes slovenly, method has caused to decline. This does not imply that a large or even any expenditure shall be made for gorgeous paraphernalia, but that the several charges shall be appropriately given, and some form of floor movements adopted at once appropriate and graceful.

For full information regarding our financial and numerical standing, I refer you to the very elaborate tables and excellent report of our Grand Secretary, who has given much care and attention to the details in connection with his special department.

New Lodge.

A petition was received by the Grand Secretary, on the 15th of July, from a number of brothers at Glenboro, the present terminus of the South-Western Branch of the C. P. Railway, asking for the institution of a Lodge there. After due consideration of the subject and much correspondence regarding the prospects for a Lodge, and believing the petitioners to be men of good standing in the community as well as enthusiastic and zealous Odd Fellows, I granted a Dispensation, and on the 27th of July instituted the Lodge, which is known as Mizpah Lodge, No. 12. The Dispensation was delivered to the following brothers : Wm. Abbott, P.G., R. W. Brown, James Davidson, W. J. Gunne, M.D., John Moir, and Isaac Moore, P.G. After the election and installation of Officers, two candidates were proposed, and by Dispensation were balloted for, initiated, and the three degrees conterred. On this occasion I was greatly assisted by Bros. C. D. Anderson, Grand Rep.; Horace J. Raymer, Grand Warden; Geo. C. Mortimore, Grand Sec'y; H. B. Rose, Jabez Miller, and R. H. Shanks, Past Grands, of Winnipeg; and Dr. Riddell, D. W. Duff and J. W. Greenway, Past Grands, of Crystal City, and by several other worthy brothers, to all of whom my thanks are given for their presence and assistance. To the brethren of Mizpah Lodge, No. 12, my thanks are also tendered for their generous reception and unbounded hospitality. The new Lodge has already several applications before it, and being located in the centre of a magnificent and well-settled farming country, has good material to draw from. I recommend that a Charter be granted by this Grand Lodge.

I have also had several letters from brothers residing at Deloraine, Boissevain, Virden, and Shoal Lake regarding the establishment of Lodges at these places, and believe the correspondence will lead up to the accomplishment of this object at an early day.

Dispensations.

During the year I have granted the following Dispensations :--

- 1.—August 17th, 1886, permitting Manitoba Lodge, No. 1, North Star Lodge, No. 2, and Minnehaha Lodge, No. 7, to hold a union picnic at Headingly, August 18th. This application did not come before me in a regular manner, as I had no communication from the Lodges, nor any evidence that the joint committee applying for this dispensation was duly authorized. The application having reached me the day' before the picnic, I had no other alternative than to sanction what had already been advertised.
- Sept. 11th, permitting Minnedosa Lodge, No. 10, to elect and install Bro. R. Hill Myers, a Scarlet member, into the office of Recording Secretary, all qualified members having declined nomination.
- Sept. 22nd, permitting Moosomin Lodge, No. 2, to hold a public ball on the 8th October.
- Sept. 22nd, permitting Manitoba Lodge, No. 1, to elect and install Bro. Daniel E. McKinnon, a Scarlet member, into the office of Permanent Secretary, all qualified members having declined nomination.
- Nov. 24th, permitting Minnedosa Lodge, No. 10, to hold a public anniversary entertainment on the 1st December.
- January 8th, 1887, permitting Minnehaha Lodge, No. 7, to hold a public anniversary entertainment on the 13th January.
- Feb. 14th, permitting Manitoba Lodge, No. 1, to hold a public concert, ball and supper on the 16th February.
- Feb. 18th, permitting Crystal City Lodge, No. 8, to hold a public entertainment on the 10th March.
- 9.—March 29th, permitting North Star Lodge, No. 2, to hold a ball and supper on the 26th April.

- 10.—April 9th, permitting Nelson Lodge, No. 9, to nominate and elect three Trustees, no election having been held in November, as required by the By-laws of the Lodge.
- April 19th, permitting Gateway City Lodge, No. 4, to wear the regalia of the Order when attending Divine Service on Sunday, 24th April.
- 12.—April 25th, permitting Moosomin Lodge, No. 2, to wear the regalia of the Order when attending Divine Service on Sunday, 1st May
- 13.—May 24th, permitting Manitoba Lodge, No. 1, to receive nominations for office at the last regular meeting in May (election night), the receiving of nominations having been unintentionally omitted two weeks previous.
- 14.—July 30, permitting Manitoba Lodge, No. 1, North Star Lodge, No. 2, and Minnehaha Lodge, No 7, to hold a union pic-nic at Fraser's Grove, 3rd August. The application for this Dispensation came from the three Lodges above named, but not until after their attention had been called to the fact that the joint committee had issued tickets and posters announcing the pic-nic. In writing to the Lodges on this subject, I stated—"It seems to me not only courteous but reasonable, if the dignity and prerogatives of the Grand Lodge are to be conserved, and its constitutional rights and privileges acknowledged and respected, that as soon as the Lodges decided to hold the pic-nic and the time and place settled, the Dispensation from the Grand Master should have been obtained, to the end that all things be done decently and in order, and subsequent arrangements regularly carried on."

Subordinate Lodges should understand-

1, That a Dispensation to hold a public celebration where the regalia of the Order may be worn or the name of the Order assumed, should be applied for and received before any public announcement is authorized; 2, That the application for a Dispensation should be accompanied by a direct promise from the Lodge, through its Officers, that no intoxicating beverages of any kind shall be offered to the members or guests present on the occasion. Therefore, I submit I am correct in holding that general instructions to a committee to arrange for a picnic or other public gath and the authori

Decisions.

During my term I have received a number of letters asking information on points easily obtainable by the writers themselves from the Constitution, and other sources equally easy of access; but as the time of the Grand Master is supposed to be always at the service of the Order, I have promptly replied to every letter, whether official or unofficial, referring to the law, and giving advice when asked for it. The following decisions on points of law have been given by me:

- Under the Constitution of the Grand Lodge of Manitoba, a D. D.
 G. M. has not the authority to grant a Dispensation permitting a Lodge to elect a Scarlet member who has not served a lawful term in an appointed office, to an elective office.
- Election of Officers, or any other business transacted at a meeting of a Lodge, when the Charter and Bible are not in the Lodge Room, is invalid.
- 3.—Under the provisions of the Constitution of Subordinates in this jurnsdiction, a Lodge cannot grant money from the General Fund in response to an appeal for aid from a Subordinate or Grand Lodge.
- 4.—An election to fill a vacancy in the office of Noble Grand having been declared void by reason of irregularities, it was held that qualified brothers who had declined nomination at the time of the illegal election were eligible for nomination when the new election was held.
- 5.—Under the By-Laws of a Lodge which provides for three dollars per week benefits after first week's sickness or disability, a qualified brother injured Jan 22, 1887, and who resumed work March 19, 1887, was entitled to seven weeks' benefits, or \$21.00.
- Under the Constitution of the Grand Lodge, when an election for Representative is held, every Past Grand in good standing is eligible.

Visitations.

On the 4th January, 1887, I visited North Star Lodge, No. 2, by

request, and, assisted by Horace J. Raymer, Grand Warden; Geo. C. Mortimore, Grand Secretary; W. J. Watson, Grand Treasurer; and W. F. Ross, Grand Marshal; installed the officers.

On the 7th January I visited Manitoba Lodge, No. 1, also by request, and, assisted by Bros. B. D. Deering, P. G. M.; W. F. Ross, Grand Marshal, and several Past Grands, installed the officers.

On both of the above occasions I found the Semi-annual Returns ready, and the business and work of the Lodge promptly conducted.

On the 8th July I visited Brandon City Lodge, No. 6, and, assisted by Bros. J. D. Bowley, P.D.G.M.; R. J. Noxon, D.D.G.M.; L. M. More, P.D.D.G.M., and E. G. Wiswell, Grand Herald, installed the officers. I also witnessed the initiation of a candidate, the work being fairly rendered. This Lodge occupies the hall in which we are now met, and with the men and means at its disposal is capable of doing first-class work.

Owing to the indisposition of Bro. Wm. Miller, D.D.G.M., and at his request, I installed the officers of North Star Lodge, No. 2, and Minnehaha Lodge, No. 7, on the 5th and 7th July respectively.

I exceedingly regret being unable to visit every Lodge in the jurisdiction, as was my desire, and trust my successor may be able to overtake this pleasant duty.

Appointments.

On the 6th January, 1887, I issued instructions to Bro. Horace J. Raymer, Grand Warden, to install the officers of Minnehaha Lodge, No. 7, (the D. D. G. M. being at the time on a sick bed), with which he promptly complied, and made due report to me.

On the 2nd May I appointed Bro. Geo. C. Mortimore, Grand Secretary, a member of the Committee on Revision of the Constitution, and to take my place thereon.

On the 12th July I appointed Bro John Thomson, P. G., Manitoba Lodge, No. 1, Auditor, in the place of C. A. Schofield, expelled from the Order.

Application for Aid Granted.

by the earthquake of August 31st, 1886, which not only completely wrecked their Hall, but rendered homeless many of the members of the Order, applied to me for leave to appeal to the Lodges in this jurisdiction for aid for the destitute, and to assist in the re-building of their Hall.

This application having the sanction of the Grand Master of the Grand Lodge of South Carolina, leave was granted on the 22nd October, and the claims of our distressed brethren recommended to the sympathy and liberality of our Lodges; contributions to be sent to our Grand Secre. tary, and by him forwarded to the proper officer.

The Grand Secretary informs me that no general response was made to this appeal.

Application for Aid Refused.

On the 14th Sept., 1886, I received a circular from the Noble Grand of Achoree Lodge, No. 14, Elizabeth City, North Carolina, asking permission to appeal to the Lodges in this jurisdiction for assistance towards building a Hall, which permission was not granted, for the reason that few of our Lodges have as comfortable places to meet in as it is desirable they should possess; and further, because the Grand Master of North Carolina had not sanctioned an appeal for aid outside of his State.

Proclamations of the Grand Sire.

Three proclamations of the Grand Sire have been received :---

1.—Proclamation dated Oct. 12th, 1886, declaring the Resolutions found on page 10,520, Revised Journal, Sovereign Grand Lodge, and adopted on page 10,659, permitting the use by members of a Grand Lodge of a scarlet ribbon worn on the lapel of the coat, in lieu of other regalia, *ineperative and void*, because, being an amendment to Art. XXII By-laws S. G. L., they were not adopted as an amendment.

2. Proclamation dated Dec. 23,#1886, referring to the Patriarchal Circle, and prescribing a form of declaration to be made by officers of Subordinate Lodges before being installed, also by candidates before being admitted to membership, and by all persons who shall claim admission as members of, or Representatives to, any Grand Lodge; and directing Grand Masters to promulgate the above to their Subordinates, and cause the same to be obeyed.

Learning from correspondence had with the Grand Sire, that while this jurisdiction was happily free from all taint of the Patriarchal Circle evil, the law had to be made of general application ; therefore on the 21st March I issued a Proclamation, reciting the orders and directions of the Grand Sire, and enjoining upon D. D. G. Masters and Noble Grands the duty of seeing that they were faithfully obeyed. I am not able to say to what extent the law has been observed, but understand in some cases the Proclamation was fyled and that was the last of it. Bv my directions the Grand Secretary procured a quantity of printed slips containing the declaration required from applicants for membership, to be attached to and form a part of all applications. These were sent to the Lodges for use in the meantime, until a form of application containing the declaration has been adopted. A copy of my Proclamation and accompanying slip, and a letter from the Grand Sire acknowledging receipt of same, is appended to this report.

3.—The Anniversary Proclamation of the Grand Sire, dated 4th February, was duly received, and, accordingly, on the 1st of March I issued the customary Proclamation, recommending the Lodges in this jurisdiction to suitably observe the 26th April, 1887, the Anniversary of the Order.

District Deputy Grand Masters.

These Officers have all reported each term such information as is called for by the form approved by the Grand Lodge at the last session. but I cannot report this system a complete success, inasmuch as the Deputies in general seem to be satisfied with simply filling up the form prescribed and mailing it, without a single remark on the workings of the Lodge, or a suggestion for the good of the Order. Much of the information contained in these reports comes to the Grand Master in a more complete shape through the Semi-annual Returns, abstracts of which are given to him by the Grand Secretary, and it does seem to me that an enthusiastic Odd Fellow, acting as District Deputy, could at least twice a year furnish information full of interest and of great value to the Grand Master, which no series of formal questions could possibly supply. I have no complaint to make against my Deputies, our relations have been very agreeable, and I thank them for what they have done, but I would have been helped had I heard more frequently from them. My objection to the system is, that it tends to have important

The only information gained from these reports worth mentioning is the unsatisfactory item that Rituals are still in general use in the large majority of Lodge Rooms; Nelson Lodge, No. 9, and Moosomin Lodge, No. 2, being the only ones which can open, initiate, confer the three Degrees, and close without a Ritual being seen. Six Lodges use the Rituals more or less, and five use them entirely. Our system of placing a District Deputy over the Lodge of which he is a member is not calculated to raise the office in the estimation of the members generally, for the old proverb holds true, and often a District Deputy is not without honor, save in his own lodge and among his fellow members. But with the distances between Lodges, any change in this respect is out of the question at present. Then let the very best men in each Lodge be recommended for the position, who will magnify their office, evoke enthusiasm in the work, and heartily carry out the instructions of the Grand Lodge

Dues and Benefits.

This very important subject was referred last year to a Special Committee, to report at this session. I am not apprised as to the extent of their investigations, nor the nature of the report to be presented, but I venture the remark that the experience of this jurisdiction, as far as it goes, will bear out the conclusions of the Committee on Dues and Benefits of the Sovereign Grand Lodge, referred to in my report of last year, page 200, Journal of Proceedings.

Finances.

The Financial Statements of the Grand Secretary and Grand Treasurer will show an improved condition of our Grand Lodge funds—yet not sufficient to avoid another special assessment.

During my term I have drawn the following Orders (countersigned by the Grand Secretary) on the Grand Treasurer :--

Decoration Day.

At the last session of the Sovereign Grand Lodge the following resolution, found on page 10,517 Revised Journal, was adopted :

"Resolved, Whereas, it is not only right and proper, but the very nature, spirit and desire of the Order, demands that a day be set apart in each year on which its members may unite in solemn Memorial Exercises in behalf of their honored dead, and it is believed that the most appropriate time for such service would be upon the 20th day of October, which day is that on which our Past Grand Sire WILDEY, who, after long years of earnest and successful work in our behalf, was gathered to his fathers ; be it, therefore,

Renoted, That the Grand Sire, in conjunction with the Grand Secretary, is hereby instructed to issue a proglamation annually, at least sixty days prior to October 20th, containing the purport of this preamble and resolution, requesting all Subordirate Lodges to assemble on the day above named and engage in appropriate memorial exercises respecting their deceased members, such exercises to be conducted in a manner appropriate to the occasion. Said proclamation shall embrace the names of such officers and members of the Sovereign Grand Lodge, and past officers and members, it any, who died during the term herein named. This resolution to take effect in the year 1887; *provided, houvier*, that if a different day be more convenient for any Lodge to hold such Memorial Service, such Lodge may select the day."

In this connection, I received on the 23rd July a copy of a resolution adopted by a joint committee of the Lodges in Winnipeg "declaring it not only advisable but expedient that a day be set apart for the purpose of holding Memorial Services and decorating the graves of our departed brethren, and that the most appropriate time for holding such services would be the first day of August in each year; and the Grand Master is requested to bring the matter before the Grand Lodge of Manitoba at its next'session, with the recommendation that such action be taken as ma Decor annua Augus engag I le

resolution claring it e purpose departed services id Master Manitoba be taken as may be requisite in order to have the first day of August set apart as Decoration Day; and that the Grand Master be authorized to issue annually a Proclamation at least thirty days prior to the first day of August, requesting all Subordinate Lodges to assemble on that day and engage in appropriate services in honor of their deceased members."

I leave the subject to be dealt with by you as may seem proper.

Endowment Societies.

While the growth of Odd Fellowship in the Province has been most satisfactory, many of our members have been attracted by the inducements held out by the various Endowment Societies which are occupying the ground with us. A provision made for those dear to us, who in the event of death would be left more or less dependent, is natural and right; but our members need not go outside of the Order to make this provision, as there are many Mutual Aid and Benefit Associations managed by Odd Fellows, which offer all the protection and advantages secured by connection with other organizations. A demand exists for this kind of fraternal assurance, and Odd Fellowship supplies the demand, though not as an integral part of its beneficial system. Without casting reflection on any institution connected with or akin to Odd Fellowship, I mention in this connection the Odd Fellows' Relief Association, of Kingston, Ontario, and the Covenant Mutual/Benefit Association, of Galesburg, Illinois, both well conducted and worthy of confidence.

Dominion Odd Fellow.

My predecessor recommended "the members of the Order in this jurisdiction to give their support to the *Dominion Odd Fellow*, by subscribing for it and contributing to its columns, and thereby aid in making it what it should be, a live paper." I emphasize this recommendation, and have no hesitation in saying that this paper may become through our co-operation on important factor in building up and strengthening Odd Fellowship in this Province. It is not simply an Ontario publication, but the publisher aims at its being in very fact as in name the DOMINION ODD FELLOW. Then let Manitobans supply the Manitoba news, and take a share in the discussion of those broad and comprehensive-questions which affect the whole Order.

Correspondence.

A letter book was procured for the use of the Grand Master, in which

will be found copies of all letters written by me and all Dispensations granted. All the letters received by me are also submitted for reference to the proper committees.

Queen's Jubilee.

I suppose that in this year of grace, 1887, a Canadian Grand Master's report without a suitable reference to the above event would be like the play of "Hamlet" with the part of *Hamlet* left out. To us, who in taking the first step in the Order are taught that "in becoming Odd Fellows no loosening of the obligations which, as good citizens, we owe to the laws and institutions under which we live is required," and that "we cannot become Odd Fellows in spirit and truth unless we are faithful to our country," ours is no mere heloyalty, but we join with our fellow subjects of every nation, kindred and tongue in acknowledging the many blessings which have accrued to our Empire during the long and benignant reign of our good Queen Victoria. We rejoice that she has been spared to celebrate her Jubilee, and heartily unite in the prayer, "God bless and save our Queen."

Conclusion.

In conclusion, I thank you for your confidence in electing me to this position one year ago, and for the support I have received from you during my term. I bespeak for my successor like encouragement, for none but those who have passed through this Chair have any just conception of the responsibilities and anxieties connected with the office.

To the Grand Secretary my acknowledgments are due, for advice and assistance freely accorded at all times. He has been a faithful officer, and has cheerfully, and at some sacrifice of his private interests, served the Grand Lodge.

I again express the hope that we may carefully and in a true fraternal spirit consider every question which comes before us, and that we may be wisely guided to right decisions.

GRAND LODGE OF MANITOBA OF THE INDEPENDENT ORDER OF ODD FELLOWS.

OFFICE OF THE GRAND MASTER, WINNIPEG, March 21st, 1887.

To the Subordinate Lodges under the Jurisdiction of the Grand Lodge of Manitoba :

In conformity with a Proclamation issued by John H. White, Grand Sire, of the Sovereign Grand Lodge of the Independent Order of Odd Fellows, I, James Davidson Conklin, Grand Master of the Grand Lodge of Manitoba, 1. O. O. F., do hereby order and direct as follows:

First : That no person holding membership in the Patriarchal Circle or its successors, by whatever name it may be known, or in any secret organization not authorized by the Sovereign Grand Lodge that has heretofore or may hereafter require as a qualification for membership therein a past, present or future membership in this Order, shall be elected or appointed to or installed into any office in any Subordinate Lodge under the jurisdiction of the Grand Lodge of Manitola, I. O. O. F; and it shall be the duty of all Installing Officers, before installing into office any person who shall have been elected or appointed to any office in any such Subordinate Lodge, to exact from each such person an afirmation in the following form, viz:

"I, upon my honor as an Odd Fellow, do solemnly declare that I am not now, and was not at the time of my election (or appointment) to the office into which I am now about to be installed, a member of the Partiarchal Circle or any successor thereof, by whatever name known, or in any secret organization not authorized by the Sovereign Grand Lodge of the Independent Order of Odd Fellows, that has heretofore or does now require as a qualification for membership therein, a past, present or future standing in this Order of Odd Fellows."

And any such person who shall neglect or refuse to take and subscribe such affirmation shall not be installed into office, but the said office shall be declared vacant, and the Lodge shall proceed to elect or appoint a qualified brother to fill the vacancy thereby created.

Second : That no person shall be elected to or received into membership in any Subordinate Lodge of Odd Fellows under the jurisdiction of the Grand Lodge of Manitoba unless he shall subscribe an application for membership which shall contain a declaration upon his honor, that he does not hold membership in the Patriarchal Circle or any successor thereof, by whatever name the same may be known or called.

Third : That all persons who shall hereafter claim to be admitted as members of or Representatives to the Grand Lodge of Manitoba, I. O. O. F., shall take and subscribe the adfirmation first herein set forth ; and no person shall hereafter be admitted

to membership therein or as Representative thereto who shall refuse to take and subscribe such affirmation.

Fourth: That any Lodge or officer who shall wilfully neglect or shall refuse to carry out any of the provisions of the foregoing orders or directions, or who shall violate the same, and any member of the Order or person who shall thereafter become a member, who shall falsely make, take or subscribe either of the foregoing affirmations, shall be deemed guilty of conduct unbecoming an Odd Fellow, and upon conviction thereof shall be expelled.

A supply of blanks containing the above declaration will be supplied by the Grand Secretary, free of cost; a fifth hereafter every applicant for membership in a Subordinate Lodge in this jurisdiction shall sign said declaration, which shall be attached to and form part of the application for membership.

Blanks containing above affirmation will also be sent to the Lodges in due time for the use of Past Grands who may at the next session of Grand Lodge present themselves for admission thereto as members or Representatives.

All District Deputy Grand Masters are required to promulgate to their Lodges the above orders and directions, and they and all Lodges shall cause the same to be obeyed.

Under instructions from the Grand Master, I issued a Dispensation for a new Lodge at Glenboro, to be known and hailed as Mizpah Lodge, No. 12, and which was duly instituted on the 29th July last.

Early in December I prepared a supplementary report, in accordance with the recommendation of the Committee on Legislation, and sent one to each Lodge, with the request that they be carefully filled out. Three Lodges failed to respond. The majority of the reports received were not correct. I took pains to go into the matter

carefully, and made out statements of what the funds should be as per the books of this office, and asked explanations of the apparent inaccuracies. Some of the Lodges replied promptly, and by this means we have been enabled to have the discrepancies corrected.

In sending out the Supplementary Reports in June, I called the attention of the D.D. G. Masters to the fact that it was their duty to see that the Lodge Reports were carefully and correctly filled out prior to installation, and also to see that they were promptly sent to this office. A majority ofLodges sent in their reports promptly, while a lew failed to report until the 30th July, and, in fact, two of the Supplementary Reports were not received until the 6th inst. I still find a number of inaccuracies in the Reports, and it is evident that some change must be made in the manner of keeping the accounts of the Lodges. Some simple form of book-keeping, adapted to the wants of our Lodges, should also be devised, and it should be firmly impressed on the Lodges that they should in all cases endeavor to secure some good accountant to take charge of the books, and if necessary pay him sufficient to make it an object to retain the office, as "on the proper management of the fiscal concerns of a Lodge depends its ability to fulfil its future obligations " I would recommend that the requisite action be taken by this honorable body in order to make it compulsory for the Lodges to have their Semi-annual Reports in the hands of the Grand Secretary not later than the 15th of January and July in each year.

From the Returns of December **%**Ist the Annual Report to the Sovereign Grand Lodge is made, and from those of June 30th the Annual Report to this Grand Body is compiled. This would barely give time to make out the statistical tables required, and balance the books so that the Auditors could give that careful scrutiny of the accounts and vouchers necessary to enable them to make a conscientious report.

Just here, for the benefit of those concerned, I would mention that the habit of sending papers to this office, and more particularly Returgs containing the Per Capita Tax, without a letter or some evidence to show from whom it is received, is not only discourteous, but wrong. Frequently I have had to write at random in order to acknowledge their arrival. I would also call the attention of Secretaries to section 73 of the Constitution of this Grand Lodge, a law that is "more honored in the breach than the observance," requiring all official communications to be attested by the Secretary and having the Seal of the Lodge impressed thereon.

Receipts for Rituals were received from all the Lodges in January, excepting Brandon, No. 6, Crystal City, No. 8, and Valley, No. 1A; and in July, North Star, No. 2, and Portage, No. 3, failed to send the necessary receipt.

The response to the appeal for relief in aid of the Lodges in South Carolina was so meagre that I have held the amount received, \$13.75, in hopes that it would be increased.

Our Semi-annual Report forms are very deficient in many particulars, besides being of a cumbersome and antiquated size, and I would suggest that a committee be appointed to draft out a new form of more modern design and containing more complete information in regard to the finances of our Lodges.

Your Committee would recommend that Clause 28, Constitution of Subordinate Lodges, be amended by striking out all after the word "week" in the sixth line, and inserting the words, "and such weekly benefits shall in no case exceed in amount one half the amount of yearly dues."

Resolved; That the foregoing be adopted.

On motion of Rep. Jamieson, No. 7, seconded by Rep. Pratt, No. 7, the Report of the special Committee on Dues and Benefits was laid on the table until the proposed amendments to the Constitution of Subordinate Lodges were laid before this Grand Lodge for consideration.

Under Order of Business No. 18, the proposed amendments to the Constitution of the Grand Lodge were considered.

1st. Each officer and representative in attendance at any regular session of the Grand Lodge, shall be entitled to receive the amount paid by him for railroad and stage fare, by the shortest travelled route, between his residence and the place in which the session of the Grand Lodge is held." The proposed amendment was not concurred in.

2nd. To amend Art. 75 by striking out the words, "other than financial," in the fifth line, was also lost.

3rd. To amend Art. 81 by inserting the word "expired" before the word "withdrawal" in the fifth line. Was adopted,

4th. To amend Art. 91 by adding the following clause :---"When any such alteration or amendment comes up for action, it may be amended by a vote of two-thirds of the members present and voting, without the

aforesaid notice; but whenever it is necessary to change this Constitution in order to conform to the laws of the Sovereign Grand Lodge, such change may be made without previous notice." Was adopted.

CONSTITUTION OF SUBORDINATE LODGES.

5th. To amend Art. 23 so that it shall read :— "Each elective officer or representative to the Grand Lodge shall be chosen separately, by a majority of all the legal ballots cast. At each election the Noble Grand shall appoint two tellers, who shall preside at the ballot box, and allow each member in good standing, as his name is called by the Permanent Secretary, to deposit his ballot. When the balloting is completed they shall examine the same and report the result, but no vote shall be counted or considered unless it be for a candidate in nomination : *Provided*, that when only one candidate is in nomination he shall be declared elected by acclamation." Was adopted.

6th. To amend Art. 79 by adding the following clause :---"When any alteration or amendment comes up for action, it may be amended by a vote of two-thirds of the members present and voting, without the aforesaid notice. but whenever it is necessary to change this Constitution, in order to conform to the laws of the Sovereign Grand Lodge, such change may be made without previous notice." Was adopted.

The following amendment of the By-laws of Manitoba Lodge, No. 1, was then presented, and referred to the Committee on Laws of Subordinates :

Insert the words "payment of insurance assessments, or," between the words "the" and "necessary," in the sixth line of By-law No. 39.

Constitution of Subordinate Lodges.

Strike out Clauses 3, 4 and 5, and substitute the following :

3. Every applicant for membership in this Lodge shall send in to the Secretary a petition according to the form prescribed by the Grand Lodge of Manitoba, signed by himself, and supported by a reference to at least one other member of the Lodge, which shall be read in open Lodge and referred to a committee of investigation composed of three brothers, two of whom shall be appointed by the Noble Grand, and one by the Vice Grand, who shall enquire into the character and fitness of the candidate, and report to the Lodge at its next regular meeting, unless the petition is withdrawn ; and the candidate shall then be halloted for, or the petition be referred back to the committee ; when, if less than three black balls appear, the candidate shall be accepted ; if three or more, he shall be rejected, and so declared.

Add the following new Clause 4:

4. Every application for membership must be accompanied by a Physician's Certificate, according to the form prescribed by the Grand Lodge of Manitoba.

Add the following new Clause 5:

5. If at any time after the election of any candidate for membership, and before his admission, objections to his admission be made by two members of this Lodge, the

Noble Grand shall declare the previous balloting annulled, and order a new ballot to be taken as at first.

To amend Clause 13, by adding after the word "ballot" on the fifth line :

"And one regular meeting shall intervene between the conferring of each degree."

To amend Clause 14, by adding after the word "for" and before the word "in" on the third line : "And any member not appearing within three months from the date of ballot for degrees shall not be entitled to said degrees, unless by another election."

Strike out Clause 48, aud substitute the following :

48. Every member not over thirteen weeks in arrears to the Lodge for dues, or an aggregate of dues, fines find assessments to an amount equal to more than thirteen weeks' dues, shall, in case of being disabled by sickness or bodily accident, from following his usual occupation, or otherwise earning a livelihood, be entitled to and may receive such weekly benefits from the funds of the Lodge as may be provided by its By-laws; provided such weekly benefits shall not exceed in amount on-half the amount of yearly dues; and provided further, his sickness or disability has not been occasioned by any unnecessary exposure, imprudence or immoral conduct, or net constitutionally diseased prior to his admission to the Lodge; in such cases no benefits can be allowed, nor will any brother be entitled to benefits until the expiration of six months from the date of his admission; all dues, fines and assessments to be deducted from benefits previous to their payment. Should a brother's disability becal and apparently permanent, but his general health not disqualify from following some occupation.

Clause 48a—new Clause,—Any brother who is in good health, but in arrears for over thirteen weeks, or an aggregate amount, including fines and assessments, equal to more than thirteen weeks' dues, shall not be entitled to any benefits for sickness or disability that may arise prior to the expiration of four weeks after the payment of said arrearages in full. "Arrears" shall be construed to be the amount in excess of thirteen weeks.

To amend Clause 49, by striking out all the words after "Lodge" on the fifth line.

The Grand Secretary then presented the Report of the Grand Representative, which was taken as read, and referred to the Committee on Distribution.

J. M. Robinson, P. G. No. 3, from the Committee on the State of the Order, submitted the following report :

To the Grand Lodge of Manitoba, I. O. O. F.

We, your Committee on the State of the Order, have had under consideration the clauses of the Grand Master's and Grand Secretary's Reports referred to us, and beg leave to submit the following report for your consideration :

1. Your Committee heartily re-echoes the sentiments expressed by the Grand Master in pages 1, 2, 3 and 4 of his Report, and would recommend the adoption of the same.

2. Your Committee have examined clauses 2, 3, 4, 5, 6, 7, 8, 9, 11, 12 and 14 on pages 4 and 5, and would recommend the adoption of the action of the Grand Master in disposing of the questions before him, as indicated by the said clauses.

3. Your Committee heartily agree with the sentiments expressed in clause 1, page 6, and are of the opinion that it would be the imperative duty of the Grand Master to refuse to grant a dispensation in cases where the formalities referred to in this clause have not been complied with ; and when such failure to comply with these formalities

is, in the opinion of the Grand Master, the result of neglect or indifference on the part of the applicants.

4. We are pleased to note, under the head of "Visitations," that the Grand Master during the year has availed himself of the opportunity of visiting many of the Lodges under the jurisdiction of this Grand Lodge; but we must join with him in regreting that he did not find it convenient to visit every Lodge under his charge, as we believe it to be incumbent upon the Grand Master to visit every Lodge under this jurisdiction when it is at all practicable.

5. Your Committee fully appreciate the force of the Grand Master's opinion as to the system now employed by Disirict Deputy Grand Masters in making their reports to the Grand Master, tending to have important duties performed in a prefunctionary manner, but we fail to see any way of meeting the difficulty other than by impressing upon District Deputy Grand Masters the importance of making that portion of their report under the heading "Remarks" very much more comprehensive.

6. Your Committee heartily endorse the opinions of the Grand Master on the question of "Endowment Societies" and the "Dominion Odd Fellow," and therefore recommend the adoption of those clauses by this Grand Lodge.

7. Referring to page 1 of the Grand Secretary's Report, your Committee regret to find that the net increase in membership during the year has not been so large as might have been expected, but have no doubt the general commercial depression prevailing accounts for this in a great measure.

8. The "Statement of Supplies," on pages 7 and 8 of the Grand Secretary's Report, we find to be most satisfactory.

9. Your Committee are of the opinion that the Grand Secretary is deserving of the thanks of this Grand Lodge for the prompt and business-like way in which he attended to the various duties committed to him, as shown by the first five clauses on page 3 of his report.

The mountains, with beautiful villas and cottages along the banks, where people enjoy the cool shade, the healthful breezes and refreshing scenery, and indescribable beauty made famous in poetic verse and legend. The vast fields and mountains teeming with wealth and beauty, where there has been such a rapid change from the wild forests and plains to the now beautiful, grand, growing, fertile country, rich in agriculture and mineral, and the varied interests that make it so attractive and prosperous.

by his physician to attend at such terms three times, one day in a week, during a period of four months of such sickness. He is not allowed to speak, but communicates in writing. His monthly salary has been paid during his sickness, the same as if he were attending regularly to business. The By-Laws of the Lodge provide for benefits, "in case of being rendered incapable by sickness or accident of providing for his own support." The case is not free from doubt. The Brother is, however, able to some extent to follow his usual occupation, and by that means does and is capable of "t procuring the means of subsistence for himself." Article III., Section 6, Constitution of Subordinates.

The question of income from investments (Section 73, Digest) has nothing to do with it. Here the income is the fruits of his employment. I therefore hold that the Brother is not entitled to benefits.

2. Our law does not recognize collateral relatives at all, unless they were members of the family of deceased at the time of his death and dependent on him for support. The right of property to the funeral benefits is in the family of the deceased, and not in the Brother. It does not begin to exist until after his death, and if there are no dependent relatives no benefits are to be paid. The law does not, in such a case, cast the estate anywhere, beccuse there is no estate to be cast.

The law covering the entire case of benefits may be found in the Digest S. G. L., Sections 86, 87, 88, 89 et seq., and in Journal, S. G. L., 1886, pages 10,254, 10,487, 10,511.

3. The By-Laws of a Lodge debar its members from benefits who are more, than thirteen weeks in arrears for dues. The Lodge appointed a collector to present and collect, at the end of each quarter, all dues owing by the members. A Brother was thirteen weeks behind in his dues, October 1st. On October 12th he paid the collector the amount due, and on October 13th he had to quit business on account of sickness. The next Lodge meeting, which was October 18th, the money was credited to the Brother's account by the Secretary, who was not the collector. The Lodge has a law, approved by the Grand Lodge, that all moneys paid to the Lodge officers between the adjournment of the Lodge at one meeting and the opening of the Lodge at the next meeting, shall be credited as paid at the meeting after it was paid to the officer. In such a case the Brother is not entitled to benefits. The Lodge-room is the place to pay dues, and if paid in recess to any member or officer, that member or officer is simply the agent of the Brother in the matter, and, as a general rule, the Lodge is only bound by it as a payment when it comes to the hands of the proper officer in the Lodge-room to be credited in his account. There is no safety in any other rule. The words "at any time," in Section 373, Digest, should be construed "at any Lodge meeting," and not in recess.

4. It was asked if, under the decision of the Sovereign Grand Lodge, in the case of the appeal of Emmons vv. Harmony Lodge, No. 9 (Journal, 10,387), the Lodge was compelled to pay only the amount of the "funeraf expenses as claimed under the law" of the Lodge, as appears in the resolution appended to the report of the committee of the Sovereign Grand Lodge, or is the Lodge compelled to pay all that is claimed in

the sustained appeal, viz., the funeral expenses under the Constitution, and the assessment of \$1 for each member under the By-Laws?

Answer—The claim presented by the heirs of Bro. John T. Howe is for both amounts, that under the section of the Constitution quoted, and also under the By-Laws, and the resolution of the Severeign Grand Lodge sustains the appeal, and the rects the Lodge to pay to the heirs of Bro. Howe "the amount of the funeral expenses claimed under their law." It is clear that if the heirs are entitled to the former amount, they are to the latter, and the words "their law" in the resolution, must mean the law of the Lodge, and the law of the Lodge is contained in both the Constitution and By-Laws.

I therefore decide that the Lodge is bound to pay the amount provided for in the section of the Constitution quoted, and also the assessment of \$1 for each active member under the By-Laws.

IN REFERENCE TO DEGREE OF REBEKAH.

5. A Daughter of Rebekah who received her degree in her husband's Subordinate Lodge during his life, is not, after his death and her remarriage to one not a member of the Order, eligible for membership in a Degree Lodge of the Daughters of Rebekah. —Digest, Section 341 ; Journal, S. G. L. 9858.

The policy of the law seems to be not to deprive her of any privilege which she possesses, but not to grant her any additional ones.—Digest, Sections 244, 345.

6. An unmarried daughter of an Odd Fellow, after joining a Degree Lodge of the Daughters of Rebekah, married a man not a member of the Order. Her dues are paid, and since her marriage she has been elected to office. In such a case she does not by her marriage forfeit her membership, and it can in no way affect her standing in the Lodge.—Digest, 344.

7. The widow of an Odd Fellow, who had received the Degree of Rebekah during the life of her husband, in his Subordinate Lodge, is eligible to membership in a Rebekah Degree Lodge upon a card from the Subordinate of which her husband was a member, although her husband at the time of his death was not in good standing in his Subordinate Lodge.

In 1874 the Grand Lodge (Sections 333, 359, Digest) authorized Withdrawal Cards to be issued by Rebekah Lodges, and provides that they may admit to membership on deposit of card. In view of the usually liberal construction⁶ of all the laws relating to the Degree of Rebekah, I am constrained to hold that the Sovereign Grand Lodge, when it provided that such Lodges might admit to membership by deposit of card, intended to cover all the cases in which cards were then authorized to be issued by any Lodge, either Rebekah or Subordinate. It will be observed that all the legislation in which good standing is required, has reference to conferring the degrees and not to membership. The question whether she could now receive the degree is quite another thing, although it is worthy of note that the legislation of 1868 as amended in 1871 (Digest, Section 323), authorizing the Lodges to confer the degree, says nothing about good standing in cases of certificates presented by Subordinate Lodges.

An unmarried step-daughter of an Odd Fellow of the Degree of Truth, if eighten years of age, is eligible to membership in a Degree Lodge of the Daughters of Rebekah. See Journal, S. G. L., 1886, pages 10,520, 10,659.

9. Since the enactment of the law (Digest, Section 351b), all officers of Degree Lodges of the Daughters of Rebekah, whether Brothers or Sisters, must wear the regula described in that section.

10. Subordinate Lodges are not entitled or allowed to purchase or use the new Rebekah Degree Ritual, and consequently cannot exchange their old Rituals for the new.

11. Rebekah Degree Lodges working under the new Ritual cannot lawfully give that work before a Subordinate Lodge open in the Degree of Rebekah. The new Ritual is for the exclusive use of Rebekah Lodges.

12. There being no German translation of the new Rebekah Degree Ritual, I decided that Degree Lodges of the Daughters of Rebekah which could not work in English were entitled to retain and use the old German Rituals until such times as translations of the new were furnished them. This may have been a stretch of power but it seemed a matter of necessity.

MISCELLANEOUS.

13. The following ex parte statement was presented for my decision : "One Martin was a member of a Lodge in Iowa, from which he took a Withdrawal Card. This he deposited in a Nevada Lodge and afterwards took a Withdrawal Card from that Lodge, which he deposited in a Lodge in Missouri, then he took a Withdrawal Card from the Missouri Lodge and removed to and became a permanent resident of Arizona. He remained in Arizona until his Card expired, and then applied to and became a member of his home Lodge in Iowa, although he still remained and yet remains a permanent resident of Arizona. Of course he was admitted a member of his Iowa Lodge on the ground of being an Ancient Odd Fellow, and he was so admitted without the consent of the jurisdiction of which he was a resident." If this be a correct statement, he was admitted in direct violation of Section 3, Article XVI., of the Constitution of the Sovereign Grand Lodge. Now, what was his status? Is he to be treated as an Odd Fellow or not? This is the guestion propounded. It has been decided that a Brother admitted illegally by card, without fault of his own, and from fault of his Lodge, must be protected in his membership so acquired. (Section 672, Digest 674.) That I conceive to be the extent to which the decisions go. In this case the applicant knew or was bound to know what the law was, and that membership thus acquired would be illegal ; the Lodge also knew or was bound to know what the law was. No decision can be found that goes to the extent of holding that membership can be acquired where both parties to the contract knew that it was an illegal transaction, except in the single case of an initiate, the reason being given for this that the initiation being declared void might be construed as releasing him from his obligation. No such reason can exist in this case. I am constrained to believe that if this case shall be held to give the party in question a good and valid membership, the Sovereign Grand Lodge might as well remit the whole matter to Subordinate Lodges. I therefore hold that, on the facts stated, Martin is not a member of the Iowa Lodge, but his status is that of an Ancient Odd Fellow.

14. The question which you ask, viz., "Can a Subordinate Lodge appropriate, in whole or in part, its Lodge funds to purchase stock in an Odd Fellows' Hall Association, which association is to erect a building for Lodge purposes, among other things?" is of very great importance and very far reaching. That there should be some limit to the power of Lodges to appropriate their funds in this direction, must be apparent to every one, but I find nothing that throws much light on the subject. I do not think that a Lodge should invest its funds to such an extent in anything as to disenable it from being in a situation to respond to calls likely to be made upon it for the relief of its distressed members, but it may and should invest its surplus funds in such a way as to produce an income by way of interest, dividends or rentals. It is my opinion that it is not advisable for Lodges to take stock in associations which are or may be controlled by others than Odd Fellows, unless it be in some business corporation. Therefore, as at present advised, I think the rule should be, and I decide, that an Odd Fellows' Lodge may, for the purpose of providing a place for its meetings, use a reasonable portion of its funds to purchase stock in an Odd Fellows' Hall Association, although such hall or building, when erected, will be, in part, used for other than Odd Fellow purposes.

15. To your question, "Do you understand, by the report of the committee, page 10,521, on Decision 33, and adopted page 10,659, that a Lodge cannot expend any money for observing April 26th, or only forbids expending money for a collation and dance?"

Answer-I do not understand that, by that report, a Lodge cannot expend any money for observing April 20th, nor do I understand that it "only forbids expending money for a collation and dance."

It seems to me to be almost impossible to lay down any general rule applicable to \mathbb{V}_{+} every conceivable set of circumstances, but I think the principle to be evolved from \mathbb{T}_{+} the decisions is about as follows:

A Subordinate Lodge may expend a reasonable amount of its funds to defray the necessary expenses incident to the celebration of the introduction of Odd Fellowship in America, in such a manner as shall promulgate and illustrate its principles, or to elevate it or dignify it in the eyes of the community, such as hiring halls, paying for printing, procuring orators, etc., but not for those things which contribute merely to the pleasure or gratification of the individual member, such as parties, balls, picnies, excursions, banquets, and the like, and that, within these limits, the question is one for the Subordinate or its immediate Grand Jurisdiction.

16. To the question, "Can the Grand Lodge of Massachusetts, under its Constitution, delegate its constitutional legislatfve powers to its Board of Grand Officers sitting in recess to grant Charters for Subordinate Lodges ?" I replied that I had no authority to decide the question, as it was one "arising out of the Constitution" of a State Grand Lodge.—Constitution, S. G. L., Article IV. Thei 20 on w well local

ts Constituficers sitting d no autho-" of a State The Grand Sire has not the authority to approve the Constitutions of Subordinate Grand Bodies, or amendments thereto, during recess of the Sovereign Grand Lodge.

19. Under Section 297, Digest, the Grand Sire may authorize a Royal Purple member to confer the Patriarchal Degrees on Scarlet members, to qualify them as petitioners for an Encampment Charter in a place where no Encampment exists, in territory under the immediate jurisdiction of the Sovereign Grand Lodge, but I very much question the power of the D. D. Grand Sire, or even the Grand Sire, to appoint any one but a Past Chief Patriarch to install officers. The principle seems to be that no one should be appointed to administer an obligation who never has received it. Therefore, as at present advised, I must hold that it cannot be done.

20. Section 289, Digest, requiring balloting for dgrees to be upon the same evening on which application is made therefore, is doubtless applicable to Encampments as well as to Lodges, though about the latter, the subject may now be regulated by the local legislation.—Journal, S. G. L., 1885, page 10,089.

21. A Brother holding a Withdrawal Card out of date, or a Dismissal Certificate, may join in applying for a Charter for a new Lodge of Odd Fellows, but the application must be signed by five third Degree members who hold unexpired Withdrawal Cards. —Digest, Sections 1102a, 1177, 1178.

The term "Brothers of the Order in good standing," as used in Article I. of the By-Laws, Sovereign Grand Lodge, Digest, Section 1162, must be construed to mean, Brothers holding unexpired Withdrawal Cards.

22. The law of New Jersey provides that "A person cannot be initiated in any Lodge than the one nearest or most convenient to his residence, without the consent of said Lodge." A person applied to his nearest Lodge, Clinton, for membership, and was rejected, of which rejection Harrison Lodge was notified. Notwithstanding this, Harrison Lodge elected and initiated such person. On complaint to the Grand Master, the Lodge plead guilty. No fraud was practiced upon Harrison Lodge, as the applicant informed the committee that he had been rejected by Clinton Lodge. On this state of facts, the Grand Master issued his mandate forbidding Harrison Lodge from conferring the Degrees upon the person initiated, and asks what is the remedy, and whether the law, Section 620, Digest, applies.

Answer—Harrison Lodge is guilty of a wilful violation of law, and is liable to such penalty as the Grand Lodge may deem adequate to the offence. I do not see that the membership of Feindt can be disturbed, or his rights to advancement interfered with.

24. When the officers at installation retire in charge of the Grand Marshal for examination, they should retire in form—that is, address the Chairs.

25. A Grand Master, when introducing a visiting Brother, enters the Lodge in his official capacity. He announces himself as Grand Master with a visiting Brother, and is entitled to be received with the honors of the Order, and must be so received. The honors are not to be given to the visiting Brother, unless he also be entitled thereto.

26. A Grand Representative to the Sovereign Grand Lodge has not the right to introduce visitors to a Sabordinate Encamptent whom he knows are not members of the Patriarchal branch of the Order.

27. Subordinate Encampments meet semi-monthly, and twelve consecutive meeting-nights, or six months, constitute a full term. With the consent of the Grand Encampment they may meet monthly; in such case the term of their officers is extended to one year (Digest, 1221), the number of meeting-nights still being twelve. A Chief Patriarch who serves a majority of the nights, and to the end of either the six or twelve-months term, is qualified to sit in the Grand Encampment. No other or different terms are permitted.

28. Appeal of Charles J. Fishel from the decision of the D. D. Grand Sire of the Sandwich Islands.

The facts in this case, as it appears from the concurring statements of the appellant and the D. D. Grand Sire, are as follows :

Harmony Lodge, No. 3, failed to hold one of its regular meetings for the term ending December 31st, 1886, from want of a quorum, occasioned by the celebration of the Fourth of July occuring on the fifth of that month, the fourth being Sunday, the appellant, the then Noble Grand, claiming that he was present at the Lodge-room, but that he could not procure the attendance of sufficient members to open the Lodge. The Noble Grand and Vice Grand were both actually present in said Lodge during said term and served more than fourteen meeting-nights of the term, and held their respective offices until their successors were installed, on the first meeting of January last. It appears, also, that on three meeting-nights of the preceding term the Lodge failed to hold a meeting, for the want of a quorum. The Noble Grand and Vice Grand of that term also served a majority of nights and held office until its close. After the installation of officers in January last, it was claimed that the appellant was not eligible to the position of Noble Grand when he was elected thereto, by reason of the failure of the Lodge to hold the three meetings above specified, and that he was not entitled to the honors of Past Grand, by reason of the failure to hold the one meeting in the last term, as above mentioned. The D. D. Grand Sire, on the authority of Section 265, Digest, so decided, and from this decision the appeal is taken.

I decided as follows : Perhaps the literal interpretation of Digest, 265, would justify your decision, but on a thorough examination of the question, and the way it came up, I am compelled to think that you have fallen into an error. The history of the matter is as follows : On the first organization of our Order the terms of Subordinate Lodges were thirteen weeks, and there appears to have been no regular time for the terms to end. It would seem that the term commenced at the first meeting after the Charter was granted and ended thirteen weeks from that time. They were not quarterly or half-yearly terms, commencing and ending with certain months in the year. Grand Sire Kennedy, in his annual report in 1842, says : "The periods at which terms of Lodges and Encampments commence and end are as greatly deversified as the number of them could possibly permit." (Journal, 445.) To remedy this defect, and so that proper statistics could be collected, it was enacted (Journal, 491.) that annual reports

Grand h terms of he number und so that ual reports be made from July 1st to June 30th; semi-annual, if any, from July 1st to December 30th, and quarterly reports on the first days of July, October, January and April in each year, and that when the longest part of the term (seven weeks or more) under the present regulation shall have expired, Subordinates were authorized to make one short term, so as to end the quarter as above specified, and the officers would be entitled to the honors ; and when less than seven weeks of a quarter shall have expired, they are directed to extend the term, and (Journal, 494) that the officers hold for the remnant of that quarter and to the end of the next quarter. By this law the terms were changed from a given number of consecutive meeting-nights to periods of time, and all had a uniform ending. Now, terms end either in January and July or April and October, six months, and the term ends when the period arrives, whether twenty-six or six meetings have been held. It may have been from a misapprehension of these things that the latter part of Section 265 was enacted. A dispensation with Lodgemeetings is undoubtedly illegal and improper, but it cannot be that an illegal dispensation of one of twenty-six Lodge-meetings, against the protest, perhaps, of its Noble Grand, would deprive that officer, who has faithfully served for twenty-five nights of a term, of the honors due to his faithful service. There is no justice in it Besides, it has been decided, over and over again, that an officer who has served a majority of nights of a term (fourteen), if in office at the end of the term, is entitled to the honors of the office. The enactment (Section 265) cannot be upheld unless it can be construed to mean that the dispensation spoken of prevented the officers from serving a majority of the nights of the term. This can, however, hardly be claimed for it. I have never had occasion before to critically examine the question, but am clear that the foregoing views are correct.

I therefore decide that the retiring officers of Harmony Lodge, No. 3, are entitled to the honors of the term if they were present in the Lodge-room a majority of the meeting-nights of the term, and held their offices to the close of the term.

I must also overrule your decision as to the preceding term upon substantially the same principle. If the officers served a majority of the nights of the term, they are not debarred from the honors of those offices from the fact that the Lodge failed, for want of a quorum, to hold three meetings out of the twenty-six. If three meetings would do it, one would, and if that were so a large number of the officers would fail of their honors for the same reason.

29.4 "A Brother paid his fee for the Second Degree, and before he was ready to take sit was called away to another jurisdiction: He made no provision for the payment of his'dues." In such a case the Lodge cannot apply the money so paid in on his dues, nor can he demand it back unless the Lodge refuses to confer the degree on demand. The demand must be made before suspension for non-payment of dues, otherwise the degree fee is forfeited unless the Brother be re-instacd.

30. Under the law of the Sovereign Grand Lodge, establishing the Degree of the Patriarchs Militant, honorary members cannot be required to wear a cap, belt and sword in order to sit in a Canton.

31. Under that law a Canton cannot be compelled to turn out for parade or drill, except on the 20th of April, when ordered by a superior officer under penalty of courtmartial and punishment such as it may see fit to inflict; but a Canton may, when so ordered, determine by vote whether it will or will not turn out, and inform the officer of its decision, without incurring the penalty of a court-martial.

32. Orders issued by superior officers in plain violation of the law creating the degree are of no binding force upon Cantons or Chevaliers, and may be disregarded.

33. Unless an association has the sanction of a State Grand Body, as provided in Sections 405, 406, Digest, it is illegal for it to do business as an insurance company under the name of the Order, and the "Odd Fellows' National Benevolent Association" is such an illegal association, unless authorized as above. (Digest, 402.) The business transacted by that or any similar association is a "private business or enterprise," within said Section 402.

Any member of the Order engaged in any such business is liable to charges and expulsion.

General Returns.

The subjoined table exhibits the condition of the Order at the close of the year **1886**, with the addition of Subordinate Bodies instituted in **1887**, previous to August **20**th, contrasted with the returns of the preceding year. The Grand Jurisdictions of Australasia and Germany are not included.

New Legislation.

A committee of five members was named by the Grand Sire to take into considera-

tion and report during the session of this Soverign Grand Lodge on the advisability of creating a *Juvenile* Order of Odd Fellows, under the direction of this Sovereign Grand Lodge.

The following are the Committee :--Reps. Kines, of Quebec ; Celley, of Vermont ; Holmes, of Iowa ; Tucker, of Washington ; Metschan, of Oregon.

The Widows' and Orphans' Fund of the Subordinate Lodges and Encampments is stamped as a trust fund for the use and benefit of the widows and orphans whose husbands and fathers, at their death, were members in good standing in such Lodge or Encampment; and that it is illegal and a misapplication of such funds, or any part thereof, for any purpose whatever except for the direct and individual support and benefit of the widows and orphans who are, under the law, legitimate charges upon such Lodge or Encampment; *Provided*, *however*, Nothing herein shall prevent Subordinates who may have placed their widows and orphans in an asylum or home, from using their Widows' and Orphans' Fund in defraying the legitimate expenses thereby incurred. And the several Grand-Bodies are instructed to see to it that this law is observed by their Subordinates.

The Grand Secretary be directed to furnish to the Grand Officers and Representatives, who have not already received them, the bound Journal of Proceedings, and at cost the Reviged Digest.

"If a brother who holds a certificate of membership in an Odd Fellows' Beneficial Association, constitutes his Lodge his beneficiary, can the Lodge by by-law pay the assessments thereon out of its General Fund." That such use of the general funds of a Lodge would be illegal.

That a pamphlet, not exceeding twenty pages, be prepared, containing extracts from the various reports of special committees on dues and benefits, and that a copy be sent to each Subordinate Lodge, together with a circular directing that action be taken thereon, and that your committee be continued, and that the Grand Sire fill any vacancies therein.

The only persons who are the beneficiaries of a funeral benefit are the orphans, or dependent relatives of the deceased or relatives upon whom the deceased was dependent at the time of death; dependent relatives are relatives who were members of the family of the deceased and were dependent upon the deceased for support at the time of death.

The following were adopted :

First—That the Grand Sire be empowered to contract for the translation and publication of our Digest in the Spanish language, without expense to the Sovereign Grand Lodge, upon such terms as he may deem fit.

Second— That authority is hereby given to Fraternidad Universal Lodge, No. 2, to remove its place of meeting from Guanabacao to the Havana.

Third-That authority is hereby given to America Lodge, No. 5, to remove its place of meeting from Regla to the Havana.

Fourth—That the dispensations granted by authority of the Grand Sire to Cuban brothers, during the recess of the Sovereign Grand Lodge, to receive the Encampment Degree in the State of Florida, are hereby ratified.

That the Grand Sire be requested to take such steps as may seem best to him for bringing about the introduction of our Order into Spain.

It is and shall be the duty of every member of the Order, on taking up his residence away from the vicinity of his own Lodge, to report himself to the Lodge nearest his residence, or when it is equally near to two or more Lodges, to one thereof, within thirty days after taking up such residence, and in making such report he shall give the name and number and location of his Lodge, and when requested by the Lodge to which he has reported, shall watch with the sick, who fike himself are away from home and their own jurisfletion ; and any such member so failing to report, shall not be entitled to affiliation with the Order, nor to attention from any Lodge. And this legislation shall not be construed to hinder or prevent any Lodge or member' from furnishing watchers, or giving attention to any sick or needy brother.

It is the duty of every Odd Fellow, when he is away from home and out of his own jurisdiction, to give attention and care to his brethren in distress, and watch with the sick when necessary, as well as when he is within his own jurisdiction.

The Grand Lodge of California, and during the *interim* the Grand Master of California, be, and is hereby instructed to direct Templar Lodge, No. —, to cause its committee of investigation in matters of Bro. Robinson to close said investigation and make report and final disposition thereof within ninety days from the adjournment of this Sovereign Grand Lodge; and Bro. Robinson is entitled to counsel before the investigation committee or committees and before the Lodge.

That the appeal of Bro. Milton N. Webber be sustained on the ground of irregularity and illegality in the appointment of the second committee by Harmony Lodge, No. 19, and that the Grand Lodge of Indiana be hereby directed to cause said Harmony Lodge, No. 19, to grant said Webber a new trial on said charges, under procedure as to appointment of committees and otherwise in conformity to law.

That the Grand Encampment of Delaware direct Reynolds Encampment to pay to Bro. Morton benefits from the twenty-second day of December, 1983, until such time as by an investigation, of which he shall have notice, and at which he is to be heard, the Encampment shall determine that he has so far recovered from his difficulty as to be able to resume his usual business or otherwise earn a livelihood.

That the appeal of St. Anastasia Mesuil Lodge, No. 46, vs. Grand Lodge be dismissed, and the action of the Grand Lodge of Indiana be and is hereby approved.

That the appeal of Bro. H. F. Roos from the action of the Grand Lodge of the State of Pennsylvania be, and the same is hereby sustained, and the action of the said Grand Lodge, in adopting the report of the Committee on the State of the Order in said matter, be reversed, and the said cause be, by said Grand Lodge, referred to its said committee with instructions to make a report in strict compliance with the said

law of said Grand Lodge, and for all other and further proper proceedings in said case.

That the appeal of A. J. Smith, and sixteen others, vz. St. Anastasia Mesuil Lodge, No. 46, and the Grand Lodge of Indiana, be sustained, and the Grand Lodge of Indiana be directed to require Canton Wabash to either give said Lodge good and first-class security for the repayment of said sum, when due, and pay the legal rate of interest annually therefor, to said Lodge or repay said sum so borrowed within a reasonable time, as said Lodge may choose.

And that it be the sense of this Grand Body that no Lodge should divert its funds from the uses for which they were paid in, nor loan the same at any time without ample security being given, and a reasonable interest being paid.

That the appeal of Hanover Lodge, No. 327, be sustained, as the law of the Grand Lodge of Pennsylvania was not conformed to, and that the Grand Lodge of Pennsylvania shall direct the Appeals Committee thereof again to consider and pass upon the case of the appeal of Bro. J. M. Stambaugh on the grounds stated in said appeal.

That the questions referred to were properly answered by the Grand Lodge of Minnesota by the adoption of the report of its Committee on Appeals, and that the appeal of Brother James Starkey be dismissed.

The duties imposed on each of the Commissioners were promptly discharged, and Encampments have been instituted at the several places named.

The Fraternal Press.

The number of the journals devoted to the inculcation of the principles of Odd Fellowship is increasing, and no one rejoices thereat more than I do. Many of them

have been sent for the use of the Gran I Sire, and they are perused with much interest; and yet it is sometimes with shame that he finds articles in some of them which breathe anything but a fraternal spirit. As a rule they are conducted properly, and, with two or three exceptions, labor zealously for the inculcation of the true spirit of friendship, and that 'Charity which suffereth long and is kind." A few there are which seem to take pride in abusing and vilifying the Sovereign Grand Lodge for its action or non-action, and in abusing its officers who are endevoring to enforce the laws they have obligated themselves to sustain. One calls a particular law a "foolish" law. Another that a law is of no binding force, and that the Order should not obey it. They seem to forget that one hundred and fifty Representatives, members of the Sovereigh Grand Lodge, men selected from the great body of the Order and from every Grand-Jurisdiction, for their ability, their integrity, their long service in the Order, are apt to be quite as wise, as honest, as faithful to their obligations to legislate for the best interest of the Order, as any one or dozen editors of newspapers, however wise or however intelligent they may be But I repeat, these are the exceptions. The great mass of them are conducted by men of gentlemanly instincts, in a fraternal spirit, and with an earnest desire to promote the welfare of the Order. Some of the articles are, doubtless, thoughtlessly written; others are not. One of the best indications of what is right and what is wrong, is to inquire whether the particular thing said or written will please your friends or rejoice your enemies. Too many of the articles during the last year have been of the latter class.

Your committee endorse the words of wisdom in the Grand Sire's report, pertaining to the "Fraternal Press," and would lay stress upon the fact, as there are some papers in our Order which seem simply to exist for the sake of the financial benefit derived therefrom, and other papers which assign one or more columns to the care of some of our brothers, for the benefit of these respective papers ; yet, in view of the fact that at times there has been too much bickering and too many personalities ; therefore, we respectfully suggest, in view of this, that all these editors and writers be impressed with the fact that they are not writing for the information of the public, but "for the good of the Order." Hence, we request them to think of the great damage done to the fraternity by the undue publicity of this feeling, and sincerely hope that these writers will remember that they are Odd Fellows, whose motto is "Friendship, Love and Truth."

Sovereign Grand Lodge.

Removal of headquarters and location of the Sovereign Grand Lodge, we have carefully considered the same, and report that in their opinion the position taken by the Grand Sire is the correct one, and should be approved and adopted by the Sovereign Grand Lodge. That the office of the Grand Secretary has been removed from the City of Baltimore and located in the City of Columbus, Ohio, and that the said Special Committee, in behalf of the Sovereign Grand Lodge, has received and accepted a sufficient deed and conveyance, securing to the respective parties all of their rights in the premises.

That the acts of said Special Committee be, and the same are hereby fully endorsed, ratified and approved.

The committee beg leave further to report that on the 25th of June last, the Grand Secretary began moving the property of his office, supplies, etc., and on July 1st the offices of the Grand Body were fully transferred to and located in the City of Columbus, Ohio.

The committee beg further to state that the rooms now occupied are complete, with all the furnishings required; are centrally located in the city, and in every way admirably adapted to the uses intended.

The committee have not taken any steps to secure the incorporation of the Grand Lodge under the laws of the State of Ohio. The committee considered the matter, and beg leave to suggest that inasmuch as Lodges and Encampments of our Order are located in every State and Territory of the United States of America, and also in the Provinces of the Dominion of Cawada, and in foreign countries, it might be of advantage to secure an act of incorporation from the Congress of the United States.

Inasmuch as Columbus, Ohio, is now the home and headquarters of the Order, the resolution passed in 1858 (Journal, 8001), poviding that all sessions of the Sovereign Grand Lodge will be held in Baltimore till further ordered, should be repealed. Therefore, the committee offer the following :

The resolution passed in 1858, on the subject, was rescinded, and that hereafter, when not otherwise ordered, the Sovereign Grand Lodge will hold its sessions in the city of Columbus, Ohio.

Miscellaneous.

The invitation to hold the next session of this Sovereign Gravit Lodge in the City of Los Angelos, California, was accepted, with the proviso that in case the Grand Sire and Special Committee of five to be appointed by him to consider the expense thereof, shall find that the mileage and per diem will exceed that of the present session being held in the City of Denver, then and in that yearn the next session of this Body shall be held in the City of Columbas, Ohio.

The Grand Sire is authorized to act for the Sovereign Grand Lodge and to receive for said Sovereign Grand Lodge such sums of money from the committee to be hereafter selected by the jurisdiction of this Order in the State of California, as will be donated for the purpose of defraying any extraordinary expense which may attach by reason of the next meeting of the Sovereign Grand Lodge at Los Angelos, in California.

SPRCLAL NOTICE

"By-laws shall immediately be forwarded in duplicate to the Grand Secretary, "authenticated by the Seal of the Lodge, and the signature of its Noble Grand and "Secretary' one copy to be retained by the Grand Lodge, and the other to be re-"turned to the Lodge, certified as approved or otherwise, as the case may be, and no "such by-laws shall be operative until approved by the Grand Lodge, or in its recease "by its Committee on Laws of Subordinates," __Con. Sub. Lodges, Art. 78.

"Semi-Annual Returns shall be accompanied by the amount due the Grand Lodge, "the same being twenty-five cents for each unsuspended member on said Return."-----Con. Sub. Lodges, Art. 40.

⁵ No Past Grand can, under any circumstances, be admitted to membership in the Grand Lodge without presenting a regular Past Grand's Certificate. A Past Grand cannot be admitted upon a Representative's certificate, nor upon the semi-annual report of his Lodge, nor upon any voucher, except the certificate required by Article 6 of the Constitution of the Grand Lodge.

If a Representative to the Grand Lodge has not been previously admitted to membership as a Past Grand, and received the Grand Lodge Degree, he must present two certificates before he can be admitted to the Grand Lodge, viz : a Past Grand's certificate, as stated in the preceding clause, and also a Representative's certificate, as required by Article 7 of the Constitution of the Grand Lodge, both of which must be signed by the Noble Grand and Secretary, and Be attested by the Seal of the Lodge.

No Past Grand should start for a Session of the Grand Lodge without knowing that the proper certificates have been mailed to the Grand Secretary, or without duplicate certificates in his pocket.

Representatives to the Grand Lodge should be elected at the first regular meeting of the Lodges in July, to serve for one year. Should a vacancy occur by resignation, suspension or decease, the certificate of the Past Grand elected to fill the vacancy, must set forth that fact upon its face.

Blank certificates can be had by Secretaries upon application to the Grand Secretary.
