



FIRST ANNUAL REPORT

OF THE

PROCEEDINGS OF THE GOVERNORS

OF THE

MONTREAL GENERAL MOSPITAL,

AFTER THE RECEPTION OF THE ROYAL CHARTER OF INCORPORATION:

Embracing in substance that of the Committee appointed to superintend the building, also that of the Committee of Management, with some particulars respecting the origin of the Institution.

In laying before the Members of the Corporation, the first Annual Report of the proceedings of the Governors during the twelve months just ended, it may not be improper, for the information of some of them, to state as briefly as possible the circumstances which led to the erection of the Hospital.

From the increase of the population of Montreal, the Hotel Dieu Nunnery was found to be inadequate to the reception of the indigent sick. This inconvenience was still further augmented by the great influx of Emigrants from the United Kingdom, some of them labouring under fevers of a contagious nature, and other diseases, that were not admissible into that Hospital. To remedy this, a subscription was made, in the year 1819, for hiring a house to serve as an Hospital. Though this was only on a small scale, the good which was effected by it was, after one year's trial, so evident, that it was deemed an object highly desirable to erect a building, which might give permanency to the establishment.

To further this design, the Hon. John Richardson, the Hon. William M'Gillivray, and Samuel Gerrard, Esquire, in the month of August, 1820, purchased on credic, (which, by a notarial deed executed by them, was declared to be in trust for this purpose,) a lot of ground in the St. Lawrence Suburbs, as a site for the intended Hospital, well adapted to the purpose, both from its proximity to the town, and the salubrity of its situation.

A plan of the building to be erected, and an estimate of its probable expense, were ordered to be made, and laid before the Directors for their consideration. The plan submitted consisted of a centre building 76 feet by 40, capable of containing 72 pa-

tients, and, on an emergency, 80, and two wings of 70 feet by 30, to cross the centre building, and to project 15 feet on each side of it, each capable of containing nearly a like number of patients.

As funds for the erection of the whole of this building could not, even by the most sanguine, be expected to be procured, it was determined to erect, for the present, the centre building only; the expense of which, exclusive of the furnace for warming it with heated air, cupola, double windows, furniture, and out-buildings, was estimated to be £2,200. A subscription to raise this sum was therefore opened in the month of December of the above-mentioned year. By the exertions of those employed to procure subscriptions, and the liberality of the public, such a sum was subscribed by the end of the month of January, 1821, that the Directors resolved that a Committee, to consist of the Hon. John Richardson, the Rev. John Bethune, Dr. William Robertson, John Molson, David Ross, John Try, and Alexander Skakel, Esquires, should be appointed to make contracts for the execution of the work, and to superintend the building.

Those gentlemen, in consequence, entered upon the discharge of the duty committed to them. They contracted with the several workmen; and had the satisfaction to witness, on the 6th June, the corner-stone laid with masonic ceremonies, and to see the building covered by the end of the year, and fit for the reception

of patients in the month of May following.

During the progress of the work, it was deemed highly expedient to follow the method adopted in the Derbyshire Hospital in England, to warm the building by air heated by a furnace placed in the basement story. Even though no saving should arise from this method, the convenience of supplying the fuel, the cleanliness, the small risk of fire being communicated to the building, were considered a sufficient reason for its adoption, and they will be, it is hoped, an adequate compensation for the money expended in its construction. A cupola was also added, to serve as an ornament to the building, and to give light to an operation room. latter of these objects, from the distribution of the interior, could not be affected. It was found indispensably necessary to erect some out-buildings. Instead of the wooden house which formerly surrounded the ground, it was thought proper to enclose it on two sides with a stone wall, and on the front with an iron railing erected on a foundation of stone.

To give a detailed account of the money expended in completing those works, would extend this Report far beyond its duelength: an abstract only shall therefore be given. It is as follows:

in August last, were labouring under typhus fever. By means of the Hospital, this disorder was prevented from spreading among the inhabitants. The alarm that was excited, about twenty-four years ago, by the arrival of a regiment infected with this disease, must still be in the recollection of many. In supporting the Hospital, therefore, we not only relieve the distresses of suffering humanity; but we use the best means to prevent those distresses from reaching ourselves.

The Legislature granted, on the recommendation of His Excellency the Governor-in-Chief, the sum of £850 towards the support of the Hospital for the year 1823. But to extinguish the debt already contracted, will demand the most strenuous and persevering exertions of the Members of the Corporation and of the friends of the Institution. An appeal must be made to the public; and an appeal to the public of Montreal, in the cause of suffering humanity, it is hoped, will never be made in vain.

Through the favourable representation and the patronage of His Excellency the Earl of Dalhousie, Governor-in-Chief, His Majesty was pleased to grant a Charter of Incorporation, under the Great Seal of the Province. This will give, not only respectability, but

This Charter, among other things, appoints that every one who has contributed to the funds of the Hospital, or who shall contribute, £5 or more, and who shall pay annually £1 or more, shall be a Member of the Corporation, and have a right to vote at the annual election of Governors. Every one who has contributed, or shall contribute, £25 or more, and who shall pay annually £3 or more, shall be a Governor for life. Every one who has contributed, or shall contribute, £10, and less than £25, and who shall pay annually £2 or more, may be elected a There chall be, for the present, of Governors annually elected, thirteen; but as soon as the Governors for life shall be less than thirteen, then a greater number of Governors shall be elected, so that the whole number of Governors, including those for life, resident in Montreal, shall not be less than twenty-six. The votes shall be in the ratio of the sum contributed, that is, one vote for every £5, so that no one have more than ten votes.

The Directors (who by the Charter are called Governors), before the patients were removed from the temporary Hospital, appointed a Committee to draw up Rules and Regulations for the better government of the Members, Officers, Servants, and Patients. These Rules, after being submitted to the Directors, were appointed by them to be the Rules and Regulations for the Hospital. These continued in force until the Charter was obtained, when another Committee was appointed to revise them, and to make such alterations in them as experience might point out, and conformity with the Charter might require. The Rules and Regulations, so revised, were laid before a meeting of the Governors duly convened for that purpose, on the 26th of April last, and, after being approved by them, were established and ordained to be the By-Laws, Regulations and Statutes of the Corporation of the Montreal General Hospital.

In conclusion, it is highly satisfactory to be able to state, both from the Reports of the Committee of Management and from the observations of the Visiting Governors, that the Medical Officers have shown the greatest zeal and assiduity in everything relating to their department; that the wards have at all times been found neat and clean, and every attention given to the comfort of the patients. The Committee of Management has sincerely endeavoured to promote the good of the Institution: how it has succeeded, it is not for the writer of this Report to decide; wherein it has failed in the discharge of the important duties devolved upon it, the candid will no doubt admit, as an excuse, its inexperience, and the difficulty attending the organizing a new institution.

BY-LAWS, REGULATIONS,

STATUTES.

Made, established and ordained by the President, Vice-President and Governors of the Montreal General Hospital, for the better government of the Officers, Members, Patients and Servants of the said Hospital, passed on the twenty-sixth day of April, in the year of our Lord one thousand eight hundred and twenty-three.

REVISED AND AMENDED, 4TH FEBRUARY, 1851.

He it made, established and ordained, by the authority of the President, Vice-President and Governors of the Montreal Gene ral Hospital, that the following By-Laws, Regulations and Statutes be, and they are hereby made, established and ordained to be the By-Laws, Regulations and Statutes of the said Hospital.

CHAPTER I.

Of the Qualifications of Members of the Corporation.

1. Every person who has contributed, or who shall hereafter contribute towards the funds of the Hospital, five pounds, Halifax currency, or more, and shall pay annually, one pound, like currency, or more, towards its support, shall become a member of the Corporation, and shall be entitled to vote at the election of Governors.

2. Every person who has contributed to the erection of the Hospital, or who shall hereafter, contribute to the funds of the Hospital, twenty-five pounds, Halifax currency, or upwards, and shall pay annually towards its support a contribution of three

pounds, like currency, shall be a Governor for life.

3. There shall be thirteen other Governors who shall be annually elected, in manner hereinafter prescribed, from among those persons who have contributed, or who shall hereafter contribute to the Institution, under twenty-five pounds, Halifax currency, and not less than ten pounds like currency, with an annual payment thereto of two pounds, or more, like currency.

4. Whensoever the number of Governors for life, resident at Montreal, shall be under thirteen, then such an addition shall be made to the number, so to be elected Governors, as to make the whole number thereof (those so resident inclusive) twenty-six.

5. No new contributor shall have a right to vote at any election of Governors, unless he shall have paid his contribution or donation at least three months previous to the said election.

CHAPTER II.

Of the Election of Governors.

1. Notice of the hour and place of meeting for the election of Governors, shall be given by the Secretary in one or more of the newspapers published in Montreal, at least seven days previous to such meeting.

2. The votes shall be given in the ratio of the contributions, (that is, one vote for every five pounds contributed, provided that

no person shall, in any case, have more than ten votes.)

3. The annual election of Governors shall be held on the first Tuesday of May, in each and every year, in the Committee Room of the Hospital, at two o'clock, P. M., and continued until three o'clock, P. M., of the same day; at which two Governors for the preceding year shall be appointed to inspect the ballots: and every person voting at said election shall personally and then and there appear, and deliver to the aforesaid Inspectors a ballot containing the names of thirteen persons, or more, as the case may be, as Governors for the ensuing year; and the Inspectors shall deposit in a bag all ballots, so delivered, and shall insert the names of the persons so voting in a poll-list kept by them for the purpose; and when the poll of such election shall be closed, the Inspectors shall open and count the said ballots, and shall openly declare to the meeting the names of the persons who shall be found to have been elected by the majority of the votes and shall deliver a certificate thereof to the Secretary who shall forthwith communicate the same to the persons so elected.

4. The Secretary for the preceding year shall, immediately after the election, give notice in writing to the Governors elected, and to the Governors for life, requiring them to meet on the Tuesday next ensuing, to choose a President, a Vice-President, a Secretary, a Treasurer, a Committee of Management, and Medical

Officers, for the ensuing year.

5. The Governors elected shall declare, either at their first meeting after their election, or by letter addressed to the Secretary, at least one day previous to such meeting, whether or not they are willing to act in their office, otherwise their election shall be void.

6. In case the number of Governors shall at any time, by death, resignation, absence, neglect of duty, or refusal to act in their office be less than thirteen: or in case, by any of those causes,

the whole number of Governors shall be less than twenty-six, the deficiency shall be made up, within thirty days after such vacancy, by the vote of the Governors for the time being, at a meeting to be convened for the purpose.

CHAPTER III.

Of the Governors.

1. A quarterly meeting of the Governors shall be held in the Committee Room of the Hospital, on the first Tuesday in August, on the first Tuesday in November, on the first Tuesday in February, and on the last Tuesday in April, in each and every

year, at two o'clock, P. M.

2. The Governors for life, together with those elected, shall choose by ballot, out of their number, on the second Tuesday in May, in each and every year, one President and one Vice-President: and out of their number or otherwise, one Secretary and one Treasurer; and also out of their number, they shall nominate and appoint by vote, a Committee of Management, consisting of five, of whom three, including their Chairman, shall be a quorum; all of whom shall remain in office one year from the date of their appointment.

3. Every President, Vice-President, Governor, Treasurer and Secretary of the Corporation, shall, as soon as convenient after their election, and before they act in their respective offices, take the oath hereinafter prescribed, to be to them administered by the President or Vice-President for the time being or for the preceding year, for the faithful and due execution of the duties of their respective offices during their continuance in the same.

Form of the Oath.

I do swear, that I will faithfully and duly execute the office of the Corporation of the Montreal General Hospital, during my continuance in the same, according

to the best of my ability, so help me God.

4. The Governors, at their meeting on the second Tuesday in May in each and every year, shall elect, by vote and not by ballot, eight Medical Officers, to be the attending Physicians for the year, which election shall be conducted in the following manner, viz: the President, or in his absence, the Vice-President, shall openly propose the names of eight Medical Officers, whose election shall be decided by the majority of the votes of those present.

5. The President, or in his absence, the Vice-President, shall and may, or at the request of two Governors, summon and call together (by letter, from the Secretary, at the Committee Room of the Hospital, at any time to be appointed by him) the Governors of the Corporation for the time being, giving them at least one day's notice thereof and intimating the purpose of the meeting.

6. Seven or more Governors, convened according to the By-Laws of the Corporation, of whom the President or Vice-President shall be one, shall constitute a legal meeting of said Corporation and shall be competent to transact all business relative to the said Corporation in as far as they are authorized by the Charter.

7. The Governors shall have power, at any quarterly or extraordinary meeting to appoint by ballot or otherwise, such Officer or Officers, and fix their salaries, as they may at any time find necessary for the management of the Hospital.

8. They shall also appoint a Steward, and a Matron or House-keeper, and fix their salaries, who shall respectively remain in office as long as they continue to discharge properly the duties thereof.

9. Two of the Governors shall, in rotation, visit the Hospital at least twice a week, and shall enter their names in a book with such observations relating to the Institution as they shall think necessary.

10. If any Officer, the Steward or the Matron, shall at any time become unfit to perform the duties of his or her office, or shall misdemean himself, or herself, in his or her office, it shall be the duty of any Governor or Officer of the Corporation acquiring a knowledge thereof, to make known the same to the Committee of Management, who shall have power to suspend the Steward or the Matron from the exercise of his or her office, if they think proper, until a meeting of Governors can be obtained, with as little delay as possible; to take cognizance of the charge or charges which may be brought against them, or either of them, and in case of complaint against any Governor or Officer, they shall examine into the case and report thereon to the President, or in his absence, to the Vice-President. And in default of attention thereto, by the Committee of Management, the Governor or Officer aforesaid, shall lay his complaint before the President, or in his absence the Vice-President, who shall cause the Secretary to summon a meeting of Governors, at a time to be appointed by him, and to give notice to the party or parties complained of, with a copy of the charge or complaint, and to the party or parties complaining: and the Governors shall, at such meeting, after hearing both parties, remove by ballot or otherwise, if they find sufficient cause, the person or persons complained of.

CHAPTER IV.

Of the President and Vice-President.

1. The President, or in his absence, the Vice-President, shall preside at all meetings of the Governors of the Corporation.

2. At all meetings of the Governors every person shall, in speaking, stand up and address himself to the President, who shall propose all questions; and if a difference of opinion shall arise on any question, such question shall be fairly stated by the President and shall then be determined by ballot (if two of the Governors require it;) and if in any case the votes be equal, the President shall have the casting vote.

3. The President shall not refuse to propose any question nor shall he dissolve or adjourn any meeting without the consent of a majority of the said meeting until the business thereof be

finished.

CHAPTER V.

Of the Treasurer.

1. The Treasurer shall give such security as may be required by the Governors for the due accounting for, and payment of the moneys which he shall from time to time receive for the use of the Hospital.

2. He shall have the custody of all bonds, title deeds, documents and other papers relating to the property of the Corpora-

tion.

3. He shall also receive all moneys belonging to the Corporation, and pay out the whole or any part thereof, on receipt of a written order from the Committee of Management, but not otherwise.

4. He shall deliver to the Secretary, three days at least previous to the general Annual Meeting held on the first Tuesday of May, in each and every year, a full statement of all his accounts, with the vouchers for the preceding year to be laid before the said meeting.

5. No moneys extorted under the pretext of Charivaris shall

be received.

CHAPTER VI.

Of the Secretary.

1. The Secretary shall attend at all meetings of the Governors, take minutes of the proceedings of each meeting, and transcribe the same into a book.

2. He shall at each meeting of the Governors read the proceedings of the last meeting.

3. Through him all communications, of whatsoever nature, shall be made to the Governors, and by him from the said Governors to the public, or any department of the Hospital.

4. He shall immediately after the election of the Governors or other Officers of the Hospital, give notice thereof in writing to the different persons so elected.

5. He shall furnish to the Governors at their Annual Meeting,

a report of their proceedings during the past year.

7. One day previous to each and every meeting of the Governors, it shall be his duty to send notice of the time and place of such meeting to each Governor, stating the purpose of the meeting.

8. If an extraordinary meeting be appointed to consider of any charge or complaint preferred against any Governor or Officer, or the Steward or the Matron, he shall give notice thereof in writing with a copy of the said charge or complaint to the party or parties complained of, and to the party or parties complaining.

9. He shall, seven days before any election of Governors, hang up a notice in the Committee Room of the Hospital, and shall state therein the names of the persons qualified to be elected, as well as those who are qualified to be the electors.

10. He shall keep the necessary books for entering all the

transactions of the Governors.

11. On the first Tuesday of April, in each and every year, the Secretary shall send the following monitory letter to each and every person, whose subscription shall then be in arrear:

The Secretary shall lay on the table, in the Committee Room, at every meeting of Governors, the journal or minutes of their proceedings, the case book of the Medical Board, if there be one, the book containing the minutes of the visiting Governors, and any other document relating to the affairs of the Corporation which they may require.

CHAPTER VII.

Of the Committee of Management.

1. They shall, at their first meeting after their appointment,

elect, by vote, a Chairman and a Secretary.

2. The Committee of Management shall meet at the Hospital at least once a week, and shall have power, and it shall be their duty to inquire strictly into the domestic economy of the house; to order all things necessary for the same; to inquire into the conduct of the Governors, Officers, Matrons, Stewards and Servants of the Hospital, and report thereon to the President as prescribed by these E_J-laws; to order all repairs; to oversee and control (as far as they have authority for the same by the By-laws,) every thing connected with the management of the Hospital; to audit, inspect, and approve all accounts, and to order payment of the same; and to report through the Secretary of the Corporation, a statement of all their transactions, to each quarterly meeting of the Governors.

3. They shall have the general charge and care of the property of the Corporation and shall enforce all necessary attention to econ-

omy, cleanliness, and good conduct.

4. They shall at their meetings make minutes of their proceedings which they shall forthwith cause their Sccretary to transcribe into a book.

5. They shall have the power and it shall be their duty to engage and discharge all servants of the Hospital, and fix their

wages.

6. The Committee of Management, shall at each quarterly meeting of the Governors, report the state of the Hospital and the state and the number of patients admitted and discharged during the

preceding quarter.

7. They shall insert or cause to be inserted in a book, to be provided for the purpose, all orders to the Steward for the purchase of the stores, and which orders must be signed by the Chairman.

8. They shall lay on the table in the Committee Room, at every meeting of the Governors, the book containing the minutes of their proceedings.

CHAPTER VIII.

Of the Steward.

1. The Steward shall purchase, under the direction of the Committee of Management, fuel, provisions, and all other stores for the use of the Hospital, except Medicines and Medical Stores, and shall be accountable for the same.

2. He shall keep in books, provided for that purpose, an account of all stores brought into the Hospital—and shall not deliver any stores under his charge, unless on a requisition from the Matron,

entered by her in a book provided for the purpose.

3. He shall keep pass books into which shall be entered all articles purchased from those tradesmen with whom the Committee of Management may open accounts; and for all other articles, he shall obtain bills of parcels; all of which he shall lay before the Committee of Management at each of their meetings.

4. He shall keep an account of the moneys due by the pay-

patients, and collect the same.

5. He shall present to the Committee of Management, every three months, or oftener, if required, a statement of his accounts and shall show his books when required.

6. He shall give timely notice, in writing, to the Committee of Management, when any of the stores are nearly expended.

7. He shall immediately on the admission of a patient, take an inventory, in a book to be kept for that purpose, of his or her clothes and other effects—shall order the clothes to be purified, if necessary—and shall be accountable for the safe delivery of the same to the patient on leaving the Hospital, or in case of death, to any person whom the Committee of Management shall authorise to receive the same. Provided, that if the clothes of any patient be in such a state as to render it necessary that they should be burned, it shall be done, if sanctioned by the attending Medical Officer.

8. He shall keep, in a book for the purpose, an account of the servants' time and wages, and pay the same when ordered by the Committee of Management.

9. It shall be his duty to take care that every part of the pre-

mises, without the Hospital, be kept in proper order.

10. He shall keep the keys of the outer doors and gates, and lock them at 10 o'clock, P. M., and open them at 6, A. M., from the first of May to the first of November, and lock them at 8, P. M., and open them at 7, A. M., during the rest of the year; unless ordered otherwise by the Committee of Management, or in case of emergency, for the service of the patients.

11. He shall report, to the Committee of Management, any

misconduct or irregularity that may come under his notice.

12. He shall write the minutes, &c., of the Committee of Man-

agement when required.

- 13. He shall harg up in the Hall of the Hospital, the names of the weekly visiting Governors, and shall on the Saturday preceding their week of attendance, give them notice thereof by letter.
- 14. He shall lay his books of accounts on the table in the Committee Room at all meetings of the Governors.

16. He shall give reasonable security to the Governors for

his fidelity.

17. He shall not absent himself from the Hospital, except on

duty, without the permission of the House Surgeon.

18. When any patient shall wish it, the Steward shall send immediately, in writing, for such Clergyman as the patient may desire.

CHAPTER IX.

Of the Medical Board.

1. The Medical Board of the Montreal General Hospital shall consist of the consulting and attending Physicians and Surgeons.

2. The number of the attending Medical Officers shall be eight, who shall make such arrangements among themselves, that the Hospital be visited once every day at least by two of them.

- 3. No person shall be eligible to the office of attending Physician or Surgeon, who is not a Graduate of a University or College in the British dominions, or a Licentiate or Member of a College of Physicians or Surgeons of Great Britain and Ireland, or other in the British dominions, of at least three years standing, and who is, moreover, not licensed to practice in this Province.
- 4. Any attending Physician or Surgeon may, after having acted in that capacity for *twelve* years, become a consulting Physician or Surgeon of the Institution.

5. The visiting hour for the attending Medical Officers shall be 12 o'clock (noon) of each and every day, Sundays excepted.

6. Should any one of the Medical Officers be unable from illness, or intended absence from town, to fulfil the duties of his office, he shall obtain the assistance of some other of the Physicians or Surgeons for the time being.

7. In all surgical cases requiring operations (except in emergencies where delay might be dangerous) and in medical cases when desired, a consultation of the whole Medical Board of the Hospital shall be summoned.

8. The attending Medical Officers shall have full power, at all times, to visit and examine the Apothecary's shop.

9. It shall be the duty of the Medical Board, to examine all candidates for the situation of House Surgeon and Apothecary.

10. The Medical Board shall communicate to the Governors, in writing, through their Secretary, their opinion of the candidate.

12. The attending Medical Officers shall alone have the power to admit and discharge any patient; except in cases of severe injuries, where the House Surgeon shall admit at any hour of the day or night, without recommendatory letters.

13. The Medical Board shall regulate the diet of the patients.

14. The attending Medical Officers shall have the power to name and appoint their own Dressers and Clerks from among the Students.

15. That for the purposes of Pathological investigation, the attending Medical Officers of the Hospital shall have the power of examining, post mortem, the bodies of patients deceased within it, at their discretion; and such examination shall only be made in the presence or by the order of the same.

CHAPTER X.

Of the House Surgeon.

1. No person shall be eligible as House Surgeon, unless he be a Graduate or Licentiate of some University or College in the British dominions, and a Licentiate of this Province; and further, unless he submit to the Governors, satisfactory testimonials of his moral character, and of his having been approved of by the Medical Board and having attained the age of 21 years.

2. The House Surgeon shall visit all the occupied wards in the Hospital at least once every morning and evening and oftener when required so .o do by the attending Medical Officer; he shall also be prepared to report to the attending Medical Officers, the state of the patients since the last visit.

3. In any case of an urgent nature, the House Surgeon shall immediately summon the attending Medical Officer, and if he cannot be found, he shall call upon the nearest Member of the Medical Board.

4. He shall not absent himself from the Hospital during the visits of the attending Medical Officers, and when at any time he goes out, he must leave word where he is to be found during his absence.

5. He must always be in the Hospital at a seasonable hour in the evening, and never sleep out of the building, unless with the permission of one of the attending Physicians.

6. He shall have charge of all the surgical instruments belonging to the Hospital, and shall be responsible for the same; he shall also superintend the making up of all tinetures, pills, preparations, &c., &c., required to be kept on hands, and shall make

up all prescriptions ordered for patients in his own particular

wards.

7. He shall insert in the case book under his charge, an account of all operations performed in the Hospital, and by whom performed. He shall be responsible for the affixing of the names, and other particulars of all the patients at their bed's head, and he shall enter in the register of patients the name, sex, age, religion, country, place of residence, disease, and time of admission of every patient received into the Hospital; also the name of the person by whom the patient has been recommended, whether a pauper or a pay-patient, and the rate per week; and the time and the manner in which every patient leaves the Hospital.

8. It shall be his duty to notify the Members of the Medical

Board whenever a consultation is required.

9. He shall draw up a quarterly report of the state and number of patients admitted and discharged previously to the meetings of the Governors, and the Committee of Management.

10. It shall be his study to certify the regular attendance of

each student of the Hospital.

11. He shall notify the Steward of the dismissal of all patients.

12. In all cases when it becomes necessary to notify the Coroner of the sudden death of any individual within the precincts of the Hospital, it shall be the duty of the House Surgeon to give such notice, and on the holding of the inquest, he shall be the Medical Officer referred to for information by that functionary, and the Jury summoned by him, and shall be entitled to the fees paid by the Coroner in such cases.

CHAPTER XI.

Of the Apothecary.

1. No person shall be eligible as Apothecary, until he shall have laid before the Governors satisfactory proofs of moral character, and of his having been examined and approved of by the Medical Board.

2. He shall compound, and make up, under the superintendence of the House Surgeon, all the Medicines required to be kept on hand; he shall take charge of such wards as are assigned to

him by the attending Medical Officer.

3. He shall visit these at least once every morning and evening, and oftener, when required so to do by the attending Medical Officer; and in the event of his observing any great or sudden change in any of the patients in his ward, he shall immediately notify the House Surgeon to that effect.

5. He shall deliver to the nurses of his wards, the different Medicines, &c., ordered for the patients of each, the directions for which shall be legibly written or printed, and affixed upon each phial, box or parcel.

CHAPTER XII.

Of the Students attending the Hospital.

1. No student who has not previously taken a ticket for attendance in the Hospital, shall on any pretence whatever, be allowed to witness any operation or dissection or to attend the Clinical Lectures.

3. Students following the attending Medical Officers during the visits, are to behave with decency and propriety, keeping their hats off at all times, and they must avoid doing any thing that may tend to disturb physicians, clerks or patients.

4. Every Student must keep off his hat, while he is in the operating Theatre, both that he may not obstruct the view of others, and as a mark of respect, and all noise and changing of seats must be avoided, as unpleasant to the operator, and hurtful to the patient.

5. Students when visiting the wards are on no account to offer any advice, or express any opinions unless when requested so to do by the attending Medical Officer.

6. No Student shall enter the wards at any time, except the visiting hour, unless by permission of the attending Medical Officer.

7. Any Student infringing any of the above regulations shall forfeit the benefit of his ticket and the privilege of attending the Hospital.

CHAPTER XIII.

Of the Matron.

1. The Matron shall visit the wards of the Hospital every morning at eight, every afternoon at one, and every evening at eight o'clock, and oftener if necessary; at these visits she shall see that the wards are properly attended by the Nurses, and that all the patients are in their respective wards, and report to

the House Surgeon the names of such patients as are absent

without leave from their respective wards.

2. She shall oversee the conduct of the patients and servants and take care that the wards, apartments, beds, clothes, linen, &c., are kept clean and in good order.

3. She shall have charge of all the furniture, beds, bedding, and dresses belonging to the Hospital, as far as regards her

department.

4. She shall report any misconduct of the patients or servants or any other irregularity occurring in the house, to the attending Physician or Surgeon; or in his absence to the House Surgeon, and to the Committee of Management.

5. She shall prevent anything being taken into the wards

except that which is ordered.

6. She shall not admit any person or persons to see any patient or patients, except at the hours appointed by the Medical Board

of the Hospital.

7. She shall superintend the preparing of the diet of the patients and be particular that the same diet, in the quantity, and at the time prescribed, be given and nothing else; she shall also keep a diet list, with the number of patients on each dict.

8. She shall not absent herself from the Hospital without the

leave of the House Surgeon.

CHAPTER XIV.

Of the Nurses.

1. When a patient is admitted into the Hospital, the Nurse of the ward, to which such patient may be ordered, shall immediately wash his or her face and hands, neck and arms, feet and legs, with tepid water; she shall give him or her (if he or she have none) an Hospital shirt and night cap, and shall deliver without delay, his or her clothes, after an inventory of them has been taken, to the person ordered by the Steward to receive them.

2. The Nurse shall, at the next visit, state to the attending Physician or Surgeon such circumstance or circumstances as may tend to throw light on the case, and shall be ready to do

the same if required, at each succeeding visit.

3. In the event of any patient being seized with violent or alarming symptoms she shall give immediate notice thereof to the House Surgeon or Apothecary.

4. The Nurses when ordered by the Matron, shall change

5. She shall receive no medicines sent from the Apothecary's shop to the wards unless labelled and directed.

6. When a death occurs, the Nurse of the ward shall imme-

diately give information to the Steward.

7. They shall clean their respective wards, &c., at 8, A. M., from the first of May to the first of November, and at 9, A. M., the remainder of the year.

8. The Nurses shall be diligent in complying with the orders of the Medical Officers, Surgeon and Matron, and they shall behave

with tenderness to the patients.

9. They shall pay particular attention to the patients, and as often as necessary supply them with the drink prescribed, and assist them when they are unable to assist themselves, and when they are able shall place the vessel or vessels containing their drink, commodiously within their reach, and take care that they never remain empty.

10. They shall see that the patients take their medicines as

prescribed.

11. They shall never, on any account, allow any thing to be brought into the wards, or given to the patients, except that which is ordered.

12. They shall give immediate notice to the attending Physician or Surgeon, or in his absence to the House Surgeon, or to the Matron, when any patient or patients shall have violated any of the By-laws of the Hospital.

13. They shall always keep themselves clean and decently

clothed.

CHAPTER XV.

Of the Admission of Patients.

1. Every Governor and Medical Officer of the Hospital, and the Clergymen belonging to the congregations of this city, may recommend patients to be admitted into the Hospital, in the manner and form hereinafter prescribed; but it shall be the exclusive prerogative of the attending Physician or Surgeon, as the case may be, to judge if the person so recommended be labouring under such disease as is admissible into the Hospital, according to the By-laws of the Corporation.

2. In any urgent case, when delay may be dangerous, the House Physician or Surgeon shall have power to admit patients, and he shall immediately give information of the same to the attending Physician or Surgeon, as the case may be, or if he cannot be found, to any other of the Medical Board of the Hos-

pital.

3. No patient shall be admitted into the Hospital whose case shall be considered incurable, or who is insane, nor whose case does not require the particular benefit of in-door practice.

4. No woman in advanced pregnancy, shall be admitted as an

in-door patient.

5. No children under six years of age, except in cases where the greater operations are to be performed, shall be admitted into

the Hospital.

6. Such patients as are unable to pay for their maintenance shall be received as paupers, such as are able to pay, shall be admitted into the Hospital as pay-patients and none of these at less than five shillings per week, for the payment of which the person recommending such patient shall be responsible.

7. The person recommending any patient or patients shall mention, in the certificate for admission, if the patient or patients be paupers, and if not, the sum they are to pay per week.

- 8. No patient shall be admitted into the Hospital as a pauper, excepting emigrants from the United Kingdom of Great Britain and Ireland, or other indigent persons passing through the town, who do not reside in the city or parish of Montreal, and the person or persons who shall recommend any patient or patients, who do not reside in the city or parish aforesaid, shall become responsible for the payment of the Hospital dues for such patient or patients, which shall not be less than seven shillings per week; and in case of his or her death, he shall also be bound to defray the expenses of the funeral, which shall not exceed twenty-two shillings and sixpence; but as special cases may occur when a deviation from this By-law may be necessary, the Committee of Management are authorized to dispense with it in such cases, and shall report the same to the Governors at their next meeting. Seamen presenting themselves for admission with a recommendation from the Commanding Officer, shall be admitted, so long as the Statute William IV., especially Section 2, Chapter 35, shall remain in force.
- 9. A male and a female ward shall be devoted to lock-ward cases. Patients shall not be admitted into the lock-wards as paupers, but each and every lock-ward patient shall pay seven shillings per week; and if it be not specified on the ticket of admission that he or she be a lock-ward patient, then the attending Medical Officer shall send back such patients to the person recommending, with the words "Lock-ward" written on the ticket; and if the person recommending shall renew his recommendation, he shall then be responsible for the payment of the Hospital dues for such patient. No Lock-ward patient shall be admitted into the common wards.

10. Two beds (one in the men's and one in the women's wards) shall be kept in reserve to receive such patients as may, from sudden accident, be in need of immediate relief.

CHAPTER XVI.

Of the Patients.

1. No patient shall smoke in the house or on the galleries, make use of obscene or profane language, nor leave the ward in which he or she shall have been placed, without permission from the attending Physician or House Surgeon, or unless required by him to give assistance.

2. The patients shall not play at cards or dice; or any other

3. They shall conduct themselves with due respect to the Ma-

tron, Nurses and Servants of the Hospital. 4. No male patient, under any pretence whatsoever, shall enter the apartments or wards for females, unless required by the Physician to give assistance, nor shall a female patient enter the apartments or wards for males.

5. No patients shall allow their friends to bring to them nor shall they use, any thing whatsoever, except the diet prescribed, without permission from the attending Physician or Surgeon.

6. Every patient shall retire to bed at nine, P. M., from the first of May to the first of November; at eight, P. M., from the first of November to the first of May; and those who are able shall rise at seven, A. M., during summer, and at eight, A. M., during winter.

7. Such patients as shall be considered able, shall assist the Nurses and other servants of the Hospital in nursing the patients, making the beds, cleaning the wards, and doing such other work as the attending Physician or Surgeon may direct. Any patient or patients not conforming to the By-laws of the Corporation, shall incur the penalty of expulsion.

8. When any patient is discharged from the Hospital for irregular conduct, the Steward shall give notice thereof by letter, in the form and manner following, to the person who shall have recommended such patient:

9. The body of any patient dying in the Hospital, shall not be removed for interment until twenty-four hours in summer, and thirty-six in winter, shall have elapsed after the death of the patient, without a written permission from either the attending Medical Officer or House Surgeon.

CHAPTER XVII.

Of the Out-Patients.

1. They shall attend in the place at the hour appointed by the Medical Board, for giving advice and medicines to the poor, gratis; and if any of them neglect to attend twice in succession, without leave from the attending Physician or Surgeon, he or she shall not be entitled to any further advice or medicine.

3. Medicines and advice will be given to the poor, at every visit of the attending Physician or Surgeon. All out-patients shall

provide their own phials.

4. No out-patient shall loiter about the Hospital gate, or premises adjoining; they shall come directly to the place appointed to receive them, and as soon as they have received the advice and medicines, which may be considered necessary for them, they shall immediately leave the Hospital.

5. Any out-patient or patients who shall violate any of the rules or regulations of the Hospital, shall incur the penalty of

dismissal.

CHAPTER XVIII.

Of Vaccination.

1. On any of the days appointed by the Medical Board for inoculating the poor, gratis, any person or persons, without the recommendation required for the admission of patients to the Hos-

pital, may present their children for inoculation.

2. The person or persons who shall inoculate any children or other persons, on any of the above stated days, shall register in a book belonging to the Hospital, kept for that purpose, the name, age, sex, and religion of each and every individual so inoculated, the part of the body on which the inoculation has been performed, the date, progress and termination of each and every case.

3. Each and every person bringing a child or children for vaccination, shall deposit two shillings and sixpence as a pledge of returning once at least with the child or children on a day fixed by the inoculator, that the appearance may be noted; non-compliance with this rule will incur the forfeiture of the deposit, but

upon due compliance with it, it will be returned.

CHAPTER XIX.

Of the Penalty of Receiving any Fee or Reward.

1. No Governor, Officer, or other person connected with the Montreal General Hospital, shall at any time presume, under any pretence whatever, on pain of expulsion, to give to, or take from any tradesman, patient, servant, or any other person, or persons, any fee, reward or gratuity of whatever kind, directly or indirectly,

for any services done, or to be done, or proposed to be done on account of, or relative to the said Hospital, except in the case of Physicians to the Institution, who, for the accommodation of their private patients, may bring them into the pay-wards of the Reid's Wing, when it does not interfere with the objects of the Institution.

CHAPTER XX.

When a pauper dies in the Hospital, (if the body be interred,) the Steward shall give notice thereof to the Clergyman to whose congregation or church he or she may belong; and the Porter shall, if necessary, assist the Sexton at the interment. Emigrant paupers of less than twelve months' residence in the country, who die in the Hospital, shall have their funerals defrayed from the money received from the Emigrant funds. With regard to other paupers, the Committee of Management are authorized to request the different religious communities to which they may have belonged, to provide for the funerals of such, unless the bodies are otherwise disposed of by law.

If any vacancy, either Medical or otherwise, occur at any time in the Hospital, said vacancy shall be filled up at the ensuing quar-

terly meeting of the Governors.

CHAPTER XXI.

Of Altering, Repealing and Making Regulations and Statutes.

damnum, or other writs, inquisitions, or precepts, has been, upon this occasion, had, made, issued or prosecuted, any statute, act, ordinance or provision, or other matter and thing, to the contrary thereof notwithstanding: provided further, and Our will and pleasure is, that the said Society and Corporation of the Montreal General Hospital is hereby constituted, made, erected and created with the express reservation and condition that our Letters Patent relating thereto may be hereafter altered and amended in such manner and form, and with such additions, diminutions, extensions and explanations as our Governor, Lieutenant Governor, or Person administering the Government of our Province of Lower Canada, by and with the advice and consent of our Executive Council of our said Province, shall judge best for the general good of the said Corporation, and for the more effectually promoting the charitable and beneficial designs of the said Society, according to the true intent and meaning of the contributors thereto.

May be altered and amended, as the Governor, &c.,

with the advice of the Executive Council, shall judge for the good of the Society.

In testimony whereof, We have caused these our Letters to be made Patent, and the Great Seal of our Province to be hereunto affixed, and the same to be entered of record in our Secretary's Office for our said Province of Lower Canada, in one of the books of Patents there remaining.

WITNESS our Right Trusty and Well Beloved Cousin, George, Earl of Dalhousie, our Captain-General and Governor-in-Chief in and over our said Province of Lower Canada, at our Castle of St. Lewis, in our City of Quebec, by and with the advice and consent of our Executive Council for our said Province of Lower Canada, the thirtieth day of January, in the year of Our Lord one thousand eight hundred and twenty-three, and of our Reign the Fourth.
