TO THE MEMBERS OF THE GRAND DIVISION OF THE SONS OF TEMPERANCE OF CANADA WEST:

BROTHERS—It is my happiness to greet you on the present occasion with congratulations on the success which has attended the labors of the past term of six months. We meet under our glorious banner of Temperance, blazoning the watchword "Victory," and cheering us onward to conquest still more extensive in the future.

OUR PRINCIPLES

It ng the initiaision for the British North American Colonies, or more properly the British North American Order of Sons of Temperance (embracing the Grand Divisions now existing in all the British North American Provinces and those to be established), to be affiliated to other National Divisions, and receiving passwords from the same source. Many are of the opinion that the privileges of Lady Visitors should be further extended. The influence of the fair sex upon our Divisions continues to be most happy and beneficial—"salubrious" says one gallant Deputy! Since our annual gathering twenty-six new Divisions have sprung into existence, and fourteen have been resuscitated. The prospect brightens as we advance. This prosperity is the result of using the means within our reach, viz., public meetings, personal application, zealous agitation, self-denial, prayer. To give stability to this improved state of things there must be

PUNCTUAL AND REGULAR ATTENDANCE

At the Division Room, diligently attending to business, training for future usefulness, cheering each other on in the work, while we renew our vows of constancy. Tardiness and neglect here, exert a blighting, withering influence, militating against both numerical and financial prosperity. A Division can't go down while seven earnest Teetotalers stand by the Charter, and "try" to make the meetings interesting. Divisions visiting each other are sure to prosper. One deputy says, at such a gathering eleven Subordinate Divisions were represented.

DUTY TO THE YOUNG.

That the youth of our Province are exposed to the drinking customs and traffic in intoxicating drinks, is admitted on all hands; and our Order has not been indifferent to the danger, for we have opened the Division Room for candidates at the early age of 14. But it appears necessary that we give more attention than formerly to the children, those of "tender years," say from 7 to 14. It is exceedingly painful to meet with boys of these ages in our prisons and reformatories, after having begged on the streets of our towns and cities, schooled in every vicious habit, and ripe for destruction before arriving at their majority. The "Cadet" system does not appear to meet the case fully. It may be better to introduce the "Band of Hope" On this whole matter, I recommend the appointment of a Special Committee of Representatives who have filled the office of Worthy Patron, whose experience in that position will be invaluable.

PARLIAMENTARY MATTERS.

Owing to the political changes which have suddenly and unexpectedly taken place, our measures are staved off till Parliament meets again; consequently it becomes necessary that you take action at the present Session to renew the petitions for our Act of Incorporation, the Prohibition of the Traffic in Intoxicating Liquors as beverages, and the establishment of an Asylum for Inebriates; and I recommend the appointment of a Committee to draft the same. It affords me great satisfaction to bear testimony to the promptness, diligence, and efficiency with which your Parliamentary agent, Abishai Morse, Esq., P.G.W.P., discharged the duties devolved upon him in that capacity, and I have much pleasure in suggesting that he be requested to continue his valuable services during the next Session of the "House."

FINANCE.

A proper financial basis is of great importance to every Division. Many of our Subordinate Divisions are poor, just paying current expenses, without any surplus for the circulation of temperance literature or paying lecturers. As a consequence, if a few of the members neglect to pay the quarterly dues, the Division is at once embarrassed, and this is frequently followed by a "breaking down." There should not be stinginess towards Teetotalism, while paying liberally for nearly everything else. As we prize all things just in proportion to the expense and labor of obtaining them, a low value must be placed on Temperance by some who advocate a cheap system. The fees and dues should average twenty-five per cent over and above the probable expenditure, and thus be prepared for any emergency. Surely a liberal spirit should ever characterize the whole membership of the Order. It is desirable that the Grand Division should fix the minimum rate of initiation fees and quarterly dues, as a guide to Subordinate Divisions throughout the jurisdiction.

Well done, faithful Deputies; but what shall be said for those who overlook their duty in this respect? Perhaps it will be sufficient to remark that this dereliction of duty greatly embarrasses the Grand Worthy Patriarch by withholding the information necessary for ascertaining the true condition of our cause. "A word to the wise is sufficient." I have also to thank the Provincial Deputies who have sent reports, for their zealous efforts in the "cause of all mankind." In accordance with G.D. By-Laws, Art. III., Sec. 1, it is recommended that there shall be a Deputy Grand Worthy Patriarch for each Subordinate Division, to be styled Division Deputy, and a County Deputy for each of the Counties. The County Deputies to organize the Subordinate Divisions within their respective districts into Unions, to be convened together quarterly at such point as shall be most suitable for counsel—such quarterly conventions to be held on the second Tuesday in the months of January, April, July, and October of each year. To the quarterly convention let each Division Deputy bring or send a quarterly Report of his Division, from which Reports the County Deputy shall make up a general Report, a copy of which shall be sent to the Grand Worthy Patriarch.

VISITS TO SUBORDINATE DIVISIONS.

Although on my lecturing tour I have not been able to visit officially many of the localities of our Divisions, nevertheless I have had opportunity of intercourse with 80 Divisions, whose members and Lady Visitors evinced a deep interest in my visit, and contributed largely to the success of my meetings. They have my hearty thanks.

TEMPERANCE PERIODICALS AND TRACTS.

I am pleased to find that many of our members subscribe for a Temperance paper, but there ought to be one in every family where there is a teetotaler. Our tracts have done great good, and much praise is due to those Subordinate Divisions liberally purchasing and freely circulating them. Temperance literature should be scattered broadcast over the land, co-extensive with the evil we seek to eradicate. The thanks of the Grand Division are due to the Tract Committee for their diligence.

CHURCH ACTION.

It has been thought advisable to present a memorial to the various ecclesiastical bodies, a copy of which will be found annexed. The action thereon of the "Conferences," "Synods," &c., &c., thus far, is of an encouraging character, and shows that our cause has the sympathy of a large body of influential Ministers of the Gospel. It will be our duty and privilege to deserve their cordial co-operation with us in the spread of sound Temperance principles.

PUBLIC MEETINGS

Should be held in the vicinity of every Division, monthly, if possible, for the advocacy of Total Abstinence principles, and explaining the working of our organization. These meetings can be made interesting, with good singing and home talentcalling out the intelligent young men of our country and bringing them forward to share the responsibilities which their fathers have borne for many years. And let it be the invarible rule, to offer the Pledge for signature at the close of the meeting, at the same time inviting "propositions" from both ladies and gentlemen.

MEETING OF NATIONAL DIVISION.

The following amendments to Constitutions were adopted at the Session of National Division, held at Halifax, N.S., in the present month:-

Part X.—To contain several additional items of Statistics.

Article IV .- A new Section added, granting power to elect the Lady Officers—the Lady Visitors to ballot for them.

Chapter VI., 2.—Add at the end "except that the Division may by vote move that he may be re-obligated," (but no fine, reprimand or suspension.)

In consequence of our noble Order attaining its majority on the 29th September next, it was unanimously resolved to celebrate that important epoch in our history in as public a manner as possible: it is therefore recommended, that every Subordinate Division have a Public Anniversary Celebration to commemorate the auspicious event.

tion me the of National Division, which is to be held at Cleveland, Ohio, on the third Thursday of June, 1864. The National Division met, by permission of Government, in the House of Assembly; its debates were conducted with the utmost courtesy and harmony. Twenty jurisdictions were represented by seventy-seven members. The "Sons" of Halifax have done their duty admirably, so as to call forth the highest encomiums from all parties. By the kind permission of His Excellency Earl MULGRAVE, the National Division presented an Address to him, to which he replied in a very happy manner. We were also allowed to visit the Citadel, and the Flag-Ship and Corvette of Admiral Milne, K.C.B. Indeed no pains were spared by our Nova Scotia Brothers to make us all feel we were heartily welcome—to their city, their homes, their hearts. En route to Halifax, I made it my business to visit the "Washingtonian Home" at Boston, Massachusetts, where I had the fullest evidence of the safe and successful working of the plan there adopted for the reformation of drunkards. The noble-hearted Superintendent, Albert Day, Esq., showed me every kindness and attention; entering into the minutest details of operation, and explaining, in his own most happy manner, how the law of kindness is the mighty lever to raise up fallen humanity from the degradation to which strong drink reduces its victims. From the lips of the reformed and the reforming, I heard words of humble confession, deep contrition, fixed determination, and high resolve. We have only to persevere in our efforts in this direction, to give to Canada an Institution which will restore hundreds of inebriates to sobriety, and gladden hearts and homes where now is desolation and sorrow.

DISCIPLINE.

It is painful to me to have to state that it was found necessary to suspend Grove Division, No. 327, for insubordination; not, however, without some faint hope of restoration to obedience and harmony. The Report of the Special Committee on the case, and subsequent action of the Executive, are herewith submitted for your approval. My decisions in all other matters have been cheerfully acquiesced in. It is to be lamented, that in some localities, certain amusements of a questionable character have been encouraged in such close connection with Divisions, as to give offence to Ministers and members of Christian churches, and causing a withdrawal of their influence. Let this be guarded against in the future.

REVIVAL EFFORTS FOR THE GOOD OF THE ORDER.

The following recommendations from the Deputies are submitted for your consideration:—

The employment of Lecturers. Admission of ladies to full membership. The subject of having a National Division for the British North American Provinces. Publication of a periodical, to be the organ of the Order. Holding public temperance meetings, regularly and frequently. It is suggested to harmonize Grand Division By-Law, Article V., 10, 22, with Rule II., 1, and XVIII.; Article III., 1; Chapter III., 1, 2; as follows, in Section 10, after the word "shall" in 7th line, there be added to complete the Section—be expelled the Order—and that Section 22 be struck out altogether.

Shall we not ask ourselves the question, What can be done to revive the Temperance cause? Are we doing our duty? Are we doing all we can? Our enemies are ever on the alert—the liquor-seller is wide awake—the manufacturer tries his art, and keeps the market well supplied—the enemy of God and man goeth about, "to and fro in the earth," tempting, ensnaring and destroying. O brothers! and ye fair ones, our Lady Visitors! let us arise, and each one resolve to go forth with renewed zeal to save the fallen, and to prevent the spread of the desolating scourge of Intemperance.

It is with great pleasure I acknowledge the uniform kindness, promptitude and fidelity of our excellent Grand Scribe, in all matters belonging to his office.

For the last quarter ending March, 1863, I find that 191 Subordinate Divisions have made returns, showing a membership of 7,092, and 4,012 Lady Visitors in those 191 Divisions. There are at the present time 281 Divisions on the list in active operation, and it is deeply to be regretted that nearly one-third have failed to make returns for the last quarter. Had all reported at this Session, we could have exhibited a noble army of at least 10,000 Sons of Temperance in Canada West, and 6,000 Lady Visitors.

The several Memorials to the Legislature ordered by this Grand Division at its Annual Session were prepared in triplicate, and through our beloved Brother Abishai Morse, P.G.W.P., were entrusted to the care of the following honorable gentlemen:— Hon. John A. Macdonald, the Memorial for an Inebriate Asylum; Hon. Oliver Mowat, the Memorial for an Act of Incorporation for the Grand Division and its Subordinate Divisions; Hon. Wm. McDougall, the Memorial for a Prohibitory Liquor Law. In regard to the Memorials I regret that nothing of importance has been accomplished.

Your valued Parliamentary Agent, Brother Morse, P.G.W.P., whilst at Quebec did good service, and lost no opportunity of seeing and conversing with a number of members of both Houses, and particularly the honorable members of the Executive Council, and arrived at the conclusion that the Grand Division will have an Act of Incorporation passed next Session as desired.

The project of an Inebriate Asylum receives general approval, and almost every member wishes it well, and seems to feel the necessity of some measure of the kind.

The Prohibitory Liquor Law has many warm friends in the House, and I trust after this election they will be largely increased.

Due notice of application for our Incorporation was given in the "Canada Gazette" and other papers, and in consequence of nothing being done at the late Session of Parliament, it is necessary that notice be given anew. This has been already attended to, so as to be prepared for next Session, which will probably meet in August.

Memorials have been forwarded to the several religious bodies in the Province, setting forth that intemperance is the parent of nearly all the evils that afflict the country; the objects aimed at by our noble organization; and respectfully soliciting each reverend body "to aid us by their powerful influence and by such deliverances as will cheer our hearts in the work we have in hand, and strengthen us to renewed diligence and zeal."

In accordance with the instructions of this Grand Division, the Proceedings of the Annual Session were prepared and printed with neatness and despatch, and forwarded as usual to the Order, and a copy to each member of the Provincial Parliament. I also got ready the necessary copy for a new edition of the Constitutions of the Order as revised by the National Division, the Code of Laws, and the By-Laws of this Grand Division. This work will be found comprehensive, got up well and in a convenient form, and can be supplied to the Order at \$1,50 per dozen copies or 13 cents each. To distinguish this work from other books of Constitutions, it might be entitled "the book of Constitutions and Grand Division By-Laws." To keep the supply equal to the demand, a large edition of new Constitutions, Code of Laws, and By-Laws for Subordinate Divisions,

I have also procured a few bonds in blank, suitable for the Grand Scribe's and Grand Treasurer's securities, thus obviating difficulties in their preparation heretofore experienced when those Officers' bonds were demanded in accordance with the Rules of the Grand Division.

Full sets of the Journals of the National and Grand Divisions are secured for reference, and have been properly bound as permanent documents for the use of this Grand Division.

It is particularly gratifying to me to report that the Sons of Temperance of Canada West responded nobly to the solicitation for assistance of the distressed British operatives. No less a sum than six hundred and ninety-three dollars and forty-five cents (\$693,45) was subscribed by the Divisions, and forwarded as desired by this Grand Division to Sir Walter C. Trevelyan, Bart., President of the United Kingdom Alliance, who has kindly acknowledged the same. Also letters of thanks from Harper Twelvetrees, Esq., Treasurer of the National Temperance Relief Committee; Charles Ashley, Esq., Grand Scribe of Manchester G.D. S. of T., and J. Vincent, Honorary Secretary, have been received, and will be laid before you, with papers and pamphlets containing information of the distress in Lancashire amongst the Abstainers, Sons of Temperance, &c.

Whilst deploring the sad condition of our suffering Brothers and tendering to them our sympathy, might we not still solicit further aid from Divisions willing to contribute towards their relief? Since the last remittance acknowledged, I have received \$1,28 from the Zimmerman Division, No. 50, S. of T., for distressed operatives.

During the past winter the Divisions have been active in holding public Temperance meetings and disseminating our blessed principles. Several influential County Conventions have been formed to further the interests of Temperance and Prohibition.

A Bill to amend the License Law in Lower Canada has been introduced by Mr. Dunkin, M.P.P., and with some amendments and alterations it is expected may be extended to Canada West. A copy of said Bill is herewith presented.

The Special Committee appointed in the matter of dispute in Milgrove Division diligently attended to that duty, and presented as the result of their arduous labors a concise report to the Executive. Subsequent events transpired in that unhappy Division, rendering it necessary for the Grand Worthy Patriarch to close the Division.

I beg to submit the following appeals, communications, and petitions for your consideration:—Communication from Sir Walter C. Trevelyan, Bart.; communication from Harper Twelvetrees, Esq.; communication from Charles Ashley, Esq., G.S.; communication from J. Vincent, Esq., Hon. Sec.; communication from P. Monaghan, Esq., G.S.; communication from C. M. Johnson, G.S.; petition from Athlone Division, No. 248, S. of T., for a set of Emblems and Ritual, &c., theirs being destroyed by fire; appeal from Brother G. Milne against the decision of the Brougham Division, No. 104, S. of T., in a case of alleged violation of the pledge.

The Committee appointed to procure Temperance Tracts for distribution, after considerable inquiry of prices of work, decided to procure 12 reams of tracts printed at the Guardian Office, Toronto, for \$116, which could be then supplied to Subordinate Divisions for \$1,25 per 1000 tracts. The Committee forwarded to me three large cases of tracts. About one half have been disposed of at that remarkably low price, and there are remaining on hand 44,500 tracts, for which orders are urgently solicited. The thanks of this Grand Division are due to Brother W. H. ORR for his valuable assistance in this important department of our work—the dissemination of sound temperance literature.

The large number of letters and correspondence received during the recess have been promptly answered and attended to, and I have to express my deep obligation to the Grand Worthy Patriarch, and to the Officers of this Grand Division and Subordinate Divisions, for their valuable, cheerful, and efficient aid in the discharge of the manifold duties of my office.

Hoping, brethren, that our present meeting and deliberations will contribute greatly to the best interests of our noble organization and the Temperance Reformation,

TO THE GRAND DIVISION OF SONS OF TEMPERANCE OF CANADA WEST:

We, your Committee to whom was referred the Report of the Grand Scribe, report as follows:

1. Your Committee congratulate the Grand Division upon the comprehensive summary of the present and prospective position of the Order, as contained in the first part of the Report; containing, as it does, sentiments flattering to the Institution, and a stimulus for renewed action for the Grand as well as Subordinate Divisions.

2. Your Committee cannot pass over the second part of the Report without noticing the number of new and resuscitated Divisions during the past six months, in which our excellent Grand Worthy Patriarch has taken the most active part—evincing that by direct, heartfelt sympathy and perseverance, much may be accomplished. At the same time, the large number of Divisions in arrears for one or more years, your Committee deeply deplore, and would recommend that D.G.W.P.'s faithfully carry out their duties, and refuse installation to the Officers of any Division until the dues of the Grand Division be appropriated and paid.

3. Your Committee regret the failure of the organization of Cadets of Temperance to accomplish the end designed; and would recommend the Representatives of the Grand Division in their respective spheres of labor to solicit every agency—Sabbath or Common School Teachers and Subordinate Divisions—to put into active operation Bands of Hope or other organizations to instil our principles in the minds of our youth.

4. Your Committee very cordially approve and appreciate the action of our Parliamentary Agent, P.G.W.P. Abishai Morse, Esq., and the action taken by Officers pursuant to resolution of this Grand Division, to obtain an Act of Incorporation; and would recommend renewed action

at the next Parliament to obtain an Inebriate Asylum and a Prohibitory

Liquor Law.

5. The Bill introduced by Mr. Dunkin for Lower Canada your Committee have carefully examined, and in some respects find it in advance of existing Bills in Canada West; and in the absence of a Prohibitory Law, would recommend it with improvements for this section of the Province. In reference to Memorials to the different religious organizations, your Committee recommend that the action of those bodies thereupon be ascertained, and laid before the Grand Division at its next Annual Session.

6. Your Committee think the thanks of the Order are due the Grand Scribe for the promptness with which the new Code of Laws has been compiled and placed at the disposal of the Grand Division, and upon a hasty perusal pronounce it a neat, compact, useful book, and would urge the propriety of every Subordinate Division procuring a supply for its

members.

7. Your Committee is pleased to learn that the Relief Fund for distressed operatives in Britain was punctually forwarded to proper authorities—and that, unpremeditated originally, said sum was distributed

among Sons of Temperance and other temperance men.

8. Your Committee deem it important, in accordance with the Report, to use every legitimate means to further the interests of our cause, and consider Temperance Tracts a useful auxiliary. The activity and success of the Committee, and especially Brother ORR, in obtaining tracts at such unprecedented low rates, is worthy of notice-thus placing those tracts in the reach of all. Your Committee recommend them to the consideration of every temperance organization, and especially to every Son of

Finally, your Committee trust that the able Report of the Grand Scribe will meet the concurrence of the Grand Division, as it does that of your Committee; and that this Session may be marked by great unanimity of

action.

Your Committee doubt the propriety of any further alteration of the position of Lady Visitors, but cheerfully bear witness that, under the present Constitution, the privilege which the Order enjoys in the presence of Lady Visitors is highly appreciated.

It is cheering to hear from the Grand Worthy Patriarch of so many new Divisions organized and so many resuscitated, and of the progressive state of the Order generally, in consequence of the faithful use of the means within reach.

Our duty to the young is a matter of earnest consideration, and it is well to deliberate on any further means of enlisting them in the ranks of total abstinence.

APPENDIX.

REPORT OF PARLIAMENTARY AGENT.

TO THE GRAND WORTHY PATRIARCH, OFFICERS AND REPRESENTATIVES OF THE GRAND DIVISION OF THE SONS OF TEMPERANCE OF C. W.:

WORTHY AND RESPECTED BROTHERS-

Having been honored with the appointment of Parliamentary Agent of the Grand Division to the Legislature at Quebec, I proceeded, in accordance with the advice of our esteemed Grand Worthy Patriarch and other friends of the Order, to the Seat of Government, with the Petitions addressed to the several branches of the Legislature.

1st. For an Act of Incorporation for our Order.

2nd. For an Act prohibiting the sale of intoxicating liquors.

3rd. For an Inebriate Asylum.

I had nearly reached Quebec when I learned that it was expected that the Legislature would adjourn for a period of three weeks. Upon my arrival, I found the report true, as the adjournment took place the next day. As there was no time to be lost, I obtained interviews on the following morning with several members of the Legislature, and had the Petitions for "Act of Incorporation" and "Inebriate Asylum" presented the same day—the first by the Hon. O. Mowar, and the second by the Hon. John A. Macdonald.

I availed myself of every favorable moment to confer with members of both branches of the Legislature, and also with the members and officers of the Government, to concert and determine on such plan of operations as would be most wise and prudent. Petitions to the Legislative Council were entrusted to that faithful and constant friend of the Temperance cause, the Hon. Malcolm Cameron; and those which were addressed to His Excellency the Governor General, were placed in the hands of the Premier, the Hon. John S. Macdonald, who readily consented to present them.

The interviews which I had with the several members of the Government, and also of the Legislature, were generally of a very pleasing and satisfactory character; but unfortunately, quite a large number of members left the city so soon after the adjournment, that it was impossible for me to see them. Some of these I visited on my return home.

Mr. Rose, Past Grand Worthy Patriarch of Canada East, was ready to render any assistance in his power to forward our measures, and I found many other friends ready to lend a helping hand.

The long adjournment of three weeks for the Easter Holidays, made it necessary for me to return home. Some of the members were of opinion that I had better go again to Quebec in three or four weeks after Parliament had resumed its sittings; but, most unfortunately for our present prospects, the sudden dissolution of the House put a stop to all our proceedings—no progress whatever having been made in any of them—the attention of M.P.P.'s having been absorbed in other questions, some of which were of much less importance than these.

I am of the opinion that we will have no difficulty in obtaining a good and sufficient Act of Incorporation for our noble Order.

The establishing of an Asylum for Inebriates is rather favorably viewed, provided that no funds are required from the Government. The necessity for such an Institution seems to be apparent to nearly all the members with whom I had the privilege of conversing, yet it is a subject on which the public mind requires to be informed.

A much greater diversity of opinion seems to exist in relation to Prohibition. Some of the most prominent members of the Legislature, as also of both the late and present Governments, are strongly opposed to it, although admitting the necessity of some better laws than exist with us at present. Prohibition must be obtained by gradual steps, and the Bill introduced by Mr. Dunkin at the late Session is an important step in this direction, and which would without doubt have become the Law for all Canada if the Legislature had continued its existence; and we may reasonably expect it to become a Law at the approaching Session. Mr. Dunkin at first intended it for Canada East; but, upon consideration with several friends, it was thought best to extend it to the whole Province.

In conclusion, I beg to say, that, while on the one hand I deeply regret that circumstances prevented the accomplishment of the important subjects entrusted to my care; yet, on the other hand, it may be for the best. We will gain additional strength by it; and as far as I know the newly elected members, I have good reason to believe that they will be much more favorable to our cause than the former ones; consequently we have a greater certainty of success.

I desire to urge upon the Grand Division the necessity of keeping these measures prominently before the country.

For us to stand still with good weapons in our hands, whilst our friends and fellow-men are daily falling by our side, is truly pusillanimous. To march forward in our strength in a good and righteous cause is our plain and only duty; and the "path of duty is always the path of safety."

MEMORIAL TO RELIGIOUS BODIES.

REVEREND FATHERS AND BRETHREN:

The Memorial of the Grand Division of the Order of the Sons of Temperance of Canada West

HUMBLY SHEWETH-

That intemperance, arising from the habitual use of intoxicating drinks as beverages, still exists to an alarming extent in this Province, as the fruitful cause of pauperism, disease and crime, alike dishonoring to Almighty God and ruinous to the bodies and souls of our fellow-men.

That the traffic in intoxicating drinks, as beverages (though a source of revenue to the Government), is so inimical to the best interests of community, and entails such a heavy expense in the relief of paupers, support of hospitals and lunatic asylums, bringing criminals to justice, and punishing for crimes committed under the influence of those drinks, that it becomes a necessity to suppress such traffic.

That while there may be a few manufacturers and venders who will be influenced by moral suasion to desist, we fear that nothing short of legal

prohibition will restrain this traffic within reasonable bounds.

That the last year has been fearfully fruitful in murders, which, without exception, were traceable to the use of intoxicating drinks and the associations of the bar-room.

That the Church of the living God is suffering directly and indirectly from the liquor traffic and drinking customs; those of her members who "have erred through wine, and through strong drink are out of the way," may be counted by hundreds, if not by thousands, while the money which should pay for carrying the Gospel to a perishing world is foolishly and wickedly squandered on poisonous beverages.

Ye men of God, we ask your help, by word, by action—in the pulpit, on the platform, by the fireside. "The priest's lips should keep knowledge." Let it flow out, baptized with heavenly fire, that the Church, in all its branches and departments, may "come up to the help of the Lord, to the help of the Lord against the mighty" evil of intemperance! Is there a greater evil, a more wily and insidious foe, which, while others slay their

thousands, slays its tens of thousands every year?

The Order of the Sons of Temperance aims at preventing the spread of this evil by inducing the drunkard to abandon his cups, the moderate drinker his occasional glass, and training the youth of our country to the practice of abstinence—by petitioning our Legislature for the entire prohibition of the traffic in intoxicating drinks as beverages, and the establishment of an asylum for inebriates.

We respectfully solicit your reverend body to aid us by your powerful influence and by such deliverances in the premises as will cheer our hearts in the work we have in hand, and strengthen us to renewed diligence and

zeal in this labor of love.
