Who is Right, and Who is Wrong ?

Who is Right, and Who is Wrong ? To the Editor of the MERCURY. SIR: --Permit me in the interests of justice and fair play to make the follow-ing statement for the information of "the powers that be" in Guelph, and the farm-ers of the County of Wellington. My son sold a certain animal at the last April Fair, which weighed on the Guelph market scales 2530 lbs., and as there were different opinions previous to its being brought to the fair about what it ahould or would weigh, I had it weighed on the public scales in the village of Hespeler some six weeks anterior is the time it was brought to Guelph. This was merely to satisfy curlosity, but it showed the beast to weigh 2590 lbs. Now how a thriving animal, after six weeks' *cutra good* feeding could possibly weigh 60 lbs. less instead of gaining at least that much is some-thing which passes my comprehension. The weighmaster at Hespeler afilms that his scales are just and right, and courts inspection; therefore I ask again. Who is right, and who is wrong? I know another farmer who believes he lost 300 lbs. on four head of cattle the same day of which I am speaking. I do not impute improper motives to any one, but the foregoing and other circumstances induce me to think, that on the occasion referred to the Guelph scales did not deal out justice. As the fair fame of the good town of Guelph is at stake I trust the proper authorities will look into this mat-ter. The loss of a few pitchfortfulls of hay is comparatively a small matter, but when so many fat cattle are weighed as at the last fair it is of great importance that the scales should be properly adjust-ed. After the sumptuous viands had been fully discussed, Mr Greeley, who presided, opened the exercises by referring to his introduction to Ame-ricans 34 years ago of the young Eng-lish writer then known as "Boz."— After guest, Mr Greeley said the American press honored itself in hon-oring the man who had climbed from the lower rung of the ladder of the press, and his triumph in attaining his present eminent position was shar-ed alike by every individual member of the fraternity. He concluded by offering as a toast, "Health, happiaess, honor and generous recompense to our friend and guest, Charles Dickens." offering as a toast, "Health, happiness, honor and generous recompense to our friend and guest, Charles Dickens."^A When the applause had subsided, Mr Dickens responded in an extended ad-dress. In the course of his remarks he alluded to the feelings caused among Americans by the unfavorable opinions expressed in his American notes and Martin Chuzzlewit. He was delighted to witness the improvement in the social, moral and material con-dition of the country, as seen during this his last visit, as in the works re-ferred to he had given his honest im-pressions at that time. On his re-turn to England he should, in his own journal, publish his present impres-sions upon America, and do justice to the people of this country. 

THE LATE RAILBOAD DISASTER. —In the case of the Erie Railway dis-aster near Port Jervis, the jury bro't in a verdict "that the accident was caused by a broken rail, and in the opinion of the jury it might have been avoided had the train run at a less speed, owing to the unsafe condition of the road." More than six weeks previously an official report of the road had been made, in which it was said "Broken wheels, axles, engines and trains off the track have been of daily, almost hourly occurrence for the last two months, caused mostly by delec-tive rails. Fully one thousand broken rails were taken from the track in the month of January. while the number removed on account of lamination, crushing, or wearing out, was much greater. February will show a still worse record than January. The con-dition of the iron at the present date is such as to give me much anxiety is such as to give me much anxiety and apprehension for the safety of the trains."

THE ASSESSMENT LAW.- Parties about to appeal against their assess-ment for the current year will require, perhaps, to be informed that the law has altered the time allowed in which to give notice to the Court of Revi-sion.
