

TO THE GRAND DIVISION OF THE SONS OF TEMPERANCE OF THE PROVINCE OF NOVA SCOTIA:

Grand Worthy Patriarch, Officers and Brethren,-

It is with no little pleasure your Grand Scribe offers his congratulations to the Grand Division, on the assembling of so many Brethren—old and faithful veterans in the Temperance movement—in annual session. 'This pleasure is enhanced from the fact, that the presence of so many Representatives of the subordinate Divisions, including two from the Island of Cape Breton, is indicative of the healthy and active condition of the Order in the jurisdiction,

CONDITION OF THE ORDER.

Having received but very few Reports from the Deputies, I cannot give any lengthened details respecting the state of the Order in each locality; the following brief notice must suffice.

ANTIGONISH COUNTY.

St. Andrew's is the only division in this county. It is prospering and doing a good work. *Twenty-one* new members were added to the division during the past quarter.

ANNAPOLIS COUNTY.

Although the divisions are not very active in this county, a number of them maintain their ground: one or two have not been heard from for several quarters. Annapolis Division, instituted about five months since, is struggling against much opposition.

COLCHESTER COUNTY.

All the divisions in this county are working well, except Agricola No. 72, from which no returns have been received for a year. Efforts, I understand, are about being put forth to get A REPORT OF A DESCRIPTION OF A DESCRIPTI

it in working order again. I am in hopes that the Order will soon be resuscitated in Truro town—especially as a promise was recently made to P. G. W. P. McArthur that efforts would be made to revive the Division there.

CUMBERLAND COUNTY.

With two exceptions, the divisions in this county are active. The exceptions are Eureka which is in a feeble condition, and Temple which is not working, and probably will not meet for some time. Excelsior Division, which ceased working several years since, has resumed opperations. Immediately after the last quarterly Session efforts were made to resuscitate Diligent River Division, but, I regret to state, without success, notwithstanding the promising prospects at the period referred to.

CAPE BRETON COUNTY.

With the exception of Bethlehem, the divisions in this county are in good working condition. No returns have come to hand from Bethlehem during the present year. Guthrie not yet resuscitated.

DIGBY COUNTY.

In this county Hope and Home Divisions are not in as flourishing a condition as formerly. The other divisions hold their ground.

GUYSBOROGII COUNTY.

Notwithstanding that Wine Harbour has had to cut off a large number of members during the past quarter, and meets with much opposition, the divisions in this county maintain their position.

HALIFAX COUNTY.

The city divisions are in good working condition—although the meetings, for several months past, have not been so well attended as the best members would wish. The same may be said respecting the other divisions in the county.

HANTS COUNTY.

All the divisions in this county are "looking up"—except perhaps Morning Star and Welsford. The latter is not very active, and the former has not been heard from for six months.

INVERNESS COUNTY.

None of the divisions in this county are working, and the same may be said respecting *Victoria County*, except, perhaps Renfrew Division, which, however, must be in a very feeble condition.

KING'S COUNTY.

Wolfville Division has been considerably reduced in number, "but it yet holds on." Living Oak has much opposition to contend against; "its members, however, live in hopes of its taking firm root." Garland is not working; Aurora has not yet been resusitated. The other divisions in the county are in good working order, and progressing—except perhaps Invincible, which has not been heard from for some months.

LUNENBURG COUNTY.

Evening Star not heard from for six months. No report from Watford. Phœnix not very active. The other divisions are faithful to their work.

PICTOU COUNTY.

The several divisions in this county are holding on well, although Albion Mines has had to cut off a considerable number of members. No report from Flowing Fountain since April; I believe it is not working. Rocklin has not yet been resuscitated.

QUEEN'S COUNTY.

This county is in the front rank so far as good working, progressive divisions can give it that position.

SHELBURNE COUNTY.

Little Star Division is still active, and, perhaps, in a better condition than ever before. Roseway holding on well, although reduced in membership. Life-Boat and South working favorably. Concord not heard from since April.

YARMOUTH COUNTY.

Upon the whole, the divisions in this county are active and doing a good work. Ohio has not yet been resuscitated.

BERMUDA.

No returns have been received for last quarter from the divisions in the Bermuda Islands. I fear the recent ravages of the epidemic which has raged in these Islands for some months past, has caused the divisions to suspend operations for a time—especially as several of the most active members, including the General Deputy G.W.P., were stricken down with the fever. By a letter received from the Deputy dated from New York—I am pleased to learn that he is' recovering and will soon return to his post.

AGENCY.

I would again urge upon the Grand Division the necessity of keeping the Agency department in constant operation. Since last quarterly meeting P. G. W. P. McAuthur has devoted one month to a lecturing tour in portions of the counties of Cumberland and Colchester—under auspices of the Agency Committee. The City Divisions and the Halifax Temperance Aid Association engaged the services of D. G. W. P. Barratt, for one month, during which period he lectured with successful results, in the eastern district of Halifax county. Brother Francis Beattie, under an engagement with the Pictou county Temperance League, is now lecturing in Pictou County, with what success is not yet known.

I would suggest the propriety of the Grand Division appropriating, say one hundred dollars for Agency purposes, to be added to amount now to credit of that department, with a view, if possible, of securing the services of some brother to lecture in counties of Guysborough and Antigonish, as also Cape Breton Island. Those portions of our jurisdiction, I think, should now receive a little attention at the hands of the Grand Division in the way of promoting the cause by the means of lecturers.

The Grand Division will pardon me, in again reminding them of the desirableness of brethren contributing towards the Agency Fund; and also of the necessity of divisons making an effort to raise money for Agency purposes.

REFORMATORY FOR DRUNKARDS.

In accordance with instructions of the Grand Division at last quarterly session the resolutions relating to a "Reformatory for confirmed Drunkards," laid on the table at that meeting, were printed in circular form, and copies forwarded to every Subordinate Division in the jurisdiction. *Twenty-nine* divisions have return answers, expressing approval of the intentions of the resolutions; *two* are averse to the proposition; and *one* would be in favour of the measure on certain conditions.

I would suggest that the resolutions be handed to a special committee to report thereon, recommending some plan whereby such a Reformatory could be put in operation in this Province.

In order to guide the Grand Division in its deliberations, or action in this matter, I addressed letters to Mr. Day, superintendent of "The Washingtonian Home," Boston, Mass.; to the Grand Scribe of California, and to a well known Temperance Advocate in the State of New York, soliciting information respecting Reformatories for Drunkards, in those States. I have not yet received any reply from California. The documents received from the other gentleman will be handed to such committee as may be appointed by the Grand Division, should it decide to adopt that course.

BANDS OF HOPE.

It will be pleasing to the Grand Division to learn that the institution of Bands of Hope is extending in this jurisdiction. This subject will likely be brought more prominently to your notice through the report of a committee appointed at the last annual session.

JOURNALS OF NATIONAL DIVISION.

Since last quarterly meeting of Grand Division, the Journals of Proceedings of the National Division, at its last annual meeting—June 1864—have come to hand. As the quota of this Grand Division was not sufficient to supply all the Subordinate Divisions in the jurisdiction, I ordered an additional 50 copies, at a cost of \$7.50 U.S. currency (\$4.12½ Nova Scotia currency.) Copies have been mailed to the address of every Division.

NEW DIVISIONS ORGANIZED DURING YEAR.

During the official year now ended *fifteen new divisions* were instituted, viz., *three* in Queen's Co.; two each in Cape Breton, Guysboro', and King's Counties; *one* each in Hants, Halifax, Antigonish, Yarmouth, Annapolis, and Bermuda.

DIVISIONS RESUSCITATED

Four Divisions which had been inactive for several years, were resuscitated during the same period.

VARIOUS MATTERS

Communications, reports, and other documents, relating to various subjects, will be laid before you during the session.

The Abstainer, the organ of this body, being now issued under a new management, and in an enlarged form, I trust will receive that patronage at your hands previously extended to it.

I feel it due to myself and the Grand Division to state, that the duties of this office, owing to the institution of new divisions, &c., has steadily increased during the last fifteen or eighteen months. The correspondence of the office has increased considerably, but I have endeavored to meet all the demands of the office on my time, with, I trust, satisfaction to the Order.

In concluding this report, I cannot refrain from expressing my acknowledgements of the service rendered me, during the year, by brother Taylor, G. Treasurer, especially in the month of June last, during my visit to Cleveland, Ohio, to attend the meeting of the National Division. The thanks of the Grand Division are also due to that officer for the interest he has manifested in the care of the funds, he having invested all the money not actually required, in the Provincial Saving's Bank.

Praying that we may enjoy a pleasant and profitable session, and that such business as may be presented for our consideration may be transacted with a view to the extension of the cause of Total Abstinence, I submit this my ninth Annual report In L. P. and F.

The Grand Scribe handed in several communications and other documents obtained by him, relating to Asylums for Inchriates, which were referred to the same committee.

The Grand Scribe read the following report:

The Special Committee to whom was referred the communication of Mr. Z. Pope Vose, Publisher, of Rockland, Maine; beg to report:

They have given the communication due consideration, and recommend this Grand Division to appoint a committee to receive subscriptions, and subscribers' names for the proposed book—" Dr. Lee's Text Book of Temperance."

Your committee, judging from the well known talents and qualification of the author, have no hesitation in recommending the members of this Grand Division to subscribe for this work: it being well calculated as a book of reference on all matters relating to the great moral reform in which we are all engaged, and well adapted to keep alive our interest in this, "the cause of all mankind."

The proposed work will not have its equal—seeing that it embraces the history of the drinking customs, ancient and modern,—the rise and progress of the temperance reformation,—the chemical history, nature, and properties of alcohol: its effects on the human system—in health and disease: its effects on the moral, social, industrial, and pecuniary interests of men, with reliable statistics,—with the remedy for the evil, personal, social, and national.

The work will, in all probability, be sold for the sum of one dollar—an amount within the reach of a large majority of the members of this brotherhood.

The G. W. P. read his report as follows :

TO THE GRAND DIVISION OF THE SONS OF TEMPERANCE OF NOVA SCOTIA.

Officers and Brothers :---

The close of another year has brought us together again, to counsel, encourage and strengthen one another for the accomplishment of the glorious object for which we are banded together, viz.: the suppression of the traffic in alcoholic liquors and the salvation of our fellowmen from the ruinous effects of their use.

And amid all that is calculated to protract the struggle and to dishearten those engaged in the warfare, we have this soul-cheering reflection, that our cause is a good one. That its origin is Divine—that its object is the elevation of men in the scale of humanity—that it is a channel through which untold blessings, temporal and spiritual, flow to the inhabitants of earth, and that in its holy and benevolent mission it has the smile and sanction of Heaven.

Moreover, there is real comfort to be derived from the consideration that we are permitted to identify ourselves with this mission of benevolence—to employ our faculties and energies, as a band of brothers, united to save the wretched and fallen from the curse of strong drink; drink which stupefies the intellect—benumbs the finer sensibilities—

destroys the affections-dethrones the reason-prostrates the manly vigour and sheds a withering blight over all the fairest portions of individual, domestic and social life.

It is a fact that needs no argument, that our frequent gathering together has a tendency to consolidate our principles, stimulate our efforts, and to infuse, as it were, new life into every department of our heaven-born institution. And as I see around me the long-tried and faithful veteran, the man of mature vigor and the ardent and aspiring youth; comprising the dignity of the learned profession, the wealth and influence of business men, and the stability and worth of the hardy sons of honest dally toil—permit me, henoured and worthy brothers, to offer you my most hearty congratulations on the favourable and joyous circumstances which have ushered in this our Sixteenth Annual Session.

Our sincere and united thanks are due to the Father of all our mercies, whose goodness like an "ever-flowing stream" has continued to refresh and strengthen us thus far on our journey, and by whose permission we are here again assembled.

In coming before you at the present time I have great pleasure in reporting the Order, throughout this jurisdiction, so far as information has been received, as generally in a healthy and prosperous condition. It is true, there are exceptions; and it is matter of deep regret that some few Divisions have only "a name to live," and now and then the votaries of Bacchus rejoice over the downfall of one from which life has taken its departure; yet we are more than compensated for the loss, by the new accessions to our numbers, which during the past year will compare favourably with any previous year of our history as a Grand Division. This statement is confirmed by the Grand Scribe's report, to which you are referred for statistics. I may say however, generally, that since our last annual meeting fifteen new, Divisions have been instituted, four old ones have resumed operations, and there has been a large increase of membership.

This, when viewed in the face of all the opposition with which the temperance movement is everywhere met, and especially when we take into the account that our Province has scarcely recovered from the shock received during the late political struggles so fatal to the cause of Total Abstinence, is a very encouraging degree of success. And still one cannot but be impressed with the conviction that much more might have been accomplished had there been on the part of every member of our Order, that unflinching, uncompromising fidelity to our principles that ought to characterize all true Sons of Temperance.

For it is a fact that cannot be winked out of sight, that, during the late political campaign above referred to in which our Province became so thoroughly agitated with the various questions which divided as under the public mind, too many professed Sons of Temperance, in the heat of political excitement forgot, or at all events disregarded the sacredness and solemnity of the pledge they took on becoming members of the order; and not only forfeited their own "sacred honor as men and as Sons of Temperance," but made use of the cursed beverage to accomplish their purposes, regardless of the evil consequences which must inevitably follow.— The late general election was not singular in this respect. What is true in reference to one is too generally true of all.

This is a state of things deeply to be deplored, and every true Son of Temperance looks at it with deep sorrow of heart, while he is conscious that every four years at least those heavt-sickening scenes of drunkenness which always occur at such times, must be enacted, again and again, and that too under the indirect, if not the direct sanction of the men who hold the reins of Government.

With such difficulties to face, the only course for true Sons of Temperance is to struggle on and fight bravely, to bring all the elements of power we have at command into exercise and persevere, knowing that we are on the side of the right, and the time will come when we shall have the "might with the right," and then we shall be sure of a glorious victory.

The press and platform are powerful engines in the temperance cause; and I am happy to be able to state that both have been employed to good advantage during the past year. The labors of Bro. Beattie, G. Sentinel, have been very sue-

cessful, in the western counties, and I am happy to know that he is continuing his labors under the auspices of another temperance organ n. Bro. Barratt also has performed good service in the eastern part of the county of Halifax as a lecturer, with very cheering success. I hope his valuable labors may be continued. Moreover, I would congratulate the Agency Committee on their having secured the labors of our esteemed Bro. Rev. A. McArthur in this noble enterprise. I feel assured that the well-directed employment of the talents and energies of that judicious and worthy brother cannot fail to produce beneficial results.

The Abstainer has borne its part in the work. Some years ago that paper was started as a monthly periodical; subsequently it became a semi-monthly, and finally a weekly paper. Its present increased size and improved type show still further advancement, which is worthy of commendation. And I am quite sure that those who have made its acquaintance in its new dress will agree in predicting for its future a greater degree of usefulness as the organ of this Grand Divisiou.

But we must not forget that both those institutions, to be effective, must be sustained and kept in motion. The mill may be a very fine superstructure—perfect in all its machinery—and yet it does not grind the corn without the propelling power. Just so with the press and the platform. We have them both in connection with our Order, but they need the propelling power. I need not tell you that that propelling power is money. If the money can be raised the laborers will not be wanting.

There is an old proverb on holy record, full of truth and wisdom: "Train up a child in the way he should go, and when he is old he will not depart from it." The majority of drunkards that everywhere disgrace humanity, are those who have imbibed a taste for spirituous liquors in early life. It is a very rare occurrence that an individual falls into drinking habits who has escaped their contaminating influences until he has attained the full age and vigor of manhood. Now if we can educate the children in the principles of total abstinence, and train them to temperate and virtuous

habits, we are fulfilling, to a certain extent at least, the injunction of that wise saying. This is just what the introduction and judicious management of Bands of Hope are calculated to accomplish; and it is with unmingled pleasure that I am able to report some degree of progress in this depart-. I would like to be able to say that this kind of proment. gress was the rule and not the exception throughout the jurisdiction. Educate the children free from the curse of the "drinking customs," free from the slavish and filthy practice of tobacco-using, and free from the demoralizing habits of profanity, and you are doing more for future generations. than could ever be accomplished by reformatory institutions Nay, the necessity for such institutions would be. alone. superseded, and earth would become a perfect Eden in comparison to the picture of wretchedness which it now. presents.

I cannot conclude this hastily prepared report without referring to the uniform courtesy and kindness I have received from my brothers in office, as well as from all the members of the Grand Division with whom it has been my pleasure to meet. To the Grand Scribe I am specially indebted for information received by frequent correspondence, which to me has been of the most satisfactory character. I am more and more convinced that in him this Grand Division has the "right man in the right place."

I have attended the several quarterly sessions during the year. To me they have been seasons of special interest, and I trust they have not been without profit to all concerned, and to the public at large in the localities where they were held.

My term of office has nearly expired. I regret that it has not been in my power to accomplish all that has been in my heart to do for the cause I love next to the cause of religion. I hope that the chair, which by your suffrages it has been my privilege to occupy during the past year, may be more ably filled, and the business of this Grand Division presided over more successfully by my successor in office, whoever he may he. I pray that God may give wisdom, guidance, and strength to all engaged in this glorious enterprise, that we may not cease our united efforts until the "drinking customs," so fatal to the peace and prosperity of our fellow, men, are entirely and forever banished from our land.

Several amendments were moved, but the report was adopted.

Bro. S. Selden presented the following report from the Agency Committee :

The Agency Committee beg to report that the arrangement suggested in their last quarterly report, as under negociation with brother McArthur for a lecturing tour, has been to some extent carried out.

Brother McArthur has lectured in portions of Cumberland and Celehester counties, occupying about three weeks, during which time he addressed twelve meetings and travelled nearly 200 miles. Collections were made at the meetings amounting to \$24.48, and a Lodge of Good Templars in Economy contributed the sum of \$2.11¹/₂.

Whilst your committee have no further report to make of their own proceedings, they have pleasure in referring to a tour undertaken by brother Barratt along the shores of the Eastern section of Halifax county, under the auspices of the City Divisions and the Temperance Aid Association. In this tour brother Barratt travelled 372 miles, addressed 18 public meetings and 15 schools. He administered the total abstinence pledge to 228 persons. Bro. B. also organized or resuscitated several Temperance Societies, and visited several of the Divisions of our Order on his way.

Your committee are also pleased to learn that bro. Beattie the Grand Sentinel has been employing the past two months in lecturing in the county of Pictou under the auspices of the Pictou County Temperance League.

Your committee are glad to learn that some of the Divisions are doing something by way of providing funds for agency operations, and hope that their successors, whomsoever the Grand Division may appoint, will be able to engage the services of one or more lecturers for longer periods during the ensuing year than has been done during the past year.

Your committee would take the liberty of suggesting that almost all the counties of Nova Scotia proper, have been visited more or less by your agents. The counties of Antigonish and Guyshoro, and the island of Cape Breton, have not participated in these benefits, and might well occupy the attention of the committee. If a lecturer could be obtained

to go in that direction there is little doubt, but he would be the means of doing great good in spreading the principles of . temperance and benevolence.

Bro. R. M. Barratt presented the following report:

The committee appointed at the last annual session to devise the best method for a systematic support to the agency fund, beg leave to report-that after giving to the matter their best consideration, they found much difficulty in deciding upon any one plan that would suit every locality. Your committee believe that a personal visitation by a competent agent with authority to deal with this question would result in a permanent contribution that would meet all the wants of this Grand Division. At the suggestion of your committee, two of the divisions in the city have adopted the practice of taking up a collection at each meeting. Athenaum Division in ten months has, by this means, realized about \$24.00, and Miemae Division in less than three months, has, by the same practice, collected over \$5. D. G. W. P. Heenan has collected within the year about \$22, from members of Chebucto Division. New Era Division pays 11 cents per quarter on each member on its books. The members of Tangier Division have agreed to pay one cent each week to the fund, \$1.45 has thus been collected by them in a few weeks. Bros. Bryden of Liverpool, Dr. McRobert of Londonderry, and the Grand Scribe, each contribute \$4 annually.

Your committee believe that the instances they have cited prove that by combined and systematic efforts all the funds required could be raised without any person feeling it to be a burden.

Your committee would suggest that an effort be made to

raise in this city \$400 for the ensuing year by individual contributions of quarterly payments, and a small quarterly grant from each of the divisions, and that the money so raised be appropriated to the payment of an agent to visit the whole jurisdiction, and who in addition to other duties shall be specially charged with the establishing of permanent contributions to the fund.

The formation of fitteen new Divisions during the divisional year, the revival of old ones that had ceased working, a general increase of membership, the augmentation of the funds of the Grand Division, the organization of numerous Bands of Hope, efforts to provide a home for inebriates, the enlargement and more frequent issue of our Temperance journal, the Abstainer, schemes devising to raise funds for agency purposes, are facts which eannot fail to encourage us in our works of benevolence, stimulate us to continued endeavour, while they serve to inspire us with hope of future success and ultimate triumph.

It cannot be doubted that the efforts of agents have contributed in a good degree to this prosperous and hopeful state of things, as we have in them the promise and pledge of what might be accomplished if this branch of effort were more extensively carried out. The grand object of our Order is the promotion of Temperance—we are not without funds—the services of lecturers can be secured. This being the case, your Committee believe that no better disposition of a portion of our funds can be made than by giving effect to the suggestion of the Grand Scribe, and would therefore submit that the sum of one hundred dollars be placed in the hands of the Agency Committee to enable them to forward their aims.

The importance of the press as an instrument of use in this moral reformation is too well understood to require special enlargement. Your Committee would congratulate the Grand Division on the appearance of the *Abstainer* in its enlarged form and more frequent issue, and would express its sense of indebtedness to its zealous, devoted and enterprising editor and proprietor, who has assumed so much responsibility in undertaking its publication. The Committee to whom was entrusted the consideration of the question of an "Asylum for Incbriates," report that they have given attention to the documents placed in their hands on the subject.

Your committee in considering the sad consequences which flow from drunkenness, and the untold evils which arise to the persons and families of those who have acquired habits of intemperance,-and have become habitual drunkards-and further considering the peculiar nature of the disease-such habit then becomes-and the great difficulty there is in applying any adequate remedy while such persons are exposed to the temptations which abound in the community, they conceive some special means are required to meet this necessity. The success which has attended institutions for the treatment of such cases, and where wise and judicious efforts have been made for reclaiming such unfortunate individuals to their families and society, leave no doubt as to the propriety of their establishment; and your committee are fully of opinion that an Asylum-such as that contemplated in the series of resolutions submitted to the Grand Division, would be of incalculable good to a large number of persons in this Province.

Your committee would therefore recommend that a committee be appointed to present the matter to the attention of the Legislature at its next session, in the form of a memorial or petition from this Grand Division.

In bye-laws of Tangier Division, your committee would recommend that the following be substituted for Article 4: *Travelling and Withdrawal Cards will be granted in accord ance with Chapter 7 of the Code of Laws.*

In bye-laws of Hall's Harbor Di ision, we would recommend that the following words be added to Section 4, Article 7: When voted by the Division.

In the same bye-laws, defining duties of the F. S. in reference to charges against members for non-payment of dues, *five* to be substituted for *three*, as the number to comprise committee to investigate charges.

Your committee would also recommend that the words,— After it has been voted by the Division, be added to Sect. 9 of Article 5, of Prince Alfred Division. The name of *Port Williams Division*, No. 195, was omitted from your committee's report presented at last quarterly session. In the bye-laws of this division we did not find anything to conflict with the Constitution or Code of Laws.

Grand Worthy Patriarch,-We, your Committee appointed to report on documents submitted by 'St. Andrew's' and Brooklyn' Divisions to this Grand Division, referring to the present provincial Liquor License Law, have met and had the matter under consideration. Among other suggestions, one is, that the present law be so amended, that whereas now it requires a majority of the rate payers of any district to petition against the granting of Liquor Licenses, that the case be reversed, and no such Licenses be granted unless a majority of rate-payers petition in favour thereof. Could this be effected we el it would be quite a boon, and the laboring oar handed to the proper parties, if they desired to use it. If this is not thought obtainable, we suggest as an improvement, that the law be so amended that a majority of the male rate payers then in the district petitioning against such Licenses, be sufficient. As the chief thing asked for is

the referring of the whole License Law to the various Subordinate Divisions in the Province for discussion and opinions, we would respectfully submit that it be so referred, and that they be requested to report thereon at the ensuing January Session of this Grand Division, giving their respective views as to the working of the law referred to, and suggesting any amendments they may consider advisable, and especially with regard to these here specially referred to.

Your committee, considering that the rules and ritual at present in use are in many respects unsuitable to the wants and capacity of the children, have had prepared a code of rules and a ritual which are herewith submitted, and which they trust will meet the approval of this Grand Division and the necessities of the organization, and would suggest that if these should meet your approval that they should be published under your authority, and in such way as in your wisdom may seem best.

With the view of procuring more full information respecting the organization throughout the province, your committee instructed their chairman to apply, through the Abstainer, for information from the different Bands at present in existence. But few answers have been received, although the committee have reason to believe that quite a number of Bands of Hope have been formed in various localities. The information they have obtained is herewith furnished in the accompanying table.* Your committee believe that the subject is well worthy the care and countenance of this Grand Division, and they would suggest the propriety of a committee of the Grand Division being appointed, with one brother to act as a general agent, and that the committee be recommended to attempt the formation of committees of corresponding members throughout the Province.

In conclusion, your committee would again commend the organization to the special consideration of the members of the Grand Division, and would urge upon them the duty to use their best efforts for the establishment of Bands of Hope under judicious management, in connection with iteir several divisions, or in their neighborhood.
