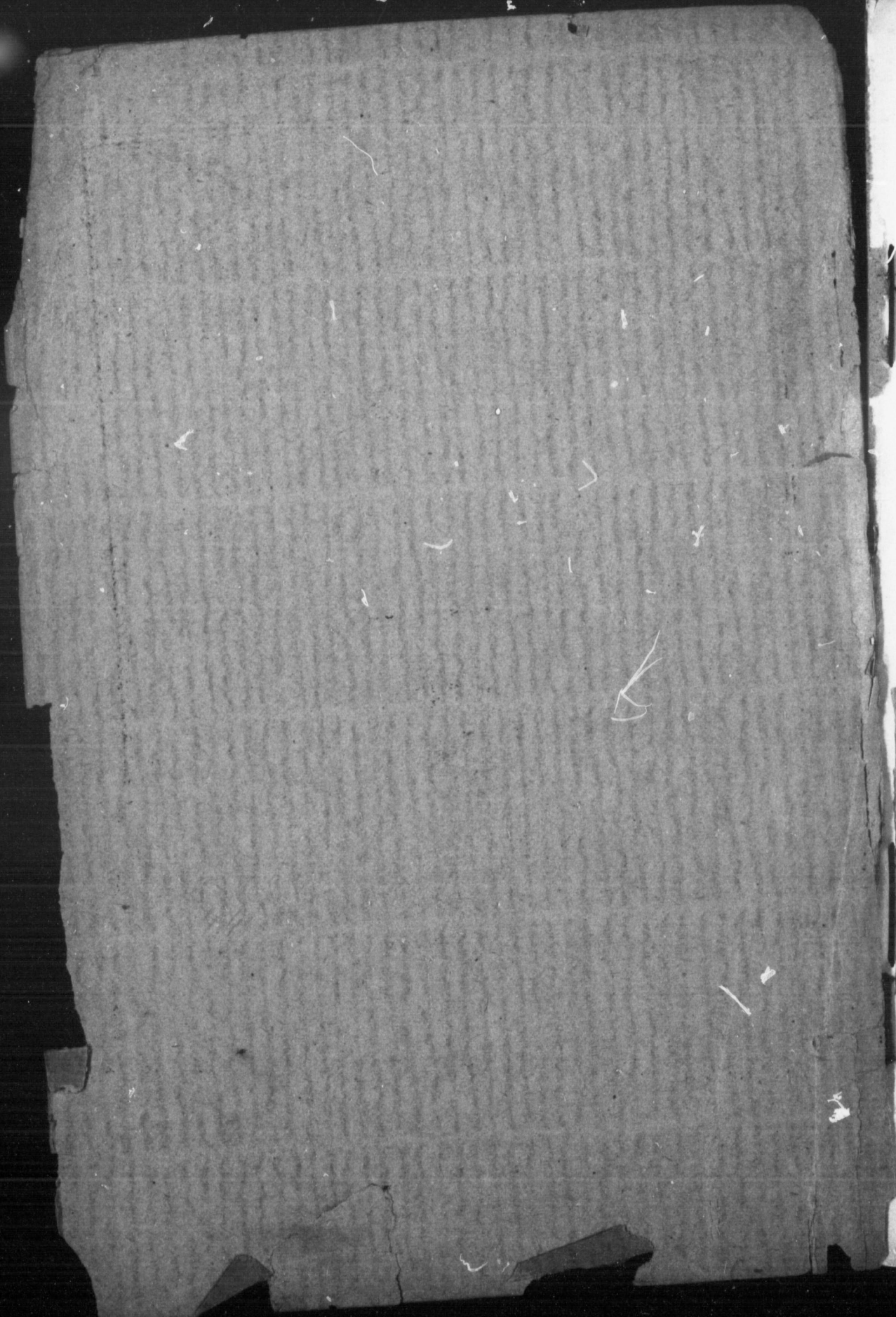

SYNOPSIS OF MINUTES OF THE ANNUAL MEETING OF THE CONGREGATION.

The annual meeting of the congregation was held on the evening of January 14, and was largely attended.

Before commencing the business devotional exercises were conducted by the Rev. Dr. McTavish, who then announced his intention of vacating the chair, upon which Mr. A. R. Creelman was requested to preside, and the Secretary of the Managers was appointed Secretary for the evening.

As this was the first meeting of the congregation held since the induction of the present pastor, addresses of welcome were made to him by Mr. J. K. Macdonald on behalf of the Session, by Mr. George Anderson on behalf of the Sabbath School, and by Mr. A. R. Creelman on behalf of the Managers.

The report of the Session for the past year was then presented by Dr. McTavish, and the Session Treasurer's statement was also submitted.

Abstracts of the results of the work carried on during the year by the various organizations connected with the church, with the exception of the Missionary Association, were read by the Secretary.

The adoption of the annual report of the Managers was moved by Mr. Donald, seconded by Mr. Petry and carried.

It was ordered that the reports which have just been presented be printed and distributed as usual.

The following gentlemen were elected to act on the Board of Managers during the next two years, viz., Messrs. C. B. Petry, G. H. Meldrum, Wm. Wilson, L. M. Livingston, John MacEwen, Donald Bain, Jas. Hedley and George Denoon.

A motion made by Mr. Jeffrey and seconded by Mr. Gibson was carried, providing that in the event of the Session deeming it advisable to employ a missionary to take charge of the Elizabeth Street Mission, his services shall be paid for by the Managers out of the ordinary revenue account of the Church, at a rate not to exceed \$300 per annum.

The question of reducing the mortgage debt on the Church was considered and referred to the Managers, who were requested to devise some method for its eventual liquidation.

Votes of thanks to the Leader of the Choir, Organist, Members of the Choir and Auditors, for valuable services rendered during the year, and to the Chairman of this meeting for the ability with which he has conducted the business, were unanimously passed.

Messrs. John Erskine and Theron Gibson were appointed Auditors for the ensuing year.

REPORT OF THE SESSION FOR 1888.

It is with deep gratitude the Session present their Report of the spiritual work in the Congregation during the year that has just closed.

Considerable apprehension was felt when it became certain that the Rev. Mr. McLeod had decided to accept a call to Victoria, B.C., and that we were face to face with a pastoral vacancy. But in the good Providence of God the vacancy was of comparatively short duration, and the faithfulness of the office-bearers, together with the loyalty of the great majority of the members, prevented us from suffering any material loss.

Since the organization of Bloor Street Presbyterian Church as a congregation, a considerable number of members in that vicinity have withdrawn from us and united themselves with that new and growing charge. Among those whose loss we feel especially are our worthy elder, Mr. John Harvie, and his esteemed wife, but we are rejoiced to think that in their new sphere they will have scope for their excellent abilities as Christian workers.

We are proud to think that during the year the Congregation has contributed two members to augment the noble band of workers in the Foreign Mission field. In April the Rev. Jonathan Goforth was ordained and designated to Honan, China, as one of the Colleges' missionaries, and in November Mr. James Gale, B.A., was appointed to begin work in the Hermit Nation, Corea, under the auspices of the University Young Men's Chris-

tian Association. Both these gentlemen rendered invaluable service in connection with the William Street and later with the Elizabeth Street Mission, and by their earnestness and devotion won the esteem of all who knew them. They are followed in their new and trying fields of labour by the good wishes and prayers of hundreds in this Congregation. We feel that we have all sustained a great loss in the sudden death of Mrs. McLachlan, of Tarsus. Being the daughter of our oldest elder, she was connected with this Congregation ever since its inception. She possessed a peculiarly sweet and earnest Christian disposition, and was ready, even beyond her strength, to help on any good work. She looked forward to a life of missionary toil with great pleasure and enthusiasm, but she was only permitted to labour a short season when she was called to lay down the cross and accept the missionary's crown. Rev. Alexander McLachlan was for many years a member and also a zealous Sabbath School worker in connection with this Church. He, together with Mr. and Mrs. Stephens and family, have the sincere sympathy of all the Congregation in this severe bereavement. During the year death has also carried off a number of others who were highly esteemed and beloved amongst us. We trust we are able to say of them all, "Blessed are the dead that die in the Lord."

The actual number of members on the roll at the close of 1887 was 475. During the year 41 have been added to the membership by certificate and 14 by profession of faith; 4 have been removed by death, 58 by certificate, and by a very thorough and careful revision of the roll a considerable number of names have been dropped. This leaves our actual membership at the close of 1888, 432.

The ordinance of Baptism has been administered to 20 infants, and the Sacrament of the Lord's Supper was observed eight times during the year, all of which were occasions of much spiritual refreshing. The Session has decided to require of all the organizations connected with the Church monthly reports at its meetings. In this way the Session will be kept fully informed as to what is being done in every department of our Church's work.

The reduction of the Eldership through removals has necessitated the re-arrangement of Elders' Districts, as will be noted in the list of Elders and their districts.

We are deeply grateful to the Great Head of the Church for the earnestness and consecration that characterizes those engaged in the work of the Congregation, for increasing liberality among the people and for tokens of blessing accompanying the teaching and preaching of the Word. In simple faith we look forward to yet higher and grander results in the future.

REPORT OF THE BOARD OF MANAGEMENT.

In presenting their report for the year ending 31st December, 1888, the Managers desire to express deep thankfulness to Almighty God for the abundant proofs of His favour enjoyed by the Congregation during the year. The Board has pleasure in reporting that all the financial engagements of the Congregation during the year have been promptly met, and although it opened with a deficit of \$163.61, and a considerable sum has been ex-

pended for permanent improvements, yet there was a surplus of \$29.06 at the close of the year, as will be seen by reference to the detailed statements of receipts and expenditure appended to this report.

The whole indebtedness of the Congregation now consists of the mortgage debt of £5,000 sterling, upon which all interest to the end of the year has been paid. Owing to the circumstance that the Congregation had no settled pastor during a considerable portion of the year, the Board deemed it inadvisable to call for donations in reduction of the debt, but expresses the hope that the Congregation will at the annual meeting adopt a measure which will result in a substantial payment being made on account of principal during the coming year.

In February last the late pastor of this Church, Rev. P. McF. McLeod, accepted a call to St. Andrew's Church, Victoria, British Columbia, and the Congregation was without a regular pastor until August following, when, in response to an almost unanimous call, the Rev. D. McTavish, M.A., D.Sc., the then pastor of St. Andrew's Church, Lindsay, was inducted as our pastor. It is earnestly hoped that he may long be spared to perform in our midst the duties of his high office.

At the annual meeting of the Congregation it was agreed that the cost of maintaining the Sabbath School and the Elizabeth Street Mission (not including missionary's salary) should be paid out of the ordinary revenue. This was done during the year, and the Board would recommend that a similar practice be adopted during the coming year. The estimated expenditure for these two objects is about \$400.

It is estimated that the ordinary expenditure of the Congregation for 1889, including the sums required for the Sabbath School and the Elizabeth Street Mission will be about \$5,850, which will necessitate the collection of \$112.50 weekly. This is quite within the power of the Congregation at the present time, and does not exceed the amount regularly contributed towards the close of the year. At the same time the Managers would respectfully point out that a very slight increase in the weekly offering on the part of a considerable portion of the Congregation would entirely relieve their successors from anxiety and render any special appeals unnecessary during the coming year.

The following Managers retire by rotation, but with the exception of Dr. Acheson, who has retired from the congregation, are eligible for re-election: Messrs. Acheson, Bain, Christie, Crawford, Meldrum, Petry, Watson and Wilson.

The following Managers were elected at the last annual meeting and do not retire until the next annual meeting: Messrs. Campbell, Creelman, Donald, Miller, Paton, Spence, Windrum and Wishart.

SABBATH SCHOOL REPORT.

The Fourteenth Annual Report of the Sabbath School Teachers' Association is presented herewith :

The average attendance for the year, and number of scholars on the roll at its close, were 160 and 208, respectively, figures which are substantially the same as those recorded for last year. During the months of July and August the school was held in the morning. This caused a considerable diminution in the attendance, so that the manner in which the average has been maintained is cause for gratification.

The collections, on the whole, have been satisfactory, although the total is somewhat less than last year. This is accounted for by the fact that the scholars' contribution of \$50 to St. Paul's Institute, Tarsus, for the past year was almost entirely collected in 1887, so that no special effort

The teachers are glad to be able to report that the library of the school, for the first time in many years, is in a flourishing condition. The total number of volumes at present on the shelves is 400, and 250 of these are of recent addition. It has been ascertained from experience that the cheapest method of maintaining the library at a proper standard of usefulness is to expend upon it a small sum annually, and this course it is proposed to follow in future.

The system adopted at the last annual meeting of the congregation, by which the current expenses of the school became a charge on the ordinary revenue account of the church, has worked satisfactorily, and its continuance is requested.

It was with feelings of the greatest sorrow and regret that every teacher and scholar in the school heard the sad intelligence which has brought such grief into the home of our dear friends, Mr. and Mrs. Stephens. They have the deepest sympathy of all in this hour of their trial, and the same heartfelt assurances are also extended to our former co-worker, the Rev. A. McLachlan, who has just suffered such an irreparable loss. They are not, however, as those who mourn without hope, and the calm and Christian resignation with which the Saviour's call has been responded to vindicates the certainty they entertain of a happy meeting-time again.

Through the resignation of Miss Gordon a faithful worker in the school since its inception has been lost. It is hoped, however, that her absence will only be of a temporary nature, and that in due time she will be once more welcomed to her accustomed place.

The teachers desire to record their annual expression of thanks to Mr. Creelman for a donation towards supplying the requirements of the Infant Class.

LADIES' AID REPORT FOR 1888.

The Ladies' Aid Society has much pleasure in presenting to the congregation its eighth annual report.

During the past year 16 sewing meetings have been held; largest attendance, 24; smallest, 9; average, 17.

One hundred and twenty-nine articles of new clothing have been completed, consisting mostly of garments for children; 8 quilts have been made and 23 bonnets and hats trimmed; these, when finished, are all priced below cost and sent to the "Mothers' Meetings," where they meet with a ready sale; the price is then returned to our treasurer and again expended in materials necessary to carry on our work. We were advised some time ago to make a very small charge on every article of clothing; this plan we have tried and find it works very successfully, allowing our purchasers at the "Mothers' Meetings" to maintain the feeling of independence so desirable and still enabling them to possess articles of clothing at a very trifling outlay.

Last year we made mention of a gift of \$25 to friends in sorrow, this year we were impressed and encouraged by having the money returned, accompanied by \$5 sent as a thankoffering. After consideration, we decided to form the returned gift into a loan fund for similar cases.

Not long ago we sent an old woman from the "Mothers' Meetings" to a distant town to reside with her son, and have received a very pleasant report of her; we also agreed

We consider all ladies of our church members of this Society; and as we have *no fees*, but carry on our work *entirely in faith*, we very heartily offer our thanks to all those who so liberally responded to our appeal on Thanksgiving Day; also to many friends who from time to time aid us with gifts of money.

Again we tender grateful acknowledgments to our firm friend, Mr. Spence, who is ever ready with generous supplies of materials; to another staunch friend, Mr. Donald, for liberal gifts of groceries, and to many others for kind, numerous, varied and useful contributions, all most acceptable.

Also, we proffer our best thanks to Dr. Gilbert Gordon for his personal reports of the cases he has undertaken for us, and his kind offer to attend to our medical requirements free of charge.

In closing this report of our work for the past year, which has been both encouraging, pleasant and profitable to each one privileged to be thus employed in our Lord's service of caring for the poor, we gratefully acknowledge His loving kindness to us as members of this Society in one word—"Ebenezer."

ANNUAL REPORT OF CENTRAL CHURCH
AUXILIARY WOMAN'S FOREIGN
MISSIONARY SOCIETY, 1888.

In submitting this, the sixth annual report of the work of our Auxiliary, our first duty is to return thanks to God, not only for the increased interest manifested in the work of our own Society, but also for the unusual activity and zeal shown in the operations of the General Society.

* \$30 of this amount is not available for ordinary expenditure as it has been set apart for a loan fund.

During the past year this Auxiliary has held twelve meetings, with an average attendance of nineteen. This shows an increase over the figures of last year, but not such an increase as we would like to see.

The Auxiliary numbers 78 members, 69 of whom are members of the General Society. Eleven are life members, three having been added during 1888.

The revenue of the Society for the year amounted to \$236.70; a gratifying increase over last year.

When we take into consideration the fact that our membership has been depleted by removals to the Bloor Street Church, we may well congratulate ourselves on our present numerical and financial standing. It should always be borne in mind in this connection, that the funds of the Auxiliary, apart from the fees, are derived entirely from voluntary offerings, and no special effort has been put forth by the Society to increase those offerings.

During the year that has just closed the members of the Auxiliary have taken a deeper interest in the work, and have manifested a greater willingness to take part in its proceedings. Many interesting papers have been prepared and read before the Society during the year. These papers have been written, as far as possible, in a line with the topics laid down on the prayer card. At the April meeting our President, Mrs. Robinson, read some very interesting extracts from a paper on Medical Missions, prepared by Miss McKellar, of Queen's College, for the annual meeting of the General Society. At the meeting in May an exceedingly interesting paper on our Mission to the Indians in the North-West was read by the late Mrs. Wishart. At the June meeting Mrs. Gibson read a sketch of the life of the late Rev. Mr. Burns, for twenty-one years a missionary to China. This paper was prepared by Mrs. Geo. Burns. At the same meeting Mrs. Petry read an instructive paper, entitled "A few thoughts on Chinese Missions," and at the December meeting Mrs. Campbell read a paper on Missions to the Jews. In addition to these papers, a number of addresses were delivered during the year, and extracts from books and pamphlets containing missionary intelligence were read. Unusual interest has also been taken in the *Letter Leaflet*, as is shown by the increased number of subscribers. The reading of letters from the *Leaflet* has helped in no small degree to

awaken Christian sympathy to the importance of mission work.

During the past year the hand of death has been laid upon our little band. On the 22nd of August last, Mrs. Wishart was called from amongst us, under very sad and trying circumstances. Although a member of our Auxiliary for a brief period, she had endeared herself to all who had the privilege of working with her. She was ever ready and willing to devote her time and talents to the good work. And it will be remembered by those who attended our last annual meeting with how much feeling she sang the two beautiful hymns, "Lead kindly Light" and "Nearer my God to Thee." We also mourn with the sorrowing relatives the death of our dear young friend, Mrs. McLachlan. From her infancy she had been connected with this church, and in her maturer years closely identified herself with Christian work. She had a loving, cheerful spirit, and the years spent here were full of happiness and usefulness. She was an active member of our "Mission Band," and occupied the position of secretary previous to her departure for Tarsus with her husband, a little over a year ago.

There is something inexpressibly sad in the sudden gathering home of youthful workers such as these. We miss their familiar faces at our meetings, but with satisfaction we think of them as with their risen Lord, engaged in more exalted service where "there is fulness of joy." We who are left a little longer to work should realize that we are summoned with a special urgency to endeavour to do more for the Master in the future than we have been able to accomplish in the past.

At all times let us remember that self-denial and energy with God's blessing will enable us to overcome every difficulty, and let us go forward into this New Year with fresh energy and increased enthusiasm in the name of Him who, while He commanded us, "Go ye into all the world and preach the Gospel," also gave us the blessed promise, "Lo, I am with you always."

In presenting our Fourth Annual Report we desire to thank our Heavenly Father for the many blessings He has showered down upon us, in our work. Our Society felt a little discouraged by a falling off in the workers, owing to a number having left the Church during the vacancy. The Society has been reorganized, our Treasurer, Mr. Gale, having gone to the Foreign Mission Field in Corea, where we will follow him with many prayers. The workers have been greatly cheered

by the untiring interest Messrs. Brebner and Ross take in the work, and hope they may continue long with us.

In closing we would thank Mr. Macdonald and Bible Classes for contributions for the purchase of tracts, and also Mr. Kilgour for covers.

Remembering the Master's promise, "Forasmuch as ye know that your labour is not in vain in the Lord," we go forward this year with renewed courage.
