STATE OF THE CHURCHES

MONDAY, 10 A. M. June 30th, 1845.

CHURCHES

The Introductory Sermon was preached by Rev. R. B. Dickie from I Cor. x: 31, after which a collection was taken in aid of Home Missions, in addition to those taken on the preceding day.

The Association being then called to order, Rev. J. Pryor was appointed Moderator, Rev. Wm. Chipman Clerk, and Bro. I. Chipman Assistant Clerk.

Revs. J. Chase and W. Hall were chosen to read the letters from the churches, and Rev's T. Delong, David Dimock, and J. Parker, to examine the same previously to their being read.

The following brethren were appointed a Committee to examine and report on any subjects referred by the churches in their letters to the decision of the Association, viz: W. Burton, E. A. Crawley, W. Chipman, S. T. Rand, C. Randall, T. Tupper, and D. Cutten.

The four Churches last named were received during the present session, the right hand of fellowship being presented by the Moderator, in behalf of the Association, to the brethren who were appointed and are named above as their representatives for such purpose.

It was then Resolved, that the Rev. Archd. Maclay, D. D. of New York, and Rev. A. V. Dimock, together with any ordained ministers or licentiates in regular standing with the Churches composing the Association who may be present and are not delegates, be invited to take a seat in council with us. No names however were understood to be reported.

Revs. J. Crandall and W. Hall, as messengers from the N. Brunswick Association, being entitled to take part in the deliberations of the session, took their seats accordingly.

Nutting, Treasurer for these objects; for Home Missions, to Isaac Chipman, acting for Treasurer; for College Buildings and S. S. Union, to the same; and for superannuated and infirm ministers, to S. Viditoe, in absence of the Treasurer for this fund, D. C. Landers.

Adjourned, to meet at 4 o'clock, when the Rev. Dr. Maclay, as Agent for the Am. & For. Bible Society, was to occupy the time in making an exposition of its history and principles. Closed with Prayer.

Monday afternoon. Met pursuant to adjournment, when the Association was favoured with a very circumstantial and satisfactory account of the proceedings which have been had with reference to the faithful translation of the Bible into foreign tongues, as pursual by the Am. & For. Bible Society, and the English Translation Society. They and the numerous audience present were appealed to also in a very able and eloquent manner, on the importance of communicating the word of God entire and unmixed to the nations of the earth.

The times of meeting of the several Committees having been arranged, the Association adjourned to meet on Tuesday morning, as 10 o'clock, when the business of the Education Society would be in order.

2. Resolved-That Collegiate Institutions are essential to the promotion and advancement of Education in general: and that Common School instruction can never be extended beyond the lowest scalenor can any country be elevated above a very inferior condition, unless means shall exist for the higher branches of Education. and bus

3. Resolved-That the principle of supporting Education through the instrumentality of denominational establishments is in itself sound, and has the sanction of experience and example in its favour, and is the only means of securing the union of religious with intellectual improvement, -and of imparting vigorous and efficient action to Seminaries of learning in countries, where, as in Nova Scotia, and in the other North American Colonies, the population is divided into many different religious denominations, and freedom and equality

4. Resolved, That the Nova Scotia Baptist Education Society gratefully acknowledges its obligations to the kind friends in Great Britain and the United States who lately assisted its agencies with great and most seasonable liberality;

And that the warmest thanks are due, and are now offered, to the Rev. John Pryor, and the Rev. I. E. Bill, who, for promoting the interests of the Society, separated themselves from their families and friends, to sustain the fatigues, risks, and anxieties, of the painful duty of collecting contributions in its aid, and by their zealous and persevering efforts brought effectual relief to the Society when in circumstances of great pecuniary necessity. manifes na . else net

5. Resolved, That the Society receives with peculiar gratitude and pleasure the donation of £100 sterling, granted by the Baptist Missionary Society of England towards the support of a Theological Professor at Acadia College-valuing the gift, not more for its munificent amount, than as a token of the sympathy and kindness of our transatlantic brethren, and hailing it as the pledge of a union which, it is hoped, may be continually more firmly cemented; in the same state of th

And that Rev. J. Pryor, Dr. Belcher, with Brethren J. W. Johns sten, and J. W. Nutting, be a Committee for preparing and forwarding to the Baptist Missionary Society in London a letter of thanks, expressive of the sentiments of this meeting, and for improving as far as possible the opportunity thus afforded, of promoting and continuing a correspondence with the denomination in the parent state.

6. Resolved, That the meeting accepts and pledges itself to fulfit the condition on which the donation of the British Missionary Sociey has been conferred, and recommends that subscriptions be commenced forthwith for raising the sum of £125 for this specific object.

7. Resolved, That while this Society recognizes the sound and judicious education of the young in all branches of useful knowledge as entirely within the scope of their efforts, and deserving of most especial consideration, they at the same time regard the raising up of a pious and educated ministry as by far the most important branch of their labours: and they are of opinion that the time has now arrived, in which the Baptist community ought to be aroused to the duty of seeking in their various churches for pious young men of promising talents, who, it may be hoped, are called to the work of the ministry, and of aiding them in obtaining a suitable education, and that to this end, this Society heg leave to suggest to their brethren the plan of several neighbouring churches uniting for the purpose of defraying the expense of educating some individuals who may be known to them respectively as possessed of good character and adequate talents.

8. Whereas many appropriations have been made for the Horton Institutions since their origin, which must be regarded rather as laying a foundation for future operations than as realizing present results, and

Whereas the current annual expenses are so very considerable as to require without delay some permanent provision to meet them,

Therefore Resolved, That the enlargement of the sphere of our Collegiate Institutions has become now a question of first and vital importance, as ensuring a greater number of friends, a larger influx of youth, to seek instruction, and a wider field of action for educated young men;—

That in order to this, immediate steps should be taken to secure, if possible among the Baptist population of Nova Scotia, New Brunswick, and Prince Edward's Island, and others friendly to our interests, an efficient combination of effort in sustaining one place of higher Education, and providing at the same time as many subordinate and tributary schools as possible.

In fulfilment of Resolution No. 6, which recommends the gathering of contributions to the amount of £125 among the churches, as a response to the paternal provision of our friends in England, a subscription was forthwith entered into by individuals present, chiefly in behalf of the churches which they represented.

2. In reply to the same church recommending some action with reference to the licensing and ordaining of ministers, the Committee

beg to report with reference to Licentiates. They are of opinion that no church has a right to expect that their license to a brother to preach shall extend beyond their own church, as otherwise their brethren of other churches would be deprived of the right of judgment; a license being in fact nothing more than a certificate that the church conferring it are of the opinion that the brother receiving it possesses gifts that may be usefully improved; but while no other church can be bound to receive such licensed brother, and no offence ought to be taken if they refuse to do so, yet a license is justly considered as a recommendation of a brother by his immediate brethren as possessing gifts for public teaching, which is advantageous as a recommendation, though it ought not to be regarded as binding on other churches. Nothing herein is intended to lessen the importance of licenses; on the contrary, this Committee are of opinion, that no brother from another church ought to be rashly invited to preach without a license, or other satisfactory credentials respecting his character and gifts. In order to guard against the granting of licenses unadvisedly, this Committee would recommend to churches never to grant them unless a council of ministers and delegates of other churches shall first have been called, and shall have sanctioned such a measure.

The Committee further report in reply to the letter before named, that with respect to the subject of ordination, this Committee are of opinion, that this subject is gone into so fully in the Circular Letter now presented to the Association, that it is not necessary further to

notice it on the present occasion.

3. On the Westbrook Letter the Committee report, that they recommend the Association to nominate a Council to inquire into the
matters in difference, and to endeavour to remain with the church a
sufficient length of time to bring the brethren if possible together,
and to make their decisive report at the next Association.

4. On the Question referred by the 2nd Cornwallis Church, the Committee report, that, in their judgment, no brother can sue at law another brother in the church without a violation of the law of Christ, except in some very extraordinary case in which it is evident that

### CIRCULAR LETTER.

The Elders and Messengers composing the Nova Scotia Baptist Association, assembled at Amherst, to the several Churches which they represent,—wish grace, mercy and peace, from God our Father, and from the Lord Jesus Christ.

DEARLY BELOVED BRETHREN,

The subject upon which we wish to address you this year, is, the "Christian Ministry," a subject, as you will readily admit, of vast importance. According to that form of Church Government which we have adopted as most scriptural, every Church is an independent body, and possesses the privilege of regulating its own affairs, being, as a Church, responsible to no power except that of the Supreme Head. You possess the right of choosing your own pastors. No earthly power can compel you to sit under or support a ministry which is distasteful or unprofitable to you. Along with this privilege, however, there rests upon you, as growing immediately out of it, a fearful responsibility—for, by it you are rendered accountable for the character of your ministers. Upon yourselves rests the duty of choosing such only as are sound in the faith, duly qualified for the work, and adapted to your circumstances.

Taking this view of the subject, you will be prepared to appreciate the instructions and admonitions which it is our privilege to address to you. Our object is, simply to refer you to what the scriptures plainly dictate respecting the part which you have to perform in the appointment of ministers.

I. And first, you should prize the gospel ministry as the peculiar gift of heaven. "When he ascended up on high, he led captivity captive and gave gifts unto men. And he gave some apostles, and some, prophets, and some, evangelists, and some, pastors and teachers, for the perfecting of the saints, for the work of the ministry, for the diffying of the body of Christ." Eph. iv: 8—12.

II. It is the prerogative of the Great Head of the Church to call men into the ministry. He only can fit them for this sacred office; He only can sustain them in it, and render them successful. "Pray ye herefore the Lord of the harvest that he would send forth labourers

into his harvest." Mat. ix. 38. "Take heed therefore unto all the flock over which the Holy Chost hath made you overseers." Acts xx: 28. See also verse 24, and Gal. i: 15, 16. Luke vi: 13. Mark iii: 13. Rev. i: 20.

III. This prerogative by no means forbids the employment of secondary agency. As in our "Effectual calling," which is the work of the Holy Spirit, there is also a call addressed to the outward ear through the instrumentality of duly appointed means; so may it be in the special call of an individual to the work of the ministry. In either case the outward call may precede, and be the means used by the Holy Spirit in order to effect by his own mighty working the inward call. In this manner was Matthias called "to take part of this ministry and apostleship from which Judas by transgression fell." Acts i: 15-26. Paul and Barnabas were in this way called to go as missionaries among the heathen. Acts xiii: 2. And with this position and these examples accord the directions given to Timothy and Titus, respecting the "ordination of Elders in every church." Titus i: 5-9. 1 Tim. iii: 1-7.

IV. The churches should earnestly desire and pray for an increase of gospel ministers. "Lift up your eyes and look upon the fields! they are white already to the harvest." John iv: 35. "The field is the world." Mat. xiii: 38. "The harvest truly is plenteous, but the labourers are few. Pray ye therefore the Lord of the harvest, that he would send forth labourers into his harvest." Mat. ix: 37, 38. Beloved brethren, look upon this field! how vast its extent! how abundant the harvest! what multitudes are falling into ruin! how few are the labourers! Hear you not those cries of agony and despair sent forth by the millions who are hastening to the judgment-seat unblest by the gospel! O brethren, think of the wants of a perishing world, and remember the gospel only can save them; and your sympathy with a suffering Saviour will be awakened, and one of your most fervent petitions will be, that the Lord of the harvest may send more faithful labourers into his harvest.

V. The churches are bound to look out carefully and call forth such men as, by possessing the required qualifications for the ministry, give intimation that such is the will of God concerning them. May that day never dawn in which our churches shall consent to dispense with that evidence of piety and of a special call to the work of the ministry, hitherto deemed indispensible! Let no one presume to take

upon him this sacred office without a well grounded persuasion that he is moved thereunto by the Holy Ghost. This caution, is, however, as we have already shown, by no means opposed to the duty just laid down. Indeed, this duty arises directly out of the one previously stated. For if we are bound to pray for any blessing, we are bound at the same time to use every proper method for obtaining that blessing. This duty arises too out of the plain and acknowledged fact, that the church is bound to cultivate all her talents in the most effectual way. If she possess gifts for the ministry, she is bound in faith and holy zeal, to bring them forth, and place them upon the altar for the divine acceptance. And should the Lord condescend to accept the sacrifice, the favour conferred by its acceptance, could not surely be valued less because the prayers and the rigilance and the exertions of the church had been called into requisition.

VI. The churches are bound to prevent, as far as possible, the introduction of improper persons into the ministry. "But though we or an angel from heaven preach any other gospel unto you, than that which we have preached, let him be accursed." Gal. i:8, 9. "If there come any unto you and bring not this doctrine, receive him not into your house, neither bid him God speed; for he that biddeth him God speed, is partaker of his evil deeds." 2 John x: 11. "And thou hast med them which say they are apostles and are not, and hast found them liars." Rev. ii: 2. (See also 2 Cor. xi: 13.) "If any man teach otherwise,—from such withdraw thyself." 1 Tim. vi: 3—5. "Lay mands suddenly on no man, neither be partaker of other men's sins."

VII. We are bound to study carefully the instructions and admonilims of the Sacred Scriptures upon this subject (as upon every other)
and most sacredly to adhere to them. Happily for us, these instructions
we very minute and explicit. The various duties, trials, encouragements, &c. of ministers, are to be found in many parts of the Sacred
folume; but, in the Epistles to Timothy and Titus, express directions
we given on the subject of ordination; and the qualifications which

"If any man desire the office of a bishop, he desireth a good work. A bishop then must be blameless,—the husband of one wife, vigilant, sober, of good behaviour, given to hospitality, apt to teach, not given to wine, no striker, not greedy of filthy lucre, but patient, not a brawler, not covetous, one that ruleth well his own house (for if a man know not how to rule his own house, how can he take care of the church of God?),—not a novice, lest being lifted up with pride he fall into the condemnation of the devil; moreover, he must have a good report of them which are without, lest he fall into reproach and the snare of the devil." 1 Tim. iii. 1—7.

Here, brethren, is a plain directory, from which we should never deviate. To be unacquainted with it, or unskilful in applying it, would argue great neglect and criminality in those upon whom devolves the duty of deciding whether a man is or is not qualified to enter the ministry. On this account, it will be proper here briefly to consider each particular separately.

1. "If any man desire the office of a Bishop." A desire for the office, is the first particular mentioned in the instructions given to Timothy. The term used by the apostle, signifies an intense desire; "to long after," "to reach after"-" ardently to desire." Such a desire we believe every man who is called to preach the gospel will have. It must spring from right motives. It must not be a desire for some secular object, to which the ministry is only to be subservi-The existence, the intensity, and the purity of this desire may be judged of from the manner in which the individual devotes himself to the glory of God and the promotion of the salvation of souls in the station which he already occupies in the church of God. But it is not sufficient that a man desire the office, however ardently, or that this desire spring from the purest motives. The Lord may be pleased that such a desire is in his heart, and yet He may deny its gratification. (See 1. Kings, viii: 18, 19.) Besides a desire, sixteen traits of character are mentioned in this same chapter, and just the same number in Titus i., corresponding in substance with these, as essential to qualify a man for the ministerial office.

Great sins committed before conversion, do not necessarily exclude a man from this office, (See I Tim. i: 13)—but since that period, he must have kept at the utmost distance from all immoralities. Time must have given weight to his professions, and uniform Christian consistency proved the sincerity of his repentance, and the reality and strength of his faith, before he can be properly eligible to the ministerial office.

3. The husband of one wife. It is on many accounts desirable that a pastor should be the head of a family, and a pattern of good works in all the domestic relations. We do not, however, understand this passage as absolutely enjoining this; but we view it as a prohibition relating to certain improper customs and habits, existing at the time the Apostle wrote, which had grown out of the former Jewish and heathen state of the newly formed churches; and which it required the utmost prudence in the Apostles and ministers to counteract and abolish. It is, however, more than sufficient to prove the compatibility of the marriage relation with the most exemplaary holiness, and the most sacred and laborious office, and it is completely subversive of the anti-Christian prohibition of marriage to the clergy, with all its attendant evils.

4. He must be "vigilant," that is, watchful; a man who keeps at the utmost distance from temptation,—who carefully watches over himself, his thoughts, his words, and his actions. How can he be fit to watch over others, who does not watch over himself? He must be quick to discern, and ready to guard against, the wiles of the enemy, and prompt to embrace every opportunity for doing good. He will manifest this essential qualification, by the uniformity and consistency of his Christian course. He who is careless, idle, or neglectful of his duties and engagements, even in temporal things, evinces a character which must undergo a complete revolution before he can be "a good minister of Jesus Christ."

5. "Sober;" having the mind, and the desires and passions, modetated and well regulated; in opposition to everything approaching to intemperance, extravagance or levity. He must be too, as the word implies, a man of prudence, one who avoids indiscretion in his words and actions. A hasty, trifling, indiscreet, vain, extravagant, or speculative cast of mind, will not do for the ministry.

6. "Of good behaviour." This obviously implies the strictest integrity, kindness, courtesy, meekness, and faithfulness, in all the

business and relations of life. He must be one who renders to no main evil for evil, but who ever follows that which is good, who "fears God and honours the king," who is "in subjection to the powers that be." Rom. xiii. 1. Neither countenancing, by example or connivance, the breach or the evasion of the laws of the land; but rendering unto all their dues—tribute, to whom tribute is due—custom to whom custom—fear, to whom fear—honour, to whom honour." Rom. xiii: 7. In all things shewing himself an example of Christian excellency and good works.

7. "Given to hospitality." This amiable disposition is just as necessary at the present day, as it was in the days of Paul, although from the difference in our customs, and our freedom from persecution, its existence may not now be demanded upon so extensive a scale as then, when there were no public inns, and travellers were in a great measure dependent upon private hospitality. Anything like a grudging, niggardly, covetous, inhospitable disposition, is always highly detrimental to the ministerial character. He who is not "a lover of hospitality, Titus i: 8—who does not actually take delight in sheltering and assisting the needy to the utmost of his ability, as well as in entertaining his friends, is ill prepared to meet without being disconcerted, the taxes which, through the kindness of many, and the thoughtlessness of more, will be continually made upon his hospitality, in case he becomes a settled minister.

8. He must be "apt to teach;" that is, ready at imparting instruction." This implies two things-1, The possession of knowledge; 2, A facility in teaching. What a man does not know, he cannot teach. And though he be ever so intelligent, yet if from any incapacity of utterance, or from any other cause, it shall be impossible or even difficult for him to convey his ideas to others, he is, of course, totally incapacitated for teaching. He who does not know by heart felt experience, the nature and efficacy of vital religion, can by no process of education, and by no combination of other endowments, be rendered a suitable religious teacher. It were better for him that mill-stone were hanged about his neck, and that he were drowned in the depths of the sea, than that he should attempt it. He could only be "a blind leader of the blind," and the result accordingly be, tha "both would fall into the ditch." The most exalted piety is not, how ever, of itself sufficient. He who is placed for the defence of the gos pel, must be prepared to defend it. "By holding fast the faithfu

All the ministers, exhibited in the New Testament as our examples, were able to do this. Not one of them was deficient in mental capacity, or knowledge. Their hearers could put the most implicit confidence in their statements, arguments, and conclusions. They never mis-stated facts; they never argued inconclusively or weakly. They were able to exhibit correctly and explicitly, all the doctrines, precepts, and privileges of Chrittianity. They could meet every case of doubt and perplexity. They used sound speech, that could not be condemned. They could instruct the ignorant, convince the prejudiced, and silence the obstinate. They were, in a word, "scribes well instructed in the kingdom;"" workmen who needed not to be ashamed;"" righty dividing the word;" "bringing out of the treasury" of Divine buth "things new and old," and "giving to each one his portion in due season." They obtained their knowledge, partly by ordinary means, and partly by those which were miraculous. For a number of years they attended the public lectures, private discourses, and familiar conversations, of the Lord Jesus Christ himself. edge of the different languages was communicated miraculously.-Their know-Here, then, are the examples of Scripture combined with its precepts. Abishop or pastor must be "apt to teach." Reason and experience perfectly coincide on this point with the Scriptures.

We do not mean to intimate that no man can preach the gospel without a collegiate education; nor do we here pretend to mark exectly the amount of knowledge which he must possess who is fit for ordination. But he should at least be well acquainted with his Bible, and be possessed of general information sufficient to prevent him from being pitied or despised for his ignorance by an intelligent congregation; and sufficient to enable him to instruct an ignorant people, should he be placed over such. According to this direction, the candidate for ordination must be examined respecting his attainments in theological and general knowledge, and his ability to teach; and unless he be capable of teaching aptly, he must not be ordained.

9. "Not given to wine." This term does not absolutely enjoin toall abstinence from all intoxicating liquors; though it certainly sancins such a course; and such was manifestly the usual practice of

thy, we recommend as the safest and best. No man can be useful as a minister, who manifests any love for intoxicating liquors; and none such should on any account be ordained.

10. "No striker." He must be prepared by a proper control of his passions, to exercise self-denial in this respect also. He must be a man whom no provocation, however undeserved or sudden, would induce to retaliate by striking the offender. A hasty, passionate man,—one who is easily excited to anger and resentment, is disqualified for entering the ministry.

11. "Not greedy of filthy lucre." No man can be useful as a minister of the gospel, if it be suspected, upon any reasonable grounds, that he is actuated by the love of money. How can he admonish with effect the worshippers of mammon, who himself bows at the same shrine? He who has recourse, for the sake of gain, to any unlawful or disreputable business, hawever needy his circumstances, must not be ordained a bishop. Such a man cannot consistently be regarded as a Christian.

12. "But patient;" able to endure hardness as a good soldier, and prepared to meet, with cheerful resignation, the trials incidental to the ministerial office. A man of a fretful, peevish, complaining, murmuring disposition,—or who is not endowed with mildness, gentleness, and clemency, is hereby pointed out as unfit for the ministry.

13. "Not a brawler;" not quarrelsome; not contentious. He must be a man of peace, and a peace maker, guarded equally against giving or taking offence easily.

14. "Not covetous;" neither desirous of that which belongs to another, and which he may not lawfully obtain; nor tenacious, to any degree of avarice, of that property which is his own.

15. "One that ruleth well his own house." An essential part of a pastor's business is "to rule well." I Tim. v. 17. Heb. xiii. 17. To do this, he must possess a peculiar tact. In no place can his ability to govern so readily appear, as in his own family. If therefore his own children are unfaithful, are accused of riot, or unruly, and are not held in subjection with all gravity, their disobedient, disrespectful, and disorderly conduct, will prove to a demonstration, that however good a man he may be in other respects, he is incapable of taking care of his own house. influence in suppressing disobedience to parents and to God, and in counteracting and subduing pride, vanity, worldliness, and immorality, in the church and in the world around him, if he fail to do this in his own family? The manner in which the apostle enlarges upon this particular, shows its importance. No man, therefore, who is incapable of "ruling well," can be called of God to take the pastoral charge of a church; such an one must not be ordained.

"16. "Not a novice." This word signifies a young convert. The ardour and zeal in the cause of God which such usually manifest, should be carefully cherished. They should be taught to devote themselves wholly, "body, soul, and spirit," to the service of the great Redeemer. But their zeal should be directed into the proper channel. Young converts cannot, without the greatest caution, be put forward to take the lead in exercises of devotion, or the business of the church, without great danger to their humility and spirituality.—Such must on no account be thrust into the ministry, "lest being lifted up with pride they fall into the condemnation of the devil."

17. Finally, it is not sufficient that the broad shield of christian chanty can be thrown around him. It is not enough that his brethren can bear with him, overlooking his infirmities, excusing his follies, and forgiving his faults. Nor is it even sufficient that he may be in high repute for piety in the church. "Moreover, he must have a good report of them which are without." The world must do homage to the grace of God which is in him. They must have no cause to suspect him of improper motives or misconduct. A minister of our holy religion, must, in order to give weight to his ministrations, not only be unsuspected, he must also be above suspicion. He, therefore, whose character, in the eyes of the world, is bad, or, upon any just grounds, suspicious, should not be suffered to enter the ministry until that repreach is removed, lest he be caught in some of the snares which satan will lay for him, and fall into reproach, bringing dishonour on himself, the sacred office, and those who ordained him.

It may not be amiss to remark, that it is expressly stated that all these traits of character, and not merely one or a few of them, "must" be found in the man who is properly qualified to enter the ministry. Nor can we suppose the inspired apostle has required impossibilities, or exhibited merely an imaginary character. These directions imply that men may be found possessed of all these qualifications. It will, however, be readily admitted, that in order to conduct properly

the examination of a candidate for the ministry, according to this directory, it requires no ordinary degree of skill and careful investigation. Hence follows

VIII. Another plain and exceedingly important direction, "Lay HANDS SUDDENLY ON NO MAN." 1 Tim. v. 22. This refers to ordination (see chap. iv. 14; 2 Tim. i. 6), and forbids all hasty ordinations. The rule is made universal, -" on no man;"-however well you may be acquainted with him; however well satisfied respecting his call to preach, and however urgent the necessity for an ordained ministeryet time must be taken-delay must be submitted to,-no man must, on any account, or under any pretence, be ordained suddenly. The Great Head of the church has given this command. All experience proves that a departure from it is fraught with the most disastrous consequences. How can it be ascertained whether any individual does or does not possess all the qualifications included in the previous seventeen particulars, unless time be taken for the examination? Surely a hasty passing visit from a stranger, cannot be sufficient to decide the choice of a church, in a matter of so much importance. We must not imagine for a moment, dear brethren, that we are secure from the possibility of deception and imposture. There exists still a necessity for "trying the spirits," according to the scriptures, whether they be of God; "for many false prophets have gone out into the world."-1 Tim. iv. 1. Nor let any imagine that an imposter can in all cases be easily detected. Error can assume the garb of truth. "Even Satan is transformed into an angel of light, therefore it is no great thing if his ministers also be transformed as the ministers of righteousness." 2 Cor. xi. 13-15.

But the detection of imposture is not the only reason for caution and delay. A man may be no impostor; he may be sincere and really pious, and yet totally mistake his calling; and be unfit for the ministry, tho ever so desirous of entering it. Again, a man may be really called of God to the work, and may possess every necessary accomplishment, and still need time and opportunity in order to become perfectly satisfied of this himself, as well as to make it manifest to others. On every account, therefore, a prudent delay in ordaining, or licencing a man to the work of the ministry, is indispensable, if we would obey the injunctions of the Great Head of the church, consult the best interests of the individual himself, or study the peace and prosperity of the churches. Without intending to attach any

1X. All the directions in the New Testament respecting the qualifirations required in those who enter the ministry, were given to ministers. They are found, not in the Epistles directed to the churches, but in Timothy and Titus. They were evidently given them as a rule by which they and all other ministers were to be guarded in the duties of their station, (see I Tim. 3. 15). And this seems evidently to imply that in the business of deciding upon the fitness of any individual for the ministry, as well as in his ordination, those who are already in the ministry, and who like Timothy and Titus are possessed of experience judgment and influence, are to be consulted. Christian lumility and prudence would suggest to the newly ordained and mexperienced, the great impropriety of their proceeding with an ordination without the assistance of their more aged and influential wethren. Nor are ministers to be consulted exclusively in this matter; or certainly since no man can be more deeply concerned in it than the candidate himself, it were absurd to suppose that his views and judgment are not to be consulted. He must be satisfied respecting his call and his qualifications too, -since the one involves the otherbefore he can consistently enter the ministry. No man should enter upon a work of such fearful responsibility without being fully persnaded in his own mind. But is he to be the sole judge in this matter? Can any man ordinarily pronounce with impartiality, correctness, and certainty, concerning his own abilities? Is not elf-knowledge of rare and difficult attainment? man more readily prove his unfitness for the ministerial office, than by despising the advice and counsel of wise and good men? The best men are liable to judge amiss, even of their own moives. They may be wholly unacquainted with the peculiarities of their own character. Nothing is more common than for a man to be mistaken respecting his competency to fill a particular sta-Many of those traits of character, above enumerated, essential the ministry, are of such a nature that others, and not ourselves, must be the judges whether we possess them or not. Hence follows aplain rule, which we would, dear brethren, affectionately and earestly urge upon you-never consent that one of your number shall eceive ordination or a license to preach merely because of his anxiety or importunity to become a preacher. To give a man a license

to preach, in other places, in order to get rid of him, if we are satisfied that he is unfit for the work, would be most injurious and sinful.

Again, if each church has the right of choosing its own pastor, they must be able, and it must be a part of their duty to judge of a minister's qualifications.-But this by no means militates against the propriety of seeking the counsel and assistance of others. See Prov. xi. 14. xv. 22. And would it not be well, especially where any room for doubt or mistake exists, for each church to make it a rule neither to call or dismiss a minister, without seeking counsel and advice from sister churches? Choosing a pastor, however, and judging of the fitness of a man for ordination, though sometimes coinciding, are yet two distinct and separate things. It is of the latter we are here particularly treating. And who so competent to decide a question of this kind, as those who are of standing experience, and influence in the ministry? aided, of course, as they should in every instance be, by the testimony and advice of the church of which the candidate is a member, and the community in which he resides? And would any church, we would ask, or any men going forth to proclaim the name of Christ, be displeased or dissatisfied to know, that they possessed the confidence, approbation, and co-operation of the body of ministers and churches with whom they were associated? Who would not rejoice to possess deservedly the approbation of all good men? On the other hand, could any thing be more unpleasant and painful to any church or minister, next to a consciousness of being under the frown of heaven, than to know that the charches and ministers, around them, condemned the steps they had taken, and were opposed to their ordination? Could any man 'not self-willed,' and possessed of the feelings of a christian, or even of a reasonable creature, endure to enter the ministry under such circumstances? We think not. Under every view therefore of this subject, we are satisfied that the course we have hitherto been in the habit of pursuing,-that of calling a council of ministers, before proceeding with an ordination, is most scriptural and judicious. We are also more and more convinced that the advice so often elicited from this associated oody, that no church should licence a man to preach, except by the advice of a similar council, can with propriety or safety be neglected. Those who sit in council upon an affair so momentous, should certainly seek aid and wisdom from above; and be careful to seek the promotion of truth and righteousness, and to guard against all improper motives. They should see to it that their judgemen is not warped, nor their decisions influenced, by any personal regard for the in dividual, or any respect for his feelings and wishes, or those of his friends; other wise they cannot expect the approbation of heaven.

Beloved brethren, we would affectionately urge upon your attention the contents of this our annual address. That the Lord may add to your numbers and to the numbers of his faithful ministers, a thousand fold, is our earnest prayer; and "may the whole earth be filled with his glory, Amen and Amen."
