The Sheriff shall, immediately upon receipt of his copies, cause one of them to be posted up in a conspicuous place on the Court House; the Clerk of the Peace, upon receipt of his copies, shall cause one of them to be posted in a conspicuous place in his Office; every Public or Separate School Head-master or Mistress shall in like manner put up one on the door of the School House; and every Post-master shall post up one of his copies in his Post Office.
