

An Act to incorporate the European Assurance Society, and to authorize the acceptance of the said Society as surety for Public Officers.

HEREAS, by an Act of the Imperial Parliament, made and passed in the twenty-second year of Her Majesty's Reign, chaptered twenty-five, the European Assurance Society was incorporated under a certain deed of settlement, dated the second day of September, in the 5 year one thousand eight hundred and fifty-four, which said deed of settlement was by the said Imperial Act modified in some particulars, and confirmed in all other respects, And Whereas, by an Act of the Parliament of this Province, made and passed in the session of Parliament held in the twenty-seventh and twenty-eighth years of Her 10 Majesty's Reign, chaptered seven, and intituled, "An Act to authorize the acceptance of certain incorporated companies as sureties for public officers," it is, amongst other things, in effect enacted, that the bond or policy of guarantee of the European Assurance Society may be accepted as security, as is in the said last-mentioned Act particularly 15 mentioned; And Whereas the last mentioned Act has been found insufficient for the purposes intended, And Whereas the said company have by their petition prayed for an Act incorporating the said Society, and authorising the said Society to give security for public officers in place of trust under Her Majesty, and for enabling such security to be accept-20 ed on behalf of such persons; And Whereas it is expedient to grant the prayer of the said petition, and to extend the provisions of the said Act of this Province. Therefore, Her Majesty, by and with the advice and consent of the Legislative Council and Assembly of Canada, enacts as follows:

- 25 1. The European Assurance Company is hereby declared to be a duly Incorporated Company within this Province, and as such, shall have, hold and enjoy, all and every such and the same powers and privileges in this Province, and of carrying on the several objects for which the said Company was established, as are granted and conferred to and upon the said company, by the said recited Act of the Imperial Parliament, and the Deed of Settlement of the said company, as modified and confirmed by the said Act, and a copy of which said deed of settlement, certified under the hand of one of the directors, and of the secretary in this province, of the said company, shall be registered in the office of the Provincial Registrar, and a copy of which, duly certified by the Provincial Registrar, or his Deputy, shall be prima facie evidence of such deed of settlement
- 2. The Governor in Council may direct that a bond or policy of guarantee of the European Assurance Society may be accepted as such 40 security upon such terms as shall be determined by the Governor in Council, and either in lieu of any other security required by law to be given, or n addition thereto, or to any portion of such security, from any

public officer who is required by any statute or otherwise, to give security for the due fulfilment of the duties of any effice to which he may be about to be appointed, or of which he may then be the incumbent, or for the due fulfilment of any obligation undertaken towards Her Majesty, or any person or persons for or on behalf of Her Majesty, and the European 5-Assurance Company shall have full power and authority to enter into and give a bond or policy of guarantee for the purposes aforesaid, and if it be expressed in the body of such bond or policy of guarantee, or by endorsation thereon, that the said bond or policy is to be exempt from the operation of any of the clauses of the said deed of settlement, 10 or of the said Imperial Act, the said bond or policy shall accordingly be exempt therefrom; but no such bond or policy shall be deemed accepted unless and until approved by the Governor in Council, and the same shall be in heu of any other security required by law to be given by such public officer, or in addition thereto, or to any portion of such 15 security, as may be stated in such approval of the Governor in Council.

3. The words "Public Officer," in this Act, shall mean and include any and every person or persons who may now hold, or may be hereafter appointed to, any office or place, or appointment under Her Majesty or under the Government in this Province.
