Strikers and Police Battle With Bullets

Serious Rioting at Fort William When Striking Longshoremen Attack Special C. P. R. Constables.

WINNIPEG CAVALRY ARE HURRIED TO THE SCENE FORT WILLIAM, Ont., Aug. 12.—(Special.)—In a clash between special C.P.R. constables and a crowd of striking longshoremen this morning bullets flew promiscuously for a few minutes. Revolvers and rifles were the weapons and while there were no fatalities, several men were seriously wounded.

CHIEF BALL of the C. P. R. police, wound in abdomen. SERGEANT TAYLOR of city police, slightly hurt. C. M. DICKINSON, reporter for Times-Journal, slightly hurt. W. C. CARRUTHERS, C. P. R. constable, knee badly smashed. JOHN LANE, butcher, forehead grazed by bullet. GEO. ANDERSON, shot thru the leg.

STRIKERS: Foreign leader shot thru groin; another thru arm; several others slightly wounded. For some time, things have been threatening among the foreigners who constitute the freight handlers, and it is feared that they will use 200 mauler rifles in these now lawless hands.

Threats have openly been made as to the appearance of the militia and prominent officials, including the chief of police, would be murdered, this last being attributed to a well-known Italian agitator.

Martial Law Declared. This afternoon a detachment of the 9th Regiment was called out. Mayor McTavish read the Riot Act, and the waterfront was declared to be under martial law.

The Riot Act was never before read in Fort William. Assembled were a number about 120, while thousands of citizens thronged the streets and heard the mayor, the chief of police and Col. Steele give addresses.

It was not until after 5 o'clock tonight that the militia, about 120 men, put in an appearance. They were lined up on McTavish-street from the freight shed on the west side of the street, front and rear, and then from a box Mayor Pelletier harangued the crowd, explaining that it was owing to them having disregarded his advice and his efforts to make a settlement which had made necessary the calling out of the soldiers.

The mayor also urged the men to return to work and all might be satisfactorily settled, and this was translated into various tongues.

The battle occurred at the corner of McTavish-street and the C.P.R. sheds. About 9 a.m. the C.P.R. brought in about a dozen constables and the P. R. station they were sworn in and then started for the coal docks. On the C. P. R. bridge were standing about 30 strikers, who followed the constables down Hardy-street. Near the sheds about 200 strikers gathered, looking for trouble.

A Rush For Rifles. "Bring rifles," was then the cry of the strikers, and about a dozen men rushed to nearby houses and came out with rifles. Sheltered by the corners of houses, they continued the skirmish and showed no signs of retreating.

Since the trouble at noon comparative quiet has prevailed. The strikers are still in possession of the sheds. The militia is still in possession of the waterfront.

'BADDECK' HOPS FOR SOLDIERS

Army Experts at Petawawa Witness a Successful Try-out of New Aerodrome.

PETAWAWA CAMP, Aug. 12.—(Special.)—"Baddeck No. 1," the new Canadian aerodrome, at 5.30 to-night for the first time left the ground, making a short "hop" of about seventy feet in length and rising 9 or 10 feet from the surface. Only one test was made.

The aerodrome went along the roadway for nearly half a mile at a rate of at least thirty miles to the hour. When J. A. D. McCurdy, the aviator, turned the controller upwards, the drone gracefully shot into the air, but he at once turned the controller down again and the drone took the ground easily.

McCurdy does not consider this an ascent; "merely a little hop," said he. "We will make another for three or four days we have got to make little hops like that to get acquainted with the ground."

Col. Fleet, deputy minister of militia, said: "The aerodrome makes great time and looks good. It is wonderful, wonderful. McCurdy is a plucky chap. They are wise not to attempt too much at first. I believe the Wrights in Washington kept the public waiting eight days before they made their aerodrome, but did not care to express an opinion."

It is understood that the aviators will make short "hops" for the next day or two and probably begin longer ascents about Tuesday or Wednesday.

While it is too early for anything definite yet, the machine seems to be well put together and it is fully expected it will be a success.

Over two hundred, including automobile parties from Pembroke and elsewhere, witnessed the flight. The militia department officials here will remain over until to-morrow's test and will return to Ottawa on Monday.

Before the flight the big field was cleared of all spectators. This morning Colonel Fleet said: "I do not think Col. Steele will be so fond to purchase an aerodrome of the present experimental stage. There is not enough known about them yet to warrant the government buying them."

LITTLE WILLIE CRABTREE DROWNS IN HUMBER RIVER

SON OF LATE COL. LEYS 'CONTESTS MOTHER'S WILL

With Two Companions Had Been Swimming—Body Recovered in 15 Minutes. William Thomas Edgar Crabtree, a twelve-year-old lad, residing at 7 Humber-street, York township, was drowned in the Humber river, opposite the Lambton golf links, about 5 o'clock last evening.

Crabtree, who is the son of the late Col. Leys of London, Ont., this morning filed a petition in the probate court asking that the probating of the will in London be not permitted, but that a former will executed in 1903, and which he declares to be the rightful one, be probated in Detroit.

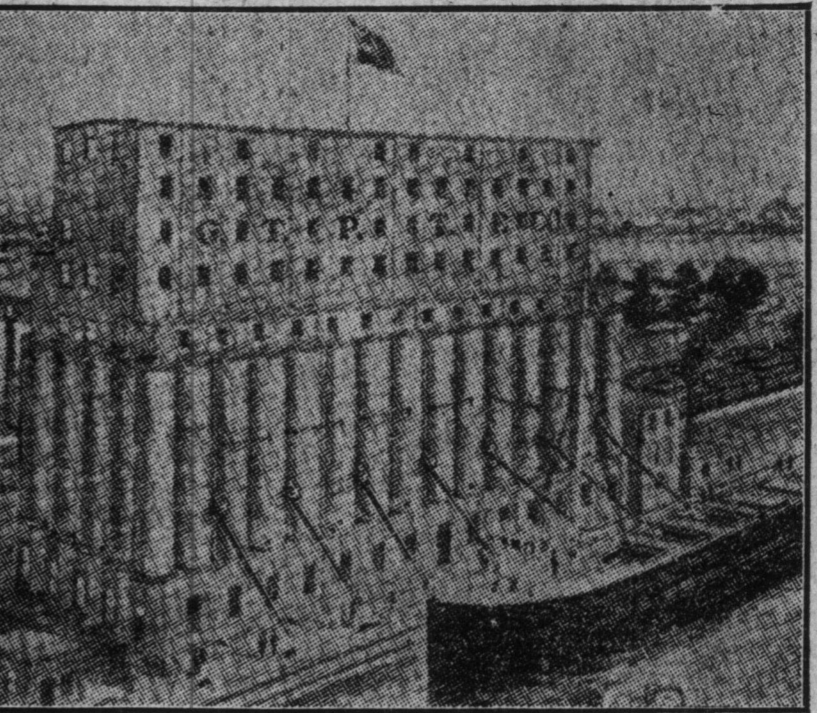

THAW'S MOTHER BERATES JEROME

"Arrogant, Vindictive Persecutor of a Sane, Acquitted Man," She Declares. WHITE PLAINS, N.Y., Aug. 12.—This afternoon a statement from Harry Thaw came indirectly from the jail physician, Dr. William J. Meyers, who testified at the hearing as one of the prisoner's witnesses and declared Thaw perfectly sane.

Thaw told him, Dr. Meyers said, that while he was disappointed by Justice Miller's decision to-day, declaring him insane he had no intention of giving up the fight.

"I am determined to make my final effort to secure a trial by jury," said Thaw. "I am more sorry for my mother than for anybody else. When I first got the news of Justice Miller's decision, I called my sister Alice on the telephone and asked her to give my mother the news of my acquittal. I was shocked at it as much as possible."

"My fight is now centered upon the appeal to the court of appeal thru which I hope to secure a hearing before a jury."

Late to-night, Mrs. Thaw, after talking over the situation with her son, wrote out the following statement for the Associated Press:

"Let no one imagine for a moment after reading this opinion of Judge Miller, that it means a victory for the district attorney of the county of New York."

"One by one the delusions which he and his alienists started out were proven, each by the mouths of several witnesses, to be stubborn facts, that would not drop at his bidding. Compliments For Jerome. "Every word was taken on under that arrogant, vindictive persecutor of a sane, acquitted man."

"So baffled was he that when he rose to make his closing speech, his argument (it was not), he had more the appearance of a school boy compelled to say a piece than the sometimes courageous, mature sophist, who dominates the courts of his own judicial district, except when wealthy malefactors are under trial."

"The license allowed him during the entire hearing to torture and insult in every possible way the man who at every turn showed himself reasonable, courteous, and every-where a superior—appeared to all unprejudiced minds to indicate but one thing. To all it looked as if the judge in allowing such unparalleled opportunity for every form of brutality was actuated by a desire to prevent his charging at the end that he had not had every opportunity to strain to the utmost the power of entrusting the man who for the time is in his power."

"It is impossible to fathom the workings of the human mind, and the reason for this totally unexpected and cruel decision of the trial judge must remain a mystery."

"I will continue struggle. "Meanwhile my son's daughter and I have no alternative but to take up again the burden I had every reason to believe was behind us forever. We, exiled from our country, will remain close to the gate, and so help the son and brother to endure an existence which the official will be a man of death itself, trusting in God's overruling providence in His own good time to vindicate the right."

"In his hour of decision, Justice Miller gently chided Mrs. Thaw for her previous census of District Attorney Jerome of whom he said: "I am sure of the evidence of any heartlessness or undue zeal on his part."

MOVING PICTURE SHOW HAD AISLES BLOCKED

And a Summons is Issued—Ald. Forth Fails to Make Charges Against Ward Foreman.

HAMILTON, Aug. 12.—(Special.)—The Crystal Palace Co., East King-street, a small moving picture concern, has been summoned to police court Friday morning, on the charge of allowing the aisles of its theatre to be blocked during performances.

There was a warm time this afternoon at the meeting of the board of w.ks. to investigate the graft charges made by Ald. Forth against some of the ward foremen, who, he said, would demand payment in whisky or money for loads of material removed from the streets. Ald. Forth said that he had made no charge, but that he had simply stated what reputable citizens had told him. Most of these happened to be out of the city at present, but if they would allow their names to be used he would make an attempt to substantiate the charges.

Mr. Solman proposed that the city and the company each take half of the block, thereby adding to the area of Memorial Park, which contains about eight acres, and giving the company the space to make up for the land to the north taken over as a park. Mr. Solman's idea was explained to the committee by Chairman Ald. J. J. Graham, and appeared to impress the members favorably. It was agreed that Mr. Solman should consult with Assessment Commissioner Forman, Park Commissioner Wilson and Deputy City Engineer Scott in drafting a definite plan to be submitted to the island committee.

Directors Will Meet. The directors of the Toronto Ferry Co. are not expected to meet for a week to discuss what will be done in regard to Hanlan's Point. E. B. Osler of Osler & Hammond, president of the company, is out of town. Men are working on the rains now, cleaning up the odds and ends.

SPANIARDS OF TITLE ENLIST IN THE ARMY

Dukes and Viscounts Are Serving as Privates With Request to Be Sent to Front.

NEW YORK, Aug. 12.—The Herald's Madrid correspondent cables: The enthusiasm shown by the high classes to take part in the African war is daily increasing. The Visconde de Saragossa has been allowed to enlist in the ranks. His example has been followed by the Duke de Bivona, who is a deputy from Jaca; the provincial deputy from Saragossa, Senor Solana, and Don Gregorio Lagranja of Gallur, and his son.

The Duke and Duchess de Medina Riosco are in Mellilla. The duke, who is a private, is now a corporal, fulfilling military duties like any other man in the ranks. He does not accept any privileges and behaves as a most disciplined and hard working soldier. The Duchess is acting as a nurse at the military hospital. The young Duke of Medina Riosco is universally considered one of the most beautiful women in Spain.

The Conde de Montijo, Don Leopoldo Mazas Don Juan Quirós, Don Federico Baxan and Don Justo San Miguel, all bearing well-known names, have enlisted as privates in the Barastro Battalion, which is about to leave for Mellilla.

The Marquesa de Povaleja is at Malaga organizing a new ambulance service and boats for transportation of the wounded from Mellilla to the city.

The Junta of women of Spanish nobility, organized by Queen Victoria and presided over by the Marquesa de Squilache, which has inaugurated charitable works in connection with the war, is rapidly collecting funds, which amount now to nearly 100,000 pesetas. While such evident proofs of patriotism are being given in high quarters, the mass of the people are furnishing no less eloquent examples of devotion to the flag. The newspapers are full of reports of the subscription raised by soldiers in hand to hand fights with ferocious Moors.

The Andalusians carry their "navajas" (long, jaiting knives), because they feel more confidence in the "navaja" than in the bayonet in case of personal encounter.

Madrid's voluntary militia, composed of merchants, merchants' clerks and landed proprietors, has offered its services to the government for garrison duty in the capital, in view of the large number of regulars sent to the frontier. This offer has been accepted, and the treasury and finance departments and other public buildings are guarded by militia.

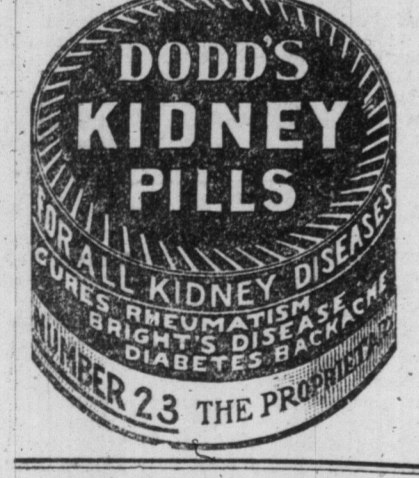

ATTITUDE OF ALLIANCE ON SUNDAY ICE CREAM Sabbath Observance Secretary Expounds Its Policy—Annual Conventions.

Rev. T. Albert Moore, Secretary of the Lord's Day Alliance, returned to the city yesterday. Speaking to the World of the activity of the Toronto police in regard to the sale of ice cream and soft beverages on Sundays, Mr. Moore said: "The alliance has never instituted any prosecutions in Toronto. It has not been necessary. The alliance, however, enforces the Lord's Day Act by the city police. Its attitude in regard to the sale of ice cream at other times is a violation of the law, and because its indiscriminate sale would entail unnecessary Sunday work on at least 2000 people in Toronto."

Secretary Moore said he noticed an editorial in The World on the prosecution of 11 persons on charges of selling ice cream on Sunday, and one person for selling liquor at Port Stanley. There was no discrimination in that against the ice cream dealers. The aim of the Lord's Day Alliance was to abolish as far as possible, unnecessary Sunday labor.

The annual conventions of the provincial Lord's Day Alliance were announced yesterday. They will all be attended by Secretary Moore. The dates are Prince Edward Island, Nov. 1; Nova Scotia, Truro, Nov. 2; New Brunswick, St. John, or Moncton, Nov. 4; Quebec, at Montreal, Nov. 9; Ontario, at Toronto, Nov. 12; Manitoba, Winnipeg, Nov. 14; Saskatchewan, Regina, Nov. 18; Alberta, Edmonton, Nov. 22 or 23; British Columbia, Vancouver, Nov. 26.

OTTAWA SCHOOL TAX DISPUTE Separate Board Will Sue City on a Peculiar Contention.

OTTAWA, Aug. 12.—There is going to be trouble in Ottawa between the separate school board and the city over the question of school taxes. A number of Catholics annually, by request to the assessors, have themselves put down as public school supporters, the public school rate being lower than the separate. This has been the practice for years without question, but the separate school board now claims that a separate school supporter, to change to the public schools, must formally notify the city clerk, which has never been done. The separate school board will therefore sue the city to recover all back taxes transferred "by request." A large sum is involved, and it was announced to-day that the city will fight the case in one which will act as a precedent throughout the province.

AN OFFICIAL "CUSS" WORD Waterville, Kansas, Decides to Permit "By Chawder" as Expletive.

WATERVILLE, Kan., Aug. 12.—"By chawder" is the official swear word in Waterville now. The people of this burg cannot use any cuss word stronger than that under pain of going to jail. The street loafers, it was charged, became so profane that the women of the town hesitated about going out on the streets. They would rather stay at home than hear men using vile language. The merchants felt the loss of the women's trade keenly and prevailed upon the city council to enact a law against swearing. In obedience to the demand the council made it a misdemeanor punishable by a fine and imprisonment to swear within the city limits. In order to help the cholic cussers out the council ruled that the women should not be considered a swear word under the new law.

TWO DREADNOUGHTS FOR CHILL. VALPARAISO, AUG. 12.—The naval council has recommended to the government the construction of two battleships of the Dreadnought type.

SIX HUNDRED HOUSES SWEEP AWAY. MONTEREY, Mex., Aug. 12.—The Santa Catalina suffered from a disastrous overflow, returned to its banks to-day, leaving a scene of desolation and destruction in the instance of Monterey. At least 14 persons were drowned. At San Luisito, a suburb, more than 600 houses were swept away. The bath house was washed and one man lost his life in the swimming pool.

GOLD IN NORTH LAND Reports of Rich Discoveries Along Line of T. & N. O.

Reports are in circulation of a discovery of gold at Night Hawk Lake, near Matheson, on the line of the Temiskaming and Northern Ontario Railway. Knowledge of the discovery has been in the hands of the commission for some time, but only this last few days has it been noted in mining circles. A. J. McGee, secretary-treasurer of the Temiskaming and Northern Ontario Railway Commission, states that the extent of the deposits are at present unknown, but that a number of prospectors have gone into the country.

NO CHANGE FOR YOUNG TURKS Will Not Be Able to Swing Turkey, Says Prof. Wicher.

"I don't think the Young Turks will be able to swing Turkey," said Rev. Prof. Wicher of the San Francisco Theological Seminary, who is spending a few weeks in Toronto on his return from a year spent in Palestine and the near east. "Of course it would be the best thing if they could, but the fact is, Constantinople is not Turkey, and they can't control the forces opposed to reform in the country districts. They will have to wait until they sent a commission down to enquire into the massacres at Adana. The only hope for the Young Turks is the utter lack of leaders in the Old Turk party." Mr. and Mrs. Wicher had the unpleasant experience of being stoned by Mohammedans in El Medjel, in Palestine. Besides Egypt and Palestine they visited Greece and Constantinople, coming across Europe thru Belgrade and Buda-Pesth.

Writa Issued. The Dominion Brewery Co., Ltd., of Toronto is asking for a writ against R. H. Garbutt of Toronto to recover \$3298.55 for money lent, for interest and for goods sold and delivered. Writ has also been issued against Mr. Garbutt by the Reinhardt Salvador Brewery, Ltd., to recover \$2822.59 under a chattel mortgage, and by George J. Foy. Hiram Baker of Toronto is entering action against Dr. J. H. McConnell of Toronto for damages alleged to have been sustained from the defendant's negligence as a medical man in setting the plaintiff's leg.

An Illegal Bonus. The applicants, besides objecting to the sale of 27 acres when the block was understood to contain only 22 acres, argue that the city in undertaking to dredge a channel held out an illegal bonus to the company.

ROBERTSON INJUNCTION OVER TILL SEPTEMBER What Will Council Do With Respect to Land Outside the Twenty-Two Acres?

September 20 has been fixed as the date for the adjourned hearing of the argument on the injunction obtained by J. Ross Robertson, to prevent the city from disposing of property on the bay front to the National Iron Co. Chancellor Boyd will sit on the case. The postponement was made by mutual consent, on the request of the city when the case came up before Justice Meredith yesterday. If the deal should go thru the council in some other form, Mr. Robertson must have time to secure a new writ. In the meantime the injunction stands. James Bicknell, K.C., appeared for Mr. Robertson and Assistant City Solicitor Wm. Johnston, for the city. Not Clear Yet.

The situation arising out of the proceedings to prevent the city from selling the Cherry-street property to the National Iron Co. has been by no means cleared by the postponement of the argument. The question to which no definite answer appears to be forthcoming is: what is the city council going to do in the meantime? It was announced several days ago that a special meeting would be held to ratify a new transaction whereby the company would pay for the additional acreage, not understood to be in the justice when terms were agreed upon. Yesterday Boyd made it clear that the injunction was only granted with respect to the particular transaction made, but as Assistant City Solicitor Johnston stated yesterday afternoon, any new transaction which was not essentially different from the original one, might give the applicants ground for applying for a fresh injunction.

WASHINGTON, Aug. 12.—It is estimated that the cost of holding the special session of congress to pass the tariff bill was at least \$500,000. This does not include the increased expenditure in printing the hearings before the ways and means committee, the various reports and documents, the congressional record, the tariff bill in its various stages and the Payne law as finally enacted. Accurate information as to the additional expense incurred by the government printing office is not available, but it is estimated to be as much as \$300,000 or \$400,000.

BRITAIN AND SOUTH AFRICA. The New York Evening Post says editorially: Dr. Jameson and Gen. Botha, sitting side by side on the steps of the throne in the house of lords, while the colonial secretary asked for the second reading of the bill to create a South African commonwealth, in which Briton and Boer should have equal rights—this is the astonishing and gratifying spectacle which England is able to offer to the world. Who could have believed it possible, when the desolating war in South Africa was raging, so short a time ago? It is a vivid proof that Great Britain has not lost her acquired skill in colonial administration. So healing and constructive a piece of legislation as this

HIS WORSHIP OF COBALT.

We publish a letter from Mayor Lang of Cobalt, in reply to an article in our columns dealing with that town and suggesting a commission, rather than municipal government, to straighten out the tangle that exists in that enterprising place.

Furthermore, Cobalt, in order to get fairly going and to straighten up, must borrow money, and a commission appointed by the government would be the best means by which to secure money sufficient to make the town substantial and to finance the laying of streets and to provide water drainage and other improvements.

The mayor admits that the taxation of the town is now limited, under the World's plan the landowners of the mining companies would be removed, municipal taxes would be levied on the mines in the present town and on the mines adjoining it so as to give Cobalt the income necessary for her municipal requirements.

Because Mayor Lang is annoyed with the Temiskaming Railway Commission it does not follow that the right kind of a municipal commission would be equally offensive to him.

When Mayor Lang talks of a Greater Cobalt he is borrowing from The World; we believe a great mining city, with hotels, stores, civic improvements, uniting Halleybury, Port Cobalt, Cobalt, is rapidly growing together on Lake Temiskaming.

MONTREAL ALDERMAN SAYS MONEY'S WASTED

City Buys 20,000 Tons of Macadam a Year That it Could Get From Its Own Quarry.

MONTREAL, Aug. 12.—(Special.)—The evidence given before the royal commission by Ald. E. Larivière at today's session was by far the most important heard since the opening of the enquiry into the roads department administration.

Mr. Larivière, who had been chairman of the roads committee for four years, declared that the administration of this department, the most important of the city hall, was neither adequate nor practical.

He also declared that the system of patronage now in vogue was most damaging to the interests of the city. There was only one remedy to stop that patronage system and that was, to have the aldermen elected by the whole people of Montreal, stated Ald. Larivière.

As to the relation between the Danforth stone and the New York blue-stone, he said that the latter was preferable, tho it was cheaper. However, the council decided to buy the Danforth this year.

Ald. Larivière stated that there was no plan of the City of Montreal, and the city was paying for damages every year because of actions taken by proprietors who had built according to the direction of the inspectors and to the contractor when permanent pavement and sidewalks were built later before their dwellings.

Mr. Larivière also made the statement that the city was losing money on every ton of the 20,000 tons of macadam bought annually for the repairing of the streets, since the same macadam could be made from the local quarries, which belongs to Montreal and is perfectly equipped, but is not now in use.

Other witnesses, employees of the road department, corroborated Mr. Larivière's statements.

CARS KEPT ON MOVE

Except When Herd of Elephants Wouldn't Leave Tracks.

Manager Fleming's plans for an uninterrupted car service during the circus parade yesterday were somewhat upset by the elephant contingent of the big show. The cars had been kept pretty well on the move, but on Col. lego-street the herd of pachyderms got on the tracks and held the right of way for a long stretch despite the efforts of the attendants at switch points. Meanwhile the cars in the rear moved slowly but noisily along, the motorists clanging bells and making other manifestations of disapproval. This brief interruption was very little to ruffle the general manager.
