THIRTEENTH SESSION, 1882.

WEDNESDAY, JULY 5th.

Pursuant to notice, published in the Royal Gazette in accordance with the 13th Article of the Constitution, the Synod of the Diocese of Fredericton met on this day in the School Room of Trinity Church, in the City of St. John, at half-past nine o'clock, A. M.

The Lord Bishop of the Diocese in the Chair. Prayers.

The Lord Bishop read the resignation of the Rev. Francis Partridge, Secretary of the Synod.

Moved by the Rev. Canon Brigstocke, seconded by the Hon. Judge Wilkinson, that the Rev. O. S. Newnham be requested to act as Secretary pro tem., and that a Committee of two be appointed, to whom, with the Secretary, shall be referred all Certificates of Lay Delegates, and all assessments paid, to report concerning the same as soon as possible. Carried.

To The Right Reverend THE LORD BISHOP of Fredericton; The Reverend THE CLERGY; and

The Representatives of the Laity, of the Church of England in the Diocese of Fredericton in Synod assembled.

The Memorial of the Rector, and of the Rector, Church Wardens, and Vestry of the Parish of Saint Paul, in the Town of Portland, in the City and County of Saint John,

Humbly Sheweth:

That the Parish of Saint Paul was set off from the Parish of Portland, and established as a Parish for all purposes Ecclesiastical or relating to the Church of England under authority of an Act of Assembly (19 Vic. c. 50) passed in 1856, which provided as follows:— That from and after the second Monday in May, in the present year, that part of the Parish of Portland, in the County of Saint John, which lies to the Eastward of a line drawn along the centre of the street passing over the Mill Bridge, and extending Northwardly to the Kennebecasis River, shall be and the same is hereby declared to "be a separate and distinct Parish for all purposes Ecclesiastical or relating to the Church of England, by the name of 'the Parish of Saint Paul; "-and, further, that "all and every the clauses, enactments and provisions of Title XXVIII, Chapter 107 of the Revised Statutes, 'of the Church of England,' shall extend to the said Parish of Saint Paul, erected by this Act, as fully and effectually as if herein specially enacted."

That certain persons claiming to be members of the Church of Engand have recently erected a proprietary chapel within the limits of the said Parish, and in the vicinity of the Parish Church, and services professedly in connection with the Church of England have been conducted therein by the Reverened John M. Davenport, who claims to hold the license of the Bishop of the Diocese, contrary to the expressed dissent and protest of your memorialists.

That your memorialists are advised that such services and proceedings are contrary to the law of the Church of England, both in England itself, and in New Brunswick.

That your memoralists believe that such proceedings are a great injustice to the lawful Rector of this Parish, and will put an end to all security enjoyed by the Clergy in their ministrations, and prove a serious injury to the Church in this Diocese.

Your memoralists, therefore, beg most respectfully to call the attention of your Lordship and the Synod to the subject, and to express the hope that it will be taken into your most serious consideration.

EIGHTH REPORT

OF THE

BOARD OF FOREIGN MISSIONS

FOR THE DIOCESE OF FREDERICTON.

(Established by the Diocesan Synod A. D. 1874.)

To the Diocesan Synod of Fredericton:

At the last meeting of the Synod, the Board of Foreign Missions of this Diocese, established by the Synod A. D. 1874, was divided into two Boards, to be known hereafter as the Board of Foreign Missions and the Board of Domestic Missions; the former Board not being interfered with, as already constituted, beyond limiting its duties to the aiding of mission work among Jews and Heathen in countries beyond this Dominion.

The members of this Board therefore beg respectfully to report that, subsequently, at a meeting held conjointly with the Board of Domestic Missions, the Rev. Canon Brigstocke was appointed joint Secretary, and W. M. Jarvis, Esq., joint Treasurer of the two Boards. After which, the Board of Foreign Missions met from time to time without any very practical results beyond consulting together what best might be done, and receiving and answering one or two communications sent by the Board of Foreign Missions of the Provincial Synod.

Further, the operations of your Board, during the past year, have been confined to mission work outside the Dominion connected with three Societies:—The Society for the Propagation of the Gospel in Foreign Parts, The Church Missionary Society, and The Society for Promoting Christianity amongst the Jews, to whom remittances, as shown in the Treasurer's account, were made.

Your Board, while refraining from going into any lengthened details with regard to the two great Missionary Societies of the Church of England, and its oldest and chiefest Society in connection with the Promotion of Christianity amongst the Jews, feels bound to express its thankfulness for the good measure of success which has been vouch-safed to all of them during the past year.

"The Society for the Propagation of the Gospel in Foreign Parts," which held its 181st Anniversary meeting on the 25th of last April, reports its gross receipts to be £134,978 17s. 8d. for the past year, and that during the same period its regular income had increased over £4,000. The number of ordained missionaries on the Society's list was 594, of whom 188 are returned as laboring in this Dominion, and the remaining 406 amongst British subjects in other Colonies and Dependencies of Great Britain. The Report also contains letters from the Bishops of the various Dioceses which had been assisted by the Society's funds, setting forth the permanent spiritual results of its labors which had come within their cognizance, full of interesting statements relative to the past, and holding out encouraging hopes for the future.

"The Church Misionary Society" held its 83rd Anniversary on the 2nd of last May. Its field is the Heathen World, and its sole object is to win souls to Christ. The Report for the past year was of the most encouraging character, the gross receipts amounting to £212,910 11s. 9d., and indisputable evidence is afforded therein that by the instrumentality of this Society the purpose for which it exists is, through God's blessing, eminently successful. The Society, or the native churches dependant upon it, have now 417 clergymen, 2,252 lay agents and 537 female agents (not including missionaries wives); total, 3,206, including those who are laboring in the North-West of this Dominion. Its operation is carried on in more than forty different languages. And one more interesting fact is that nearly 300 of the Society's native converts have been admitted to holy orders, of whom upwards of 200 are still laboring in connection with it. On the river Niger all the clergy are colored men, with a colored Bishop at their head. At Sierra Leone not only are the clergy colored men, but they are supported by their own people. As is also the case in some parts of India.

The London Society for Promoting Christianity amongst the Jews held its 74th Anniversary meeting on the 5th of last May, reporting an income of £37,055 19s. 2d. exceeding that of the former year by upwards of £2,800, which was a source of much gratification to the Committee and its friends, as being one evidence, among others, of an increase of zeal for missions to Israel. It is difficult to understand how members of the Church of England can fail to take an interest in the welfare of the Jewish people. Using as we do Jewish records, and Jewish formularies; singing as we do the songs of Zion, how is it possible not to take a deep interest in the promotion of Christianity amongst the Jews? The fearful persecutions and wrongs to which the Jews of Russia, and other places of Europe, have been subjected, have doubtless drawn more attention towards them, increasing the sympathy and efforts of the Christian Church in their behalf, while at the same time they may be preparing that ancient people to turn unto the Lord, when his word shall be fulfilled. "They shall remember me in far countries; they shall call upon me and I will hear them, and I will say, It is my people." With regard to the progress of mission work amongst them, which is certainly bound up with obstacles and impedi-

ments unknown in any other mission field, there is much to encourage those whose expectation is from the Lord. Thus, one of the Society's missionaries, the Rev. Dr. Stern, has himself within the last ten years baptized nearly two hundred Jews and Jewesses; and the baptismal register in the Chapel of the Society in Palestine Place, London, which till within the last few years was the centre of the Society's Home Mission, contains the names of more than 800 Jewish people who during the last twenty years publicly avowed their faith in Christ crucified.

And in that country where the pioneer missionary laborer, Henry Martyn, gave his life for the Gospel's sake, it is cheering to know that from thence urgent calls have been received from Jews themselves for Christian instruction which have been responded to by the Society, which is now establishing a vigorous, and as it is to be hoped a permanent, mission in Persia.

The sums received by the Board for these Societies during the year 1881-2 have been as follows:—For the Foreign Missions of the S. P. G. \$385.70; for the C. M. S. \$80.66; and for the S. P. C. Jews, \$178.08. The Board gladly notice an increasing interest in the work of Foreign Missions throughout the Diocese, evidenced by an increase in the number of parishes or missions sending contributions from 34 in 1879-80, and 30 in 1880-1, to 39 in the year now closed.

FIRST REPORT

OF THE

BOARD OF DOMESTIC MISSIONS

FOR THE DIOCESE OF FREDERICTON.

(Established by the Diocesan Synod 1881.)

To the Lord Bishop of Fredericton,

and members of the Diocesan Synod:

Your Board of Domestic Missions, having been only established one year, has no lengthened report to make of its labors; nevertheless, there are several points of interest connected with its work to which it gladly draws attention.

We record with pleasure that a much larger sum than last year has been contributed to the Diocese of Algoma, and that some contributions have been received for the North-West Missions. By the Treasurer's report of last year, it will be seen that the total amount raised for that Diocese was \$464.72; while during the year just ended it was \$788.52, showing an increase of \$323.80. This sum does not include all that is contributed to Algoma, as some parishes which support children in the Indian Homes send direct to the Homes, and not through our Diocesan Treasurer. Seventeen dollars and fifty-three cents have been received for the North-West. The details of these amounts will appear in the Treasurer's report.

In the month of April an appeal to the Clergy and Laity was issued, calling attention to the claims of Algoma and the North-West Territory, as well as reminding them of the appointed day of Intercession for Missions. As regards that day we would here say, that it seems to be very generally considered an inconvenient season for its special work. We nevertheless trust that until any change be duly made, it will be regularly observed in every Parish, that so united intercession may not cease to be offered up on behalf of the Church's unity, and the extension of her Missionary work.

Turning to the field of labor committed to our care, we find several points worthy of record. On the 7th December, 1881, the Bishop of Algoma was taken to his rest, and our Missionary Diocese was deprived of its faithful, loved, and devoted Head. During the eight years of his Episcopate his labors were abundant, and were carried on amid much discouragement, and with much self denial. His untiring zeal, his simple devotion, and his deep piety, made him the loved friend and trusted counsellor of his Diocese, and leaves an example worthy of close imitation. His work, necessarily arduous and difficult, was eminently

During his short Episcopate the number of the Clergy successful. increased from seven to fifteen; Church buildings from nine to forty; and the congregations from fifteen to upwards of ninety. We believe that no more rapid progress has been made in any Diocese on the Continent, and that the Church may look with pride and thankfulness on this her first Missionary venture. To fill the vacant See the Provincial Synod was summoned by the Metropolitan to meet in Montreal on It did so with much anxiety, as the question arose whether or not Algoma should be maintained as a separate Diocese. We rejoice to say that after full deliberation the Synod resolved to maintain it, and to ask the Church to make the salary of the Bishop \$4,000 per annum. The first nomination was the Rev. Edward Sullivan, D. D., Rector of St. George's Church, Montreal, who was unanimously elected. The Church is to be congratulated on the appointment, and will, we trust, show her appreciation of the noble self-sacrifice made by Dr. Sullivan in accepting it, by giving him at all times her full sympathy, and much self-denying help. We are credibly, though unofficially, informed that the Venerable Society for the Propagation of the Gospel in Foreign Parts has made a grant of £1,000 towards the endowment of the See of Algoma on conditions that a sum of £4,000 be raised elsewhere for the same object within the next five years. We trust that the sum required will be raised, that so the grant of the S. P. G. may be secured.

By the North-West Territories is to be understood that vast extent of Country comprised within the four Dioceses of Ruperts Land, Moosonee, Saskatchewan and Athabasca, but the attention of the Church is more especially directed to the Diocese of Ruperts Land, out of which the others were formed, and in which the Province of Manitoba is situated. All are aware of the great and rapid increase of population in that country, and it is easily seen that except the resources of the Church are very largely increased it is quite impossible for her to meet her requirements. To assist in doing so, is the Church in Canada being called to the work, and she has already made a beginning. In a communication from the Bishop of Ruperts Land which appeared in the Montreal Gazette, April 27, it is stated that within the present year \$600 had been received from the Central Board, \$600 from the Diocese of Quebec, and \$350 from St. James' Cathedral, Before the year closes, we hope that many further sums will be added to those received.

The idea is prevalent that the settlers have more or less of capital, and therefore require no help from the older Dioceses of Canada, or elsewhere. On this point we quote the Bishop of Ruperts Land: "I "am afraid," he says, "from what we learn, that many Churchmen in "Canada do not realize the situation of these settlers. "the sale of property in the old Provinces, have come with means to us. "Farmers doing this, I presume, usually have several sons for whom "they take free homesteads in our West. By the time they have built "houses on these and stocked their farms at an expense unknown in "Ontario, probably few of them have for a year or two any spare money. "It is said too, that many earnest Churchmen of means have left "parishes in the old Provinces west, who should enable us to get on "very well for ourselves. We should be glad to be furnished with the "names of such Churchmen. As a fact most of our immigrants "have little or no capital left after they arrive here, and lay out two or "three hundred dollars in necessaries."

It is clear that if the Church of England does not come forward liberally at this juncture she will lose for ever the honor that now awaits her of being the Church in that country. On this point we quote the words of one not of us, and which will be taken as an impartial judgment. The author of "From Ocean to Ocean," thus writes: "The duty that now devolves upon the Episcopal Church in Canada "is to follow up its own children settling all over the North-West, and "to give them the form of service to which they are so profoundly "attached. If they neglect the duty of the present they can "never occupy hereafter the position in the North-West to which they "are historically entitled."

Most earnestly therefore we commend the work before us in Algoma and the North-West to the hearty support of the Churchmen and the Churchwomen of the Diocese, trusting that every Parish will make towards it a yearly contribution. In enriching others, we enrich ourselves, for he that watereth shall be watered also himself.

REPORT OF THE COMMITTEE ON SUNDAY SCHOOLS.

To the Lord Bishop of Fredericton and members of the Diocesan Synod:

The Committee on Sunday Schools beg to report as follows:

That owing to the Chairman, the Rev. E. S. W. Pentreath, leaving the Diocese during the year, your Committee have not been able to accomplish much. They have however pleasure in believing that the work of Sunday Schools is gradually developing, and becoming more and more throughout the Diocese a regular and efficient part of the work of the Church.

In Saint John the Teachers' Association continues its work with unabated interest. Its usual tri-monthly meetings and services have been regularly held.

The united Service of children of the various schools in the Deanery of St. John, was held in Trinity Church on Ascension Day, and was of particular interest, the Church being crowded in every part, and the children joining heartily in the service.

Several Teachers offered themselves as candidates at the Sunday School Teachers' Examination in connection with the Church of England Sunday School Institute, England, in May 1881, some of whom gained First Class Certificates, duly signed by the Archbishop of Canterbury and York, and the rest obtained Second Class.

Ten Teachers were Candidates at the present year's examination, the result of which has not yet been ascertained.

Your Committee draw attention to the work of the St. John Teacher's Association for the purpose of pressing the formation of similar Associations in every Deanery of the Diocese, and hope that before another year passes many others will be formed.




