# SESSION XV.

MONTREAL, Wednesday, Sept. 18, 1844.

The Rev. Alexander McKid, on the call of the Moderator, conducted the devotional exercises of the Synod, in praise, reading the Scriptures, and prayer.

Sederunt, as before, with the addition of Mr. Thomas Fraser, *Minister*, Mr. Hugh Brodie, and Mr. Angus Cattanach, *Elders*.

The minutes of yesterday's sederunt were read, and sustained.

Mr. Clugston having intimated his intention to secede from the Synod, and assigned his reasons for coming to this conclusion, the Synod appointed the following committee, to deal with him, tenderly and affectionately, viz., Mr. Machar, Mr. Simpson, Mr. Urquhart, and Mr. Mowat.

The Synod had transmitted to them, by their Committee of Bills and Overtures, a variety of papers from the adherents of the church, both in the congregations whose ministers have seceded, and those formerly vacant, craving the counsel, advice, and assistance of the Synod in various matters. The said papers having been read, and deliberated on, the Synod referred the whole of them to the following committee, viz., Mr. McGill (Convener), Dr. Liddell, Dr. Mathieson, Mr. George, Mr. Thompson, and the Hon. Mr. McGillivray,-with the following instructions :-First-To enquire into the course which should be pursued by the adherents of this church in regard to property belonging to the church, now in the hands of the seceding brethren :----Secondly. To enquire into the course of duty to be recommended to the adherents of this church, in localities where there are no ministers of the church, as to their attending on the ministry of the Seceders :- And Thirdly-To consider the course to be pursued in regard to session books :---And to report to the Synod to-morrow.

It was moved by Dr. Black, seconded by Mr. Urquhart, and unanimously agreed to, that the thanks of the Synod be given to Dr. Cook for the excellent sermon delivered by him at the opening of the Synod, and that he be requested to furnish a copy of the same for publication.

The Moderator produced and read a letter from the Colonial Committee of the General Assembly of the Church of Scotland, to this Synod. The tenor whereof follows :----

To the Moderator and other Members of the Presbyterian Church of Canada in connection with the Established Church of Scotland.

DEAR BRETHREN,—The Colonial Committee of the Church of Scotland embrace the earliest opportunity of conveying to you an expression of their sympathy in the painful and peculiar circumstances in which you are placed, as well as an expression of their highest approbation of your conduct in the trials with which you have been visited.

The Committee deeply regret that the dissensions which have so much disturbed the peace of the Church in our own land should have found their way to the land of your adoption, and that divisions so unseemly, and so injurious to the interests of religion, should have found a place among those, who, as the servants of one Master, and the ministers of one Church, had dwelt so long together, like brethren, in unity.

But we are fully persuaded that you are not the cause, and therefore not chargeable with the consequences, of this unhappy strife. You have maintained your principles with great steadfastness, and defended them with great ability, and you will have this testimony from the intelligent and upright of every country, that you have acted like consistent men and Christian ministers.

Your great offence, in the eyes of your opponents, seems to be this, that you refuse to disown a Church, which has done nothing to forfeit your affection, or call for such a deed on your part. The Church of Scotland has never claimed any authority, nor exercised any control over your Synod; neither has she ever possessed, nor desired to possess the right of any such interference. Her ambition and her efforts have been limited to the cultivation of brotherly affection, end the rendering of pecuniary aid to those who had many claims on her regard. Letter from the Colonial Committee. against her in your Synod, as formerly in many of her own courts, are as destitute of truth as they are devoid of charity, and we feel refreshed with the meekness and the power with which you have exposed and refuted all such errors.

Page Tenth.

You have our best thanks for the able manner in which you have pleaded the cause, and vindicated the principles of our national establishment. The Church of Scotland continues to possess, as she has ever done, spiritual independence and spiritual freedom ; and those who say that she has surrendered her liberty, either ignorantly misunderstand or wilfully misrepresent her condition. She is jealously alive to all undue interference with her rights and privileges, and as she never has compromised, so we trust she never will compromise, her character, by giving up what necessarily belongs to her as a Church of Christ. And adhering to her in her day of trial, you will be gratified to learn that almost all the vacancies created by the painful and extensive secession which took place in May, 1843, have been filled up with able and acceptable ministers, and that she is now in a state of as great efficiency as in the brightest days of her past history.

Attached as you are to our country by the ties of birth and kindred, and to our Church by a full approbation of her doctrines and discipline, we cannot doubt that the remembrance of former times will cause you to feel more than a common interest in all that is passing amongst us : and we beg to assure you that such recollections strengthen the affection we should ever cherish toward you, as they will increase our efforts to promote your peace and advance your prosperity. With you the harvest is great, and the labourers are few, and we feel ourselves called on, by every consideration, to assist you to the utmost of our power.

We are not ignorant of the means that have been employed to entice the people among whom you labour, to leave your ministry; of the efforts that have been made to sow the seeds of dissention among yourselves; and though these endeavours have been attended with partial success, we yet rejoice to think that so large a majority of the office-bearers of your Synod and of your people have resolved to maintain their connection and intercourse with the Church of Scotland. This resolution we regard as alike worthy of your intelligence, in us sincere ples succeeded in which has eve your welfare.

It is our confident hope, as it is our earnest prayer, that the Master whom you serve may support you under all your trials, and direct you in the path which He himself will approve, so that all events, however seemingly adverse, may be overruled for promoting His own glory and the good of those that love Him.

Knowing well the peculiar difficulties with which you are encompassed, we beg to repeat the expression of our sympathy with you in all your trials, and to renew the assurance we have given, that you shall have all the assistance at our command, in whatever way and at whatever time it can be rendered.

The Synod agreed to record the high satisfaction with which they have received this kind and affectionate letter of the General Assembly's Colonial Committee, feeling, in present circumstances, the importance, to this church, of the ample recognition, therein contained, of the spiritual independence of this court, and duly appreciating the affectionate and Christian temper which the whole communication manifests. And the Synod do further declare the deep interest which they must ever take in the well-being of the Church of Scotland, and their earnest desire that all its divisions may be healed,—that every thing in its condition or its administration fitted to impair its usefulness and efficiency may be removed,—and that the time may speedily come when the national church shall embrace the whole population of our beloved country.

# Page Twelfth.

The Synod instructed the Moderator to transmit an extract of this minute to the Convener of the General Assembly's Colonial Committee.

The Committee appointed to revise the Records of the Synod reported that they had examined the same, and found them accurately and carefully kept,—and recommended the Synod to attest them. The Synod ordered the records to be attested, which was done by the Moderator accordingly.

The Synod appointed Mr. Andrew Bell to be Synod Clerk.

The Synod having called for the report of the Committee on the circumstances of the adherents of the Church in those congregations whose Ministers have seeded from the Church, the same was given in and read by Mr. McGill.

The Synod sustained the report, and, after mature deliberation, ordained as follows :--

I. Respecting the property of the Church that may be put in peril by the recent secession.

Where the majority of a congregation have seceded and continue to hold the Church property clearly deeded to a congregation in connection with the Church of Scotland or with this Synod, the Synod recommend that the minority shall not relinquish their right to the property, but, for the sake of peace and with the hope that the present division shall be healed, that they shall use all forbearance and discretion in the assertion of their rights; and that they shall not bring the matter to issue in a court of law, unless they are constrained thereto by continued and wrongful possession on the part of the majority.

With the view of preventing, so far as possible, the evils of litigation, the Synod appoint the following committee to meet a committee to be appointed by their Seceding brethren, if they shall approve of the measure, to whom conjointly all disputes and difficulties connected with church property, shall be submitted for advice, viz. :

For Canada West.—Rev. John Barclay, Toronto; John Cameron, Esquire, Toronto; Dr. Telfer, Toronto; Archibald Barker, Esquire, Markham.

For Canada East.—Rev. Dr. Black, Montreal; Hon. Peter McGill, Montreal; Andrew Shaw, Esquire, Montreal; John Boston, Esquire, Montreal. And in ca mittee at th appointed by

The Synod, taking into consideration the lamentable evils of the recent disruption,—continuing to regard with sincere affection their protesting brethren,—and earnestly desiring the restoration of union, declare their willingness to enter into correspondence with them on this subject, and appoint the following as a committee to confer with any committee to be appointed by their protesting brethren, should they deem it expedient to make such appointment, viz., Rev. Dr. Cook, Quebec; Rev. Robert McGill, Niagara; Hon. Judge McLean, Toronto; Rev. Principal Liddell, Kingston; Hon. John Hamilton, Kingston; Rev. Hugh Urquhart, Cornwall; Hon. The said Committee reported that they had prepared an answer, which was given in and read by Mr. George, the Convener. The further consideration of the same was deferred until to-morrow.

Act anent spiritual independence. with ; and although the independence and freedom of this Synod, in regard to all things spiritual, cannot be called in question, but has been repeatedly and in most explicit terms affirmed, not only by itself, but by the General Assembly of the Church of Scotland, yet as in present circumstances it is expedient that this independence be asserted and declared by a special act :

Page Sixteenth.

It is therefore hereby declared, That this Synod has always claimed and possessed, does now possess, and ought always, in all time coming, to have and exercise a perfectly free, full, final, supreme and uncontrolled power of jurisdiction, discipline and government, in regard to all matters, ecclesiastical and spiritual, over all the ministers, Elders, Church Members and congregations under its care, without the right of review, appeal, complaint or reference, by or to any other Court or Courts whatsoever, in any form or under any pretence; and that in all cases that may come before it for judgment, the decisions and deliverances of this Synod shall be final. And this Synod further declares, that if any encroachment on this supreme power and authority shall be attempted or threatened, by any person or persons, court or courts whatsoever, then the Synod, and each and every member thereof, shall, to the utmost of their power, resist and oppose the same. And whereas the words in the designation of the Synod, "in connection with the Church of Scotland," have been misunderstood or misrepresented by many persons, it is hereby declared, that the said words imply no right of jurisdiction or control, in any form whatever, by the Church of Scotland over this Synod, but denote merely the connection of origin, identity of standards, and ministerial and church communion. And it is further enacted and declared, that this supreme and free jurisdiction is a fundamental and essential part of the constitution of this Synod; and that this may be fully known to all those who may hereafter seek admission into our church, it is enjoined that all the Presbyteries shall preserve a copy of this Act, and cause it to be read over to, and assented to by, every Minister and Probationer who may apply for ordination or induction into any pastoral charge.

the Committee had audited the accounts of the Treasurer, and found them carefully and correctly kept,-and showing the amount of the claims on the Synod Fund. The Synod sustained the report, and ordered it to be kept in retentis :----And inasmuch as it appears from the said report that there are many of the congregations in arrears for several years to the Synod Fund, the Synod, in accordance with the recommendation of the committee, instruct the clerk to transmit to the minister of each congregation a circular informing him of the years for which the congregation is in arrears,and in the case of vacant congregations, to transmit the circulars through the Presbytery Clerks. The Synod also instructed the clerk to furnish the clerk of each Presbytery with a summary of the arrears specified in the circulars sent to the several congregations within the bounds of such Presbytery. The Synod further enjoin ministers and congregations to pay immediate attention to this matter, and remit their arrears through the Presbytery Clerks,-and instruct Presbyteries to take immediate action to secure the payment of arrears by the congregations within their bounds.

Mr. Mowat gave in his resignation of the office of Synod Treasurer. The Synod accepted of the same;—and it was agreed that the thanks of the Synod be given to Mr. Mowat for the efficient and faithful manner in which he has so long attended to the interests of the church.

The Synod called for the report of the committee appointed to deal with Mr. Clugston,—when Mr. Machar (the Convener) reported on behalf of the committee that they had met with Mr. Clugston, and Mr. Gibb, the elder from the session of St. John's Church, Quebec, and dealt with them, but that both Mr. Clugston and Mr. Gibb had persisted in their determination to withdraw from this church. Synod to take some steps to provide the administration of ordinances in the Gaelic language, in said settlements. The Synod, after mature deliberation, instructed the Presbytery of Quebec to take such steps as to them may seem best for procuring a Gaelic missionary for these destitute settlements, and, in the mean time, appointed the Rev. Thomas Mc-Pherson, of Lancaster, to labour among them for at least one month during the ensuing winter.

The Synod had next transmitted to them, by their Committee of Bills and Overtures, an overture from the Presbytery of Montreal anent the administration of ordinances by ministers not having pastoral charges. The Synod, in conformity with the recommendation of the committee, and after full deliberation, ordained that no minister of this church, not having a pastoral charge, shall administer baptism, dispense the Lord's supper, or celebrate marriages, within the bounds of any Presbytery, without the sanction of such Presbytery having been previously obtained, or within the bounds allotted to any settled minister, without the consent of such minister;—and that any contravention of this rule shall incur censure, and, if repeated, such other exercise of discipline as the Presbytery of the bounds may see meet to inflict.

The Synod had also transmitted to them, by their Committee of Bills and Overtures, a memorial from certain members of the church at Smith's Falls, employed as lockmasters and lock-labourers on the Rideau canal, anent their exclusion from church privileges by the session of Smith's Falls, on the ground of their being obliged, under the present system of arrangements on the canal, to attend the locks on the Lord's Day, stating their case at large, and craving that the Synod would take their case into consideration and grant such relief as may seem to be required. The Synod referred the memorial to Mr. Urquhart, Dr. Mathieson, and Dr. Liddell, to consider the same and report to the Synod.

The Synod had transmitted to them, by their Committee of Bills and Overtures, a memorial from Messrs. The Presbytery of Bathurst reported that, according to the instructions of the Synod at last meeting, they had disposed of the case of the Rev. William Smart of Brockville, and the Rev. Robert Boyd of Prescott, and that Mr. Smart and Mr. Boyd had both withdrawn from the body. The Synod instructed the Presbytery of Bathurst to intimate to the Governor General the withdrawal of Mr. Smart and Mr. Boyd, and that they are no longer ministers of the Presbyterian Church of Canada, in connection with the Church of Scotland, or of the Church of Scotland in Canada.

Whereupon the Synod agreed heartily to recommend these school books to the notice of parents and teachers, and all others who feel an interest in the mental improvement of the youth of this country, or who exercise an influence ever their education. And instead of No. 10, the Treatise on Arithmetic, the Synod, on the suggestion of their committee, agreed to recommend to Messrs. Armour & Ramsay the re-publication of Murray's Commercial Arithmetic, on account of the clearness and fulness which the principles of the rules and the reasons of the several operations are explained and illustrated in that work.

The Synod called for the report of the committee on the memorial of certain members of the church at Smith's Falls, which was given in and read by Mr. Urquhart. After long deliberation, the Synod agreed to approve of the diligence of the session of Smith's Falls in this case; but, at the same time, considering the hardship of singling out for discipline a few out of the many persons, who, it is a matter of notoriety, are smilarly situated, the Synod recommend to the session that the memorialists be dealt with in all tenderness; and, inasmuch as that the suspension bears partially and injuriously on individuals instead of the numbers similarly circumstanced, the Synod recommend to the session to MONTREAL, Monday, Sept. 23, 1844.

After mature deliberation, the Synod instructed the Clerk to institute the necessary enquiries, and should it appear that the undertaking will meet with sufficient encouragement on the part of the office-bearers and members of the Church to ensure the defraying of the expense of publication without involving the Synod in any pecuniary responsibility, or should the publication be undertaken by a bookseller or publisher on his own responsibility, the Synod authorize the Clerk to publish a complete and uniform set of their whole minutes from the organization of the Synod in 1831, and to add, in the shape of notes or appendices, such further materials, drawn from the Records of Presbyteries and the documents in possession of the Synod as may be deemed useful or necessary for illustrating the minutes as well as the history and progress of the Church,-and for this purpose the Synod instruct Presbytery Clerks to furnish, from the records of their respective Presbyteries, the dates of the ordination and admission of their several ministers,-of their removals and deaths, where there have been any,-of the organization of congregations and sessions,-and short memoranda of any other matters that may be of historical interest :---and the Synod further appoint the remaining members of the first meeting of Synod in 1831 to be an advisory committee, to any of whom the Clerk may apply for counsel and direction in any matter connected with the publication of the minutes, or the selection of matter for the illustrative notes.

The Synod re-appointed the Members of the Presbytery of Montreal to be a Committee to carry on the French Mission, Dr. Mathieson to be Convener,-and instructed them to print the report just given in, or such portions thereof as they may see fit, with a list of the contributions, and circulate the same through the bounds of the Church ; and, besides their Annual Report to the Synod, the Synod instructed them, hereafter, to print and circulate throughout the Church, Quarterly Reports on the progress of the mission. The Synod further instructed the Committee to take all prudent steps to raise a fund sufficient to pay off the debt on the French Church property lately purchased, and, if necessary, to send a deputation to the United States to receive contributions for this object ; and appointed trustees to receive and hold the said property in the name of the Synod.

The Synod, further, enjoin those congregations which have not, during the past year, contributed to the funds of the French Mission, to send in their contributions immediately,—and also recommend, to all the sessions and congregations in connection with the Synod, increased liberality and punctuality in contributing to the support of this important mission.

The Synod called for the Draft of the Letter to the Free Church of Scotland, which was given in and read,—and, having been maturely and deliberately considered, was adopted, and ordered to be engrossed for the signature of the Moderator.

The grand object for which we are called, as ministers and rulers of the Church, is to preach the Gospel of our Lord Jesus Christ to our fellow-sinners, and it will be our aim, with all diligence and prayer, to lead our people in the path of duty and finally to the inheritance of a blessed immortality. To this great work we trust we shall be enabled to devote ourselves with a diligence and fidelity that our Divine Master will bless and approve.

It is known to your Excellency that at our late meeting in Kingston a number of our Brethren conceived it to be their duty to separate from us mainly on the ground of our connection with the Church of Scotland, and the responsibility which that connection appeared to them to involve concerning recent events in that Church.

We have no wish to conceal that differences of opinion exist among ourselves on these points, but being in full and indisputed possession of all the freedom and privileges necessary to a Christian Church, and apprehending no danger of interference on the part of the Civil Powers with our Spiritual Jurisdiction, we are thoroughly persuaded that this diversity of opinion is a proper subject of mutual forbearance, and no valid ground for separation.

The evils arising from religious dissensions, especially in this land, both as it respects the progress of the Gospel, and social order, are so manifest that we shall continue to use every just and reasonable means to bring back our Seceding Brethren into their former fellowship with us. We are perfectly agreed in our adherence to the same Standards of Doctrine, Discipline, and Worship,—and the sole point at issue between us is, not any thing arising from our circumstances in this colony, but from the judgment formed respecting the circumstances which occasioned the disruption in the Parent Church, and the mode in which we should act on that judgment.

The Memorial of the Synod of the Presbyterian Church of Canada, in connection with the Church of Scotland—

HUMBLY SHEWETH :

That your Memorialists observe, with deep regret, the evils which result from the traffic carried on, upon the Sabbath, on the Rideau Canal.

That your memorialists regard the devout observance of the Sabbath as one of the most important duties of religion, and one of the chief supports of virtue, morals, and good order; and hence, they cannot but deplore the open, public, and continual desecration of that Holy Day, which is practised every season along the whole of that canal.

That by this practice, those numerous persons who are employed on, or in connection with the canal,—in the management of the steamboats, propellers, and barges, and the lock-masters and lock-labourers, are deprived of that rest which every individual in a Christian country ought to enjoy on the Sabbath; and, in various ways, the habit of Sabbath-breaking is formed or cherished in many, especially the young and thoughtless,—a habit which generally leads to other vices and crimes.

That, besides the evil consequences to which the practice directly or indirectly leads, and the offence which it gives to all well-disposed persons, your memorialists regard it as in itself sinful, an act of rebellion against that God, who commands all to keep the Sabbath holy, and, from the public nature of the offence, and from its being sanctioned in some degree, by the Government, involving the guilt of national sin.

That, so far as your memorialists can ascertain, no injurious effects, as regards the trade of the canal, would follow from closing it on the Sabbath ; and that, by a little attention, the owners and captains of steamboats could so arrange their business as to perform it on the six lawful days of the week :—in confirmation of which opinion, it may be menMemorial to the Governor General anent the Sabbath traffic on the Rideau canal.

The evil consequences of that division have unhappily extended to this province, although we entertained the hope that the wide difference between the position of our church and that of the Church in Scotland, would have exempted us from being involved in these contentions. In this expectation we have unhappily been disappointed, but no efforts shall be awanting on our part to restore that union which is so essential to the social order and spiritual well being of the Presbyterian body in this province, and which, as it appears to us, our relation to the Church of Scotland should never have disturbed.

In the prosecution of our labours, we are exposed to many difficulties and hardships; and when we consider the benefits which the diffusion of divine truth is calculated to confer on a country, we indulge the hope that your Majesty will ever preserve us in the secure possession of all our rights and privileges, so that we may be enabled to extend more widely throughout this province the blessings of religious and moral instruction.

We renew our wishes and our prayers for your Majesty's health, prosperity, and happiness, for your domestic happiness, and the success and glory of your reign. We implore the Almighty Ruler of the Universe, that He may endow your Majesty and your Royal Consort richly with all spiritual and temporal blessings, and, that after a life employed in the exercise of every public and private virtue, you may be at last received into His heavenly glory, through the merits of the Divine Redeemer.

After mature deliberation, the Synod agreed that the Rev. John Maclaurin, of Martintown, be sent as soon as possible on a missionary visit to the various Highland settlements in the western part of the province, where no regular minister is stationed, and to explain to the people, if he shall deem it expedient, the true independent position of this Synod. The Synod instructed the Presbytery of Glengary to devise means for defraying his travelling expenses, and supplying his pulpit during his absence;-and recommend the ministers, who are stationed in the vicinity of those places which Mr. Maclaurin may visit, to accompany him in his visitations and assist him by their advice and co-operation. And in the event of the negotiations for re-union with the seceding brethren failing, and of the continuance of their attempts to alienate the affections of the people from this church, the Synod instruct the Commission to select at least two ministers, suitably qualified, and to send them forth to the places where their services may be most needed, to vindicate the Synod in its present position and use their best endeavours to build up the church in those places, to organize congregations, and to direct them, as they best can, into the means by which they may procure the settlement of pious and able ministers among them.

The Synod called for the report of the Commissioners on the Clergy Reserves, which was given in and read by the Convener. The Synod ordered the said report to be kept in retentis.

The Rev. John Machar having resigned his office as a Commissioner of the Synod under the Clergy Reserve Act, the Synod appointed Charles Tait, Esquire, of Montreal, to be a Commissioner of the Synod in his stead, and instructed the Clerk to communicate to the Governor General this alteration in the list of the Commissioners.

I trust that the only difference which exists does not necessarily render such a measure impossible; and I have great gratification in learning that your endeavours will not be wanting to produce that desirable result. Religious dissensions can hardly fail to be followed by great evils; while blessings are sure to attend on union, harmony, and brotherly love."

### To the Moderator of the General Assembly of the Free Protesting Church of Scotland.

REVEREND SIR,-We, the Ministers and Elders of the Presbyterian Church of Canada, in connection with the Church of Scotland, in Synod assembled, feel ourselves constrained by an imperative sense of duty to ourselves, and the people under our care, to address to your church a few words of remonstance, respecting the course of conduct which you have pursued towards the Presbyterian Church in this country. unquestioned right of jurisdiction in all things spiritual; we naturally supposed, that we were not called either by duty or expediency, to agitate questions which neither did, nor could practically concern us.

Amid many difficulties and privations, which are neither experienced, nor conceived of, by ministers of any denomination in Scotland, we were engaged in the peaceful prosecution of our labours in this extensive region. In such circumstances we should naturally have expected, from all churches professing the same faith, every possible encouragement and assistance. It was therefore with much surprise and regret, that we observed in some of the organs of the Free Church, expressions of a desire to produce, or at least to countenance, a disruption in our Synod, and division and strife among our congregations. We were for a time willing to ascribe this to ignorance of our condition, or to a want of due consideration of the position of our church; but from the subsequent conduct of the Free Church in publishing and sending out letters, addresses, and other documents, calculated to excite the feelings of our people, and commissioning deputations for the same purpose, we are compelled, however unwillingly, to conclude, that there exists a desire, on the part of the leaders of that church, to disturb and distract the congregations under our care. We cannot regard such conduct, as wise, generous, or christian, but still, when we think of the high character, and the beneficent efforts of many of the members of your church, we cherish the hope, that when the case is fully and fairly represented, you will see cause to adopt a different line of conduct.

We enjoy the very same liberty, and stand in the very same position, as that for which those who now constitute the Free Church so long contended; a position similar to that of the Irish Presbyterian Church. We are as entirely free, in every sense of the word, as the Free Church itself, or as any church in the world, whether established or not established. Scotland, they utterly vanish in Canada." It cannot therefore be regarded as unreasonable, that, when called upon suddenly to make a change in our position, which we clearly saw would plunge us in unnumbered evils, without the smallest corresponding benefit, we should at least pause, and deliberate, before taking a step, which would be attended with such fearful consequences; and we certainly had a right to expect, that before being accused of acting from unworthy motives, and exposed to unjust censures, both here and in Scotland, as being indifferent, or hostile to the Redeemer's cause, we should have been, at the very least, requested in a calm and christian manner, to state the reasons of our conduct.

We claim for ourselves the same liberty of judging and acting which we concede to others, and we solemnly declare, that in all we have done in this matter, we have acted according to our conscientious convictions of duty, and with the most earnest desire to do what would be most conducive to the spiritual welfare of our people,—and we cannot but feel ourselves therefore deeply aggrieved, when we see charges which we must characterise as reckless and unwarrantable, brought against those who, to say the least, have been as faithful and laborious in the service of the Lord, as they who bring forward such allegations; men who have borne the burden and heat of the day, who have spent years of ill-requited labour in gathering in those, who but for their exertions would have been strangers to the means of grace.

Let it not for a moment be supposed, that we entertain any hard, or hostile feelings towards the Free Church. Many of its members we revere and love; we admire their devotedness and their zeal; and we cannot doubt that in taking the position they assumed, they acted on the most sincere convictions of duty; we should therefore gladly welcome that church, as a fellow-labourer with us, in evangelizing this country, and surely the land is wide enough for us both; there is work enough to employ all our exertions, and all our means. Why then may we not say to each other, "Let there be no strife I pray thee between thee and me; Is not the whole land before us ?" We trust that this representation will be taken, as it is intended, in good part. We are fully convinced that the conduct adopted by your church towards ours, has tended to excite feelings of dislike in the minds of many persons in this country, who were once disposed to regard the Free Church with affection and esteem; and that it would conduce to your honour and advantage, no less than to our peace and welfare, to adopt a course of conduct, more liberal, more conciliatory, and more Christian.

The Synod had also transmitted to them, by their Committee of Bills and Overtures, an overture anent the formation of a Lay Association, for the advancement of the general interests of the church. The Synod having duly considered this matter, and being well assured that there are many adherents and members of the church, who, although not office bearers and not of course admissible to sit in her courts, are nevertheless well qualified, as well by their zeal for the well being of the church as their business habits, to advance those interests of the church which are more connected with secular things, and are desirous of lending their aid, appointed the following committee, viz., Mr. Lambie (Convener), Mr. George, Dr. Liddell, and Dr. Mathieson, to digest a plan for the formation and operations of a Lay Association, and to report to the Commission of Synod, and, as soon as the Commission shall have approved of said plan, the Synod recommend the formation of a Lay Association, for the advancement of the general interests of the church, with branches or committees of the same in the several cities and principal towns throughout the Province.
