An Act further to extend the time for paying up the new Stock of the Commercial Bank of the Midland District.

WHEREAS the President, Directors and Preamble.
Company, of the Commercial Bank of
the Midland District, have, by petition to the
Legislature, prayed for a further extension of
5 the time within which their new shares of
Capital Stock must be wholly paid up; and
whereas it is expedient to grant the prayer of
the said petition: Be it therefore enacted,
&c.
