An Act further to extend the time for paying up the new Stock of the Commercial Bank of the Midland District.

**W**HEREAS the President, Directors and Preamble.  
Company, of the Commercial Bank of the Midland District, have, by petition to the Legislature, prayed for a further extension of  
5 the time within which their new shares of Capital Stock must be wholly paid up; and whereas it is expedient to grant the prayer of the said petition: Be it therefore enacted, &c.
