January 23rd, 1895.

Rev. W. C. Clark, Pastor, acted as Chairman, and C. M. French as Secretary for the evening.

Moved by Mr. W. B. McCulloch, seconded by Mr. J. H. Robertson, that the minutes of last annual meeting as printed in the reports be adopted. Carried.

The Report of the Kirk Session was then presented by the Pastor, Rev. W. C. Clark.

The Report of the Mission Fund was read by Mr. John Anthony, the Treasurer of that fund.

Mrs. Robert McClure submitted the Report of the Sabbath School.

The Report of the Woman's Foreign Missionary Society was read by Miss Mattie Smith.

Miss A. Sharp presented the Report of the McLaren Mission Band.

Moved by Mr. John Smith, seconded by Mr. J. H. Robertson, that Mr. John McClure be re-appointed Treasurer. Carried.

Moved by Mr. John Anthony, seconded by Mr. R. Patterson, that Dr. French be re-appointed Secretary of the congregation. Carried.

Messrs. R. Young, John Smith, J. H. Robertson, and Wm. Magill were elected Managers of three years by ballot.

Mr. Wm. Anthony, jr., was elected Manager for two years to fill a vacancy.

Messrs. John McCulloch and J. C. Kirkwood were appointed Auditors for the current year.

By a comparison of the contributions of 1894 with those of former years, it will be seen that there is a decrease in almost every direction. In searching for a cause for this shortage it may be attributed to a number of things : 1. There is the general depression in nearly all lines of business, which has affected our town to a considerable extent. 2. It was not necessary that so much should be raised for General Revenue, as the expenses this year were less than for some time. 3. Many of our people felt they had been giving too much for the support of Missions and the other schemes of the church, and this year lowered their offering. 4. Owing to the vacancy and the settlement of a new pastor the interest of the people in the outside work of the church was allowed to subside. 5. During the year a number of our best supporters have removed from our midst, and some of those who have taken their places have not as yet fully adopted our plan of giving.

During the past year our communion roll has suffered more than usual. There has been a continued call for certificates, and by a

revision of the roll 14 names were removed by the order of the Session. Although we have had an addition of 39 yet we find ourselves at the close of 1894 with 5 members less than at the close of 1893.

In the Session there has been considerable change. The congregation, after being vacant for about nine months, decided to call the present pastor, who was ordained and inducted on June 28th. On the 14th of September, after a long illness, borne with a true Christian spirit, Mr. Wm. Whitehead, a brother deeply loved and deeply regretted, ceased from his labours and passed into his rest. The Session, feeling the need of assistance, asked the congregation to elect six new Elders. The result of the ballot was the choice of Messrs. James McCracken, Wm. Miller, John B. Leslie, Andrew Buckham, Wm. S. McClure and Wm. A. Kirkwood, who were ordained on December 16th.

A smaller number than in any previous year have been removed from us by the hand of death. Three had passed middle life and, having fought the "Good fight of faith," went home to receive the "Crown of Righteousness," from the hands of the "Righteous Judge." One was but beginning to realize life's joys and sorrows when without pain, without sickness, she fell "Asleep in Jesus," and one was a little child. Having been by baptism received into the earthly church, a few weeks after he was called to the arms of his Saviour.

During the past year we have had no special reasons for rejoicing, but neither have we had any special reasons for being discouraged. Our heritage is a goodly one. With earnest prayer and simple trust we have been trying by God's grace to bring the "Kingdom of Heaven" into our own hearts and into the world. We trust that in some small way that the united efforts of this congregation during the year now gone may be owned and blessed by "Him who ruleth over all."

This year we would as people ever drink at the "Wells of Salvation," and ever walk with God. We would guard against being luke-warm or formal in our worship and service. We would grow in "Knowledge and Grace," and liberally support and advance the gospel by which we ourselves have obtained "Everlasting Life."

MANAGERS' REPORT.

It is with heartfelt thankfulness that the Managers present the Financial Statement of the Congregation for the year 1894.

It is true the revenue has fallen below that of last year. The chief reason, and a substantial one, for this is that at the beginning of the year there was a somewhat general reduction in the W. O. by envelope. Then during the first half of the year, while the Congregation was without a settled Pastor, the plate collections were small, and the contributions by envelope on the whole not quite so regular as usual. Consequently during this time, although the expenses were reduced, the balances of cash in bank from month to month showed but little increase.

We are grateful to be able to say that the Annual Payment of \$1000 on Church debt was made at the proper time—the beginning of the year. Although the special contribution at the Anniversary of church opening fell short of the \$1000 by \$53.46, yet there was sufficient funds from the Regular Revenue, owing to increased payments toward the end of the year to make up the deficiency, after all claims, including the half year's interest, had been met, and the Managers, as a matter of course, thought it better that this should be done and the payment made. One particularly gratifying feature is that while the contributions have been sufficient for necessary expenditure, they have been perfectly free and spontaneous. We trust that the generous liberality which has characterized the congregation in the past will be continued, so that there may be an abundant provision to supply all the temporal wants of the Lord's House, and may He "who giveth liberally and upbraideth not," keep and guide the congregation through the year upon which it has entered.

Tenth Annual Report of Brampton Auxiliary to the W. F. M. S.

Our Society has held Monthly Meetings regularly during the year.

In May Miss McWilliams, a returned missionary from India, gave an address under the auspices of our Society at one of the Wednesday night Prayer Meetings. The meeting was well attended and the address very interesting.

A bale of Clothing valued at \$25.65 was sent to the Northwest Mission Schools in September.

Our Society has sustained a loss in the removal of Mrs. Corbet, our most faithful and efficient Treasurer for the past seven years.

Our membership is about the same as last year and numbers 73. Of these 11 are "Scattered Helpers," this being an increase of 6 over last year, and Mrs. John McClure, who has charge of this branch of our work, hopes at the end of this year to report a still greater increase.

While nothing of special interest has marked our work, we are glad to be able to state that on the whole our meetings have been as well attended and as much interest has been shown as in previous years. But we should not rest satisfied unless we are making progress, and we would urge on ourselves the need of individual effort. At the close of 1895 may it be said of each of our women that by her prayers, by her gifts, and by her efforts to bring others into the work "She hath done what she could."

SABBATH SCHOOL REPORT FOR 1894.

The Teachers and Officers of the Sabbath School respectfully submit :

That the School is apparently in a healthy and prosperous condition.

The interest shown by all is encouraging, and while there is cause for humiliation and confession of shortcomings on our part, we have also great cause for thanksgiving to our Heavenly Father for His forbearance with us " His unprofitable servants."

For any fruit that may have been gathered during the past year, to God be the praise. We regret, however, to see from the following financial report that the offerings for Missions and for the general expenses of the school have decreased very much throughout the year.

The offerings on the first Sabbath of the month are devoted to Missions, fifty dollars of which goes to the support of a pupil in Pointe Aux Trembles school, a worthy object, we believe, and trust, by the blessing of God great results will follow.

The collections on the other Sabbaths are for the general expenses of the School, the providing of suitable papers, helps, etc. Among these we would make special mention of the Sunday School Times, a paper we believe worthy of a place in every home. Fifty-five copies of this paper are distributed every week in such a way that only one copy goes to one home.

We ask therefore that the offerings this year be more liberal and that the parents co-operate with us in this matter.

And now what have we learned as we studied together the lessons of the past year ?

That "God created man in His own image," holding communion with Him.

We learn also of the entrance of sin and its awful consequences. Separation from God, from holiness and happiness to misery, jealousy, hatred, murder. Oh ! the dreadfulfulness of sin !

We also learned that with the entrance of sin the promise of God's grace is given. (Gen. 3, 5.) And as we followed the generations of Noah and Abraham and Joseph we came to Moses and left him where he led God's chosen people out of Egyptian bondage.

Through all this we see the promise brightening until " the fulness of the time was come, God sent forth His Son." How appropriately the lessons of the last six months of the year follow those of the first, commencing with the Birth of Jesus, the Second Adam. Hear the words of the angel to the shepherds, " Unto you is born this day in the city of David a Saviour, which is Christ the Lord." Glorious fulfillment of the promise, Gen. 3, 15.

What are some of the teachings we learn from the life of our blessed Lord ?

Remember the interview with Nicodemus, His emphatic words, " Except a man be born again he cannot see the Kingdom of God."

Finally, our hope and trust is that we have learned much from the study of the life and teachings of our Lord, and hope as we continue this study it will become increasingly interesting.

Now unto Him who is able to keep you from falling, and to present you faultless before the presence of His glory with exceeding joy.
