are many Presbyterians and people of dissenting denominations who are in the habit of attending our evening services. Secondly, we are surprised to find them so numerous and so organized a body as to expect the sermons to be toned down to suit their tastes. Thirdly, we don't understand the object of their appealing to the Mail, or through its columns to the public, against preaching which they do not agree with. Certainly neither the Mail nor the public exercise any control over the preaching in St. George's.

To add one word in seriousness: Christian disunion, or schism, is-to speak in the mildest way of it-undeniably a very grave hindrance to Christianity. Even Sectarians are now admitting that much, and are seeking re-union, such as seems to them practicable. Surely then, on that ground alone, no clergyman ought to be censured for raising his voice in favour of unity and in condemnation of schism; rather should he be censured if he failed to do so. And if there is ever to be unity, is it possible for it to be in theory only, and not in actual visible fact. And if it must be the latter, or not at all, "Presbyterian" must inevitably concede Mr. Kingston's claims for the Apostolic Church as the centre of union, in preference to any modern body, to be well founded In our opinion elergymen should speak, and speak boldly, giving no uncertain sound, on such subjects as this.

Some amusement was created by the appearance in the Mail shortly afterwards of a letter signed "Anglican," which was a parody or rather a copy mutatis mutandis of "Presbyterian's" letter, which had the effect of shewing the latter in a rather ridiculous light.

We insert the above Communication, because it bears witness to a plain Scripture doctrine, viz., that of Christian Unity.
