




Real GDP Growth




Inflation rates





World's Stock of Direct Investment Abroad Distribution by Major Source Countries




1980 Total = US\$ 518.9 Billion



1990 Total = US\$1690.1 Billion





WORLD MERCHANDISE TRADE SHARES


WORLD MERCHANDISE EXPORTS




WORLD MERCHANDISE IMPORTS




CANADA AND G-7 TRADE PERFORMANCE



Merchandise Exports






Total Exports \$76.2B

Merchandise Imports





Foreign Direct Investment in Canada





Croissance du PIB réel





Total 1980 = 518.9 milliards \$US













Exportations de Marchandises






Exportations Totales: 76.2 Md\$

Importations de Marchandises






