## REPORT

*Of the Committee of Management of the Corporation of the St. George's Society of Ottawa, for the year ending 4th April, 1871.*

To JOHN SWEETLAND, Esq., M.D.,  
*President of the St. George's Society,*  
*Ottawa :*

SIR,—The time has arrived when, the tenure of their office having drawn to a close, it is expected that this Committee should present to their brother members a Report embodying the principal transactions which have taken place in connection with the Society for the proper management of whose affairs, during the past year, they deem themselves responsible. This they are prepared to do the more readily, as it will be found that the progress of the Society has, during that period, been unprecedentedly great, and its sphere of usefulness proportionately enlarged.

They are conscious that in the discharge of their duties, the obligations assumed by them have been faithfully carried out, and that in no instance, to their knowledge, have the funds committed to their charge been misapplied or diverted from the legitimate and benevolent purposes for which they were created and intended.

With these few introductory remarks, your Committee proceed to note in as succinct a manner as possible, such circumstances and events as will, in their opinion, prove of interest to the many members present, to the Society at large, and to its numerous outside friends.

Anniversary  
Celebration  
1870.

The last Anniversary Celebration may, not inappropriately, be characterized as a "Revival." For several years previously a spirit of apathy had been manifested to such an extent, that it was deemed prudent to dispense with the customary Procession on St. George's Day, 1869. This had had the desired effect of awakening many somnolent members to unusual activity; and it was resolved at the last Annual Meeting, that a Procession should, as in former years, take place on the ensuing Anniversary. In accordance with this resolution, the Members, and their friends of English birth or extraction, to the number of at least two hundred, assembled at Salmon's Hotel, at ten o'clock, on the morning of St. George's Day, and from thence, headed by Gowan's Band, proceeded to Christ Church, where an appropriate sermon was preached by the Rev. H. Pollard, Chaplain to the Society, from the following text:—"The enemies of my Lord the King, and all that rise against thee to do thee hurt, be as that young man is."—2 Samuel, chap. 18, verse 32.

A collection was made, as usual, in aid of the Charitable Fund; the sums collected amounted to \$17.57.

After Divine Service the Procession re-formed, and returned to Salmon's Hotel, where a cold collation had been prepared, to partake of which a large company sat down, the chair being occupied by the President, John Sweetland, Esq., M.D.

In the evening a Concert was given in H. M. Theatre, half the nett proceeds of which, it had previously been decided, should be presented to the County of Carleton General Protestant Hospital. The gross receipts on account of this entertainment amounted to \$138.94, and the expenses to \$54.31½, leaving a nett balance of \$84.62½, of which sum \$41.75 had been paid over to the Treasurer of the excellent Institution referred to. With the remaining portion of the nett proceeds (\$42.87½) your Committee were enabled to defray the expenses attending the Procession (\$35.31½), and to place to the credit of the General Fund \$7.56. They have good reason to believe that the manner in which the Anniversary was celebrated gave unqualified

At a Quarterly General Meeting held on the 5th July last, it was unanimously resolved that a special vote of thanks from the Society be presented to W. J. Wills, Esq., the Immigrant Agent residing in this City, for the uniform kindness extended by him to the recently arrived poor of English birth and origin.

Your Committee experienced great pleasure in carrying out the wishes of the meeting, and lost no time in forwarding to the gentleman, whose frequent acts of kindness so justly merited the expression of regard embodied in the resolution, a copy of the Vote of Thanks engrossed on parchment.

At the same meeting a resolution was adopted to the effect that, inasmuch as the Secretary to this Corporation had, on all occasions declined, most respectfully, to receive any pecuniary recompense for his services, a sum of fifty dollars (\$50) be appropriated to the purchase of a suitable gift for presentation to that gentleman. This very agreeable duty was promptly discharged. On the 19th July last, a handsomely bound copy of "The Comprehensive Family Bible," was presented to the worthy Secretary of the Society (W. Mills, Esq.), whose thanks for the generous recognition of his services have been duly recorded on the minutes of the transactions of this Corporation. The cost of the presentation was forty-six dollars (\$46).

The business appertaining to the office of Secretary having increased to such an extent as to justify the appointment of an Assistant, a resolution was adopted on the 5th of the month last above mentioned, creating and sanctioning the office of Assistant Secretary, Mr. W. R. Truman being elected on that occasion to fill the office for the remaining portion of the current year.

On the 10th of August last an Excursion by the steamer "Alexandra" to Butternut Grove, the summer residence of G. B. L. Fellowes, Esq., distant about thirty miles from the City of Ottawa, took place. The kind permission of the proprietor having been freely granted for the purpose, a pic-nic on an extensive

scale was held on the beautiful grounds referred to. The weather throughout the day proved most propitious, and a vast number of persons embraced the opportunity afforded of enjoying themselves thoroughly, at a trifling expense. Gowan's Brass and Quadrille Bands accompanied the excursionists, and remained on the grounds until the hour specified for the return of the party to town.

The affair proved most successful, both in a pecuniary and popular sense. Although the expenses attending it were, necessarily, very heavy, a nett sum of \$121.58 was realized therefrom.

On the 22nd of September last a Concert was given at the Skating Rink Music Hall in this City, under the auspices of the four National Societies, in aid of the fund then being raised with a view to the relief of the many sufferers from the then recent and destructive bush fires. Your Committee have great pleasure in informing their brother members that the profits accruing from this entertainment, and subsequently handed over to the Treasurer of the Fire Relief Committee, amounted to \$110.67. The success which attended this Concert may be justly ascribed to the good feeling and harmony which prevailed at the Councils of the Committee specially appointed, and composed of an equal number of the representatives of each nationality.

Particular attention is called to the following resolution, which was adopted at the Quarterly General Meeting held on the 4th of October last:—"That the clause in Article No. 4 of the By-Laws of this Society, relating to the Election of a Chaplain by ballot, be expunged; and that in future it shall be competent for the Members present at an Annual General Meeting to appoint one or more Chaplains, without resorting to the system of balloting."

Your Committee regard this amendment in the By-Laws as a very necessary and salutary one, inasmuch as its adoption extends that proper courtesy and respect which they conceive to be due to all ministers of sound religion, no matter to what denomination of Christ's church they may belong.

the Society were summoned to take part in one of those mournful processions, which whilst reminding us of the frail tenure of human existence, silently counsel us to improve the time which may remain to us, in such a manner as to strengthen the hope of our future and eternal happiness. Three days prior to the above date, the Rev. C. C. Codd, one of the oldest members of the Society, and who had held, for many years, the sacred office of Chaplain to this Corporation, breathed his last. But few men in our midst have enjoyed more fully the esteem and affection of their fellow-citizens than did the Reverend gentleman, to whose demise your Committee now refer, and certainly none could be found more deserving of that esteem. His life had been mercifully extended some few years beyond the allotted period of man's earthly sojourn—threescore years and ten, and its termination was marked by Christian reliance and peaceful resignation. The merits of the deceased gentleman were so well known and so generally appreciated, that to descant upon them on the present occasion, would appear fulsome. In following his mortal remains to the grave, the members of this Society were actuated by a desire to bear testimony to the great esteem in which he was held by them during his lifetime, and to evince their earnest sorrow at his departure.

The death of Mr. Codd, was followed the day after his interment, by that of his suffering widow.

Your Committee feel assured that in expressing their deepest sympathy with the several members of the respected family so suddenly bereaved, they but reflect the sentiments of this large and influential assembly.

On the evening of Thursday, 15th December last, a grand concert was given in H. M. Theatre, in aid of the Christmas Special Fund, under the direction of Messrs. Mercer and Brewer, to whom, as well as to the several ladies and gentlemen who so kindly placed their valuable services at the disposal of the Committee on that occasion, this Society is greatly indebted. The nett proceeds of this entertainment amounted to \$46 21, a sum much less than was expected to have

Donations.	been realized, but amply supplemented by donations in cash and kind. These donations were thankfully acknowledged at the time, through the medium of the daily newspapers of this city, so that it is not necessary to enter into a recapitulation here, beyond stating that the donations in cash amounted to \$78 50—in goods, valued at \$33 30. With these resources at their command, your Committee were enabled to distribute to 44 families, representing 196 individuals, the following necessary articles, to wit : 25 loads of wood, 540 lbs. meat, 500 lbs. flour, 17½ lbs. tea, 84 lbs. of sugar, 52 lbs. of raisins, 72 (4 lbs.) loaves of bread, 29 bushels of potatoes, and a pair of blankets.

The total receipts in cash on account of this distribution, reached the sum of \$124 71, and the expenditure amounted to \$127 68. The \$2 97 expended in excess of the receipts, having been drawn from the General Fund.
Total receipts and disbursements on account of Christmas Fund.	The value of the fuel and provisions supplied, may be set down at \$158 98.
Value of goods supplied.	The goods were distributed on the premises belonging to the Treasurer, (Thos. Starmer, Esq.) on the 24th December.
Date and place of distribution.	This pleasing feature in the operations of the Society, has for several years past, met with the heartiest support of its members, and has attracted some attention from many benevolently disposed persons outside of the Society. For the earnest sympathy of these kind friends, so unmistakeably manifested in their generous donations to this Special Fund, the Committee of Management feel sincerely grateful.
Remarks.	In the month of January last, a list of members in arrears was placed in the hands of Mr. J. G. Davis, for the purpose of collection. This list contained the names of fifty (50) individuals, whose aggregate indebtedness amounted to \$162. Of this sum, \$46 has been collected and paid over to the Treasurer. The list still remains in the hands of the Collector, to whom promise of payment, in the course of the present month, has been made by several of the members concerned.

by resolution adopted at a General Meeting held on the 5th July last, they have had an appropriate Badge manufactured, from a design by Mr. H. Pace, to be worn by the Treasurer on suitable public occasions. The cost of this insignia of office was \$16.

Cost of Badge.

During the past year 103 applications for relief have been entertained—the sums granted ranging from one to fifty dollars, according to the exigency of the case presented to the notice of the Committee.

Number of applications entertained, &c.

Many instances of extreme destitution have occupied the attention of your Committee. One case in particular, that of a poor widow, suffering from physical infirmity, and having six children depending, almost entirely on her exertions for their daily bread, demands especial remark. For some months past, the care of this large and destitute family has been a matter of serious solicitude, and it was only after expending the sum of fifty dollars (\$50) in providing for their necessities, that it was deemed expedient to petition the Corporation of this city in their behalf. On the 20th of February, a petition (a copy of which is now before this meeting) was presented by a deputation from this Committee, to the worshipful the Mayor and Corporation, in council assembled, by whom it was referred to the Finance Committee for consideration. The result of their deliberations has been an award of \$50 toward defraying the expenses of this poor family to England.

Remarks on cases relieved. An extreme case.

Petition to Corporation.

In connection with this case, it is only right to add, that, in addition to the \$50 advanced from the funds of the Society, many necessary articles have been contributed from time to time, by individual members thereof; and further, that subscriptions, amounting in the aggregate to twenty-two dollars (\$22), had been obtained through the prompt and generous exertions of Mrs. W. Proderick, of this city. The active philanthropy of this lady has been duly recognized by your Committee. At an adjourned meeting held on the 29th of November, a resolution embodying the thanks of the Society in favor of Mrs. Proderick, was unanimously adopted, and a copy of the same engrossed on parchment, has been formally presented to her. The sum (\$22) last above mentioned was handed over

to the President of the Society, who would, in his private capacity, account for its proper application.

Since the last Annual Meeting, eight persons (five adults and three children) have been buried at the expense of this Corporation, involving an outlay of sixty-nine  $\frac{50}{100}$  dollars (\$69.50).

Register.

At the Quarterly General Meeting, held on the 3rd day of January of the present year, a resolution was passed sanctioning the introduction of a Register, wherein employers requiring help, and Englishmen seeking for employment, might enter their names, and make known their wants. A Form of Register had been prepared, but owing to the pressure of other matters, an opportunity of testing its adaptability had not been afforded.

New members.

Your Committee have great pleasure in stating, that during the past year, 64 additional members have been placed on the Roll of the Society. This announcement they feel assured will prove highly gratifying to their brother members, and will lend encouragement to the gentlemen who may be appointed to hold office during the ensuing year.

A Visiting Committee of Ladies, suggested.

Your Committee, desirous of guarding against the practice of imposition upon the charitable Fund of the Society by worthless and depraved characters, most respectfully suggest that a Visiting Committee of Ladies be appointed at the earliest convenience.

Leaving out of the question the plausible misrepresentations occasionally made with a view to deceive, cases will at intervals arise of such a delicate nature as to absolutely require investigation by ladies whose experience would ensure prudent provision being made, in order to meet the urgent wants of the party or parties applying for relief.

Number of meetings held.

The amount of business transacted in connection with the affairs of the Society during the past year has been by no means light, as will be readily conceded when it is known that the transaction of that business has absorbed the attention of no less than thirty-two (32) meetings.

The large accession of Members having rendered it necessary that more ample accommodation should be secured for the Quarterly and other General Meetings than was at the disposal of Mr. Salmon, it was decided to hold the Quarterly Meeting of October last in Gowan's Hall. The following one was held on the 3rd January last, in the "St. James' Hotel" (Mr. Evans'), since unfortunately destroyed by fire. Accession of members.

The room in which the present meeting is held, has been kindly lent for the occasion by the proprietor, F. Champness, Esq. Meeting in Gowan's Hall, October, 1870. Meeting in St. James' Hotel, 3rd Jan., 1871.

The Committee of Management continue to meet, as heretofore, at Salmon's Hotel, which place they presume, will be regarded as the head quarters of the Society, so long as it may suit the convenience of the generous proprietor to furnish the requisite accommodation. Your Committee would not intentionally omit to place on record their sense of the obligations they are Thanks due to the Sister Societies,

under to the Members of the Sister Societies, and to the many other patrons of the various entertainments given by the Society.

Adoption of Report.

In conclusion, your Committee sincerely trust that the Report now submitted by them will meet with the approval of this assembly. They make no apology for its length, seeing that no subject irrelevant to the interests of the Corporation has been introduced.

Prosperous state of the Society.

The present prosperous state of the Society, notwithstanding the very many heavy demands which have been made upon its funds, is exceedingly gratifying, and the retrospect of its benevolent operations still more so.

Conclusion.

Having rendered a just account of their stewardship, they retire from the honorable position they have held, and fervently pray that the Almighty may, in His infinite goodness, be pleased to watch over, and continue to bless and prosper the affairs of the St. George's Society of Ottawa.
