An Act to Incorporate the St. George's Society of Toronto.

WHEREAS, John Beverley Robinson, Thomas Brown, George S. Jones, Robert Dodgson, F. W. Coate, George T. Walton, George Bilton, George Thomas, Henry Godson, Julian Sale, Isaac Faulkner, B. Saunders, Frank John Joseph, and others, have, by their petition to the Legislature, represented that, the Association, of which they are members, known as the St. George's Society of Toronto, has for many years been formed for the benevolent purposes of affording pecuniary, medical, and other relief to such natives of England and Wales, and their descendants, as may from sickness or other causes have fallen into distress, and have prayed that for the better attainment of the objects of the said Association, it may be invested with corporate powers, and by reason of the good affected by the Association, it is expedient to grant the prayer of the said petition: Therefore, Her Majesty, by and with the advice and consent of the Legislative Council and Assembly of Canada, enacts as follows:

1. The said John Beverley Robinson, M.P.P., Thomas Brown, George S. Jones, Robert Dodgson, F. W. Coate, George T. Walton, George Bilton, George Thomas, Henry Godson, Julian Sale, Isaac Faulkner, B. Saunders, Frank John Joseph, and such other persons as are now members of the said association, or shall hereafter become members thereof, under the provisions of this Act, and the By-laws made under the authority thereof, and their successors, shall be and they are hereby constituted a body politic and

corporate, by the name of the *St. George's Society of Toronto*, and may by that name sue and be sued, implead and be impleaded, answer and be answered, defend and be defended, in all Courts of Law and places whatsoever, and by that name they and their successors shall have perpetual succession, and may have a common seal, and may break, change, alter, or renew the same at pleasure, and shall have power to purchase, take receive, hold and enjoy such real estate, as may be required for the actual occupation of the said Corporation and to alienate, sell, convey, lease, or otherwise dispose of the same, or any part thereof, from time to time, and as occasion may require, and to acquire other instead thereof; Provided always, that the said Corporation may acquire any other real estate or any interest therein, by gift, devise or bequest, if made at least six months before the death of the party making the same, and the Corporation may hold such estate for a period for not more than three years, and the same or any part or portion thereof or interest therein which may not, within the said period have been alienated and disposed of, shall revert to the party from whom the same was acquired, his heirs or other representatives; And provided also, that the proceeds of such property shall have been disposed of during the said period, may be invested in the public securities of the Province, stocks, of chartered banks, mortgages, or other approved securities for the use of the said Corporation.

2. The affairs and business of the said Corporation shall be managed by a Committee of management, consisting of a President, a first, second, and third Vice-Presidents, a Secretary, or Secretaries, a Treasurer, two Chaplains, three Physicians, and seven other Members, to be elected annually at a General Meeting of the members of the Corporation held in conformity to the By-laws, thereof, and any five members of the said Committee shall be a quorum for the despatch of business.

3. All deeds, sealed with the Common Seal of the Corporation, and signed by the President or Vice-Presidents and by some other member of the Committee of Management, and countersigned by the Treasurer, and none other, shall be held to be deeds of the Corporation: Provided always, that the Treasurer, for the time being, may receive all moneys payable to the Corporation and grant valid receipts therefor.

4. It shall be lawful for the said Corporation to make By-laws for the admission and expulsion of members, and for the proper administration of the property and affairs of the Corporation, and to repeal or amend the same from time to time; and such By-laws and amendments shall be proposed and seconded at a previous Quarterly Meeting. No number of members less than one-fifth of the Corporation (including the presiding Officer) shall form a meeting for the purpose of altering such By-laws, nor shall any alteration be made therein unless two-thirds of the members present agree to it.

5. The General Meetings of the said Corporation shall be held in such manner, after such notice, upon such requisition, and at such times in the City of Toronto, as shall be directed by the By-laws of the Corporation then in force.

6. The usual place of meeting of the said Corporation shall be held to be the legal domicile thereof, and service at such place of any notice or process of any kind, addressed to the said Corporation, shall be held to be sufficient service of such notice or process on the Corporation.

7. The By-laws of the said Association, in so far as they may not be repugnant to this Act or the laws of this Province, shall be the By-laws of the Corporation, hereby constituted, until they shall be repealed or altered as aforesaid; Provided always that no By-law shall impose a penalty or forfeiture exceeding two dollars.

8. Until others shall be elected according to the By-laws of the Corporation, the present officers of the Association shall be those of the said Corporation, that is to say, the said John Beverley Robinson shall be the President, the said Thomas Brown shall be the first Vice-President, the said George S. Jones shall be the second Vice-President, the said Robert Dodgson the third Vice-President, the said F. W. Coate shall be the Treasurer, the said George T. Walton shall be the Secretary, the Reverend J. Beaven, D.D., and the Reverend H. Scadding, D.D., shall be the Chaplains; Edward Hodder, Francis Badgley, and William Hallowell shall be the Physicians, and the said George Bilton, George Thomas, Henry Godson, Julian Sale, Isaac Faulkner, B. Saunders, and Frank John Joseph, the other members of the Committee of Management.

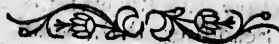
9. No person otherwise competent to be a witness in any suit, action, or prosecution in which the said Corporation may be engaged, shall be deemed incompetent to be such witness by reason of his being or having been a member or officer of the said Corporation.

10. All subscriptions of members due to the Corporation under any By-law, all penalties incurred under any By-law by any person bound thereby, and all other sums of money due to the Corporation, shall be paid to the Treasurer thereof, and in default of payment may be recovered in any action brought by him in the name of the Corporation in any Court of competent civil jurisdiction: Provided always that nothing herein contained shall be construed to prevent any member from withdrawing at any time from the said Corporation after payment of all arrears due to the funds thereof, including the annual subscription for the year then current.

11. The said Committee of Management shall yearly, in the month of January, insert in some newspaper published in the City of Toronto a statement of the amount of the funds and property, debts and liabilities of the said Corporation, certified by the Treasurer and two Auditors elected at any General Meeting of the Corporation.

12. Nothing in this Act shall affect any right of Her Majesty, Her Heirs or Successors, or any party or person whomsoever, such rights only accepted as are herein expressly mentioned and affected.

13. This Act shall be deemed a Public Act.



BY LAWS.

BY-LAW I. The Society shall consist of such persons of English birth or descent, in the male line, as shall be elected members thereof, according to the regulations hereinafter made; and until a Sister Society of St. David's be organized, Welshmen and their descendants will be considered as eligible to become members of this Society, and to stand in the same position therein as Englishmen and their descendants.

II. The objects of the Society are to unite Englishmen and the descendants of Englishmen in a social compact, for the promotion of mutual and friendly intercourse; and for affording to such persons of English birth and descent as may stand in need of their advice and counsel, and such pecuniary assistance as the funds of the Society may enable it to give

III. In addition to the officers named in the Act of Parliament Incorporating the Society, **SIX STEWARDS** shall be elected who shall arrange for the celebration of the Annual Festival on **St GEORGE'S DAY**, and report such arrangements at the quarterly meeting next preceding for adoption. Also a **MARSHALL AND STANDARD BEARERS** shall be appointed by the **PRESIDENT**.

IV. The officers of the Society shall be elected as follows: Any member may nominate a Candidate for each office, in succession; and in the event of more than one nomination for any one office, the decision shall be by ballot.

V. The President and Vice-Presidents shall not be eligible for re-election to the offices respectively filled by them for the next succeeding year.

VI. The General Annual Meeting of the Society shall be holden on the third Friday in January each year. In each year there shall be holden four Quarterly General Meetings, viz.: 1st. The Annual General Meeting, and one each on the first Friday of the months of April, July, and October. Monthly Ordinary Meetings shall be held on the first Friday of each month throughout the year, excepting in January, April, July and October as otherwise provided.

VII. Any gentleman desirous of joining the Society shall, at a General or Ordinary Meeting, be proposed and seconded by members, and may be elected by a majority of such meeting, on payment of the first year's subscription, and not otherwise.

VIII. The Annual Subscription of Members shall be Two Dollars. The Subscription year shall be from 1st January to 31st December. Any new member elected between the 1st of January and 30th of September shall pay the full subscription for the current year; any elected on or after 1st October, may be admitted on paying for the current quarter only.

IX. A Subscription of Five Pounds shall be a Life Subscription, and the same shall be invested at interest as a permanent fund for the charitable purposes of the Society.

X. The Annual Meeting shall order the investment of such proportion of the surplus funds (if any) as may appear desirable, and in such manner as may be then determined, and the annual subscriptions, with the interest of investment, shall constitute the ordinary funds applicable to the charitable purposes of the Society.

XI. The Treasurer shall be authorised to advance to a distressed individual, a sum not exceeding Two dollars, upon the written recommendation of the President or either of the Vice-Presidents, or of any member of the Managing Committee by them appointed to grant such relief. Pro-

vided, always, that such recommendation do not involve the payment of more than two dollars to any one person or family. In cases demanding more than the ordinary relief thus afforded, the same shall be referred for further enquiry and action to the Managing Committee as hereinafter set forth.

XII. The Managing Committee shall meet weekly, and any five members thereof shall form a quorum. It shall be their business to direct the affairs of the Society, generally, under this constitution; to determine all matters referred to them by the Society, and to prepare for each annual meeting a Report of the proceedings of the Society for the year, to be submitted previous to the Election of Officers.

XIII. The Managing Committee may make loans (not exceeding five pounds to one person or family), from the ordinary funds of the Society, to persons in temporary distress or trouble, upon receiving such reasonable security as they may deem expedient, provided the periods of such loans do not exceed six months. It shall have power to grant extended relief in particular cases at discretion, the orders upon the Treasurer being in all such cases signed by two or more of the Members of the Committee.

XIV. The anniversary of St. GEORGE shall be celebrated by a Dinner, or otherwise, as may be determined at the General Quarterly Meeting in April. No expenses of any Anniversary Festival, or of any social entertainment whatever, shall be charged against the funds of the Society.

XV. The President (or in his absence, the senior Vice President,) shall direct the Secretary to convene a special General Meeting of the Society, upon requisition (stating the purpose thereof) from any five members, and the Secretary shall call a special meeting of the Managing Committee, either by direction of the President, (or, in his

absence, the Senior Vice President,) or upon the requisition of any two members of the Committee.

XVI. The Chair shall be taken thirty minutes, precisely, after the hour appointed for meeting, and if there be not then a quorum of at least ten members present, the meeting shall be forthwith adjourned.

XVII. Any member in arrears of subscription for two years shall be considered as having withdrawn from the Society, and his name shall be erased from the list of members without further notice, and it shall be the duty of the Managing Committee, to sue and recover the amount due, in any Court having competent jurisdiction. *No member shall be entitled to vote at the annual election of officers, or at any subsequent meeting, who shall not have paid his previous year's subscription.*

XVIII. The annual subscription shall be considered due and payable in advance, on or before the 23rd day of April in every year.

XIX. Any member elected to fill any office, refusing to serve, shall be fined two dollars, and any member of the Managing Committee absent from the regular Committee Meeting three times in succession, (unless absent from home, or in consequence of sickness,) shall be fined One Dollar, and it shall be the duty of the Managing Committee in all cases to see the fines collected.

XX. The duty of the President will be to preside and preserve order at all the meetings of the Society, and generally to watch over and superintend its concerns to the best of his ability. In his absence, the senior Vice-President present shall exercise the authority and duty of the President. In case of the absence of the first four officers from any meeting, the members present shall be empowered to elect a chairman out of their number.

XXI. The Secretary shall have charge of the Seal, Banners, and other insignia of the Society. He shall keep a fair register of all proceedings, orders, rules, and regulations, and manage the correspondence. He shall issue certificates of admission to each member on his having signed the Constitution, to which he shall affix the Seal of the Society. He shall, when necessary, summon the Society to its various meetings, and shall sign such cards of invitation to the Anniversary Celebration as may be required of him by the Stewards. He shall also, at all meetings of the Society, and of the Managing Committee, enter into the respective minute books the names of the members present at such meetings.

XXII. The Treasurer shall have the custody of the funds. He shall countersign such certificates of admission as may be issued by the Secretary. His accounts shall be fairly kept and exhibited to the President and the Managing Committee, whenever called for, and shall also be laid before the Society at its January meeting.

XXIII. In case of the death, resignation or removal of any of the officers during the year for which they were elected, the Society shall, at the next meeting, choose others in their places to serve for the remainder of the year.

XXIV. To preserve order, and to expedite the business of the Society, any member who may have proposals to make, or observations to offer upon any proposition, shall rise and address the President; and no person shall interrupt another when speaking, if the speaker be in order.

XXV. The introduction of political or religious subjects, on their discussion, shall never be allowed at any meeting of the Society, and in the event of any member introducing or speaking on such subjects he shall pay a fine of one dollar.

XXVI. The members of this Society shall faithfully observe and conform to all the rules and regulations that

shall be made by the society, and entered in the Books thereof, on pain of being dismissed from it and having their names erased from the list of members.

XXVII. If the majority of all the members present at any general meeting shall vote for the expulsion of a member, his name shall be erased, and he shall never afterwards be admitted to any meeting of the Society, unless again elected by ballot, as in the first instance; provided always, that no proposition for the expulsion of a member shall be in order, unless one clear month's notice has been given of an intention to submit it at the then next ensuing quarterly meeting.

XXVIII. The Banners and Flags of the Society shall not be used except on occasions where the Society, as a body takes part in the proceedings, or where the Society is represented by its Officers.

XXIX. That at any Quarterly or Annual Meeting the members present may, on one month's notice previously given, elect any one of its members an Honorary Life Member, in consideration of services rendered the Society, and also may elect any distinguished person eligible to become a member, in like manner for services rendered either the Society or the Country.

XXX. An Obituary Record shall be kept by the Secretary of any member of this Society who may hereafter die; stating his birth and parentage, if known, date of admission as a member, his position, general character, and such other facts in regard to him as may be interesting to chronicle. Such Record to be published with the Annual Reports.

XXXI. All Fines collected under these By-laws shall be paid to the Treasurer, and to go to the general funds of the Society.

XXXII. All Donations of Five Pounds and upwards shall be invested by the Managing Committee, and form a portion of the permanent fund, the interest on which shall alone be applied to the ordinary expenditure of each year, unless such Donation is made for a specific purpose.



REPORT OF THE
MANAGING COMMITTEE

OF THE ST. GEORGE'S SOCIETY, FOR THE YEAR 1860.

"The Committee of the St. George's Society appointed at the Annual Meeting in 1860, have now at the close of their year of office to give an account of their stewardship:

"The year that has just passed, your Committee feel will be regarded in the annals of the Society as one of peculiar interest. The benevolent action of the Society has been well sustained, the promotion of a social compact among Englishmen and their descendants in the land of their adoption has been fostered, and although loyalty was ever the watchword of the Society, it has in the year 1860 had an opportunity, which may never again recur, of evincing that loyalty in a manner, which, whenever the recollection is aroused will cause a glow of pleasure to kindle in the breast of every member of the Society.

"In proceeding to detail the expenditure of the benevolent fund of the Society during the past year, your Committee feel that it will have a useful effect to embody in their report some account of the manner in which the relief of the Society is disbursed, the labor involved, the caution used, and the efforts made, that while the deserving are never "sent empty away," to the deserving only shall the bounty of the Society be disbursed.

"The Committee of your Society meet every Friday throughout the year, at half-past five o'clock, and sit generally till half-past seven or eight, examining the applica-

tions for relief which present themselves. The cases are taken down in the relief book in the following order: the name of the applicant, the occupation or trade, whether married or single, and if married the number of his or her family, with particulars of the members of the family able to work and assist the parents, and of those still in infancy, the place in England or Wales from whence they emigrated, the date of their emigration to Canada, particulars of their employment or non-employment since, the cause of distress which leads to their application to the society, and last, not least, a recommendation from some one to whom they are known (the Clergyman of their Church preferred) that the case is one really deserving of relief. These particulars being noted, the applicant retires while the Committee deliberate; if satisfied a sum of money or an order for food or fuel is given; if not, one of the Committee undertakes personally to visit and report on the case. At these meetings the applications are frequently very numerous, but on no occasion, although their sittings have at times been much protracted have they risen until every case presenting itself has been disposed of. In addition to these weekly meetings of the Committee some one member has undertaken from month to month what may be termed the daily relief—that is holding the relief book at his private residence or place of business where urgent cases which cannot be deferred until the Friday meeting receive his attention, are temporarily relieved, and are afterwards reported to the weekly meeting. An alphabetical index of all cases thus relieved is kept; an applicant therefore attending a second or third time is at once recognised, and the continuation of their distress becomes *then* the subject of inquiry. The Records thus kept are handed from Committee to Committee, and form a valuable aid to those taking office for the first time. Your Committee in giving these details

would merely add that your society will at once recognise the delicacy attaching to their office, and they have a deep sense of satisfaction while reflecting on the large number of cases which have come under their investigation during the past year in believing that none left the Committee Room without feeling that their distress was sacredly confided to brother Englishmen, who in disbursing your bounty endeavored at the same time to throw a kindly veil over the suffering of the recipient.

"The number of applicants whose cases have been thus examined during the past year amount to several hundred, but your Committee do not feel, that after these details it will be necessary to enumerate in their report any of the names of the parties. The Relief Book itself is laid on the table.

"The above particulars have more immediate relation to direct pecuniary relief. Your Committee must also name another mode of aid, which your society has been able to extend very beneficially, namely, assisting by passes on the Railways, parties who cannot find work in Toronto to places where work offers, and on this head they must express the obligations the Society is under to all the Railway Companies who kindly and generously contribute to the bounty, and aid the objects of the Society by conveying to their destination at half price any party presenting the order of the Society.

"Another manner in which the Society has been able to relieve distress has been in recommending cases for admission into the General Hospital, and your Committee are very sensible of the kind attention with which their recommendations have been always received.

"Under the head of relief your Committee must lastly particularize in their report the distribution of English cheer on Christmas Eve to poor English families. The

success attending their efforts in this behalf was most gratifying, and the special collection taken up for the purpose, after meeting the requirements of every applicant, left a balance of \$111.24 to be carried to the general fund of benevolence. The following are the details of this truly English distribution:—

"The number of families relieved was nearly 400, comprising by the particulars recorded on examining the cases, some 1,495 souls.

"The distribution took place in one of the stores under the Romain Buildings kindly lent to the Society for the occasion by the Hon. Mr. Attorney General McDonald. In an appended sheet are given the names of those who subscribed in money and kind, and while any attempt to particularize individual energy on an occasion where the energies of all were most pleasurably displayed may be considered invidious, the manual labor given by Mr. William Grainger, Butcher, of the St. Lawrence Market, in addition to a most handsome donation, should be named for the especial recognition and thanks of the Society.

"The Christmas cheer was generally distributed to English families, but after such were relieved the Committee extended the boon on a limited scale to a number of other applicants; thus while verifying the proverb that "charity

begins at home," in this instance not allowing it also to end there.

"Having thus set out the disbursements of the Society in the cause of benevolence, your committee now come to an enumeration of the funds collected for that and other purposes, and an account of the manner and sources of their collection.

"On this head, as first in order, your Committee record the services in the Cathedral on St. George's Day, which produced an offertory collection of \$205 25. In alluding to these services your committee feel that the thanks of the Society are in an especial manner due to their respected chaplains, the Rev. Dr. Beaven who intoned the services, and the Rev. Dr. Scadding for his eloquent and appropriate address at the morning service, and to the Rev. E. K. Kendall (then Professor at Trinity College, but who has since returned to England) for his impressive sermon at the Evening Service and to the other clergymen who assisted at the services. Of the musical portion of the services, there was but one opinion expressed which was embodied in the following resolution presented to Mr. Carter at the time, and which your committee here reiterate.

"That the thanks of the St. George's Society are in an especial manner due and are hereby cordially tendered to their esteemed life Member, John Carter, Esq., the Organist and Conductor of the Choir of the Cathedral Church of St. James, Toronto, and to the Ladies and Gentleman composing the Choir for their kind aid in the perfect and solemn Church Services performed in the Cathedral on St. George's Day, the 23rd April 1860, and that copies of this resolution be forwarded to Mr. Carter and to the Ladies and Gentlemen of the choir."

"On this occasion, the Society assembled at their Rooms on Yonge Street, and thence with their Banners and Re-

galia proceeded to the Cathedral. At the morning service a large Congregation was present and at the close of the services the Apostolic Benediction was pronounced by the venerable and respected Bishop of Toronto. The evening attendance was still more numerous, it being estimated that not less than 5,000 were present within the sacred walls. Your Committee earnestly recommend a continuance of this observance of St. George's Day as well calculated to evince to the World that the proceedings of the St. George's Society are undertaken in reliance on, and to the glory of Him from whom all good counsels and all just works can alone proceed.

Your Committee would next record the annual excursion of the Society which took place on the 31st July. Ample preparations having been made, a large party of excursionists proceeded by early train on the Northern Railway to Bell Ewart, whence by the steamer "Morning," they proceeded to Jackson's Point, on Lake Simcoe, at a short distance from which, in beautifully wooded grounds, kindly placed at their disposal by Col. Boucher, by whom, together with Mr. Sheppard, and many other of the neighboring gentry, they were most hospitably welcomed; a day of thoroughly English recreation, or, in the words of the advertisement a "genuine English Pic Nic" was enjoyed, and the result of which, deducting expenses from receipts, was an addition of \$50.52 to the funds of the Society. Such re-unions are in a special manner calculated to keep up a kindly feeling among English families. A dinner is almost necessarily confined to one sex, but on happy occasions like the one now recorded, the fair daughters of England can also listen to a recital of the objects of the Society and thenceforward encourage her sons to persevere in their accomplishment.

The next matter to be recorded is the part taken by

the Society in the reception of His Royal Highness the Prince of Wales on his late auspicious visit to Toronto. With a view to a becoming participation in this great event of future Canadian history, your Society were specially called together at an early day, and after due deliberation decided on the acquisition of new Banners and Ensigns to be then first unfurled. These Banners which now grace our room reflect high credit on the designer and painter, Mr. Todd; the first bearing on the chief side a spirited representation of St. George's victory over the dragon, as taken from Wyon's beautiful medallion, and on the reverse the three Lions of England. The second banner having on the chief side the Plume of the Prince of Wales, and on the reverse the Star and Garter. There were also procured a complete set of national Banners, comprising the Red White and Blue Ensigns; the Union Jack, and the St. George's Cross; nor were the jewels of the Society overlooked, a new and beautiful jewel having been procured for the President, and the set of jewels for the other office bearers being made perfect and complete, but the enthusiasm of the Society did not stop here, for among the most beautiful arches erected in the city was the one raised by the Sons of St. George, while the address prepared by the President and presented to His Royal Highness, further testified the loyalty of the Society.

"Thus furnished with ensigns and regalia the St. George's Society took its place in that great procession, admitted to be unrivalled for extent and enthusiasm, which welcomed our future Sovereign, the beloved son of our beloved Queen, Albert Edward Prince of Wales, in his triumphal entry into Toronto on the 7th September, 1860, an event to be witnessed to be thoroughly conceived; an event which will be a lasting reminiscence of joy to every loyal Englishman, and of which this slight record, embodied in

their Report, the committee feel your society will appreciate. The Address presented to His Royal Highness is also annexed to their Report.

"Before concluding their report your committee desire to bring before the Society a subject which has frequently occupied their own deliberations, and the importance of which they deem so great that they embody it in their report for the future consideration of the Society. It is the acquisition at the earliest possible day of suitable rooms in some good locality to bear the name of the Society, and where both its committee and public meetings can be held. Your committee in drawing attention to this matter, desire at the same time to record their thorough approval of the high character attaching to the "Globe Hotel." where the meetings of the Society have been so long held, and from the worthy proprietors of which your committee have to acknowledge the greatest courtesy, attention and assistance in all matters connected with the Society, but they are deeply impressed with the conviction that our association never can take its proper place as a Benevolent Society while its meetings are held at an hotel, and that many will be induced to become members and give valuable aid, so soon as the Society acquires its "St. George's Hall" in some separate building. The expense attending the acquisition of such a room need not be considerable. With the banners and ensigns of the Society it could be readily and appropriately decorated, and but for the various other calls on the liberality of the members during the past year, it was the hope of the Committee that they might have initiated some step towards the accomplishment of this change—as it is, they warmly commend it to the Society.

"Finally, your Committee desire to appeal urgently to members of the Society to pay up arrears of dues and for punctuality in paying the annual subscription into the

hands of the Treasurer. A reference to the balance sheet appended to their report will at once shew that the receipts of the past year have been chiefly made up of sums raised by what they may term extraordinary efforts, while the ordinary dues of members remain unpaid. The collector of the Society has now a long list of dues in arrear in his hands for collection, and it is earnestly hoped that when this Report is read, and the efforts of the Society well considered, their successors in office will be encouraged in their labors of the ensuing year by an immediate and hearty response to this appeal.

G., &c. &c. &c.

MAY IT PLEASE YOUR ROYAL HIGHNESS,

The St. George's Society of Toronto crave permission to approach your Royal Highness on this auspicious occasion, to express their devoted loyalty to their beloved Queen and their homage to your Royal Highness, as the illustrious Heir to the Crown of that mighty empire "on which the sun never sets."

In the progress of your Royal Highness through this great dependency of the British throne, your Royal Highness has witnessed that unity among the subjects of her gracious Majesty who have made Canada their home, and has received that undivided outpouring of Canadian love and loyalty which may render it matter of surprise that Societies possessing features of individual nationality exist amongst us. On his Retiring from the Office of President.

"SIR,—We, the members of the St. George's Society of the City of Toronto, upon the occasion of our annual general meeting, desire to express our appreciation of the able and efficient manner with which, during the past year, you have occupied the position of President.

"When leaving the home of their fathers the sons of St. George, ever jealous of their peculiar characteristics, and desiring to maintain their cherished nationality, were formed into a Society for the maintenance of social and friendly intercourse with their countrymen, and associated in that kindly compact for the performance of charitable and benevolent deeds, so that in a distant and strange land the wanderer might find a home, the stranger a friend, and the bereaved widow and helpless orphan be saved from the blast of a cold and inhospitable world. These praiseworthy purposes have never been lost sight of by their successors, and while we submit that, as an Englishman, you must have felt grateful pride in being placed at the head of a community, having in view the furtherance of such disinterested and laudable objects, we assure you that we shall ever advert to your tenor of office with a gratifying knowledge that we were presided over by one who, as a scholar and a gentleman, portrayed in a courteous and amiable disposition the noble characteristics of an English worthy.
