In publishing the announcement of another session of the Halifax Medical College, the faculty desires to draw attention to a few points in connection with the history of the Institution.

Inaugurated thirteen years ago as the Medical department of Dalhousie College, it has for the past four years had an independent existence under its present name. During the whole of this time the College has steadily advanced, and the progress which has been made is taken as ample evidence of the wisdom of its establishment.

From its original inception as a merely preparatory school, the College has gradually advanced to the standing of a first class. Medical Institution, where a thorough and complete. Medical education is afforded to a large class of young men, drawn from various parts of the Maritime Provinces, who would otherwise have gone away to pursue their studies chiefly in the United States, at a loss to the country and at greater expense to themselves.

By the requirement of a strict Preliminary or Matriculation examination, by increasing the duration of the period of study and by the high standard of the professional examination demanded, it is claimed that the qualifications of young men entering the profession, even in cases where their entire course is not taken in this College, have been rendered very much superior to the average in former years.

The Faculty feels that its efforts have been productive of good results and that the correctness of the views entertained by it in the early years of its existence must now be evident, and would therefore unge upon the consideration of the profession, the public and more particularly of those, intending to pursue the study of medicine the claims of the Halifax Medical College.

In connection with the advantages of the Institution, attention is drawn to the importance of Halifax as a medical centre, it enjoying advantages for the study of those rare forms of disease which find their. way to important seaports. In this respect it surpasses every other City in the Dominion, as being an open port during the winter, it is a resort for shipping at that season, when the others are by nature debured therefrom. The Provincial and City Hospital is supplied constantly from this source, while it receives a yet greater number of cases from all parts of the Province, affording the student an extended field for observation; here also are open for competition each year the positions of House Surgeon and Clinical Clerk. In addition to this, he has afforded him the resources of the Provincial Alms House, with its large infirmary of chronic and incurable diseases, its Lying-in Wards for instruction in obstetrics, &c., and the City Dispensary, with its large attendance, where he may study Minor Surgery, affections of the Eye and Ear, and the various forms of disease that make up the routine work of the practitioner of Medicine.

The College Building erected for the special purposes of Medical teaching is in every way fitted for the object in view. It is situated in an open and airy locality, in close proximity to the Provincial and City Hospital and the Alms House. The Lecture Rooms, Dissecting Room, Reading Room, Library, Museum, Chemical Laboratory, &c., are well lighted, ventilated and warmed, and are fitted with all the modern appliances for imparting knowledge.

The supply of material for Dissection is abundant, a great desideratum considering the difficulties experienced in this regard by many other Institutions.

The Chemical Laboratory fitted up at a large expense is furnished with all the most recent apparatus necessary for the pursuit of a course of study in Practical Chemistry.

The Clinical material both at the Hospital, Dispensary and Poor's Asylum is varied, abundant and always available.

The courses of Lectures of this College have been accepted by the General Medical Council of Great Britain and by the Medical Schools on this continent.

Evidence of the improved status of Colonial Colleges in the Mother Country is given by the late action of the General Medical Council, regarding the standing of their Graduates, as shown by the following resolution passed at a meeting of that body, held May 1971.

"That the medical qualifications granted under latt authority in any part of Her Majesty's Dominions outside the United Kingdom, and entitling to practice in such parts, should be registrable within the United Kingdom on the same terms as qualifications which are granted in the United Kingdom, but in a separate and alphabetically arranged section of the Register." in any n, and in the ranted ranged The attention of students is called to the fact that the exception made in the Provincial Medical Act, regarding students who commonced their studies before a certain date, has now ceased to take effect; and that in future the Provincial Medical Board will rigidly enforce the clause demanding four years of study previous to graduation. It will thus be seen that degrees from Colleges requiring a less number of years of study will no longer qualify for Registration under the Act.

Since the establishment of the University of Halifax, the Halifax Medical College has become affiliated with that Institution, thus affording the student an opportunity of obtaining a University Degree without the necessity of going abroad for it.

One of the students of the College has already availed himself of this privilege, and it is a good proof of the efficiency of the training given, that he passed the examinations for the Degree of M.B. with honors; and in no instance, as far as known, have students from this Institution failed to pass the examinations required by the old country Colleges.

The following extract from the regulations of the Senate of the University of Halifax, is of interest in this connection :

"During the years 1878, and 1879 and 1880, Candidates for the Degree of Bachelor of Medicine or of Bachelor of Science, who have passed the Preliminary Examination of the Provincial Medical Board, shall, upon producing to the Registrar eatisfactory evidence of this fact, be allowed to proceed to the Examination for the Degree of Bachelor of Medicine or of Bachelor of Science without being required to have passed the Matriculation Examination of this University."

Students of Dentistry will find it of advantage to attend the Lectures on Chemistry, Anatomy and Practical Anatomy.

To Druggists' Assistants the courses in Materia Medica, Chemistry, and Botany, offer an opportunity to qualify themselves for passing the examination required to admit them to a Degree in Pharmacy in accordance with the regulations prescribed by the College, with regard to which, see Regulations, &c., for Students in Pharmacy, or for passing the Board of Examiners of the N. S. Pharmaceutical Society.

Students of Law will find it desirable to attend the Lectures on Medical Jurisprudence, especially as part of the course is delivered by a legal gentleman.

In continuing the prosecution of their endeavour to furnish a sound Medical Education, the Faculty has to state that no effort will be spared to keep the standard of teaching on a level with the present state of Medical Science.

Session of 1879-80.

The Thirteenth Session will commence at the Halifax Medical College on Thursday, the 23rd of October, 1879. The regular order of lectures will begin on Monday, the 27th of October, and will be continued during the six months following. The Public opening exercises will be held some days later.

REGISTRATION.—All Students are required at the beginning of the Session, or as soon afterwards as possible, to register their names with the Registrar, Dr. J. F. Black, or in his absence with the Assistant Registrar, Dr. A. Lawson. The time fixed for closing the register is the 30th of November in each year.

SESSIONAL EXAMINATIONS.—Sessional Examinations will be held twice during the Session, viz : before the Christmas Vacation and at the close of the Session, attendance upon them being compulsory. These examinations are only auxiliary to and do not take the place of the Pass Examinations in the Preliminary and Final subjects, except that, in Botany and Medical Jurisprudence, which, if satisfactory, will be considered sufficient.

DEGREE EXAMINATION.—The division of the Examination for Degree into Preliminary and Final, having been found to be most advantageous to Students, is adopted by this Faculty, and it is hoped that the greater number of third year Students will avail themselves of this arrangement.

While the College regulations permit a Student to graduate after three years' attendance upon Lectures, provided he furnish proof that he has studied one year before attending Lectures with a private practitioner, yet he is recommended to devote four years to systematic instruction, as less time is scarcely sufficient to acquire a fair knowledge of the many subjects which compose the curriculum.

THE PROVINCIAL AND CITY HOSPITAL, visited daily at 12 M., by the Medical Officers, and the CITY ALMS HOUSE containing from 200 to 400 inmates, many of whom are in the Hospital Wards, are available to students without fee. The best opportunities are here presented for clinical instruction, midwifery practice, and the study of the treatment of diseases; likewise for the observation of pathological appearances, which will be demonstrated by *post moriem* examinations. There is a Hospital fee of \$1 for certificate of attendance.

THE HALIFAX DISPENSARY is carried on after the model of the DeMilt Dispensary, New York, being divided into four departments, viz: (1) Surgical. (2) Medical. (3) Diseases of Women and Children. (4) Diseases of Eye and Ear. Here the student has the advantage of becoming practically acquainted with the less severe forms of disease, the privilege of seeing patients with the visiting physicians, and opportunities for Obstetric and Dental practice.

The new and spacious building lately erocted for Dispensary purposes is now fully equipped and in active operation. The number of applications for relief has largely increased, amounting during the past year to 9,500.

Extracts from the Regulations.

COURSES OF LECTURES, FEES, &c.

1st .- Each Professor shall deliver at least five lectures during the week, except in the classes of Clinical Medicine and Clinical Surgery, in physic, Surg each of which only two Lectures shall be required; and in that of ractice the Medical Jurisprudence, if extended through six months, in which case the Provinci three Lectures a week will suffice.

2nd.-Each Lecture shall be of one hour's duration.

3rd .-- Every professor shall occasionally examine his class upon the subjects treated of in his preceding Lectures ; and every such examination shall be considered a Lecture.

4th.-A roll of the names of the Students attending each class shall to such ex be called from time to time.

5th .-- All tickets which have not a certificate as to attendance upon the course and presence at sessional examinations attached, shall be rejected when presented as testimonials previous to examination for degree, unless the omissions shall be satisfactorily accounted for.

6th .- The fee for each class shall be \$12, with the following exceptarry out th tions :--- For each of those of Medical Jurisprudence, Practical Chemistry and Botany, \$6. Practical Anatomy, \$8. Practical Pharmacy, \$4. These fees are payable in advance to the Registrar.

7th .- All Students desirous of attending the Lectures, shall, at the commencement of each Session, enrol their names and residences in the established Register of the College, and procure from the Registrar a ticket of Matriculation, for which each Student will pay a fee of \$2, or a perpetual Matriculation ticket will be granted on the payment of \$5.

8th .- The said Register shall be closed on the 30th day of November in each year.

9th .- Any student, after having paid the fees, and attended two courses of any class, shall be entitled to a perpetual ticket for that class, except in Practical Anatomy.

10.--The courses of . all Classes, except Practical Chemistry, Botany, and Medical Jurisprudence, shall be of six months' duration; the Classes of Practical Chemistry, Botany and Practical Pharmacy of three months' duration ; and that of Medical Jurisprudence either of three months' duration, in which case five lectures a week shall be given, or of six months duration, in which case only three Lectures a week shall be required.

11th.-The course shall commence on or about the 25th October in each year, and with the exception of a vacation at Christmas, shall continue for the six months following.

12th .- All students except graduates in arts of recognized Universities are required, by Provincial law, to submit to the matriculation examination, the commencement of their Medical studies being counted from that date.

Fee for Examination, \$5. This fee shall not be returned in case of rejection of the candidate. The Preliminary or Matriculation Examination is appointed by the Provincial Medical Board for the first Wednesday in May, third Wednesday in September, and third Wednesday in November

N. B.-Graduates in Arts of recognized Universities are not required to submit to this examination.

REGULATIONS FOR DECREE IN MEDICINE AND SURGERY.

1st.—No one shall be admitted to the Degree of Doctor of Medicine and Master of Surgery, who shall not have attended Lectures for a period of at least four years, subsequently to the date of passing his Matriculation Examination, in this College or some other University, College, or School of Medicine approved by this College; (a certificate from his tutor or tutors that the applicant has been one year studying Medicine in the office of one or more registered Medical Practitioners will be received in lieu of one of the four years of study—but in any case three years will be required.)

2nd.-Candidates for the Final Examination shall furnish Testimonials of attendance on the following branches of Medical Education, viz t

Anatomy, Chemistry, Materia Medica, Physiology, Principles and Practice of Surgery, Obstetrics and Discusses of Women and Children, Principles and Practice of Medicine, Practical Anatomy, Clinical Medicine, Clinical Surgery.

Practical Pharmacy, Medical Jurisprudence, Botany, Practical Chemistry,

Of which one course will be required of three months duration.

4th .- He must give proof by ticket of having attended for at least ix months the practice of a Lying-in-Hospital, approved of by the college, or of having attended at least six cases of accouchement; also a in case of ertificate from a registered Medical Practitioner, of "Proficiency in the Examina-Practice of Vaccination.

5th .- No one shall be permitted to become a candidate for examinanesday in ion, or shall receive a Degree, who shall not have attended at least one Bession of this College, and have obtained from it the tickets for one full course of all the branches included in its curriculum.

6th. A Medical Session consists of registration and attendance upon courses of Lectures on at least two of the regular subjects of study.

7th .--- A course upon Practical Anatomy is understood to mean that the Student shall have dissected the body once, i. e. three parts.

8th .- Courses of less length than the above will only be received for the time over which they have extended.

9th .- Every candidate for the Degree must, on or before the 15th day of March, present to the Registrar of the Medical Faculty Testimonials of his qualifications entitling him to examination, also a Thesis or Inaugural Dissertation upon some subject connected with Medical or Surgical Science, and at the same time deliver to the Registrar of the Faculty the following certificate :

I, the undersigned, being desirous of obtaining the Degree of Doctor of Medicine and Master of Surgery, do hereby declare that I have attained the age of twenty-one years, (or, if the case be otherwise, that I shall have attained the age of twenty-one years before the next graduation A. 10th .- The trials to be undergone by the candidate shall be !-

(1). A general written and oral examination on all the branches of Medical and Surgical Science.

(2). A Clinical Examination in Medicine and Surgery conducted at the bed side, cases being submitted for Diagnosis and treatment in the Wards of the Hospital. In estimating the standing of Candidates and the number of marks to be awarded, Professors shall take into account the regularity of their attendance, and the diligence and care they have evinced in reporting cases.

The examinations will be divided into Primary and Final, the former comprehending the branches of Anatomy, Chemistry, Materia Medica, Physiology, and Botany or Zoology; the latter, those of Practice of Medicine, Surgery, Obstetrics and Medical Jurisprudence. It will be ellowable for the student to present himself for the primary examination at the end of his third Session (or third year of study).

12th .- The fee for the Degree of Doctor of Medicine and Master of Surgery shall be twenty dollars, to be paid by the candidate before examination, together with a Registration Fee of one dollar.
