An Act to amend a certain Act passed in the 12th year of Her Majesty's Reign, intituled, "*An Act to amend the School Law of Lower Canada*".

WHEREAS it is expedient to amend the Act passed in the Preamble. twelfth year of Her Majesty's Reign, intituled, "*An Act to amend the School Law of Lower Canada*;" Be it therefore enacted, &c.,

5 That from and after the passing of this Act, the School Commissioners for any School Municipality, in addition to the powers granted to them under and by virtue of the Act above cited and other Acts relating thereto, all which powers are hereby reserved to them, may institute suits or prosecutions in the manner and for the causes and reasons mentioned in the 16th Section of the Act above cited, before any Commissioners' Court for the trial of small causes, sitting within the Municipality interested, if there be such Court, and if not, in the Commissioners' Court for the trial of small causes; nearest to the Municipality interested in such suit or prosecution; and the said Court of Commissioners of small causes, is hereby required to take cognizance of and determine upon all and every such suits or prosecutions so brought before them, in the manner and form prescribed by the law creating such Court.
