INSTRUCTIONS.



ALL Barrack-Masters are to account to the Deputy-Barrack-Master-General, or other person at the head of the Department, in the District they serve in, for all the barrack bedding, furniture and utensils, they receive in charge for the use of the troops.

They are also required, and directed, to send to the Deputy-Barrack-Master General, or other person at the head of the Department in the District they serve in, at the close of every two months, or oftener if required, the following Returns, Reports and Accounts, viz.

I. A Return of barrack bedding, furniture and

utensils, for which they are accountable, beginning with the quantity in charge at the period the last return was made up to, the quantity received from the Commissariat since, with a copy of the receipt given for them, certified by the head of that Department, at the place where such articles are received, deducting such articles as are deficient, and paid for by the troops : Provided the money is remitted for them with the returns, then, and not otherwise, the Barrack-Master will be allowed to take credit for them : taking care to have the vouchers for such deficiencies made out on whole sheets of foolscap paper, specifying the articles, and prices thereof, certified by the commanding officer of the corps or detachment with whom such deficiency has occurred, that it is correct, and the remains in charge on the period to which the return is made up, with a Statement, or Distribution, thereof, specifying the articles in store, and in use by each corps or detachment, vouched by Inventories from the respective commanding officers, or receipts signed by them, all agreeable to the forms now in use—of this inventory, or receipt, the return of stores, and the copy of the receipt given to the Commissariat, for articles received from that department, the original only is required to be sent.

II. A report of the state and condition of the Barracks and Government Buildings in their

charge, and the manner in which they have been occupied, for the two preceding months, specifying the rank and names of the Officers, and the number of the non-commissioned Officers and Privates occupying each room, or quarter, during that period, which report must be countersigned by the officer commanding the Post.

III. A return of the officers, non-commissioned officers and privates, that march into, and out of, barracks, during the period of every two months, specifying the names of the officers, and the day they arrive and leave the post.

IV. Certificates of the Officers of the Staff, who may be stationed at the Post, that are entitled to an allowance of Lodging Money, also Regimental Returns of Lodging Money due to Officers of Regiments, taking care to return such only as are present doing duty, and not quartered in any Barrack, or Government Building; nor are any Officers of Regiments to be returned for Lodging Money, when there are vacant Quarters, suitable to their rank, notwithstanding they may not occupy the same—These Regimental Returns to be made out, according to the Forms and Rates now in use.

Officers to be accommodated in Barracks, according to the Scale No. 2, annexed.

V. The expence incurred for Washing Barrack Bedding, to be made up in accounts in triplicate

every two months, at the rates mentioned in Scale No. 3. These accounts to be accompanied by a certificate on each, from the commanding-officer of the corps, or detachment, in whose use it has been, that it was returned dirty into store, which will be a sufficient voucher, to authorise the washing. These accounts to be also certified by the Barrack-Master. It must be remembered, that sheets are always paid for by the troops, and never brought into the accounts with the other bedding. On the delivery of clean sheets to a corps, or detachment, the Barrack-Master is to make application to the Quarter-Master of such corps or detachment, or person acting as such, for payment for the washing thereof, at the rate of three pence half penny per pair, for every pair so issued. No bedding that has been in use of one corps, or detachment, can be issued to another, without previously being washed. The bedding is to be exchanged, according to the periods marked in Scale No. 4 and 5, and no corps or detachment can be allowed to have it exchanged oftener, unless a special authority is issued for that purpose, by the officer commanding at the Post where such exchange may be found necessary : which authority must be forwarded with the certificates, and accounts for washing the same : and it is the particular duty of the Barrack-Master to see that the bedding is exchanged at the proper periods,

VI. The accounts for the hire of buildings, for Barracks, or other purposes, must also be forwarded in triplicate, and the agreement entered into for the hire of such places, must accompany them on the first charge being made, which, when approved, will be an authority for the same.

VII. When a corps or detachment arrives at a Post, or Garrison, the Barrack-Master will require from the commanding officer a correct return of the rank and names of the officers, and number of the non-commissioned officers and privates, of which it consists: He will then deliver over to him, or such person as he shall appoint to receive them, Barracks, Bedding, Furniture and Utensils, according to the strength, and agreeable to Rules hereafter mentioned in No. 4 and 5. Quarters are to be given to officers according to their rank, and to correspond with those marked in the Report of Barracks, as being occupied by such officers.

Such a number of barrack rooms, and quantity of bedding to be issued for Regimental Hospitals, as the commanding officer or surgeon may require, and the officer commanding the Post may approve of the rooms being furnished the same as privates' rooms.

Proper apartments are also to be furnished for Officers' Mess, if such are in the Barracks, but no furniture, or utensils, are to be delivered for that or any other purpose, than above described, with

out a special order from the officer commanding the Garrison or Post, or from the Head-Quarters of the District: and copies of all orders of that nature, received by Barrack-Masters, must be sent to the Deputy-Barrack-Master General, at Halifax.

Barracks being delivered and furnished, the Barrack Master will make out a correct inventory thereof, specifying the names of the officers occupying each apartment, and the number of non-commissioned officers and privates, and the quantity of bedding, furniture and utensils, in each room, also the state and condition (minutely detailed) in which every article, and particularly glass, locks, plaistering, &c. &c. were delivered in, and will require the commanding officer to sign the same: a duplicate of which he will transmit to the head of the Department in the District, with his return of Stores, &c. as aforesaid.

VIII. He shall also, accompanied by the commanding officer or quarter-master, or some person acting as such, inspect the barracks, bedding, &c. in use of the troops, once in each month (viz. between the 20th and 24th days) renewing the Inventories, and charging the Regiment with all Deficiencies and Damages, except such Damages as he is conscious have arisen from fair wear only, at the prices established in Scale No. 7: and will remit the amount to the head of the Department as before directed: but if it should appear that the

inspection was not made in due time, or the demand on the commanding officer for the amount of the Deficiencies and Damages not made immediately after the inspection, such amount shall be made good by the Barrack Master himself. The vouchers for Deficiencies to be in triplicate, and of that for Damages the original only need be sent.

For all other losses of Stores, the Barrack Master is of course held responsible, unless satisfactory certificates, from the officer commanding at the Post, are produced, that the accidents by which they became deficient were unavoidable, such as a Barrack or Store taking fire.

IX. On the removal or embarkation of corps or detachments from a Garrison or Post, the Barrack Master, accompanied by the commanding officer, or some other officer appointed by him, shall minutely inspect the Barracks, Bedding, &c. charging for all deficiencies and damages, the same as at a Monthly Inspection: but as this Inspection cannot be made before the troops have marched out of the Barracks, he will, in order to save time, and prevent many other inconveniencies, require the commanding officer to deliver up the Bedding, Furniture, &c. into the Barrack Store, or some other place of security, the day before the corps embarks or marches; and inspect the Barracks immediately after the troops have quitted them,

and require the commanding officer to send a party to sweep and clean them out before he takes them in charge from him, which will enable him more correctly to ascertain any damage they may have sustained, and will charge the same, except fair wear, at the established rates : but in case damage has been done to the floors, plaister, or any other parts of the building, the amount of which cannot be ascertained from the foregoing rates, he will call on the Engineer to send a proper person to estimate the same, and where there is no Engineer the most respectable Mechanic of the place, and will charge the same agreeable to their Estimate, which Estimate must accompany the account.

But if Commanding Officers prefer making good any damages, that may appear at monthly inspections, or embarkations, to that of paying for them, at the above rates or estimates, they may be allowed to do so, and the Barrack Master will be responsible that such repairs are executed by mechanics in the best manner, but no such permission will be allowed with respect to bedding, furniture, or utensils, which must be paid for, at the established rates.

X. Note—All cracked glasses, and iron pots, found on the embarkation of any corps, or detachment, must be charged as if deficient.

XI. When barrack bedding, furniture, &c. is wanted for the use of the troops, either on

their arrival, or to exchange articles rendered un-
serviceable, or to replace articles deficient, and
paid for at monthly inspections; the Barrack-
Master will make a requisition for the same, on
the head of the Commissariat, at the post or gar-
rison, which requisition must be laid before the
officer commanding the post or garrison, for his
approval, previous to the issue being made.

XII. When Barrack Masters obtain leave of
absence, or are removed from one post to another,
they are, along with the person, appointed to re-
lieve them, to inspect the bedding, &c. in store,
and in use of the detachments, &c. and send to
the head of the department, a correct return of
the quantity, and state of the same, signed by
them both, as well as a correct report of the state
and condition of the barracks, and by whom oc-
cupied, signed as above; they are also required to
account and settle with the troops for all deficien-
cies up to that time, and to deliver over to their
Successor, all Papers, Books, Forms, Letters, In-
structions, &c. An Inventory of which, signed
by both, to be sent to the head of the Depart-
ment; their Cash Accounts must also be made up
to the period, or so arranged that their Suc-
cessor may be enabled to make them up at the
end of the period, during which they may be
relieved.

XIII. When Commanding Officers of Corps, or

Detachments, return any Officers for Lodging Money, Barrack-Masters will require from them, a return of the names of the officers that have occupied the barracks in their charge, specifying the exact time each officer has occupied the same during the period, and if it should then appear that any of the officers returned for Lodging Money, could have been quartered in barracks during the time they are so returned, the Barrack-Master will acquaint the Commanding Officer that it is contrary to his Instructions and the established Regulations to admit any such charge in his accounts, nor is he to admit any charge for Lodging Money, for a back period, not within the period of the two months, for which he is making up his accounts, except in cases where it may appear by the certificates of commanding officers that the officers so returned were employed at distant harbours, or posts, within the district, at which there are no barracks, or on the recruiting, or other service of their corps. These certificates, as well as the aforesaid returns, must accompany all Lodging Returns.

XIV. No expence to be incurred for the removal of bedding, &c.

XV. Barrack-Masters will cause the chimnies of barracks, and government buildings in use of the troops, to be swept once in each

XVI. Should any officer refuse or avoid paying
 for any deficiency or damage, immediately on their
 being ascertained, with an account thereof render-
 ed to him by the Barrack-Master either at monthly
 or other inspections, or on a corps or detachment
 leaving a post, the Barrack-Master will immediately
 apply to the officer commanding at such post for
 his interference, and if payment is not ordered
 by him, for the amount, the circumstance is im-
 mediately to be communicated to the Deputy
 Barrack-Master General, with an Account of the
 Deficiencies, verified upon oath, by the Barrack-
 Master, before a Magistrate, and also the reason
 assigned by the officer for not paying the same,
 which the Barrack-Master will require him to give
 in writing.

XVII. When repairs are required to the Barracks
 at a Post, where no Engineer, or person acting as
 such, is present, the Barrack-Master will cause an

Estimate of the Expence requisite to be incurred for repairing the same, to be made out, which Estimate must be forwarded to the Deputy-Barrack-Master General, certified by the officer commanding at such Post : and the Barrack-Master is not to proceed to carry any of the work mentioned therein into effect, until he receives information that the estimate is approved, unless there is an absolute necessity for the same, and he is directed by the officer commanding to do so.

The account for this work to be made out in triplicate, and forwarded with the others at the end of the period during which the same is performed.

XVIII. Barrack-Masters are authorized to make a charge for Utensil Money, for the non-commissioned officers and privates of a corps that may be stationed at a Post, or Garrison, at the rate of nine-pence halfpenny, sterling, per man : they are, however, only entitled to this allowance once in every twelve months—this charge only to be made at such Post as may be the Head-Quarters of a Regiment. The account to be in triplicate, certified by the officer commanding, and also by the Quarter-Master of such Regiment.

XIX. All accounts, Estimates, &c. to be certified by the Barrack-Master.

XX. When any bedding, furniture, or utensils, in charge of a Barrack-Master, proves unserviceable,

REMARKS.

No. I. A General Officer on whom the Command of the Forces throughout the whole of His Majesty's Provinces in British North America, shall devolve, will be considered as having a right to receive the Allowance of Lodging Money and

Office Rent, which he would be entitled to, if he held the Commission of Commander in Chief, in addition to that which establishes his Rank on the Staff.

II. A General Officer to whom the command of a whole District shall devolve, will be considered as entitled to receive the allowance of Lodging Money appertaining to the rank next above that which he holds on the Staff, provided such officer has not local rank in North America, which places him above that he holds in the Army.

III. Any officer, either on full or half pay, holding a Staff situation, the allowance of Lodging Money appertaining to which is inferior to that which would be attached to his regimental rank, will be entitled to receive such as he would draw, if serving with his regiment.

IV. Officers having brevet rank, can receive the allowances of Lodging Money appertaining to that rank.

V. A Captain commanding at the head-quarters of a regiment, when there is no Field Officer of the same within the limits of the District, is to be considered as entitled to the allowances of Lodging Money appertaining to a Field Officer.

VI. When a Deputy Commissary and Store-keeper General is obliged to occupy more than

one room as an office for his assistants and Clerks, twelve pounds per annum will be granted for each room actually hired for this purpose, on his certificate that this has been unavoidable.

VII. Whenever the Commissary and Comptroller General of Army Accounts is not resident in a District to which a Comptroller of Army Accounts is attached, six pounds extra per annum, will be allowed for the office rent of the Comptroller of Accounts for the District.

VIII. No person is to receive Lodging Money in more than one capacity.

IX. All persons under the Board of Ordnance, who are entitled to receive either Lodging Money, or a consideration in lieu thereof, are not to be permitted to receive any allowance of Lodging Money from the Barrack-Master-General's Department.

X. No persons to whom Quarters are allowed, can, on any pretence whatever, be permitted to receive Lodging Money.

XI. When buildings or rooms belonging to Government are allotted for Officers or Offices, no Lodging Money or Office Rent can, on any pretence whatever, be allowed to such Officers, or for such Offices as they are appropriated to.

XII. No allowance of Lodging Money, or Office Rent, is to be made to any person, unless he comes under one of the descriptions mentioned in

the Schedule, without a special order from the Commander in Chief.

XIII. No person, when on leave of absence, though within the limits of the Command, unless he is called upon to do duty at the place where he is permitted to pass his leave, can receive his allowance of Lodging Money during the period of such absence, unless by a special order from the Commander in Chief.

XIV. Every person is required to make his demand for the whole of his allowance of Lodging Money on the day succeeding the close of each two months, for such sum as may be due to him for the two months preceding. viz: on the 25th of February, 25th of April, 25th of August, 25th of October, and 25th of December, under pain of forfeiting such allowance, should he neglect complying with this Order: the Barrack Master General being hereby required to acquaint all Barrack Masters of Garrisons and Posts under him, that should they return any person for the allowance of Lodging Money due him for any period of longer standing than that of two months, they will do it at the risk of being proceeded against for disobedience of General Orders. The Quarter-Masters of Regiments, and the Officers doing that duty with Corps and Detachments, are to make the demands of Lodging Money for the Officers of the Regiment, Corps, or Detachments, to

which they belong ; but all General. District. and Garrison Staff Officers, are each to make their own separate

XV. The foregoing Order is not meant to prevent General Officers commanding Districts, in particular cases where they are sensible that unavoidable accident alone has prevented an Officer from returning himself for Lodging Money agreeable to this Order, from authorizing the person at the head of the Barrack Department to give in a return of Lodging Money for the back period, so that the Officer, to whom it is due, may recover the same.

XVI. When there are rooms sufficient in the Barracks allotted for a Regiment, Corps or Detachment, for all the Officers belonging thereto, no allowance of Lodging Money can, on any account, be paid to such as may obtain the permission of the Commanding Officer of the Garrison or Post to hire quarters elsewhere for themselves without a special order from the Commander in Chief or the General Officers commanding Districts where he is not resident, except in the case of married Subalterns, with whom it will always be optional to take their Quarters in the Barracks, or not, provided they do not hold the Staff situation of Adjutant or Quarter-Master, these being always required to live in the Barracks, if there are rooms allotted for their accommodation.

XVII When Officers are required to encamp, and no Bat or Forage Money is allowed them, such as were in the receipt of Lodging Money, previous to the encampment, at the close of the same, may be expected to return to their hired Quarters again, will be permitted to continue to receive their Lodging Money during the period they are encamped; the same indulgence will be extended to such Officers as may suddenly be ordered on command, and afterwards return to their hired Quarters, for the period they have been so absent, provided such does not exceed one whole Quarter beyond that in the course of which they may be moved.
