**An Act to annex School Section No. 3, in the Township of Matilda, in the County of Dundas, to the School Section of the Village of Iroquois.**

**W**HEREAS previous to the incorporation of the Village of Iroquois, Preamble. in the Township of Matilda, in the County of Dundas, the Trustees of School Section No. 3 of the said Township of Matilda, within the limits of which the said village of Iroquois then was, did by special assessment of the inhabitants of the said School Section, erect within the limits of the said village, a large and commodious stone school house; And whereas by virtue of such incorporation, and the said Village of Iroquois thereby becoming a distinct School Section, the inhabitants of the said section as at present constituted have no voice in matters relating to the management of the said School House, to their great detriment and inconvenience, and in order to remedy such injustice they have prayed that the said School Section may be annexed to the Municipality of the village of Iroquois for school purposes only; Therefore Her Majesty, &c., enacts as follows:

- 15 I. From and after the                    day of                    next, the present School Section No. 3 of the Township of Matilda, in the County of Dundas, shall with the Village of Iroquois, in the said Township of Matilda, form one School Section irrespective of the incorporation of the said Village, and the inhabitants of the said united School Section shall, upon 20 such union, be at once restored to all the rights and privileges with respect to the School House above mentioned, and the other property appertaining to the former School Section, No. 3, which they would have hitherto enjoyed if the said Village of Iroquois had not been incorporated.

- 25 II. This Act shall be deemed a public Act.
